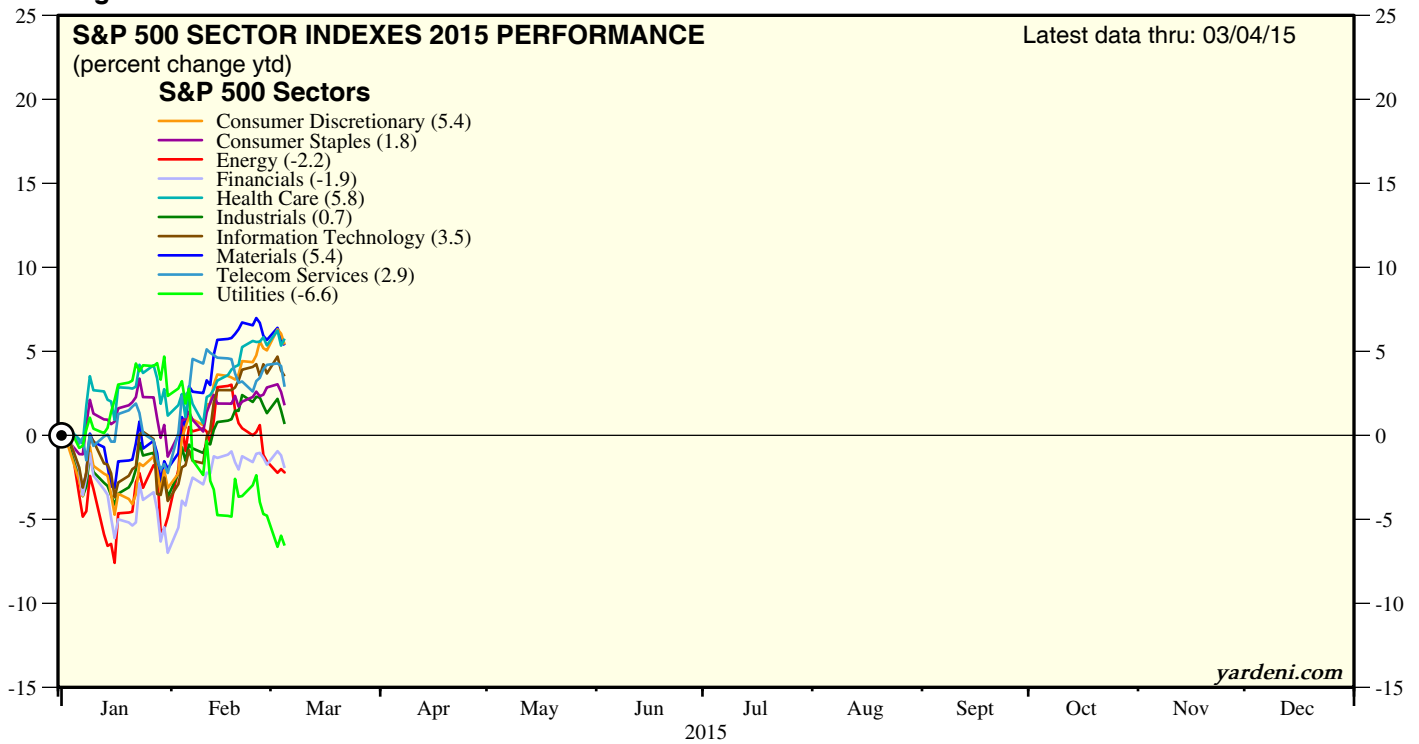
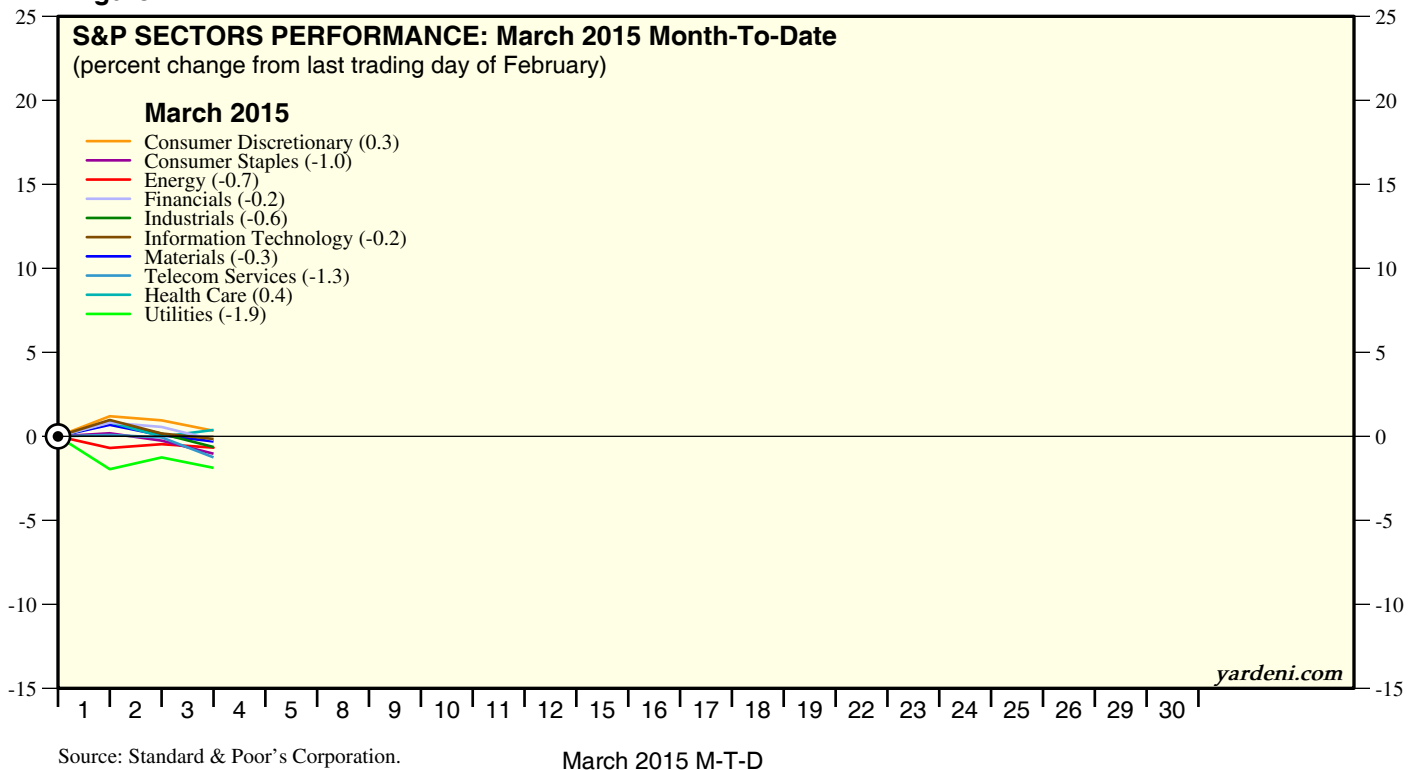

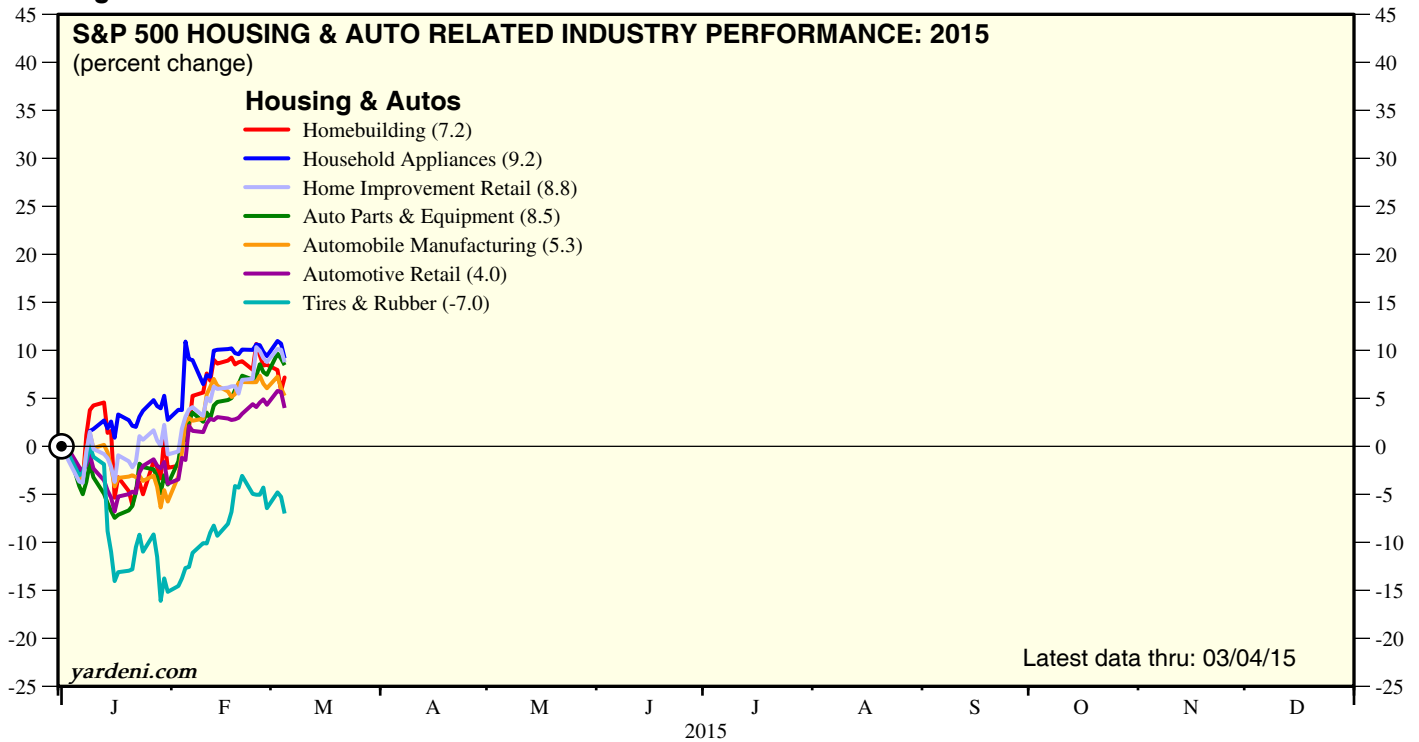

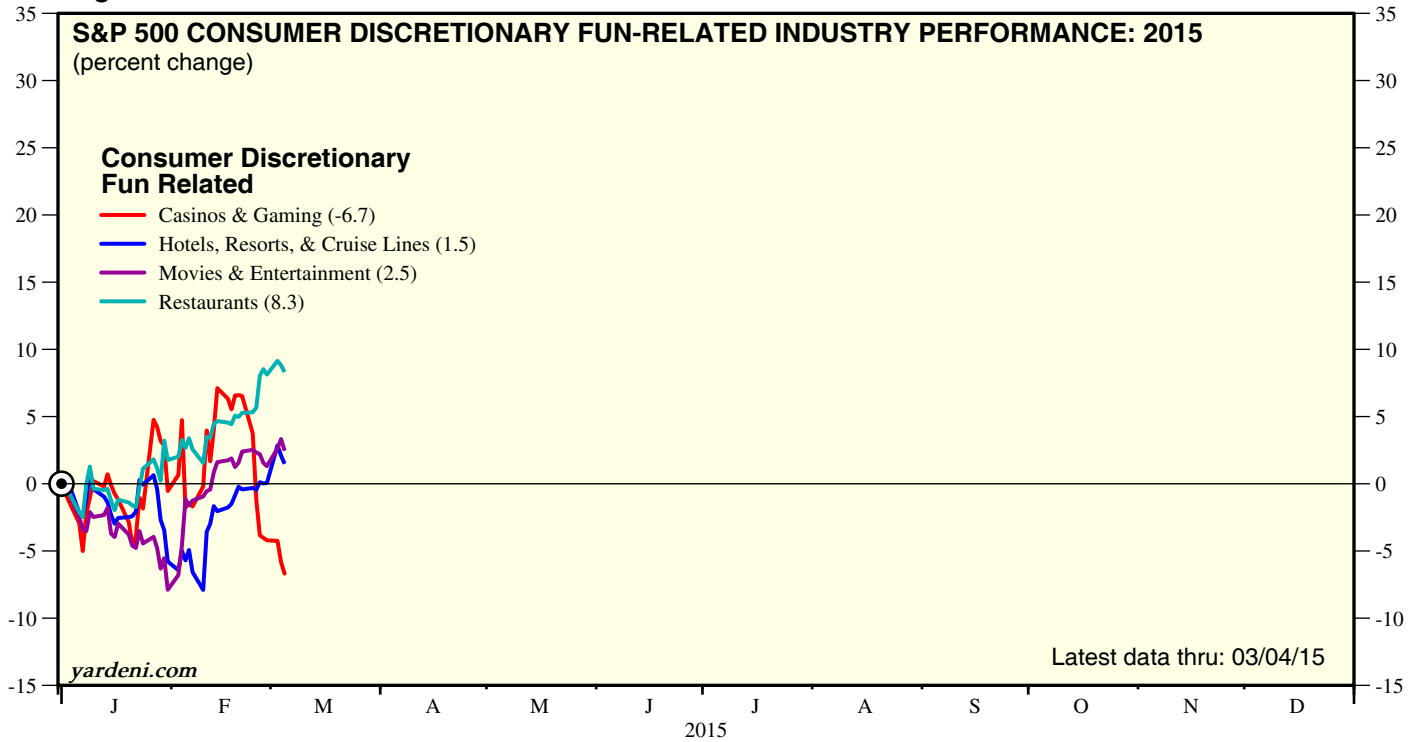

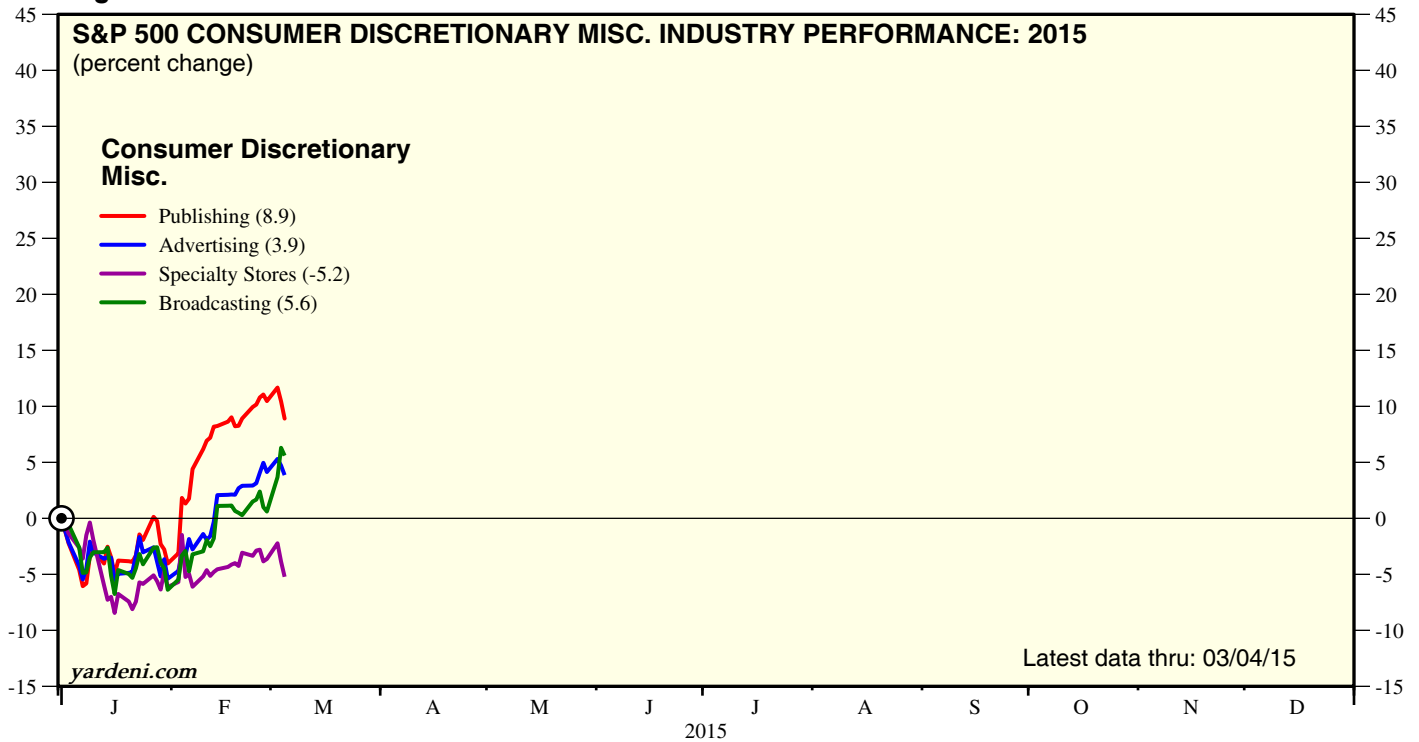

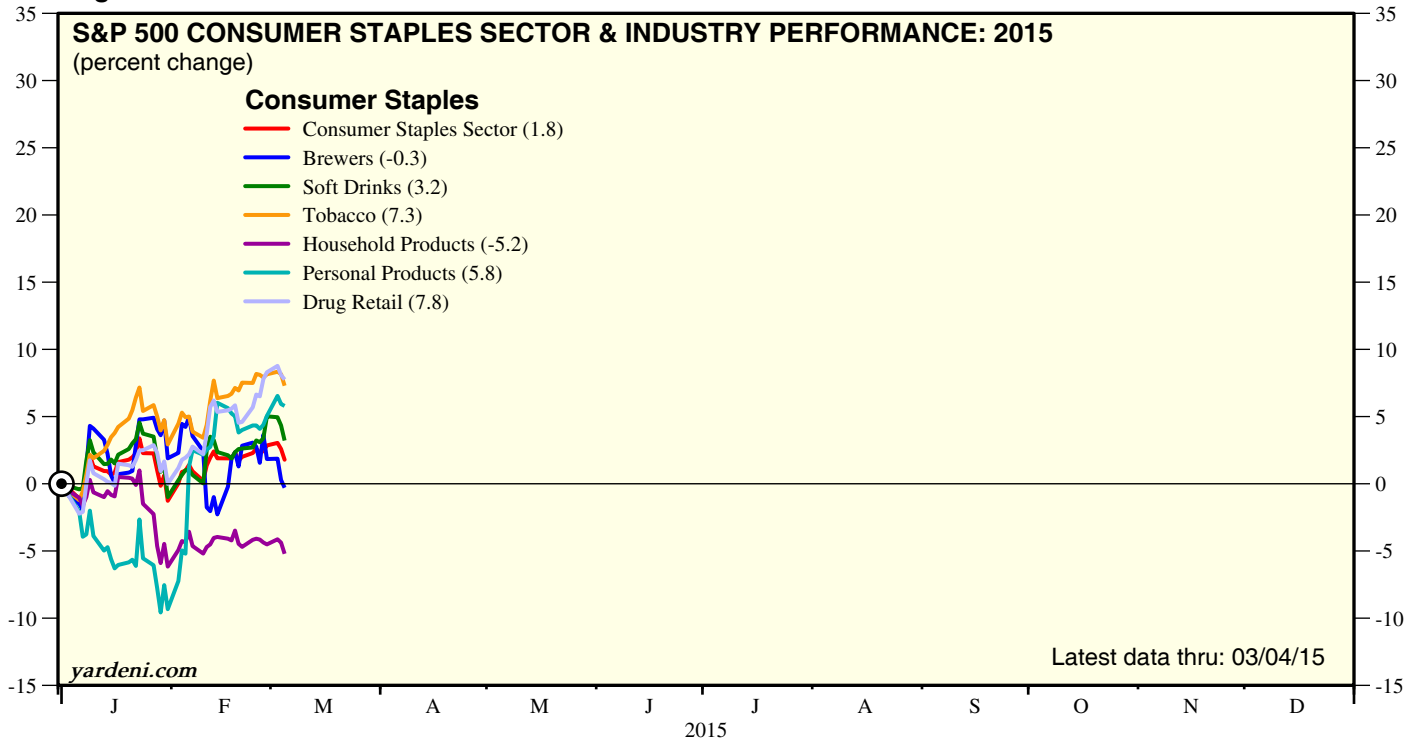

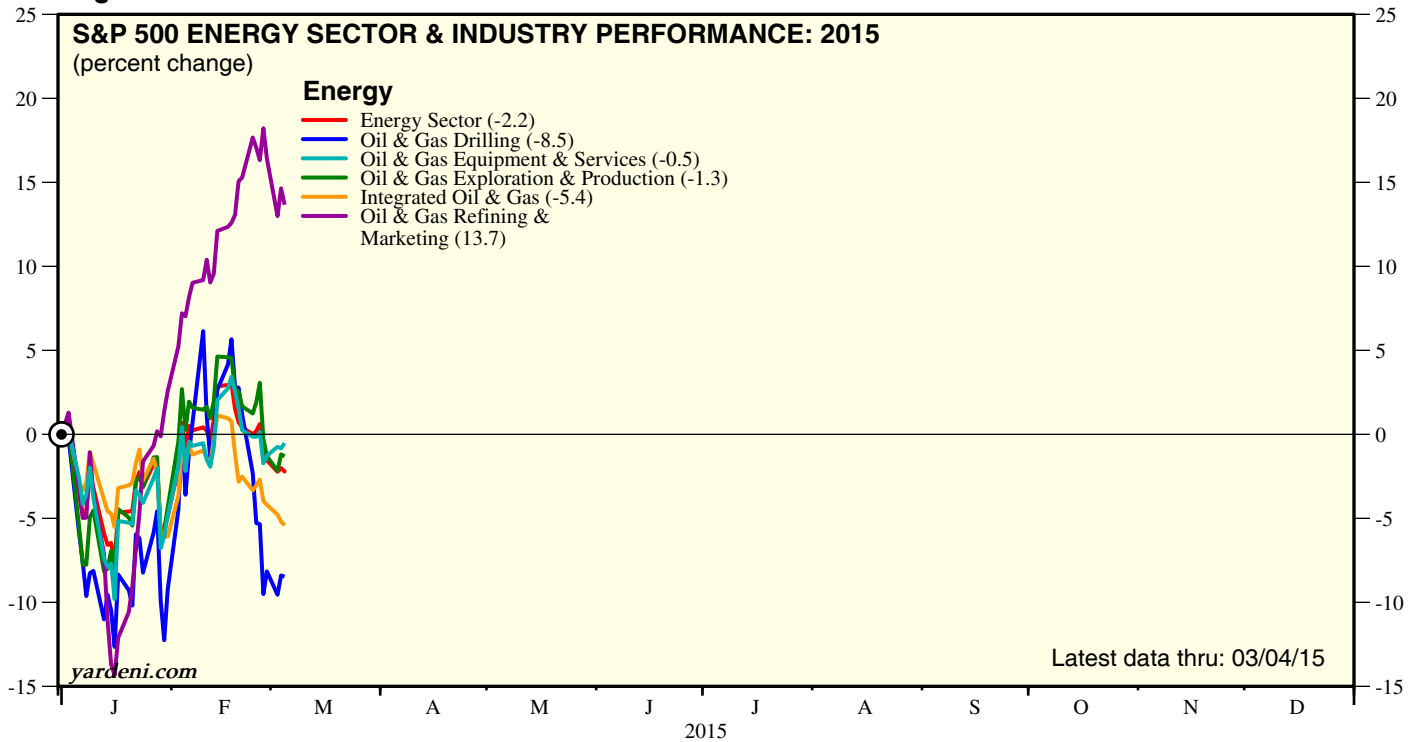
S&P 500 Consumer Staples & Energy

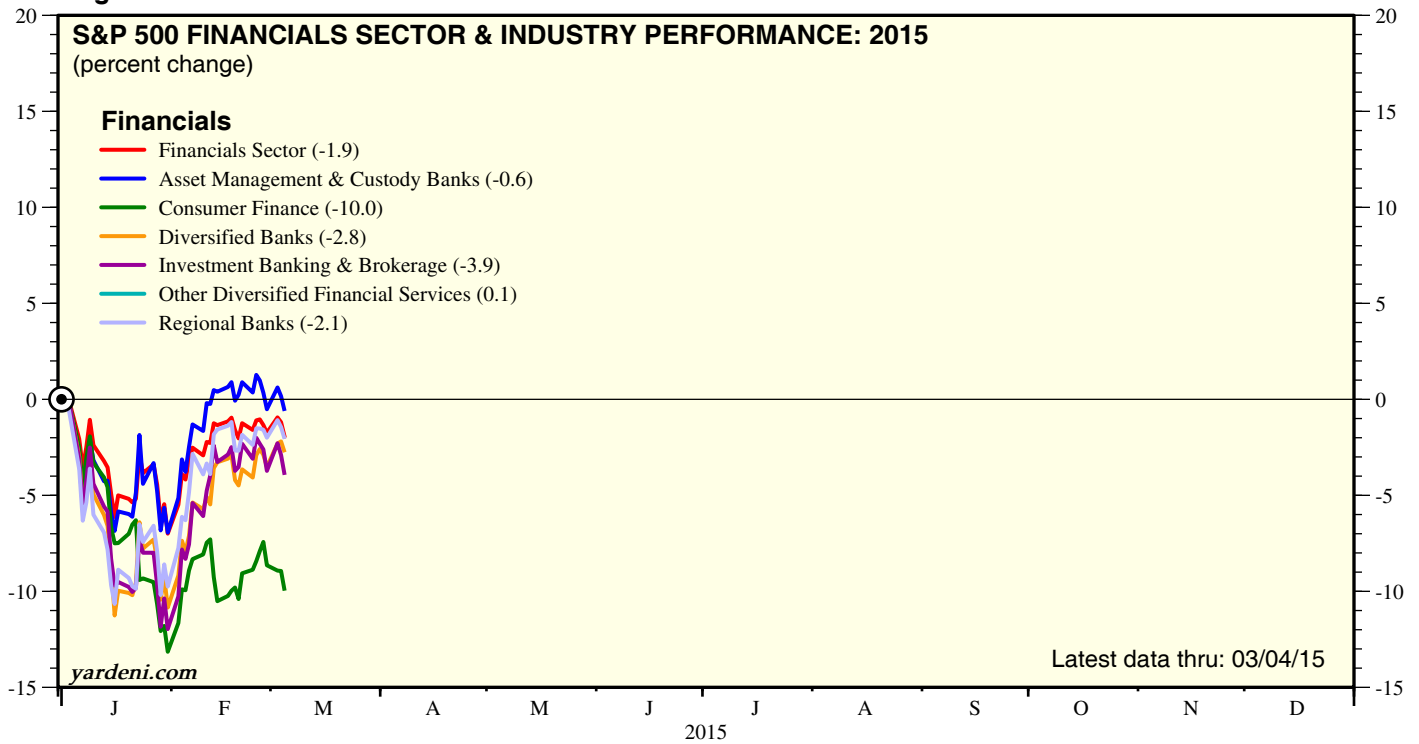

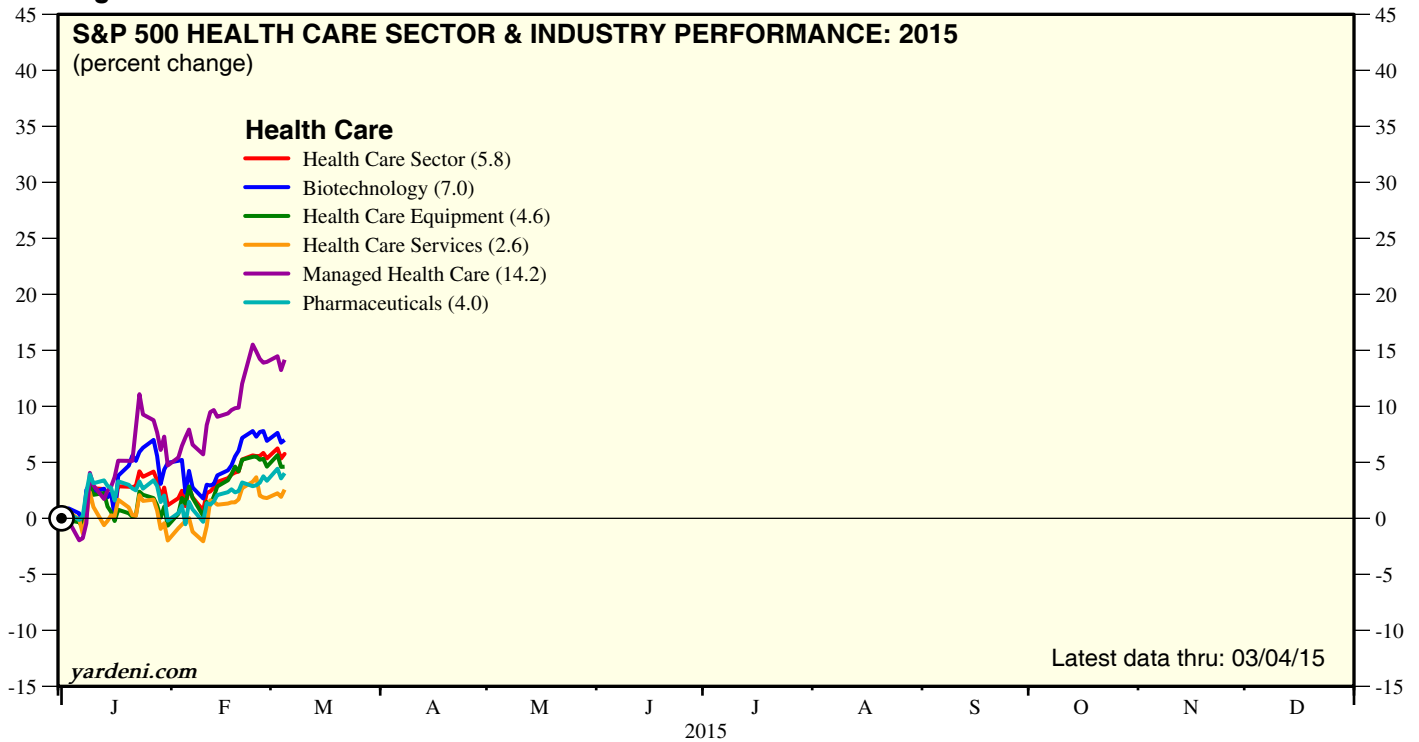
S&P 500 Financials & Health Care

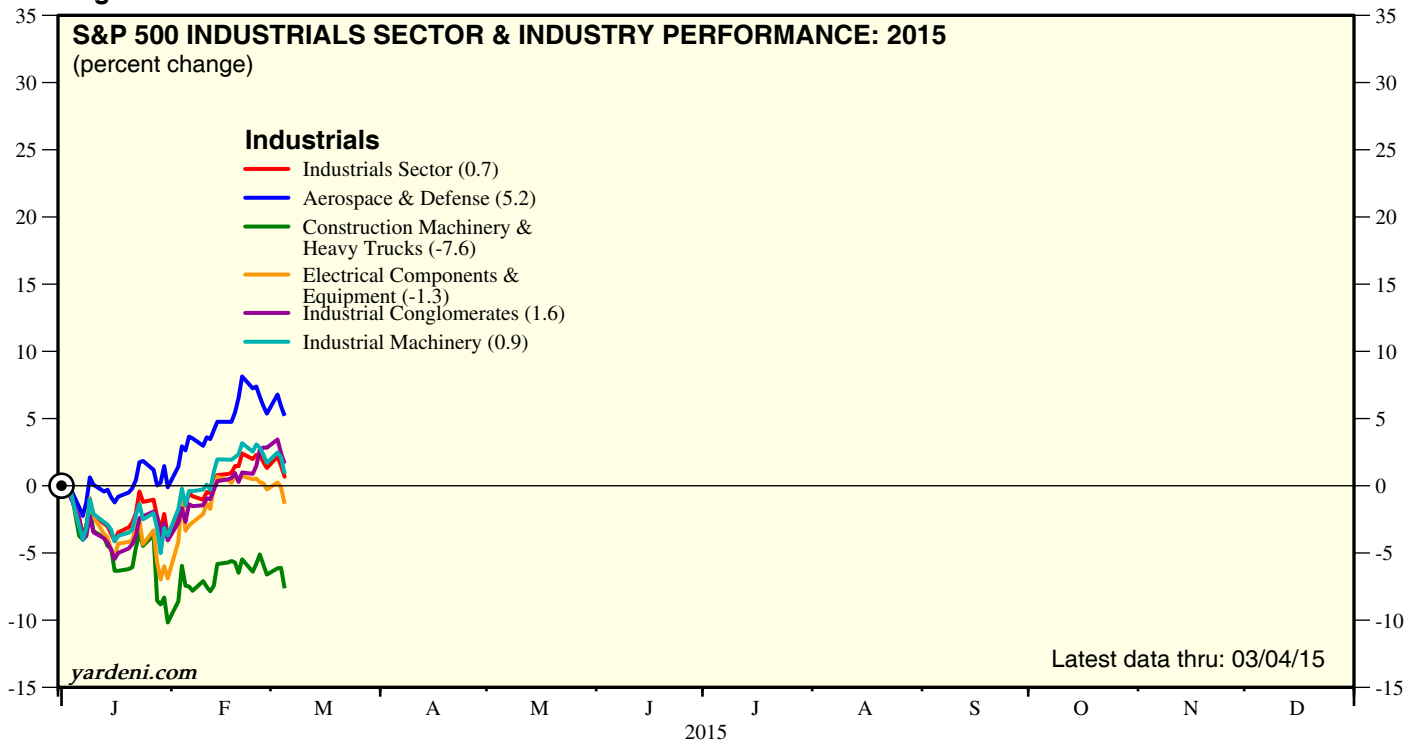

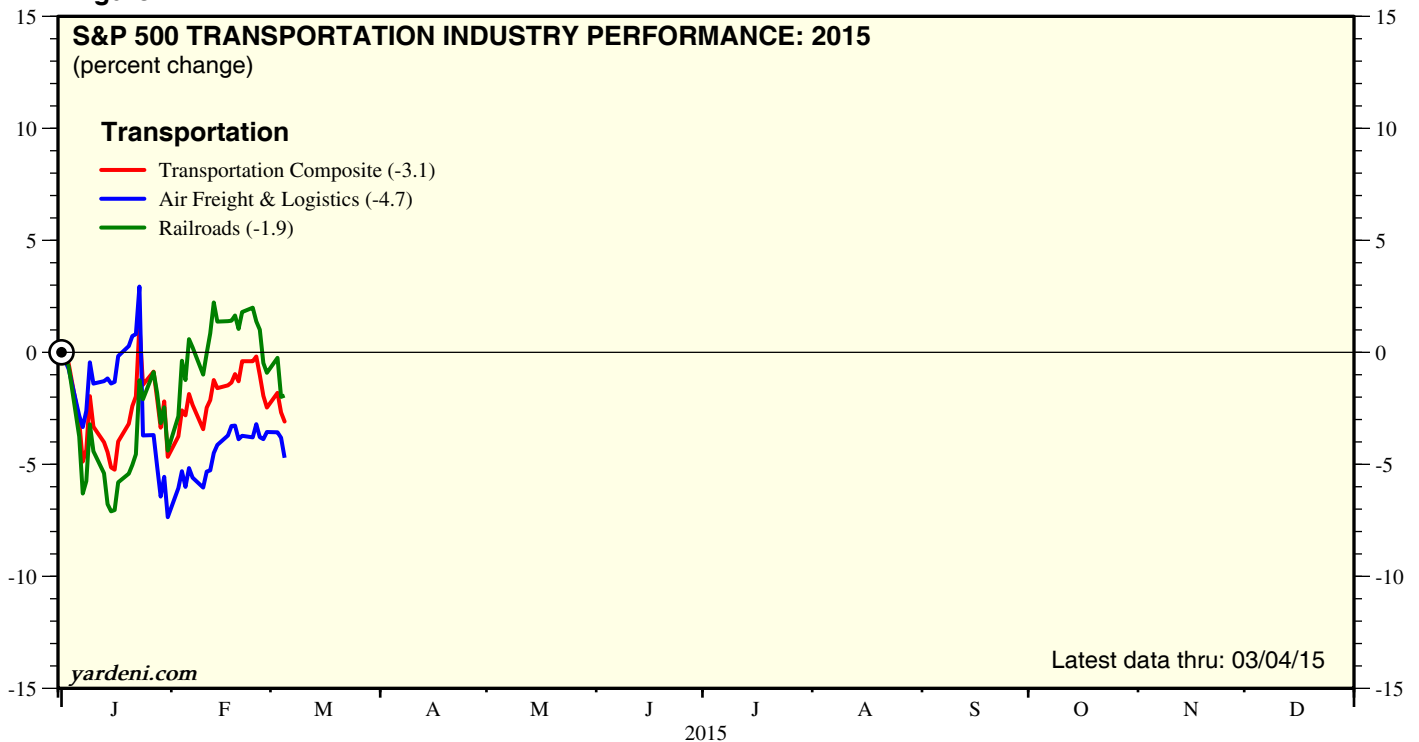
S&P 500 Industrials & Transportation

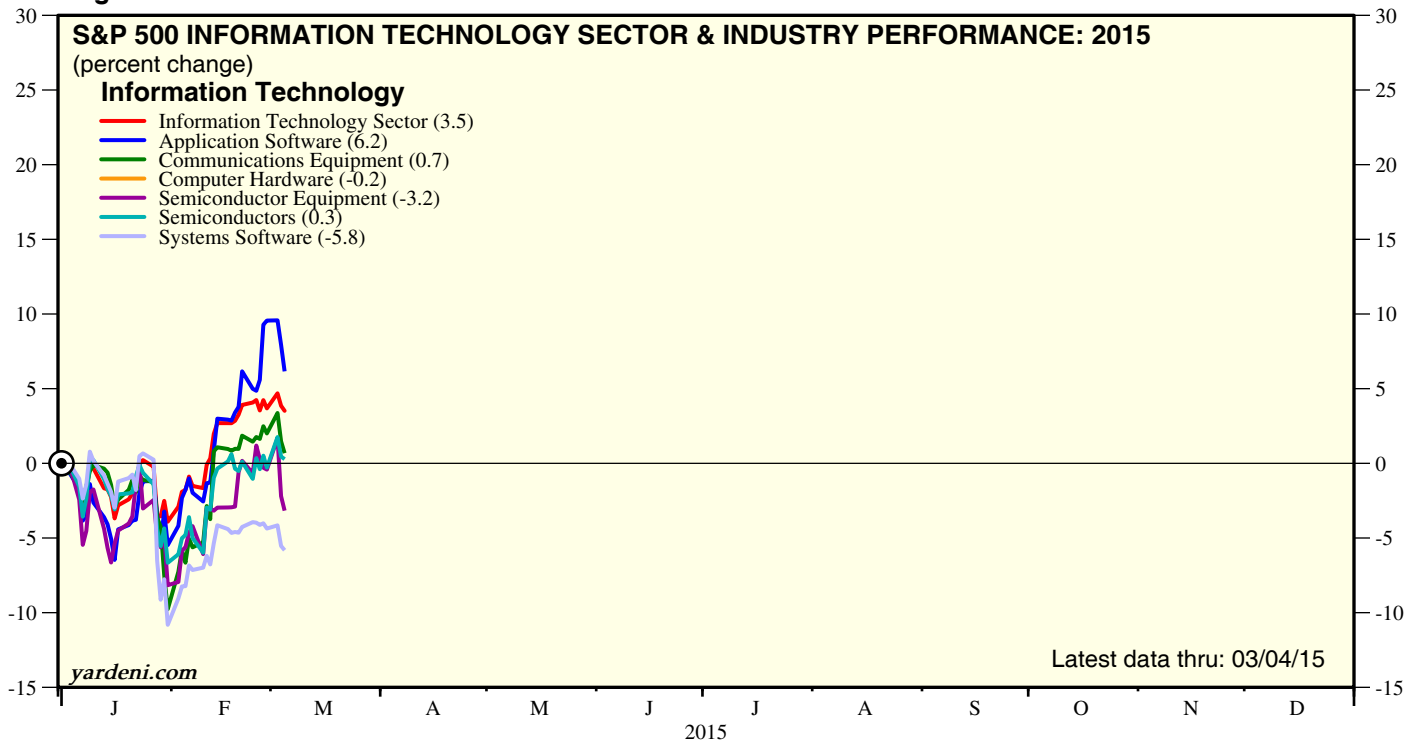

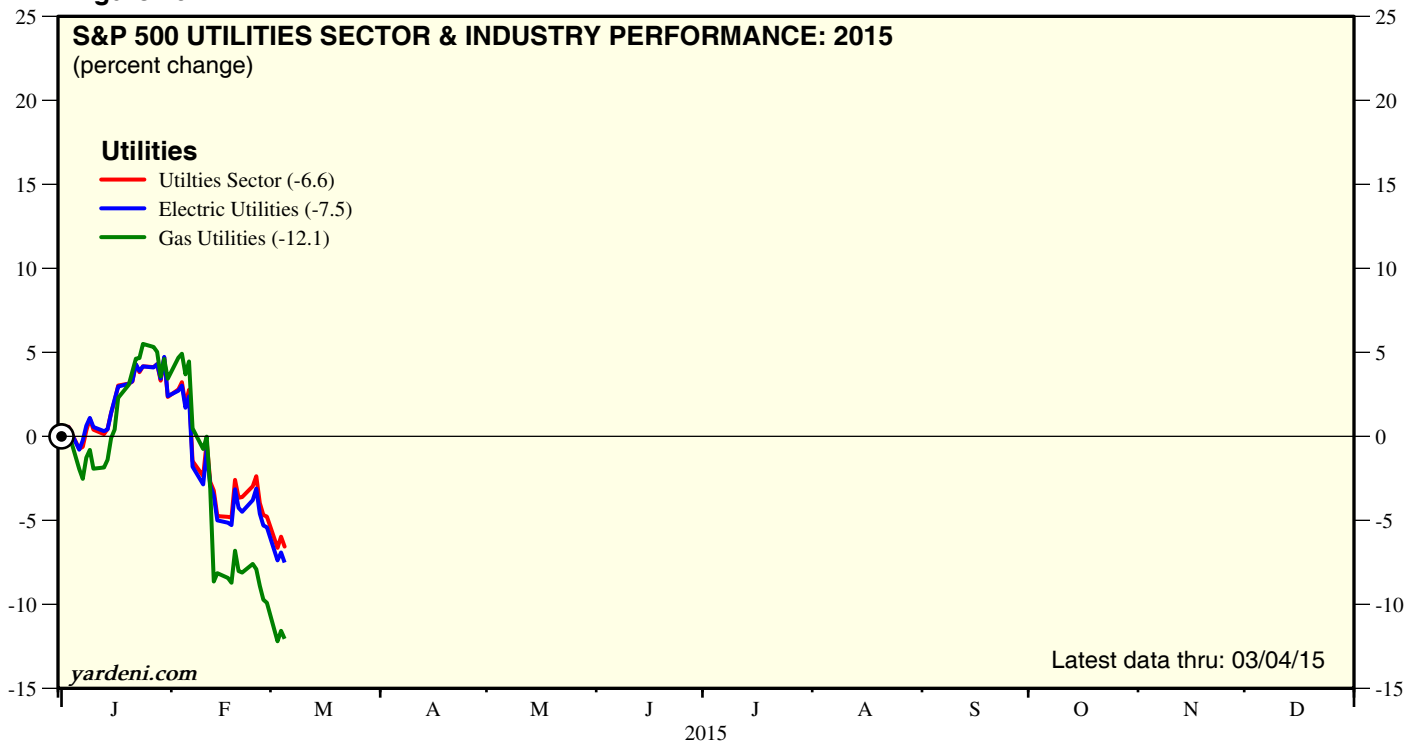
S&P 500 Telecommunication Services & Utilities
