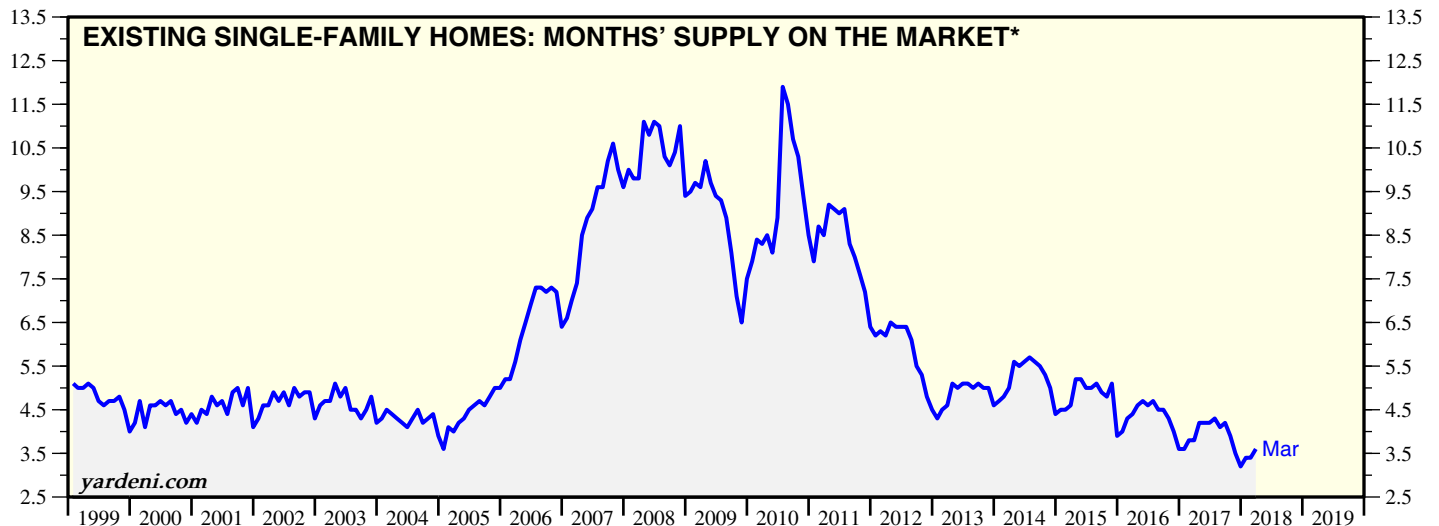
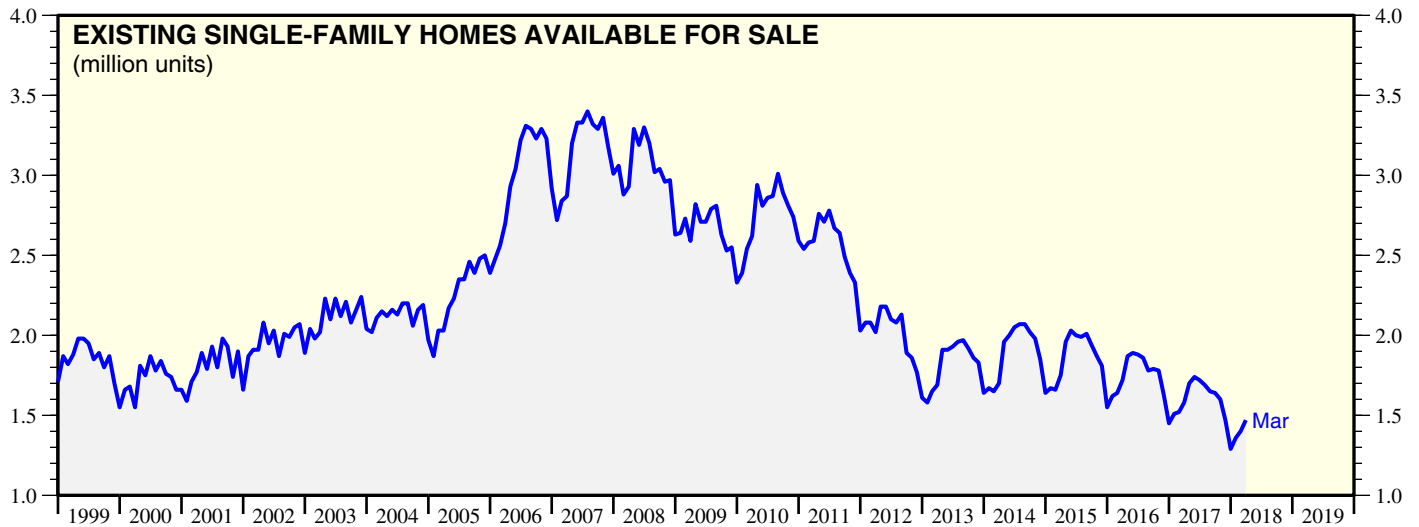
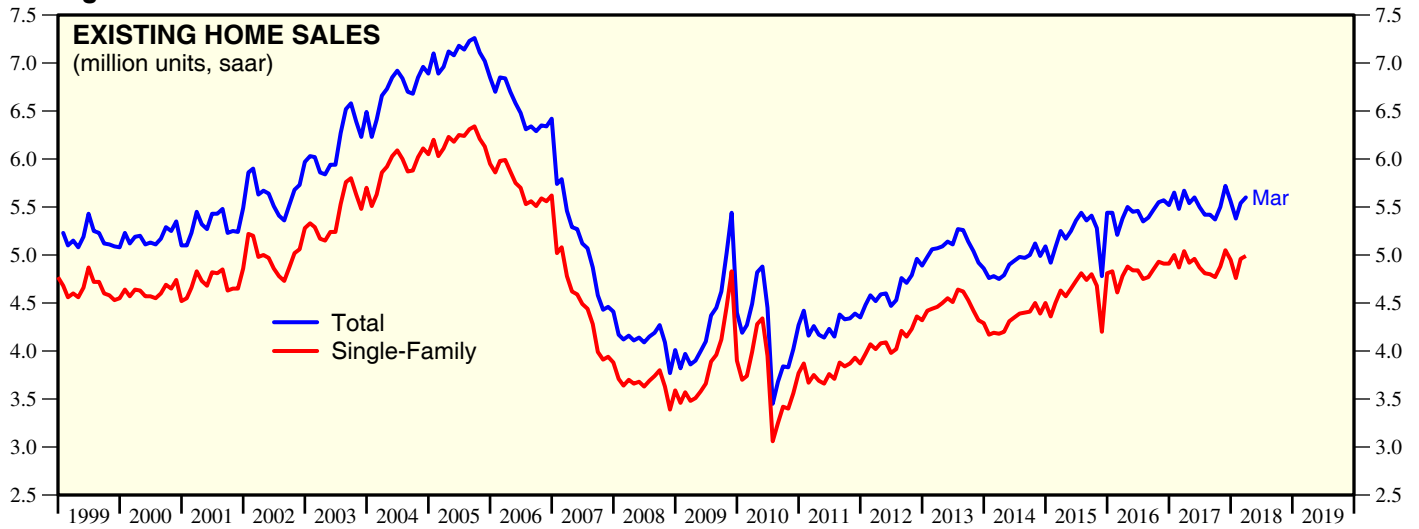

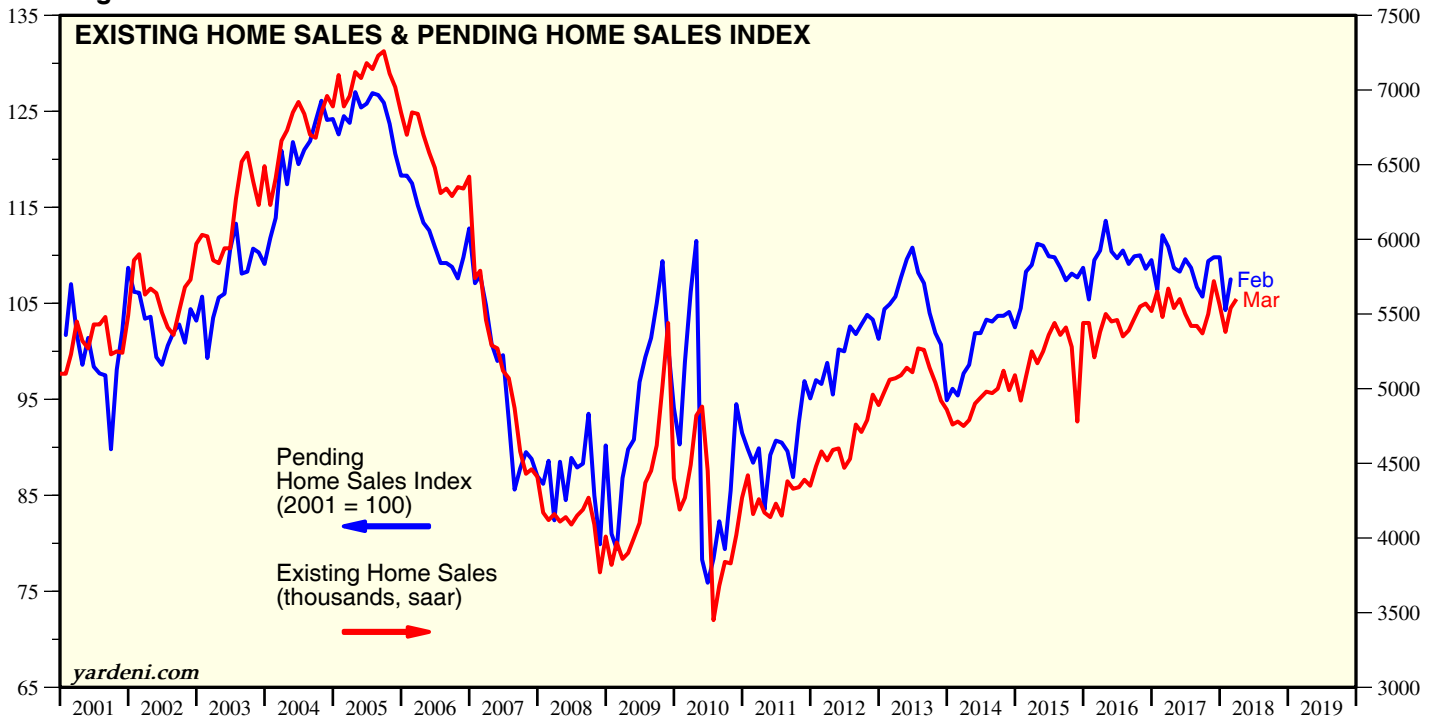


* Ratio of existing single-family homes for sale to existing single-family homes sold.

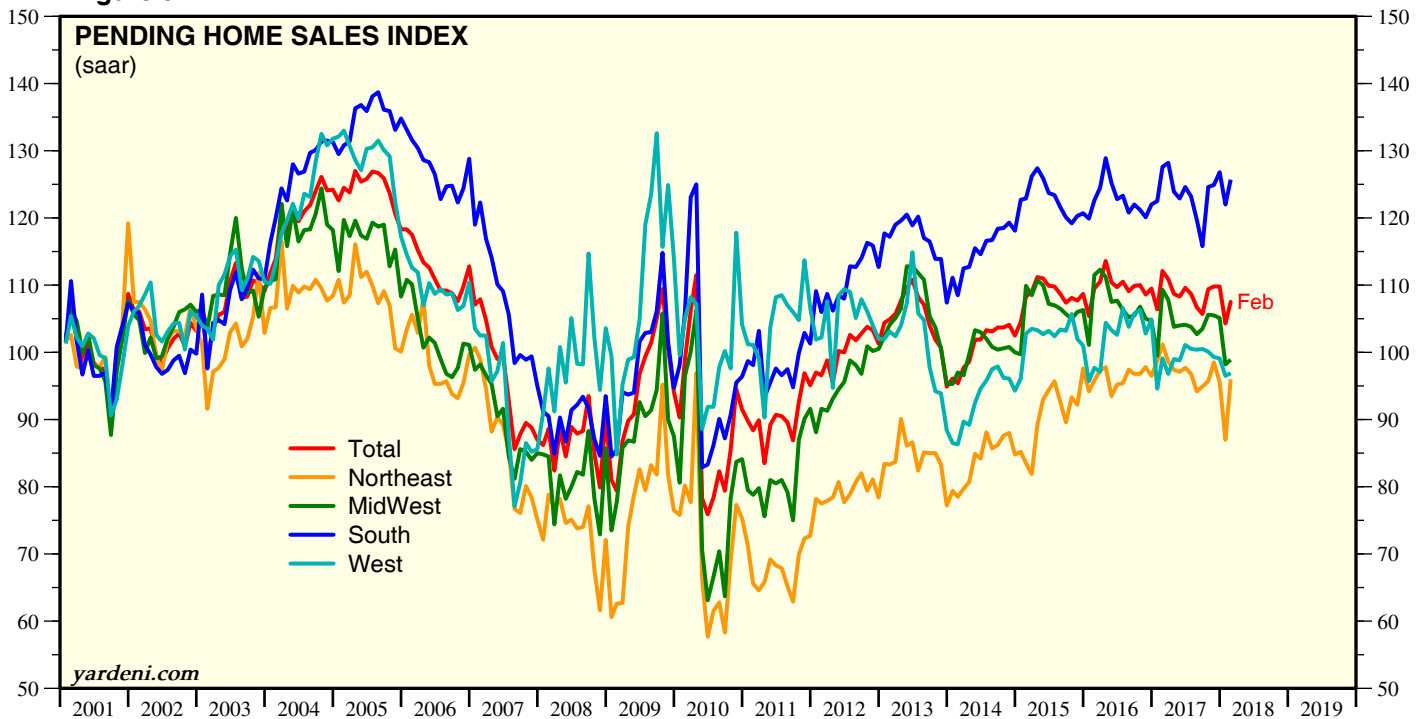

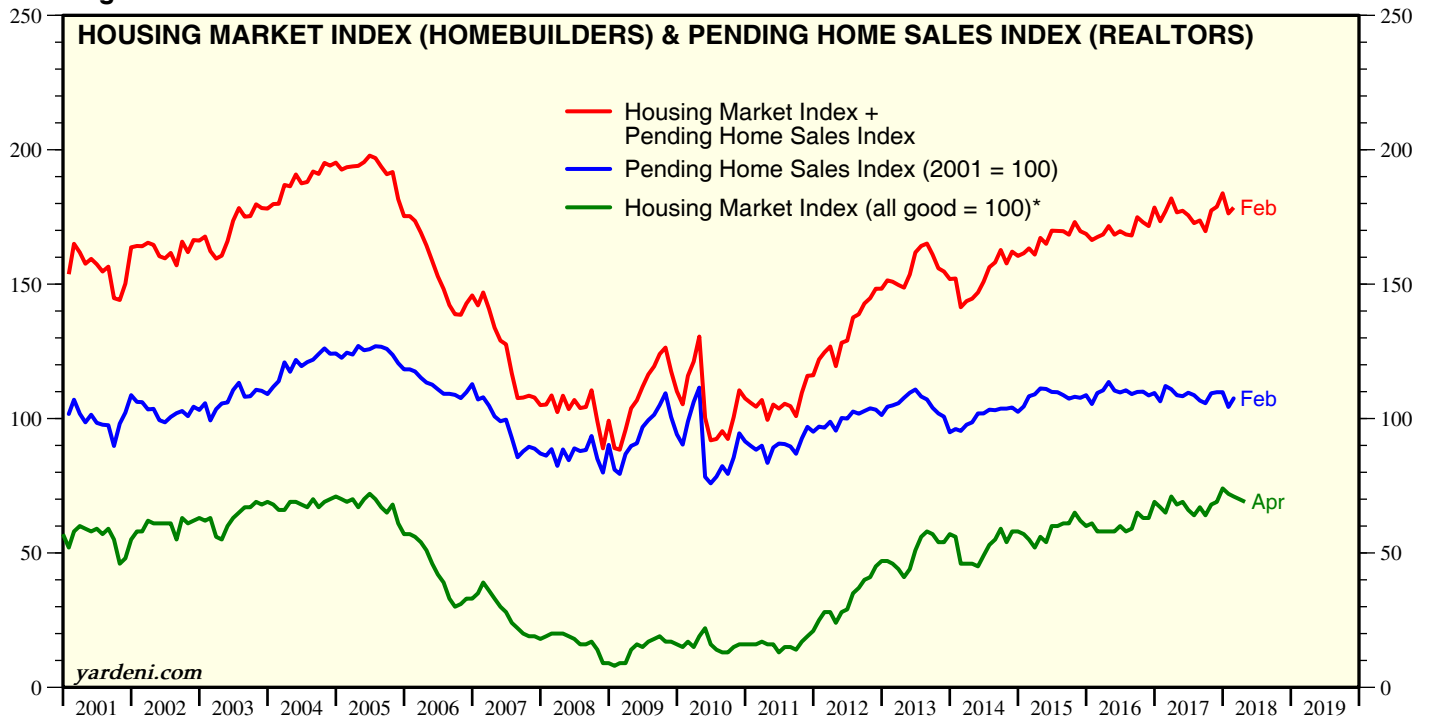
