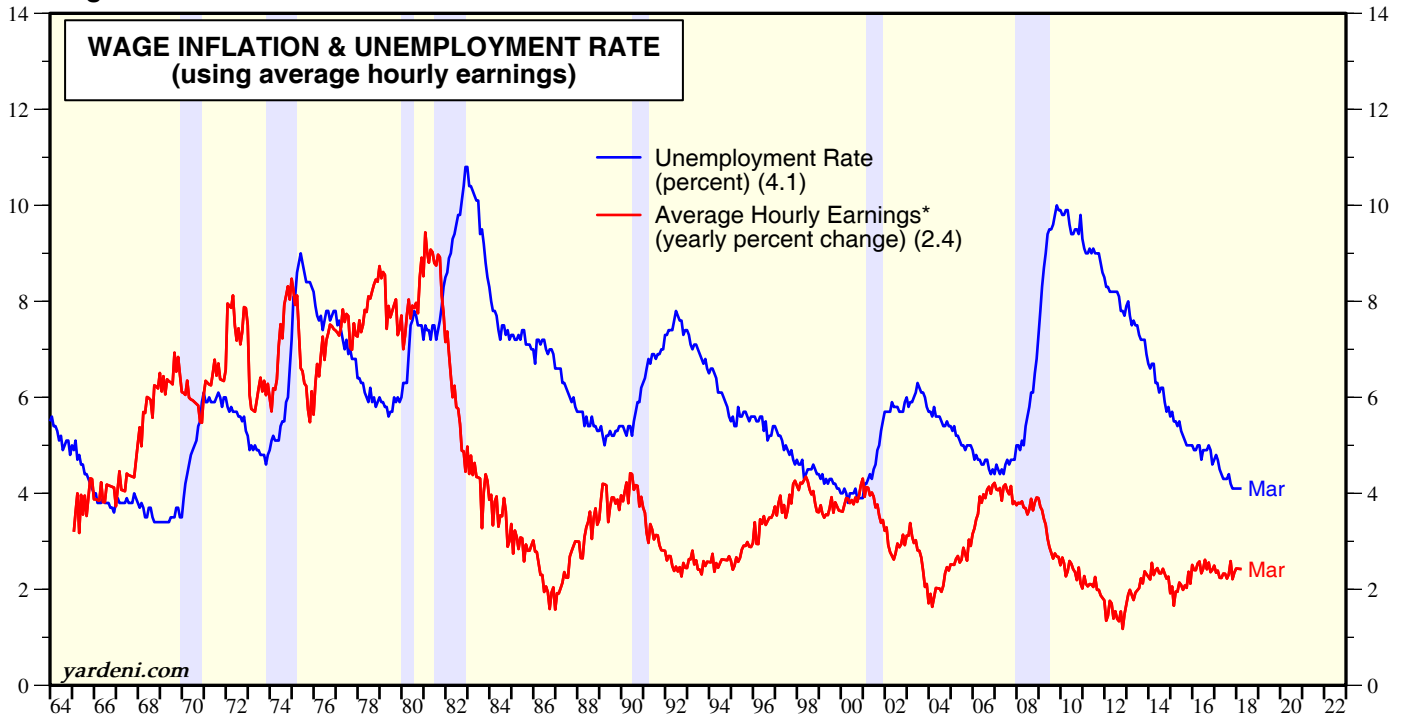

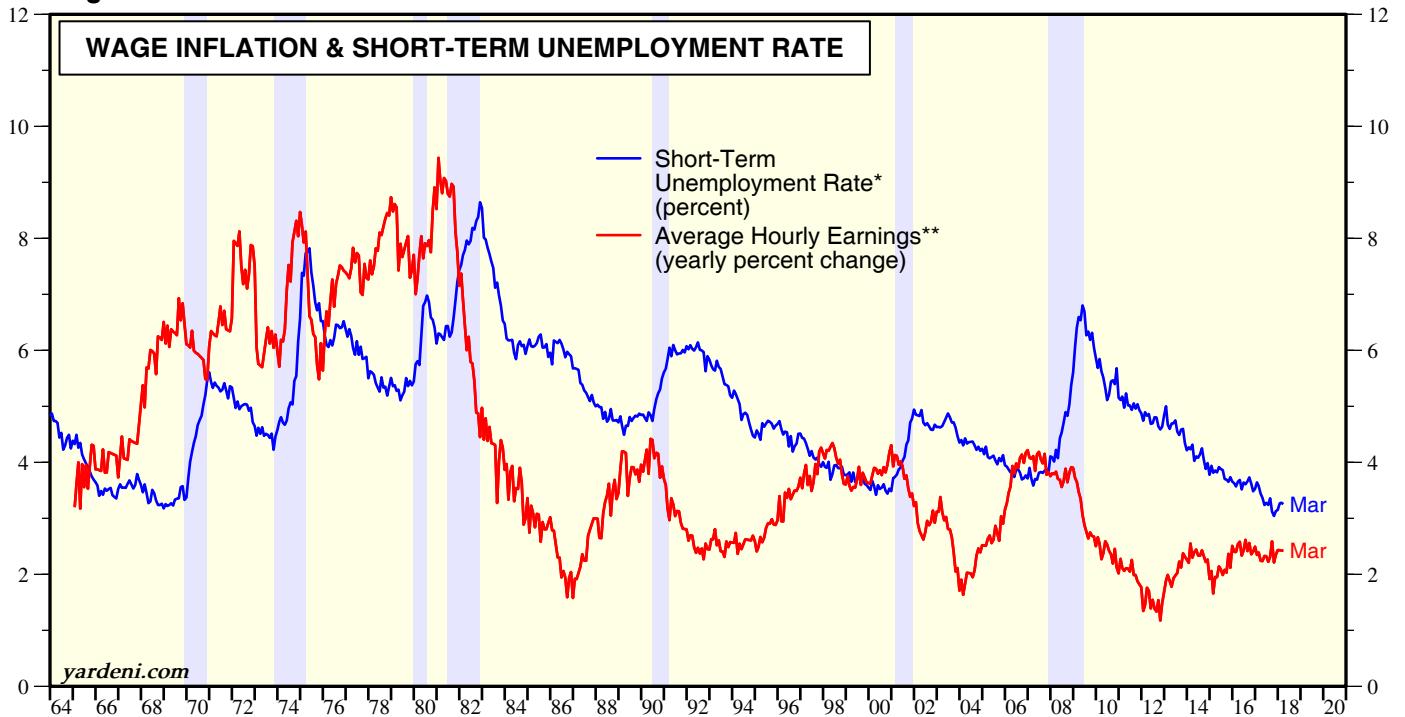

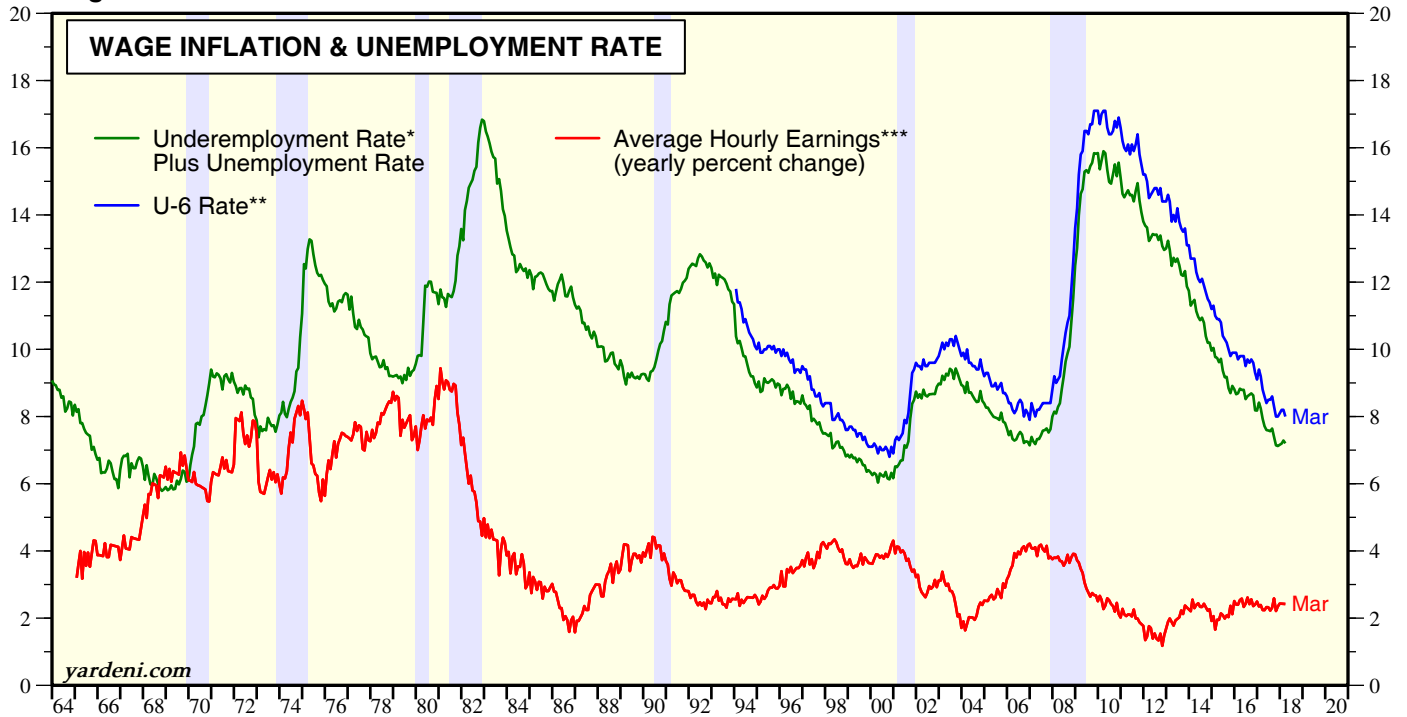

 Note: Shaded areas denote recessions according to the National Bureau of Economic Research.

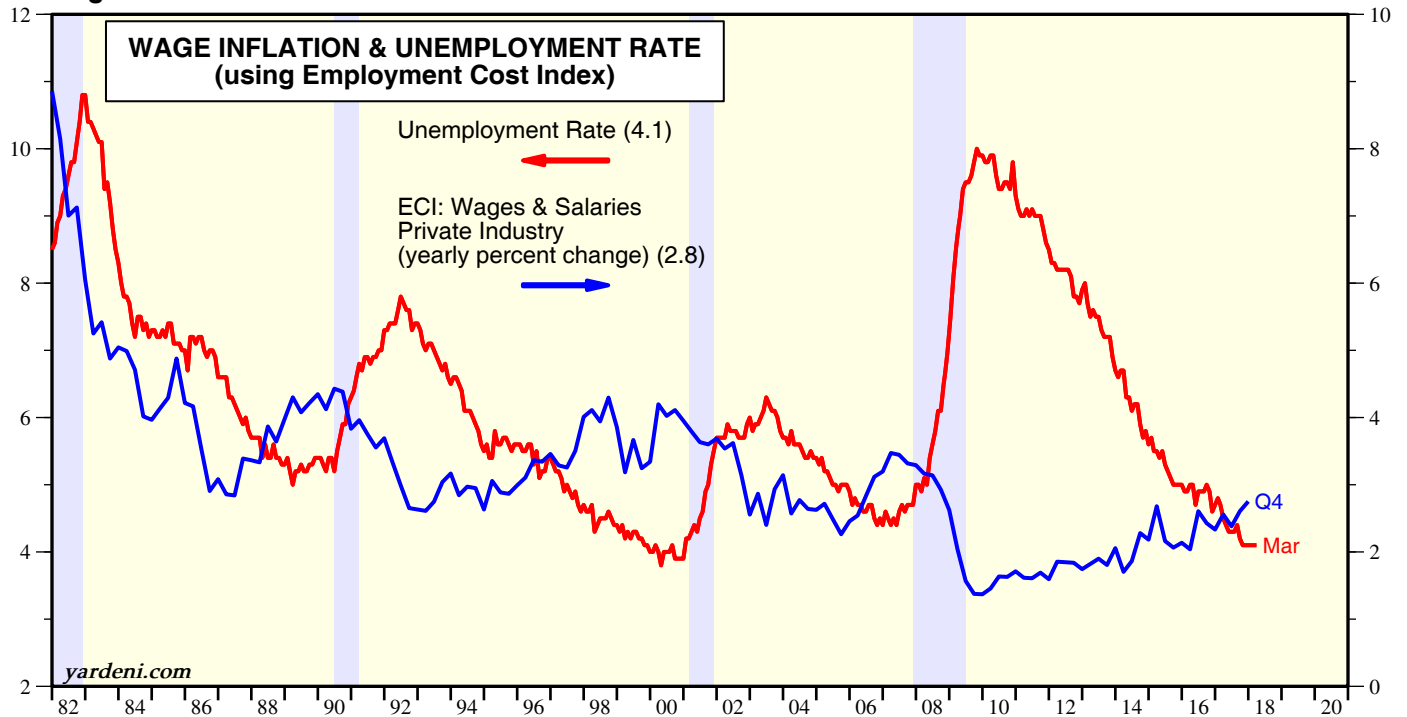

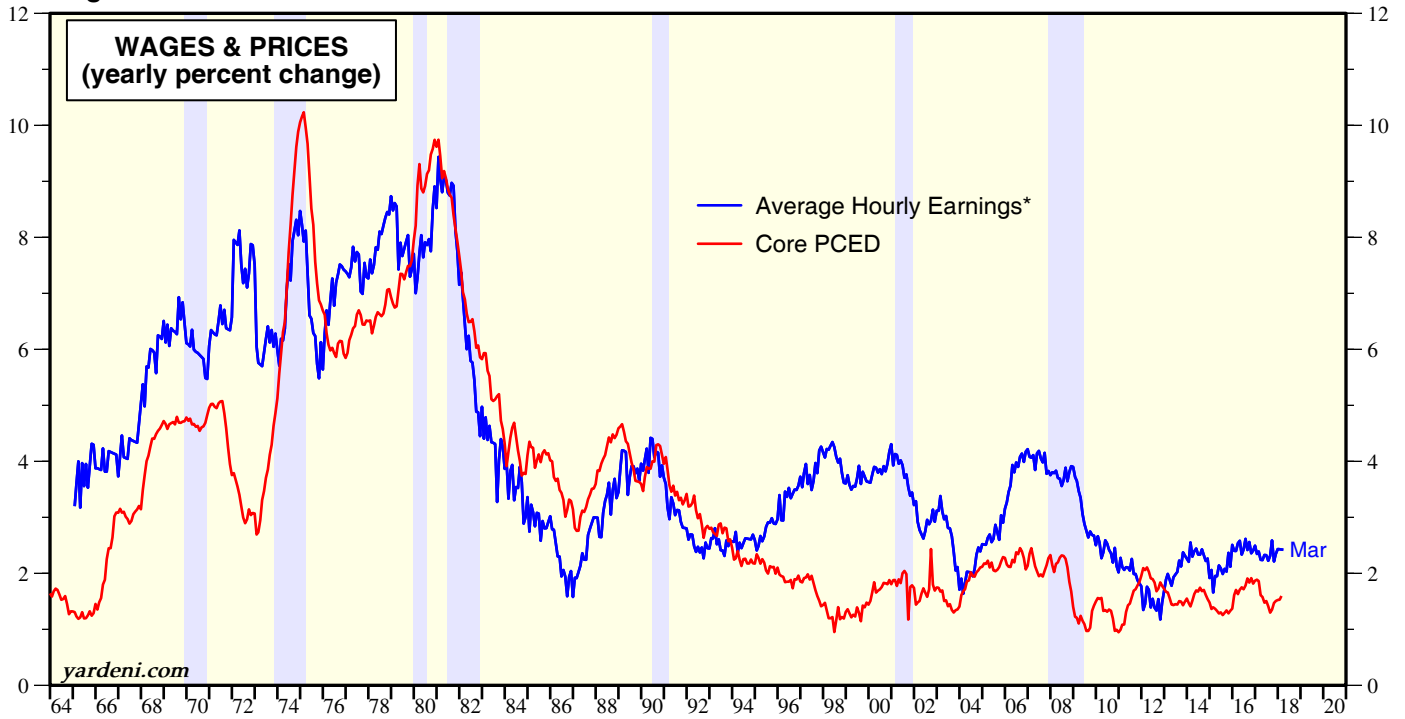

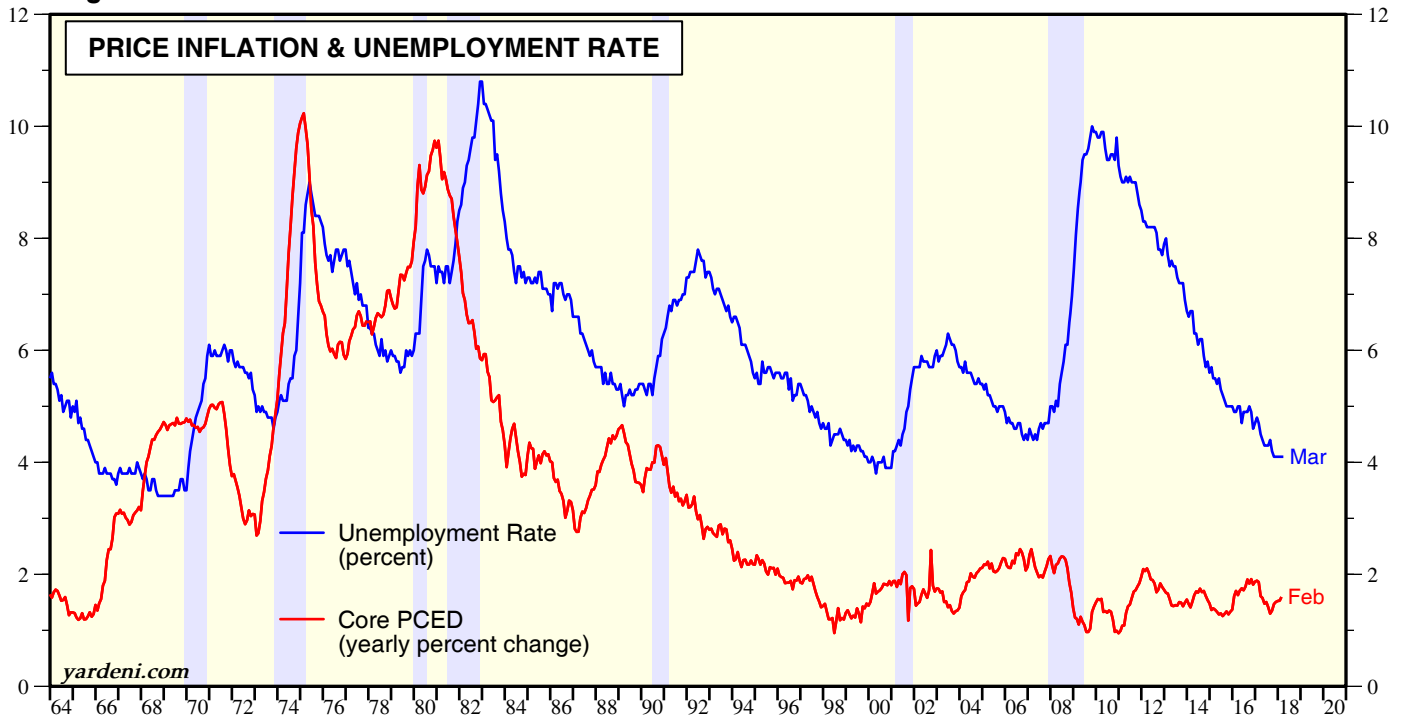

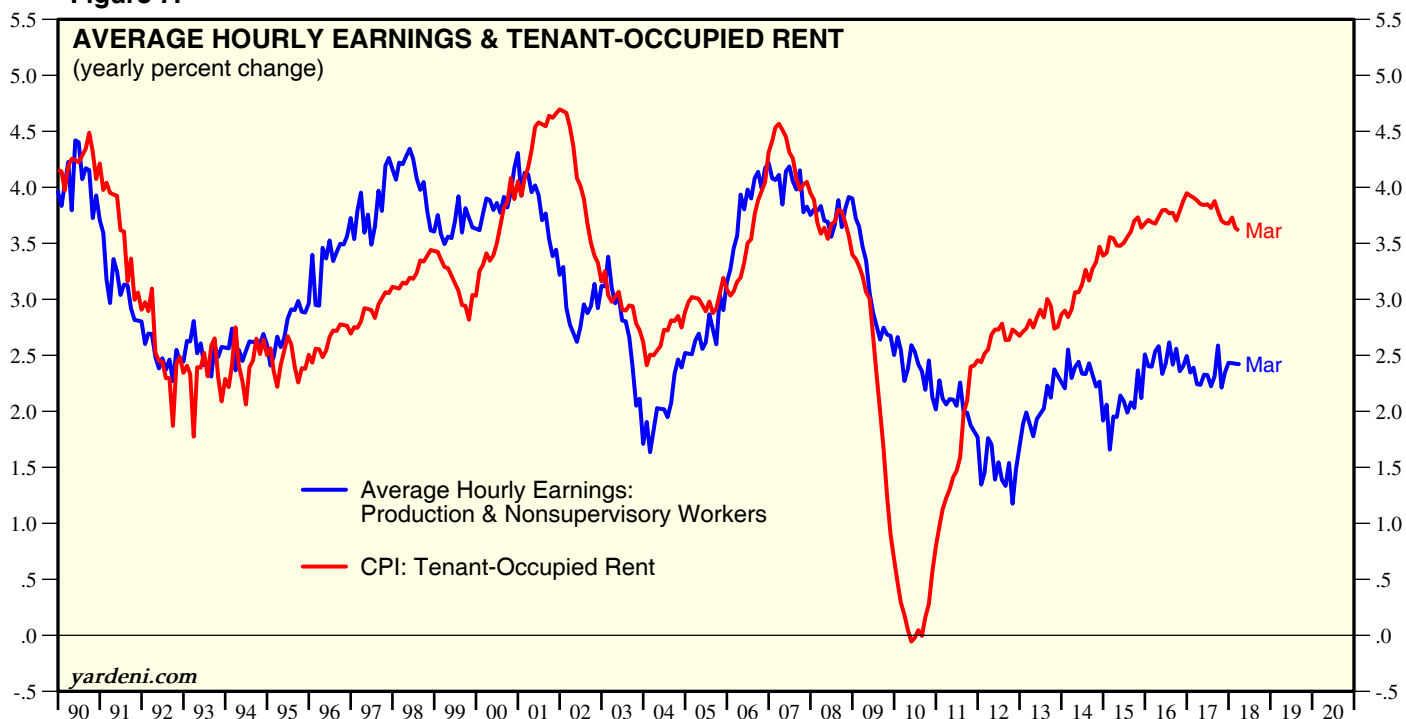

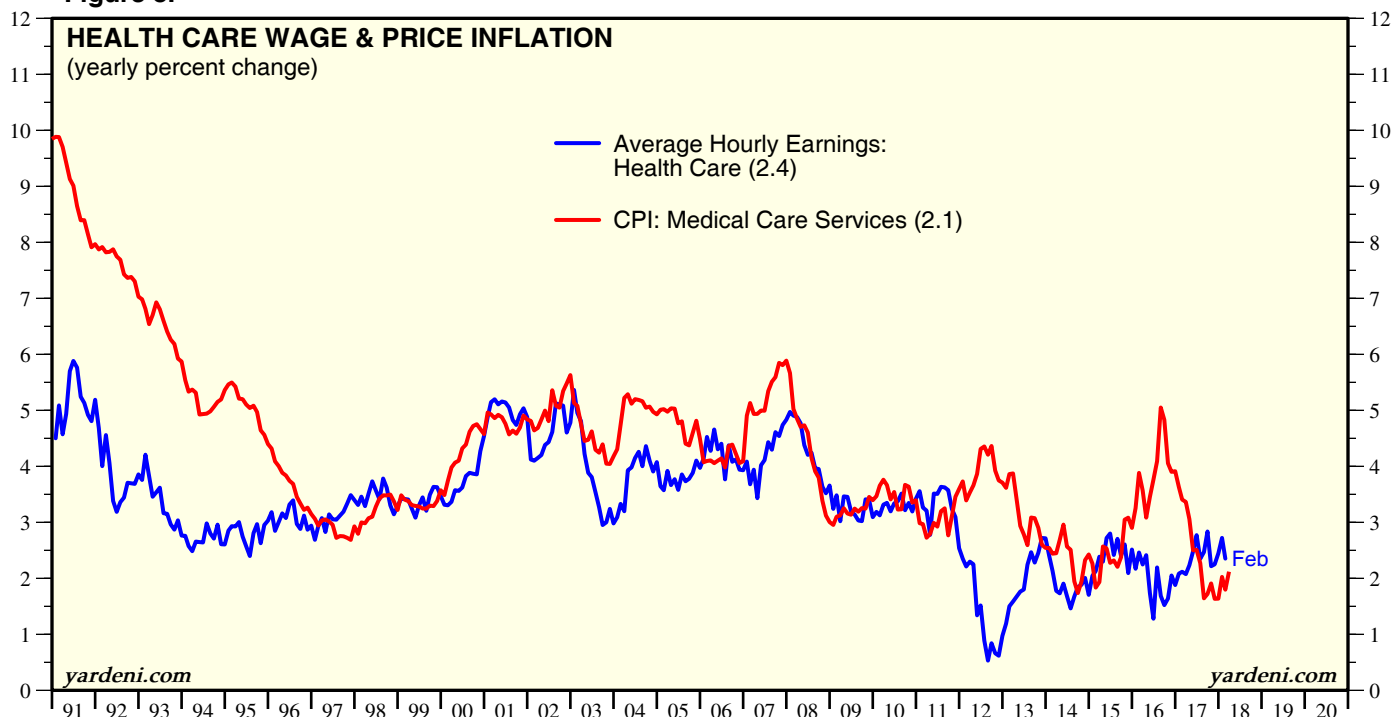
Average Hourly Earnings

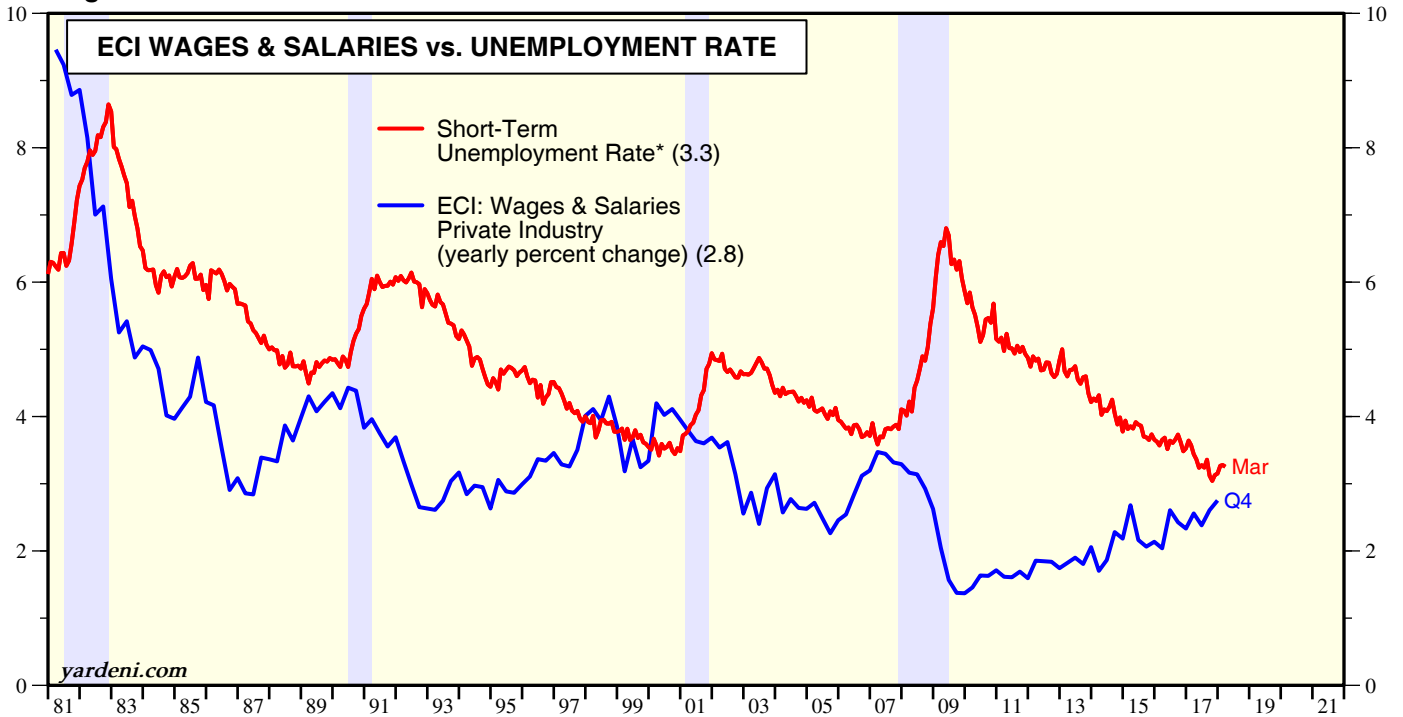

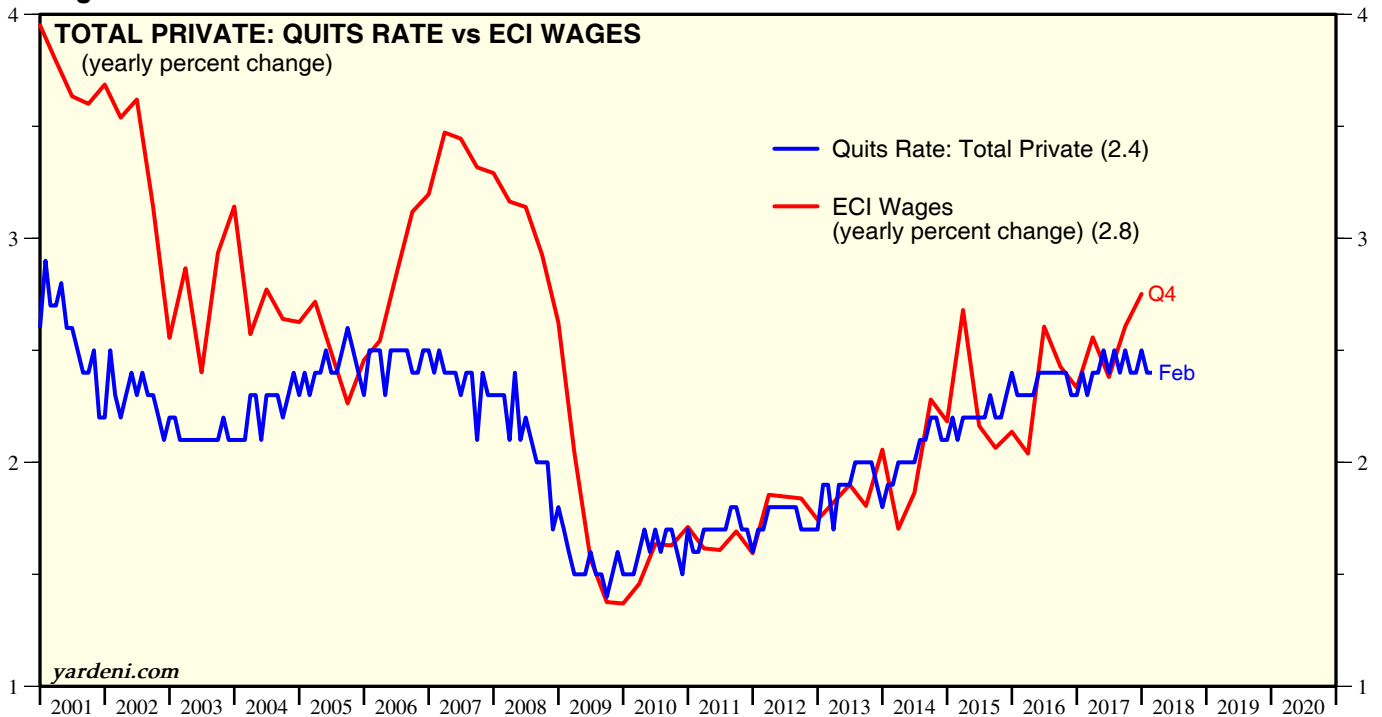

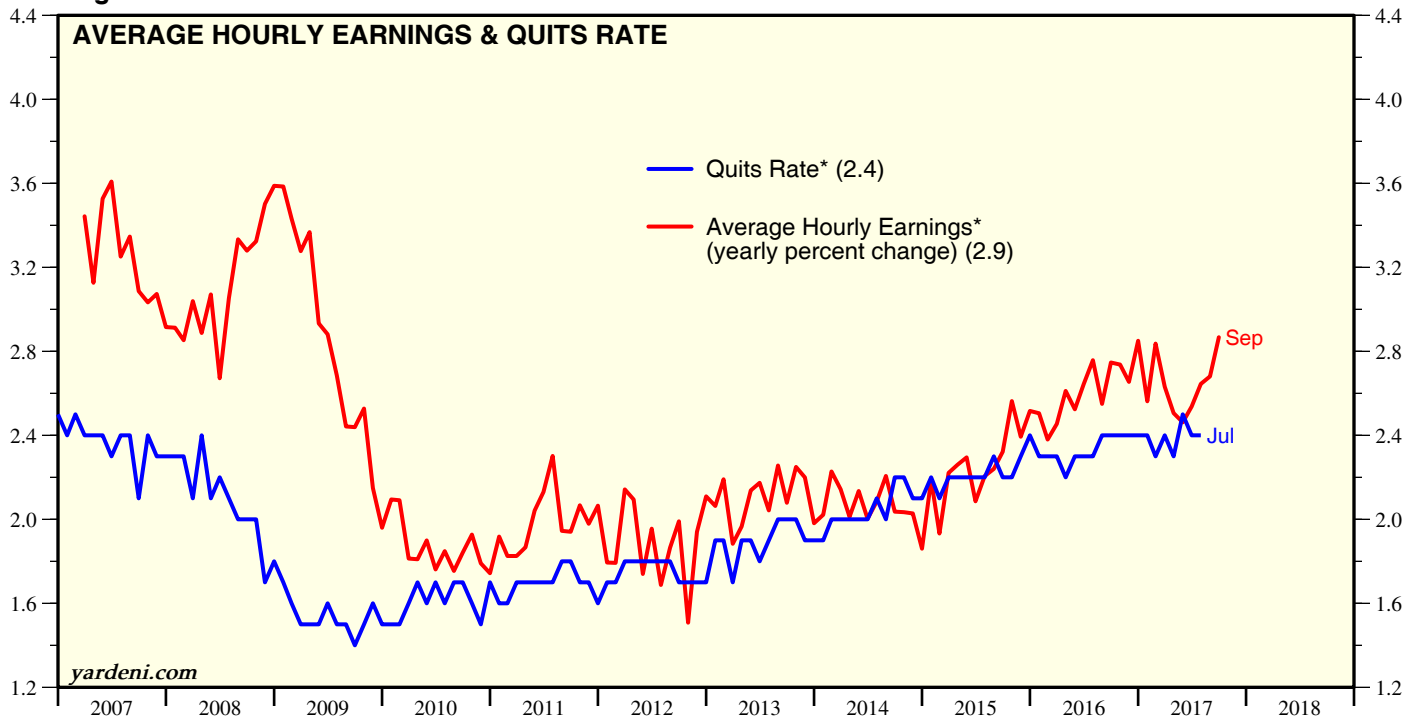

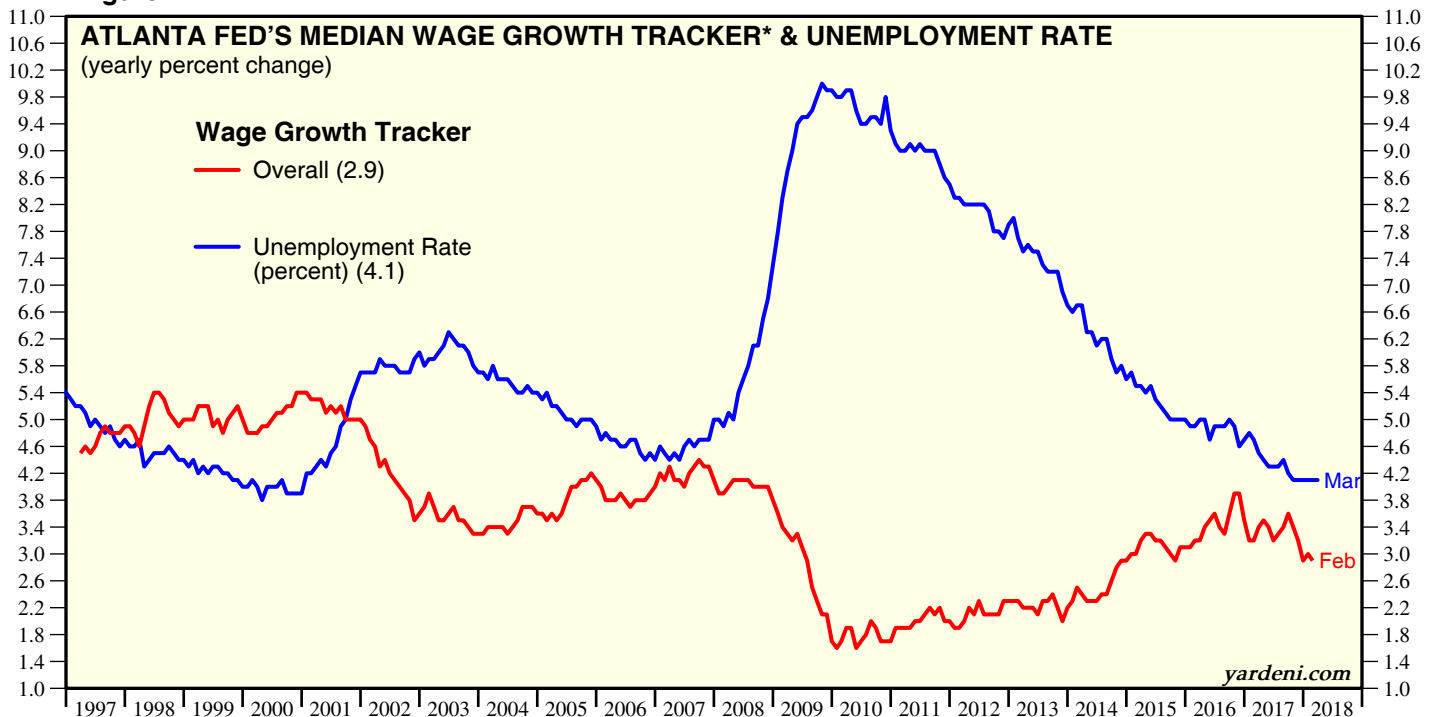

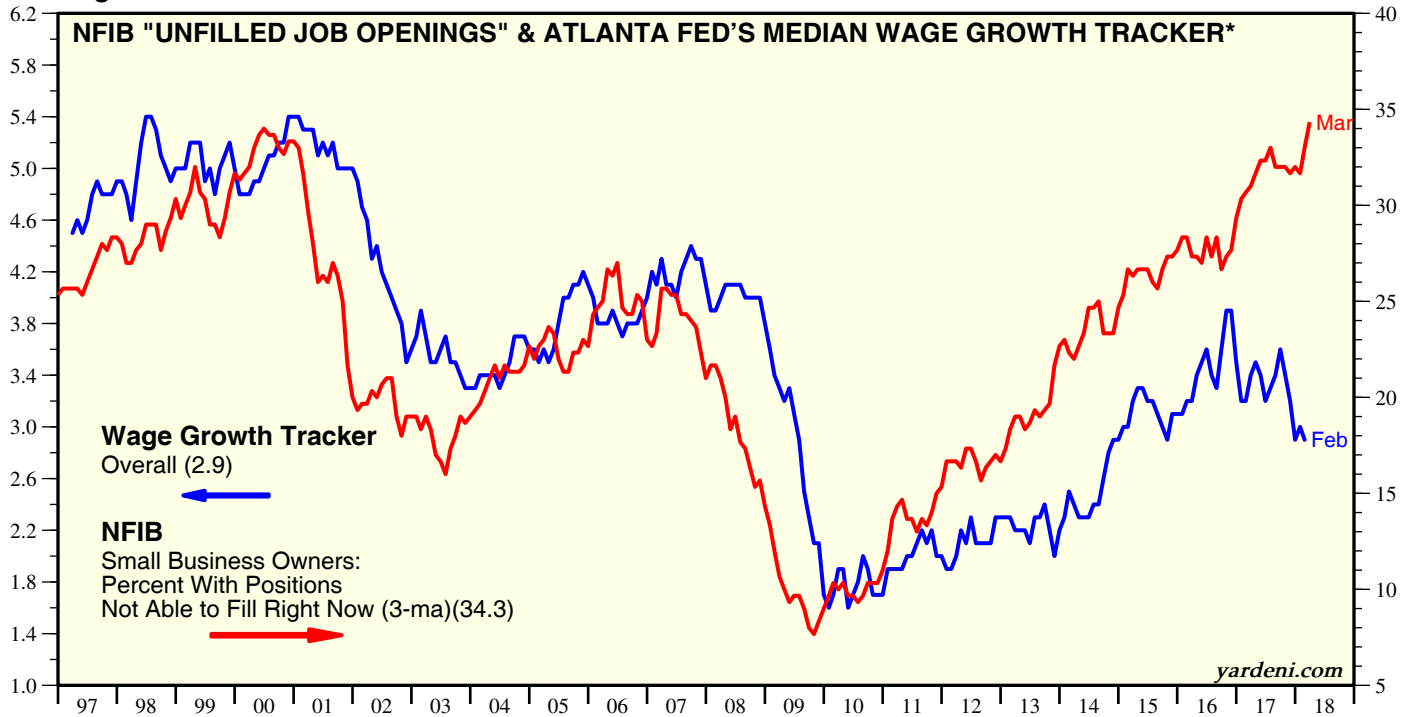

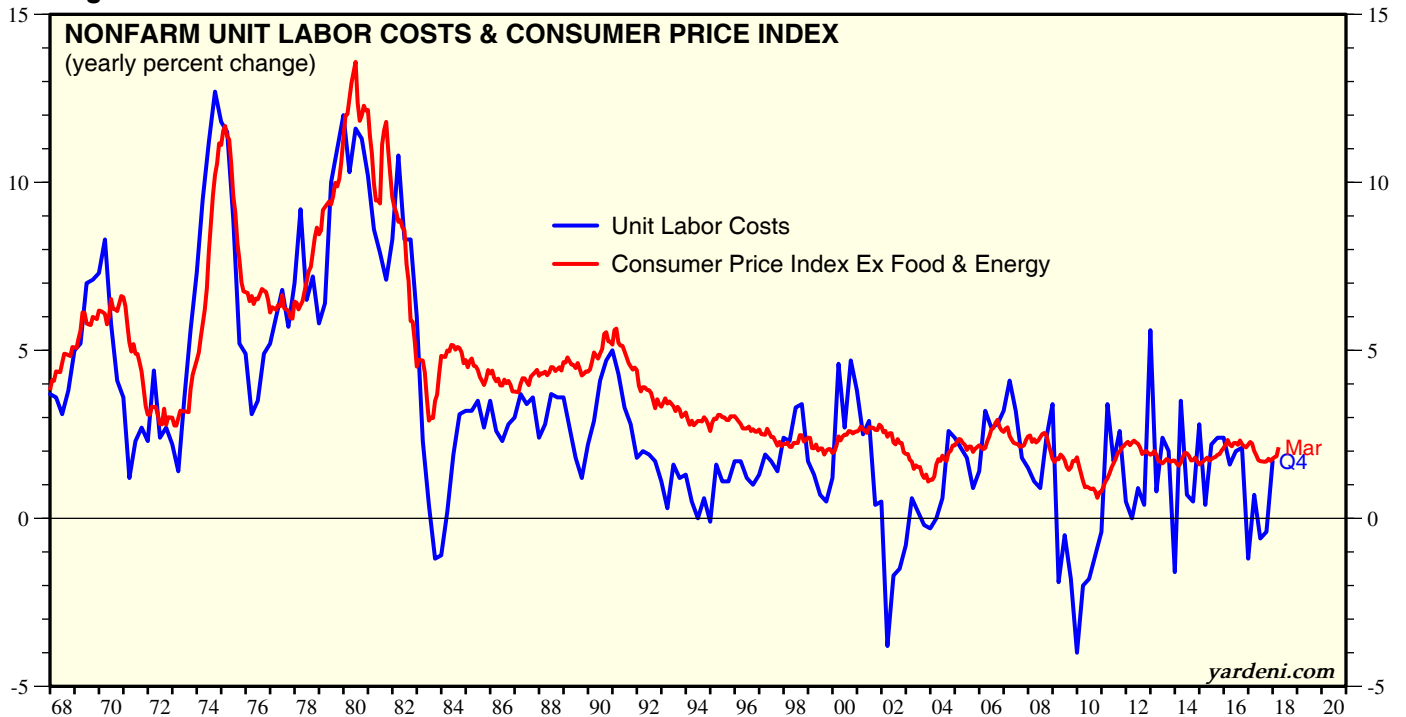
Unit Labor Costs & Inflation

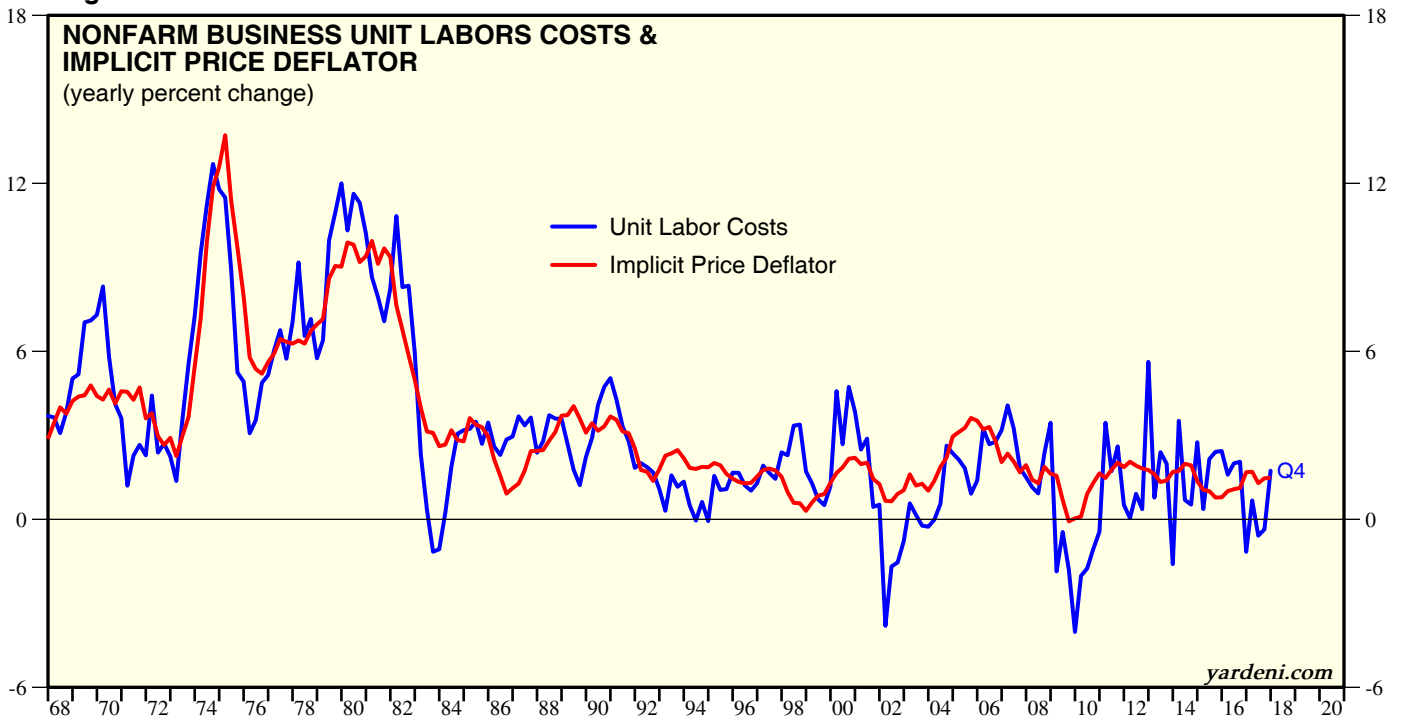
