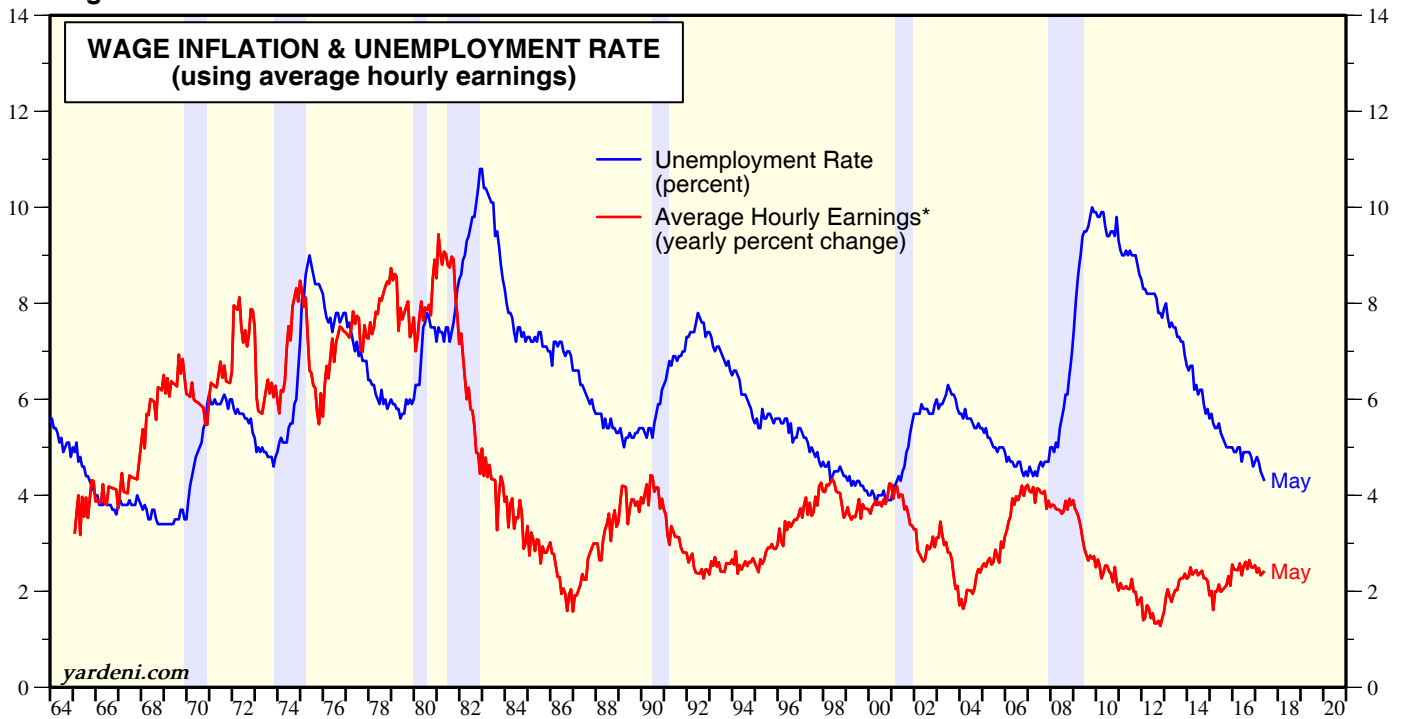

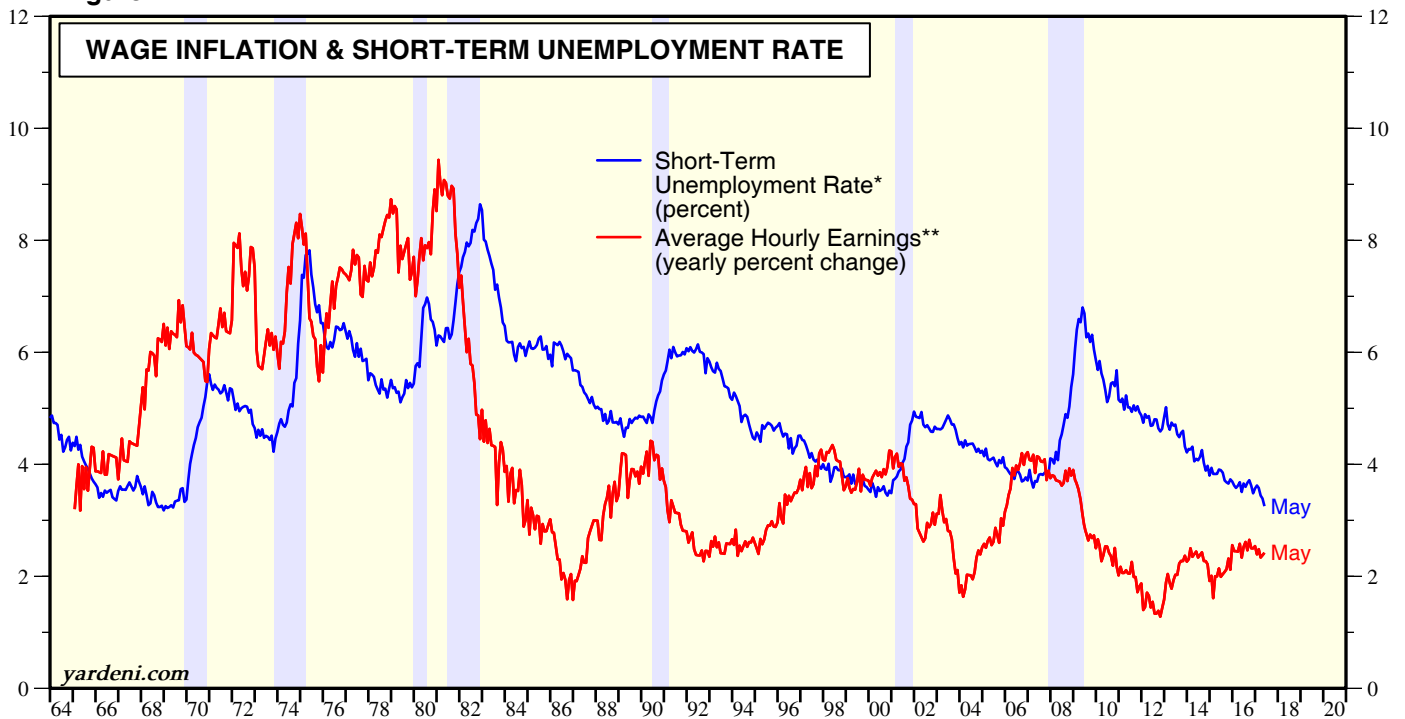

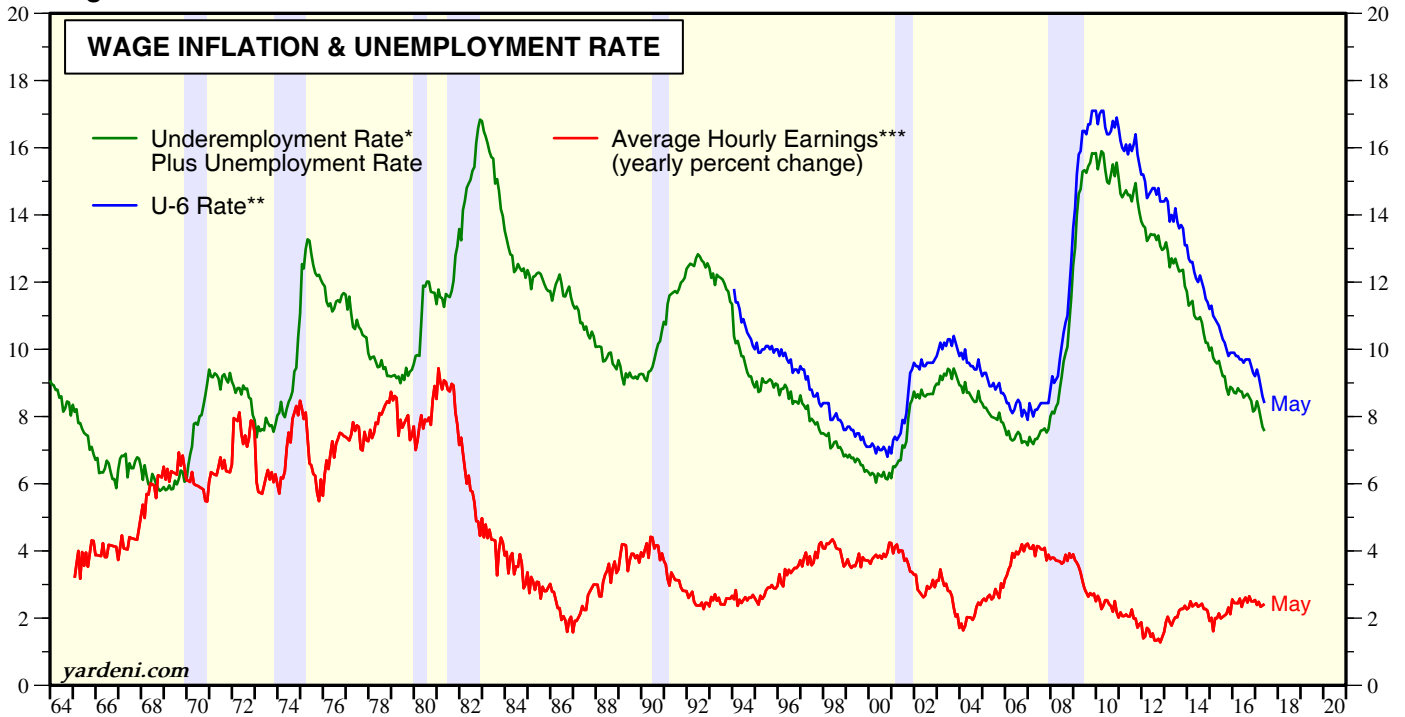

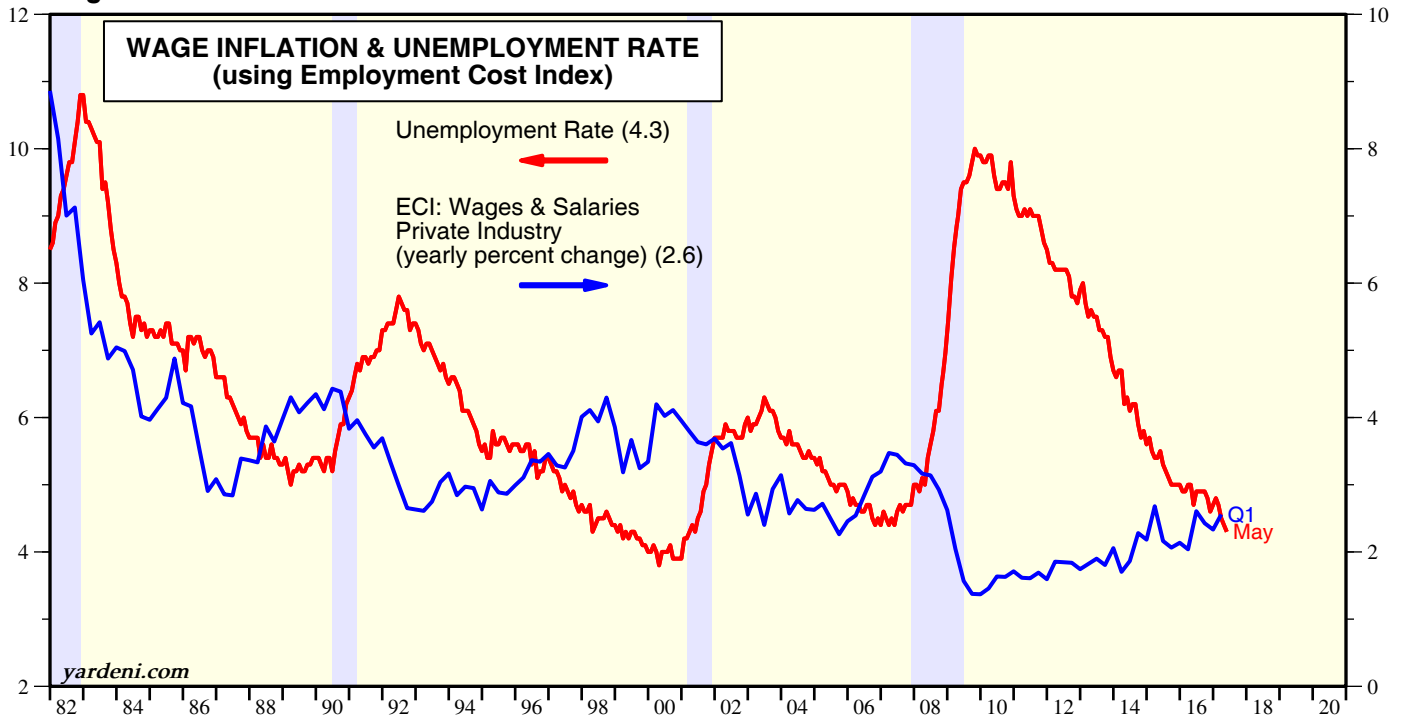

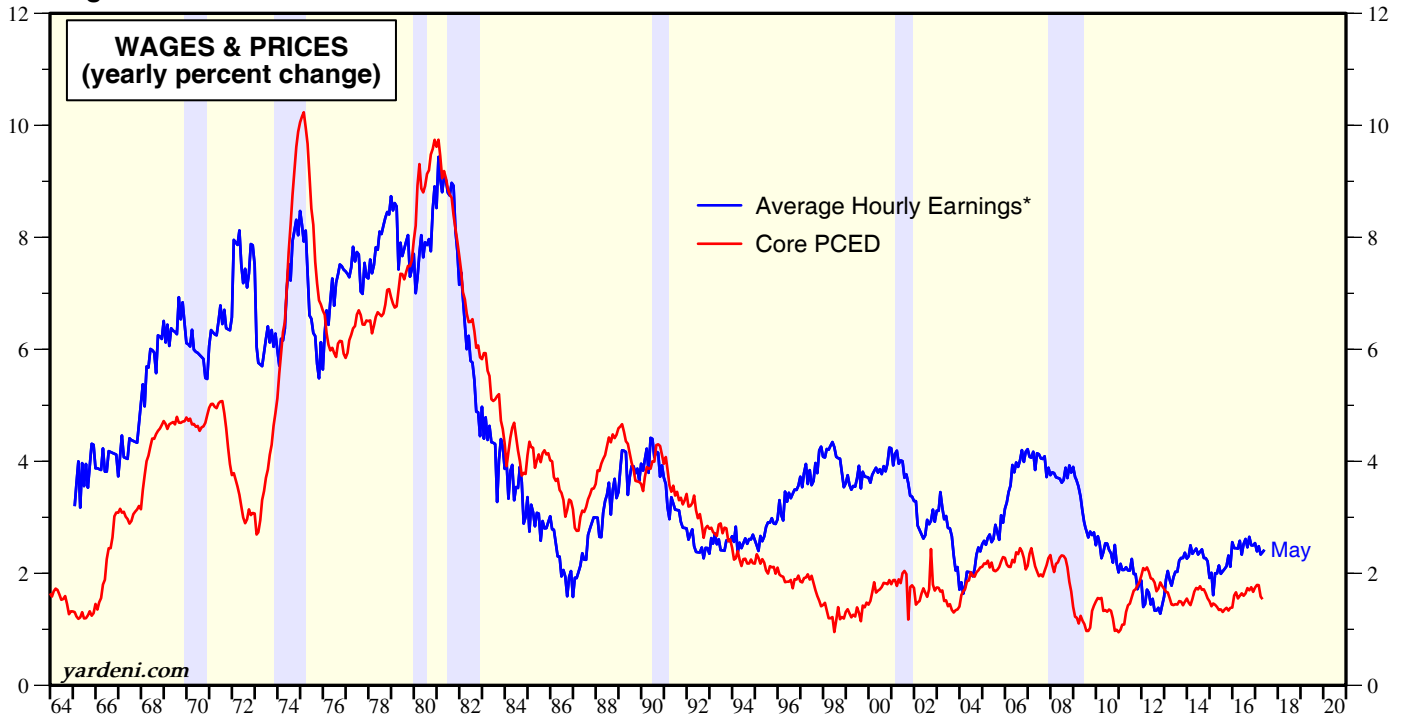

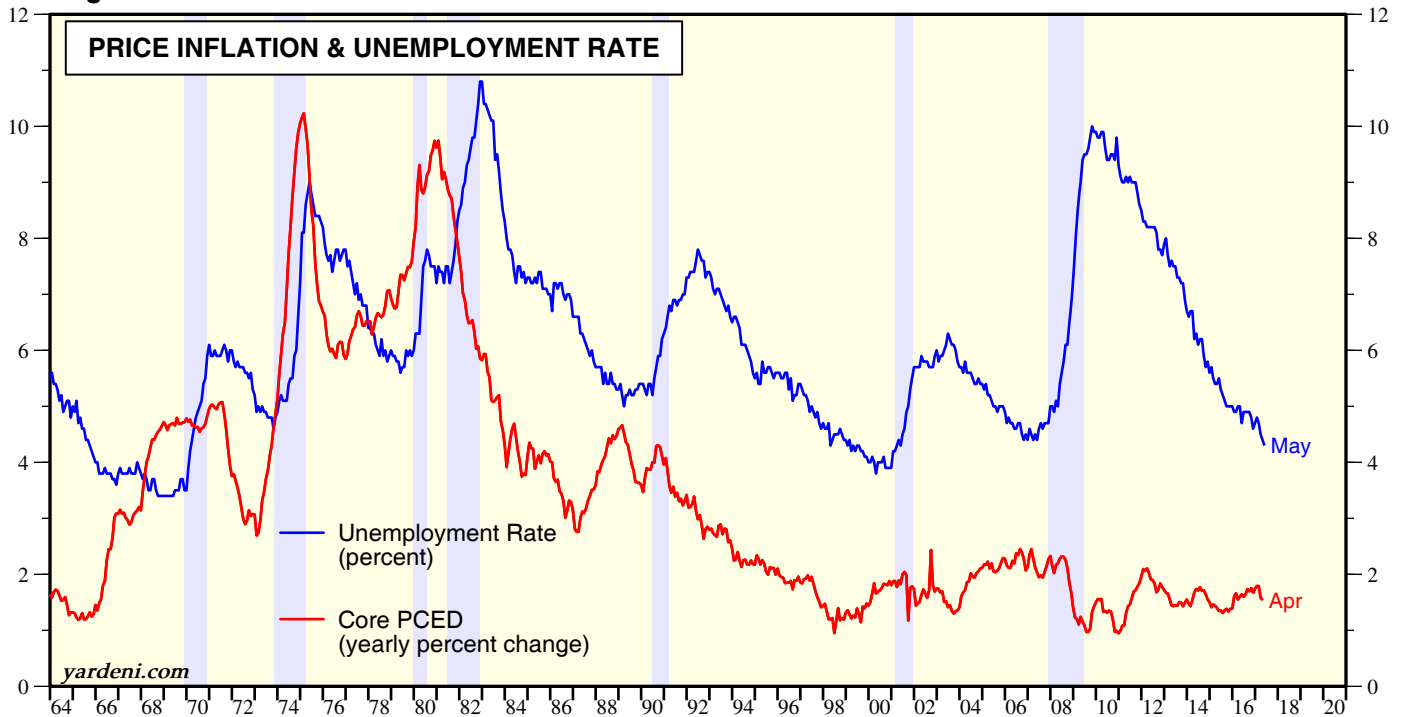

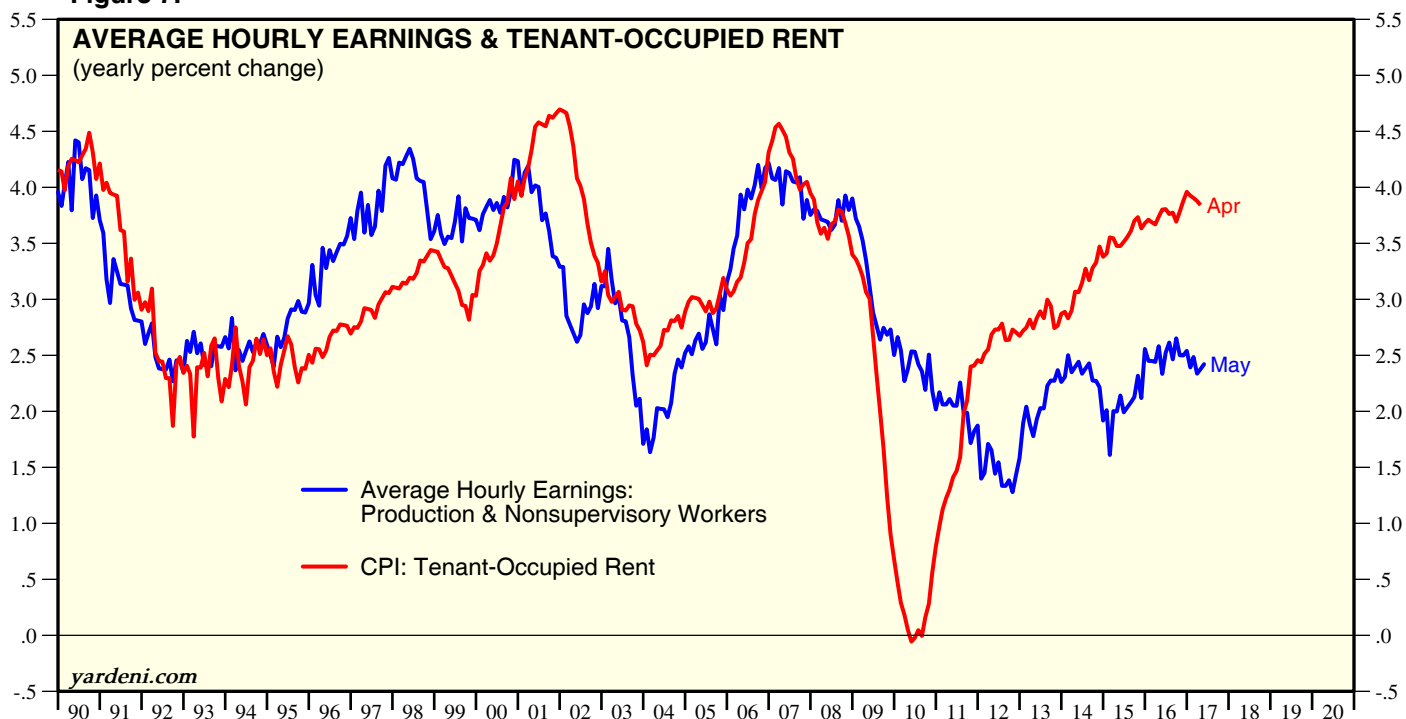

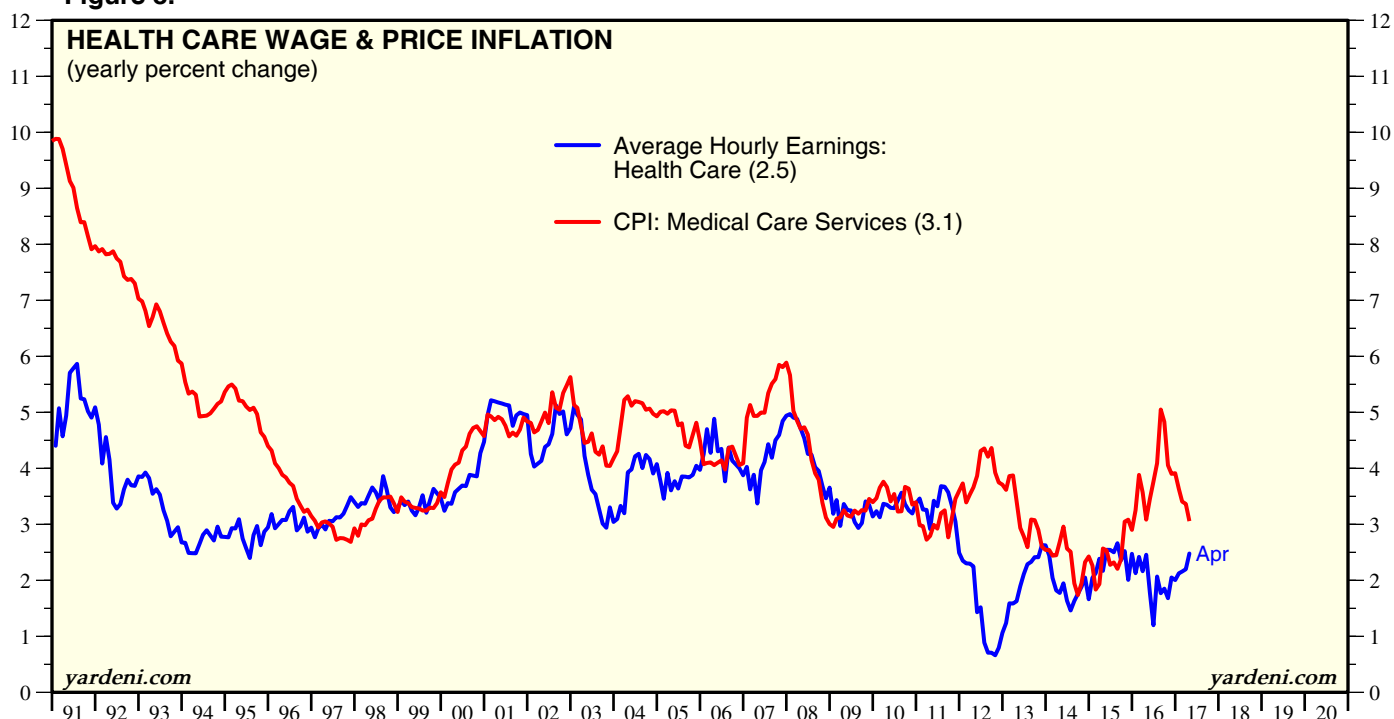
# Average Hourly Earnings

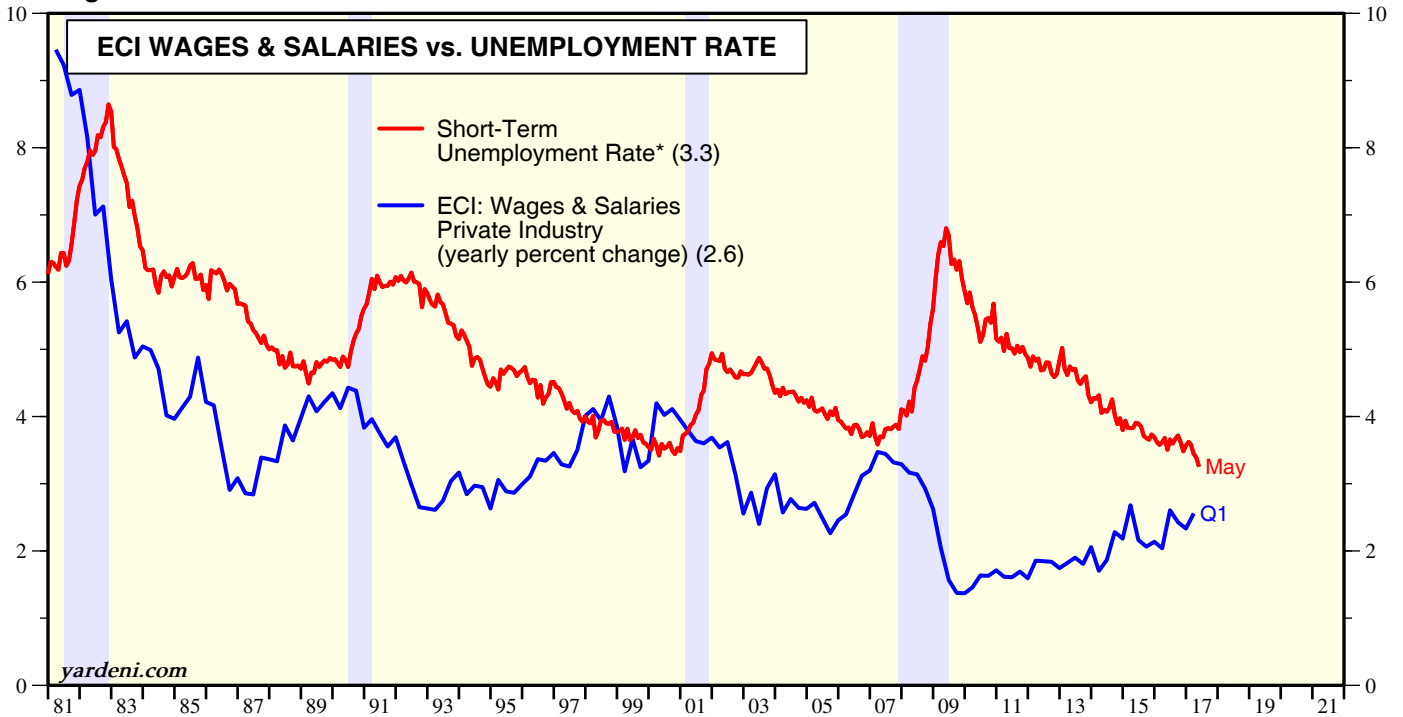

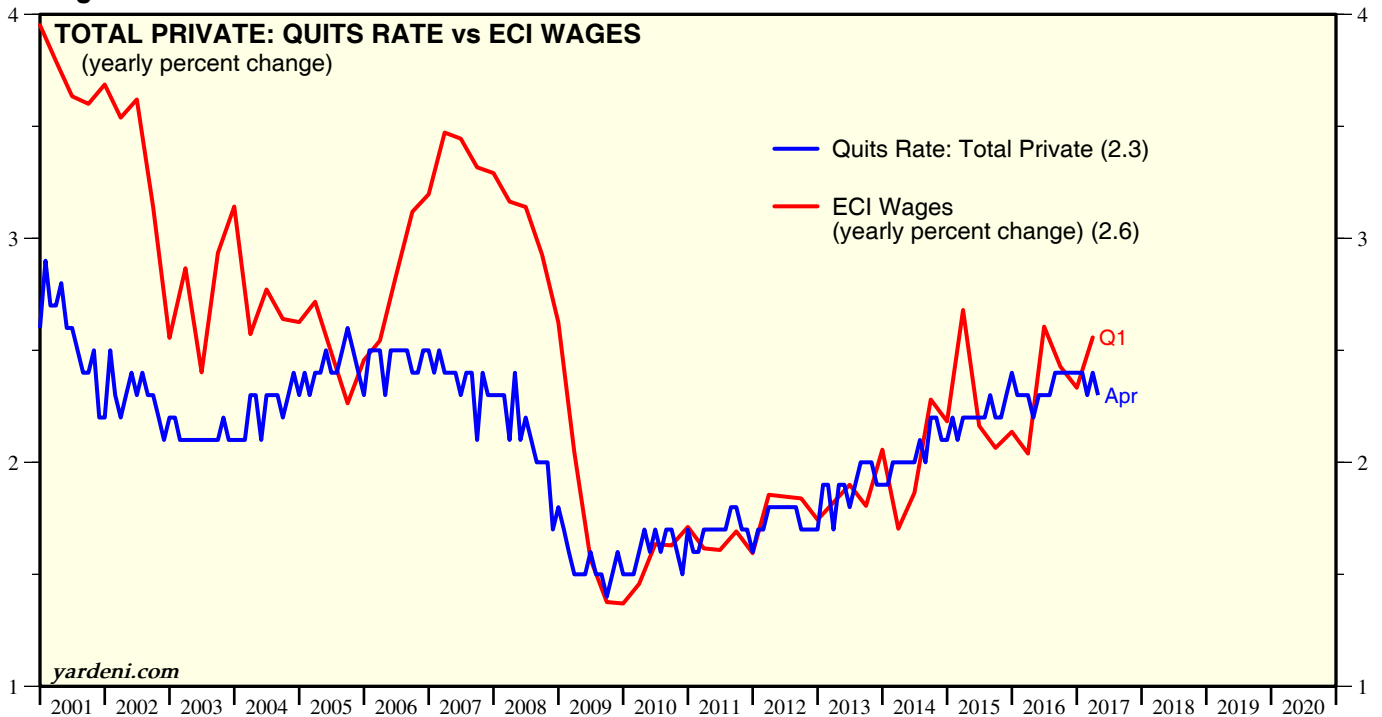

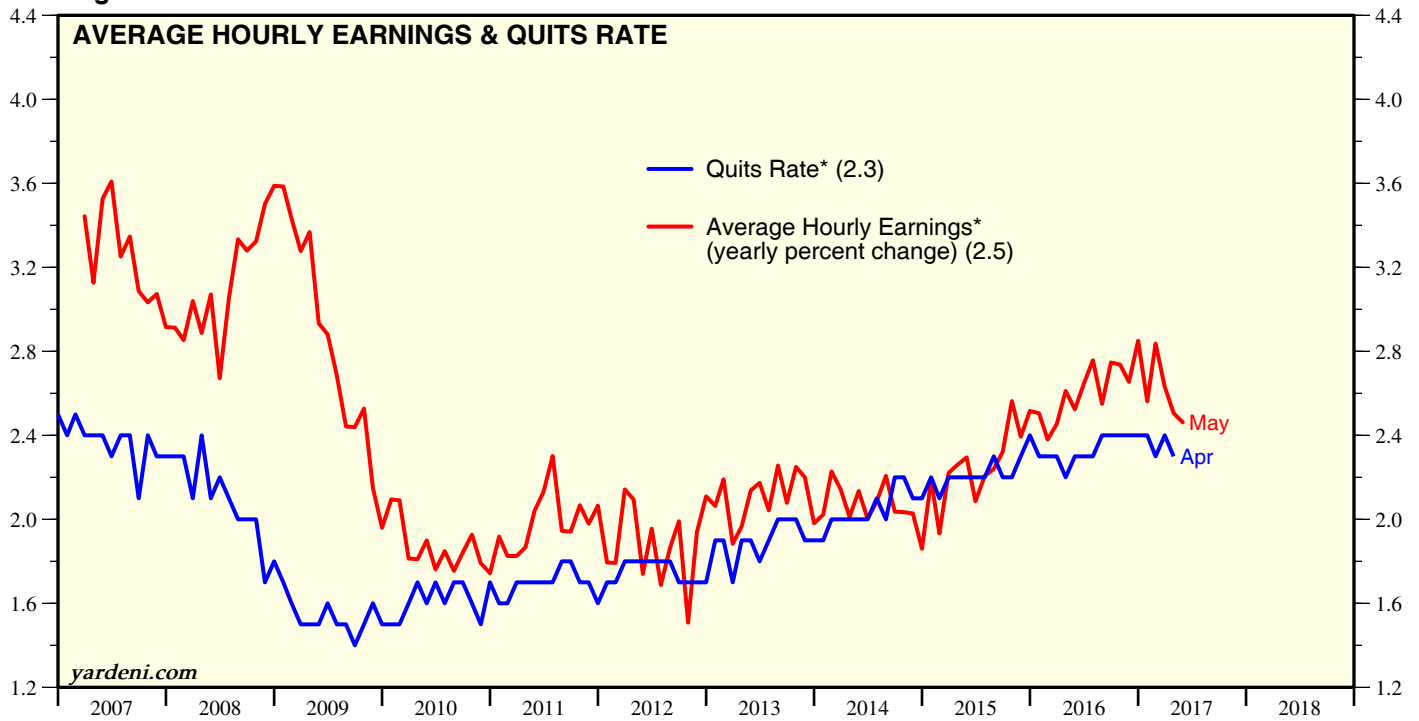

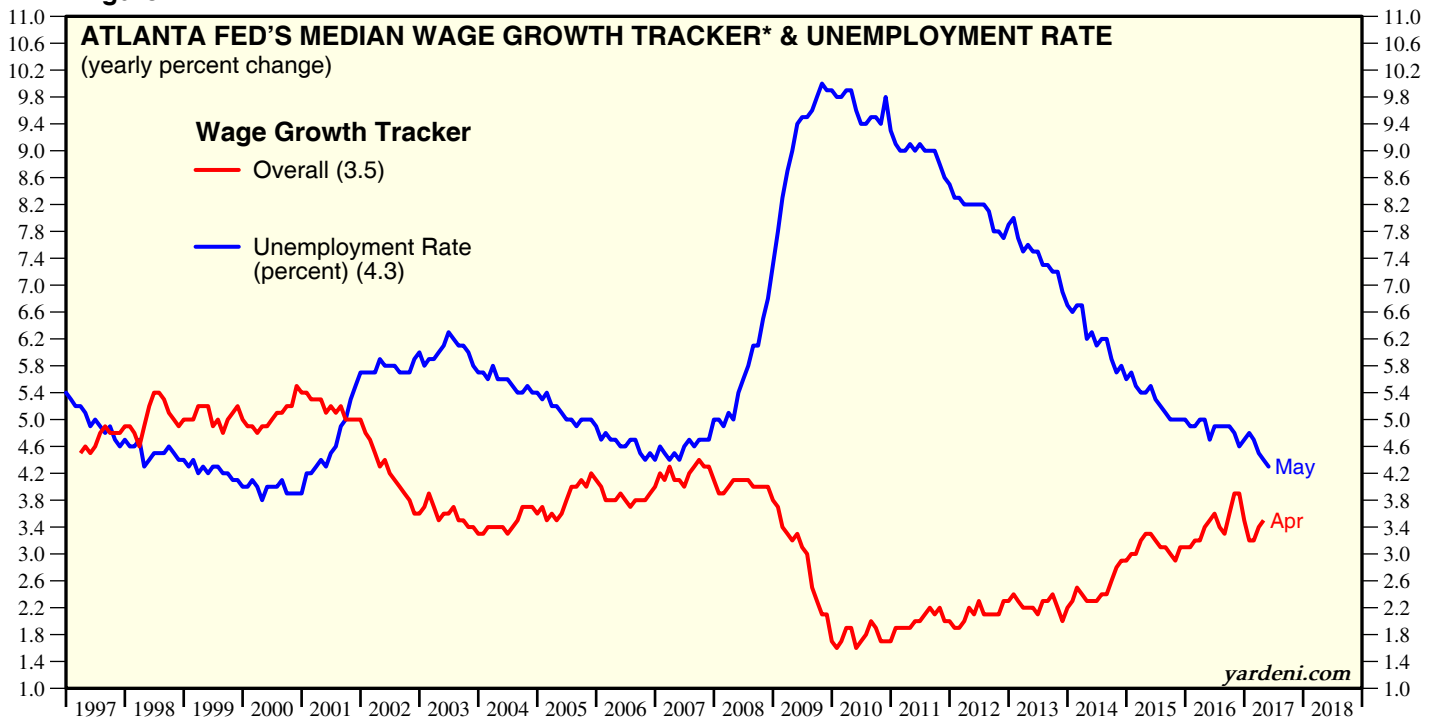

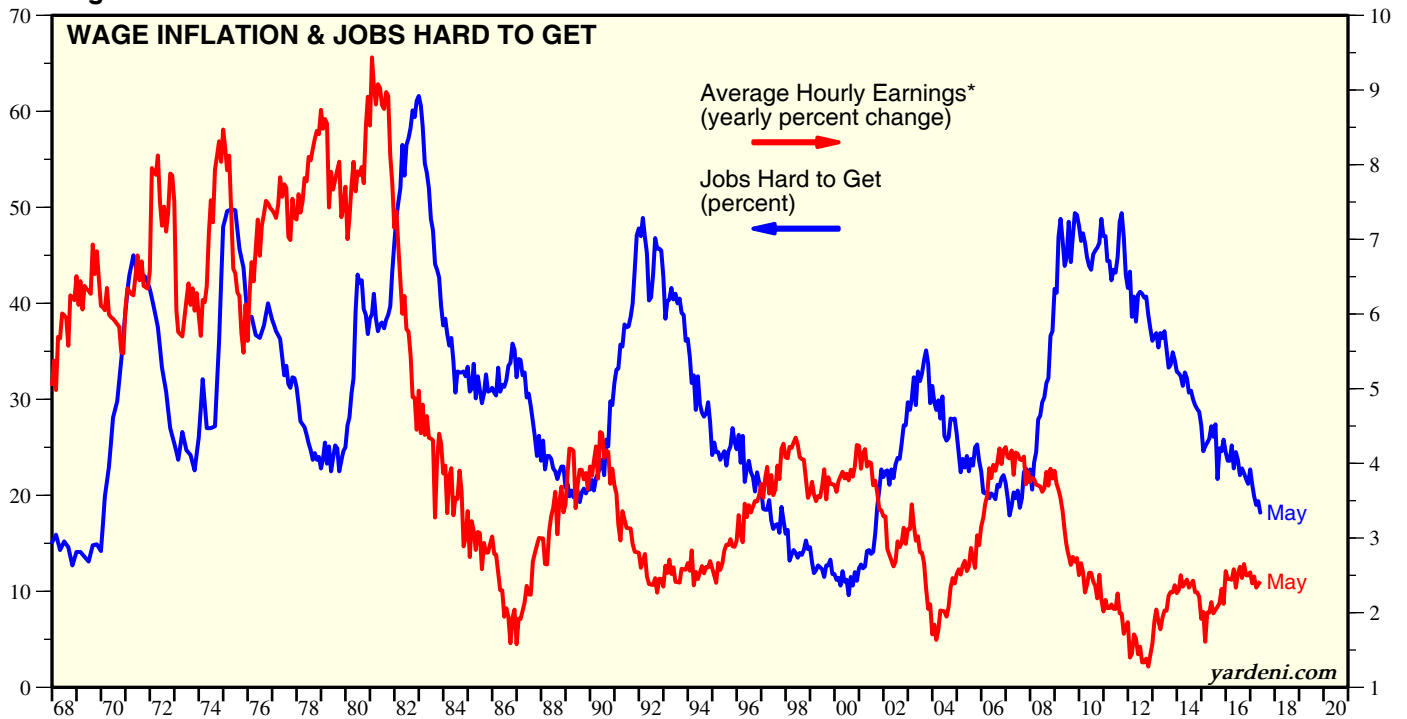


\* Three-month moving average of median wage growth.

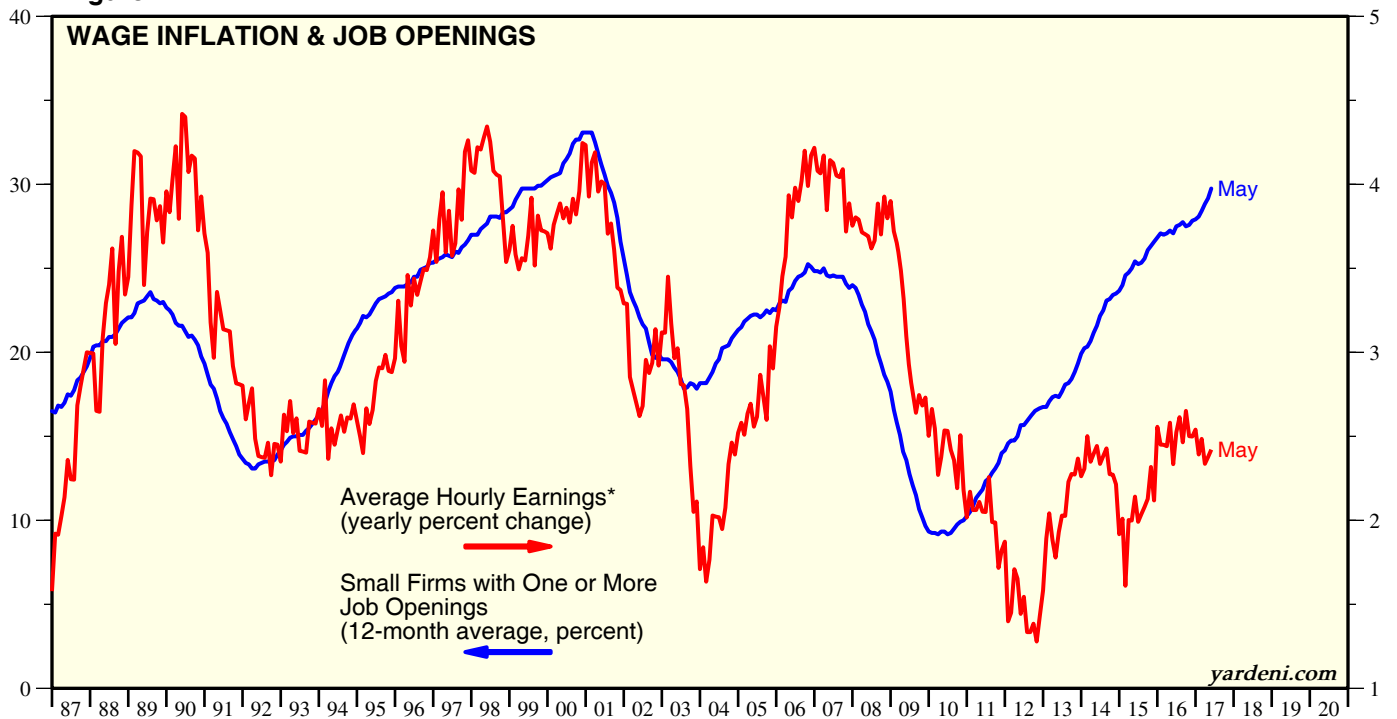

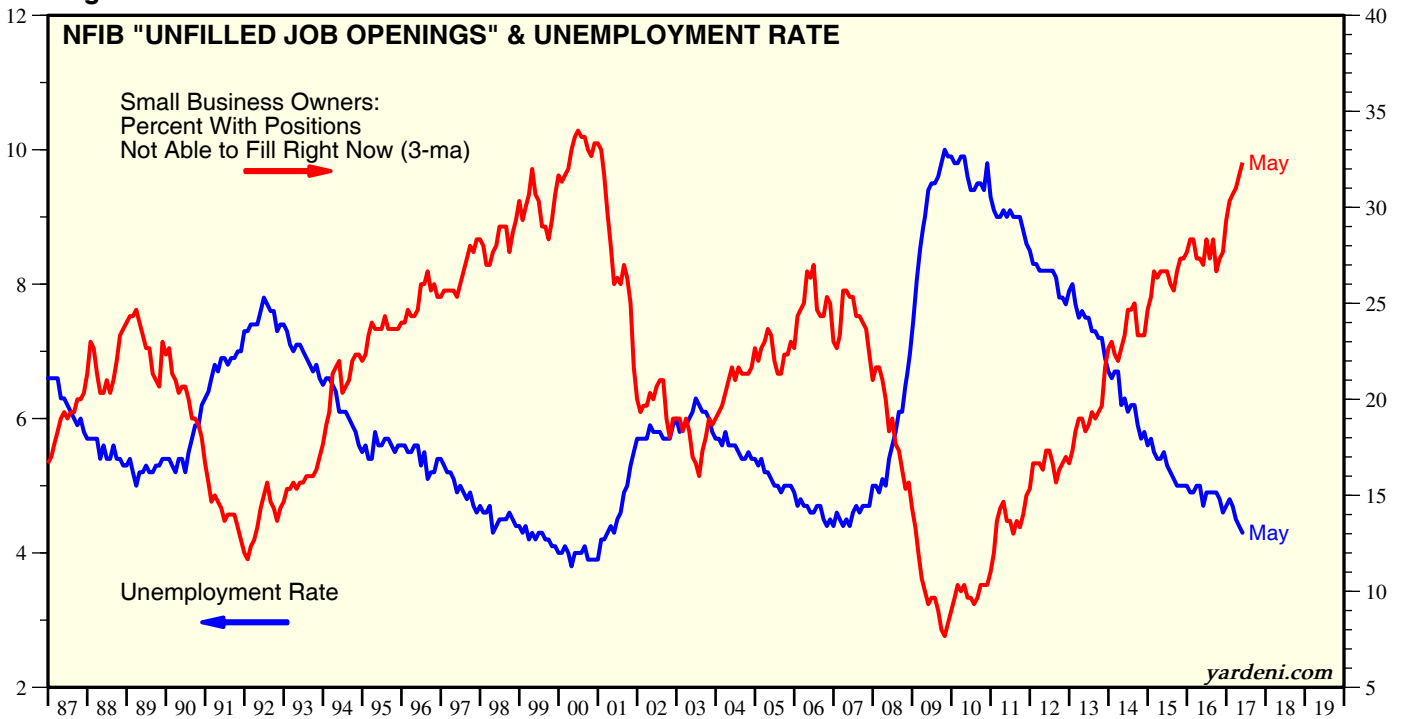

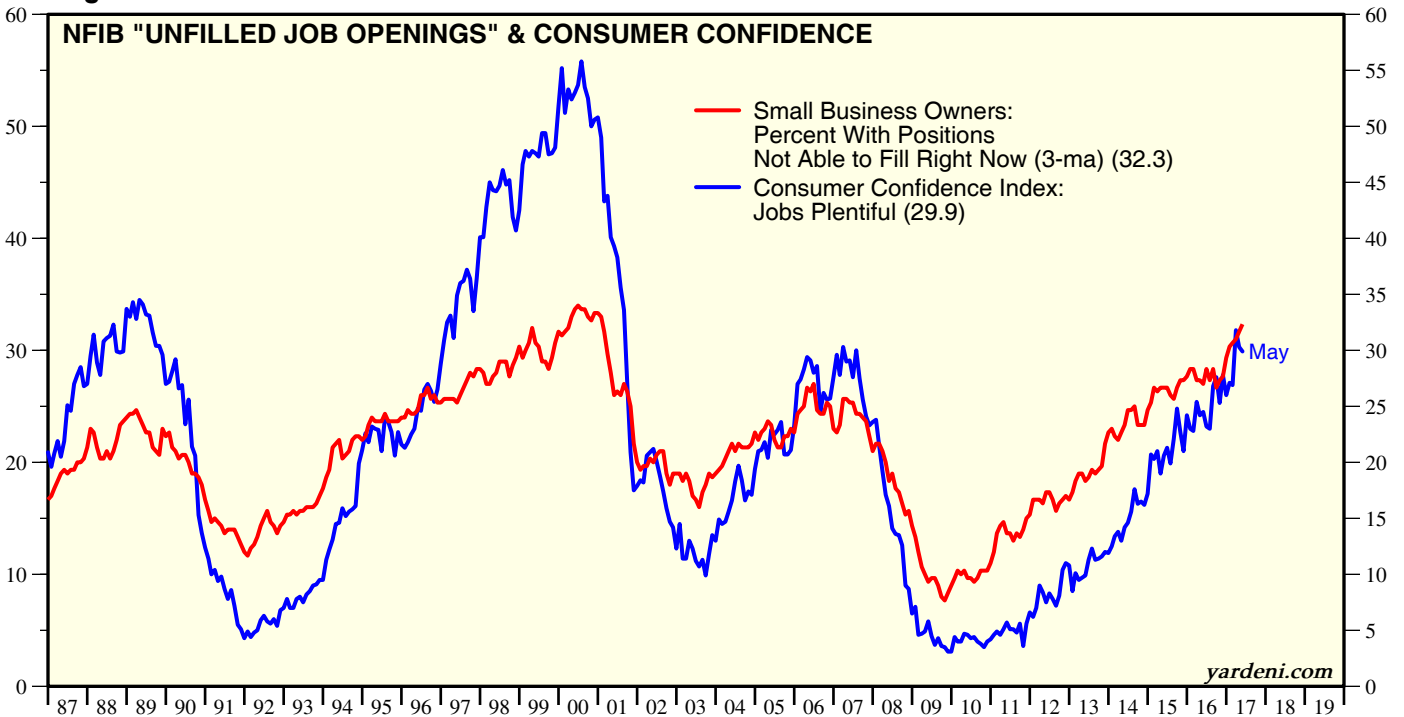

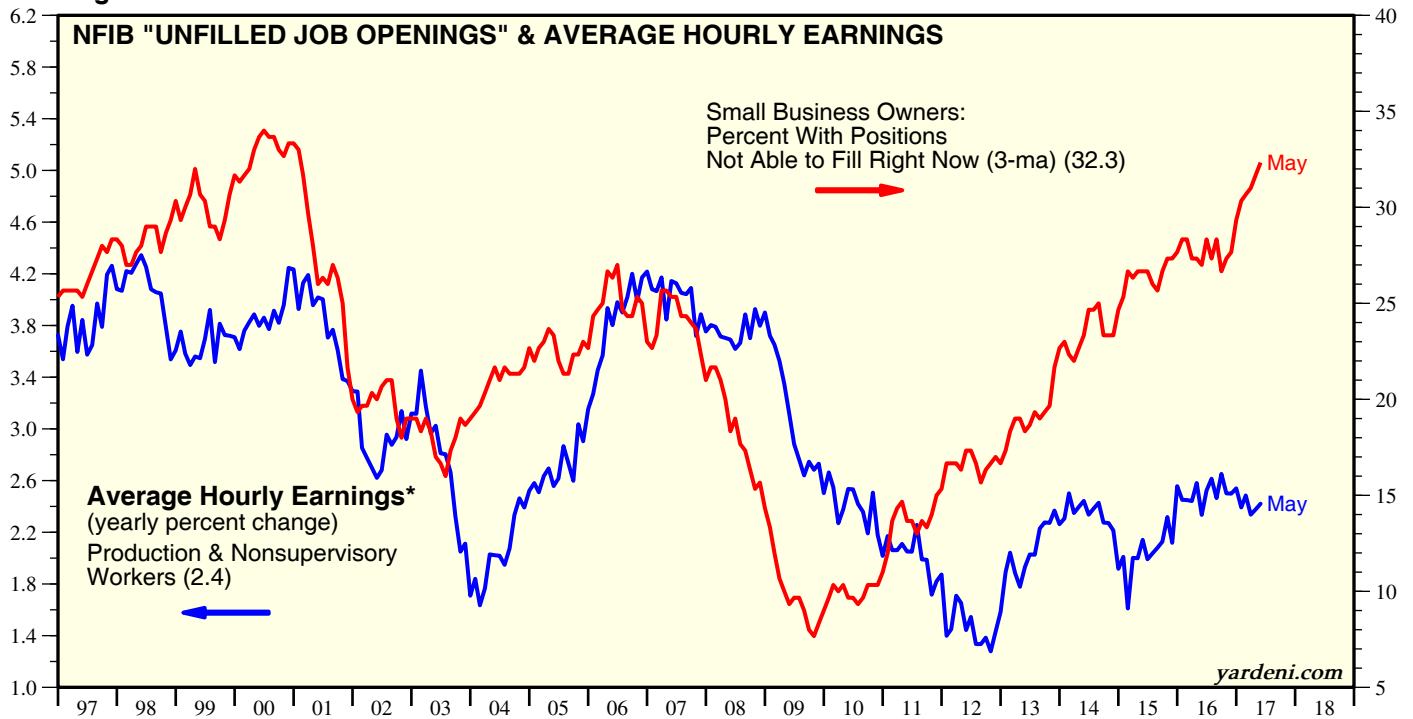

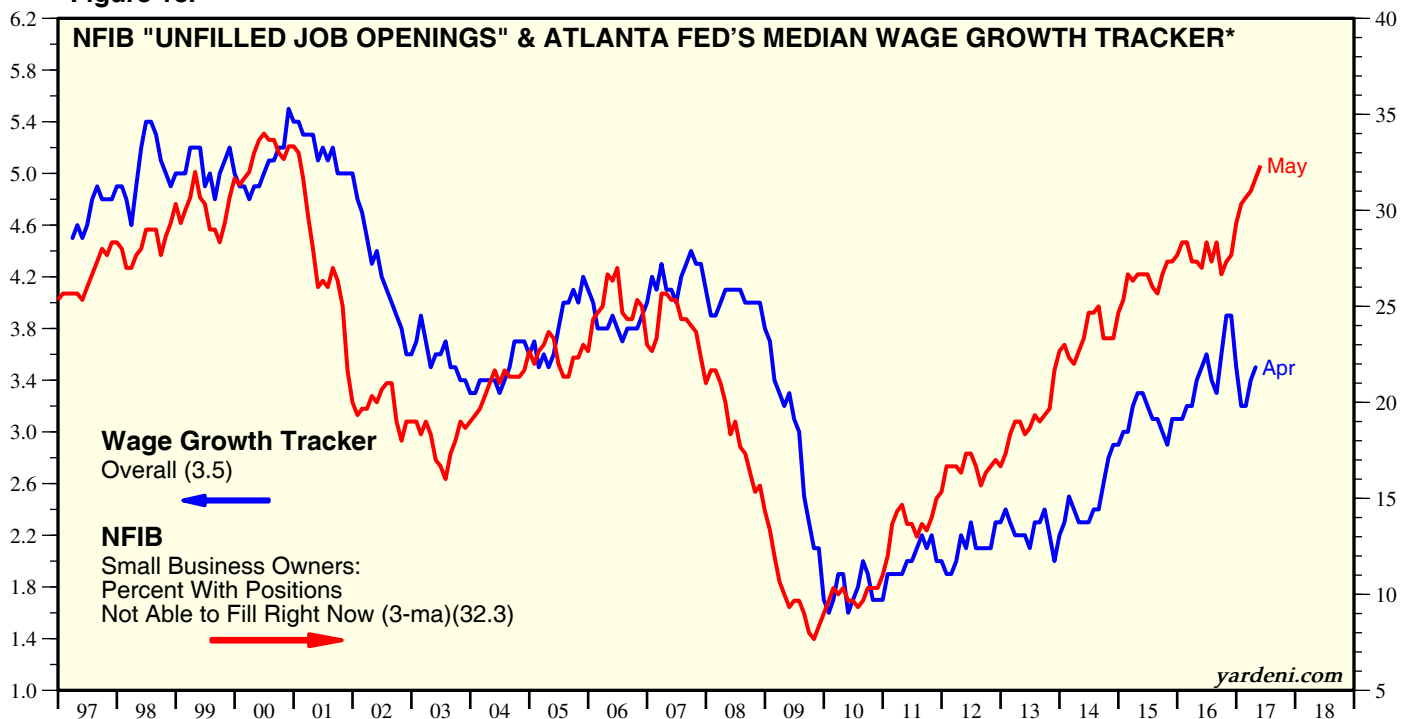
