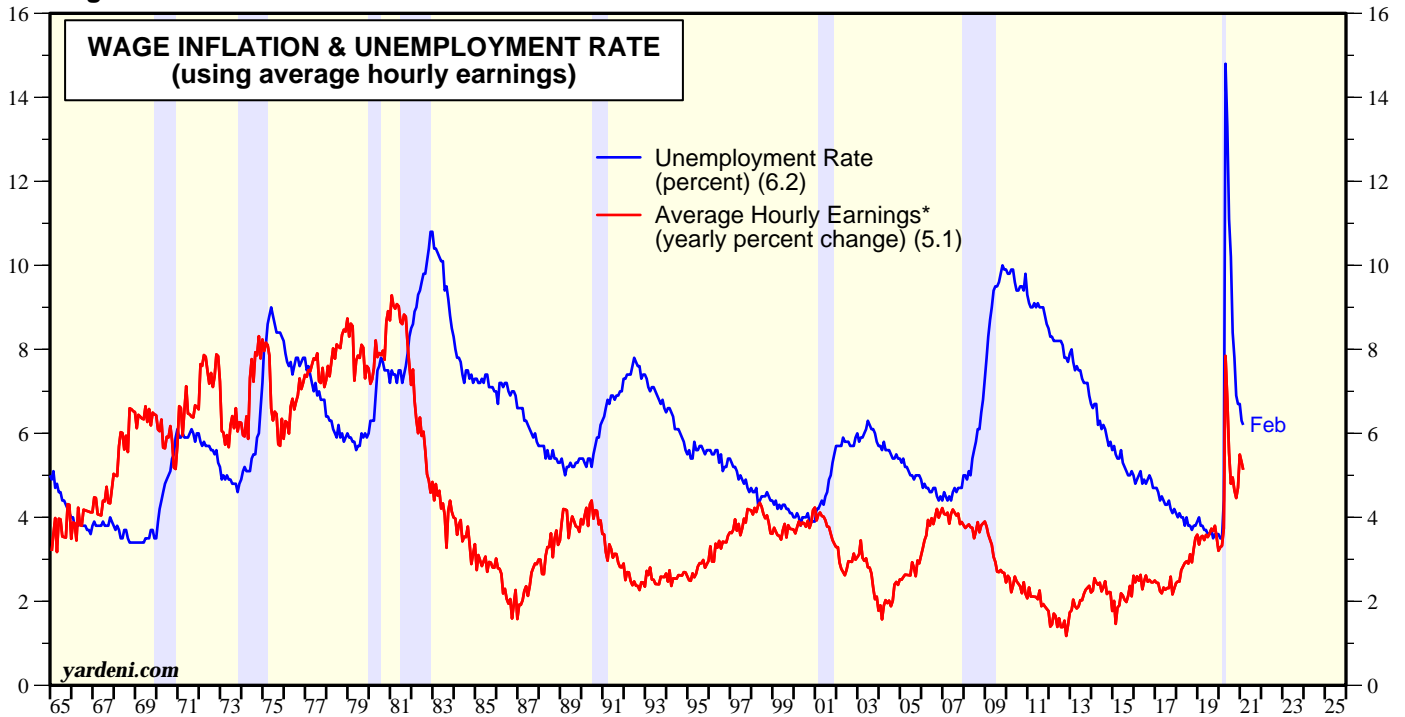

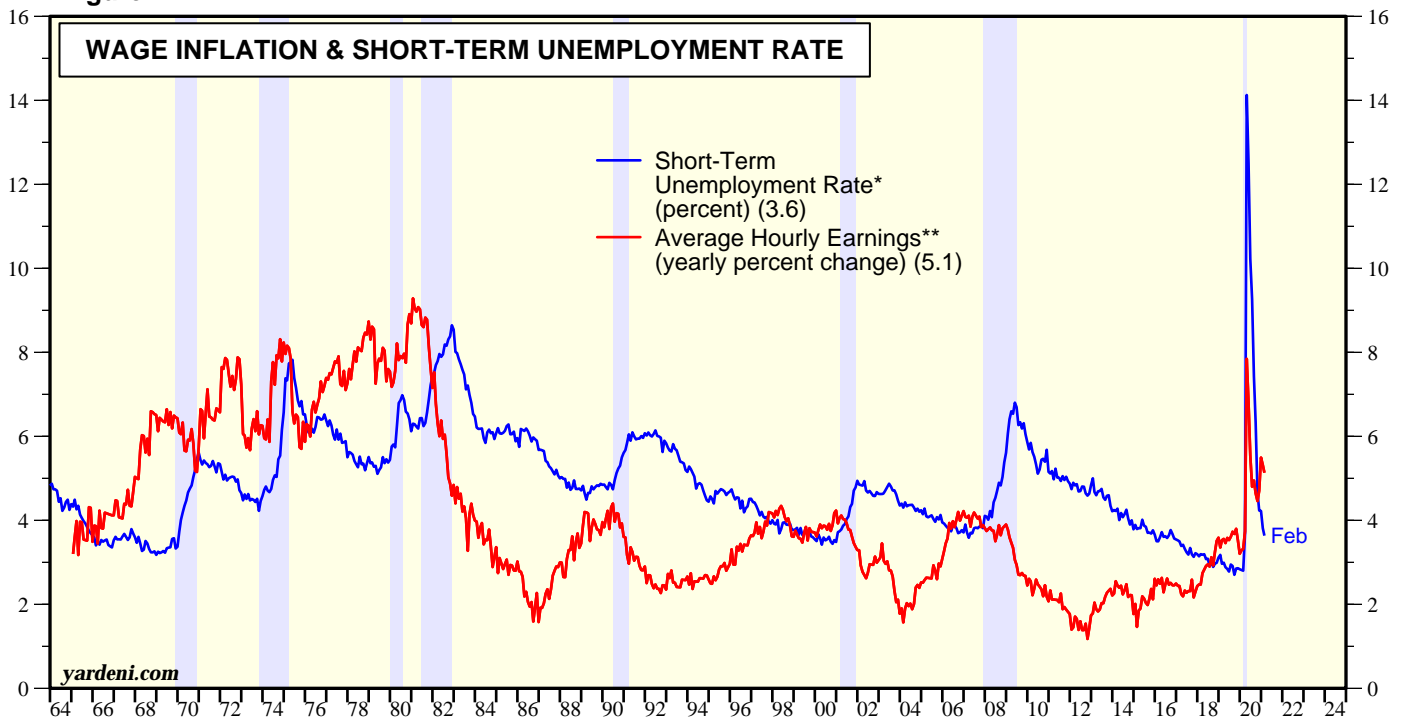

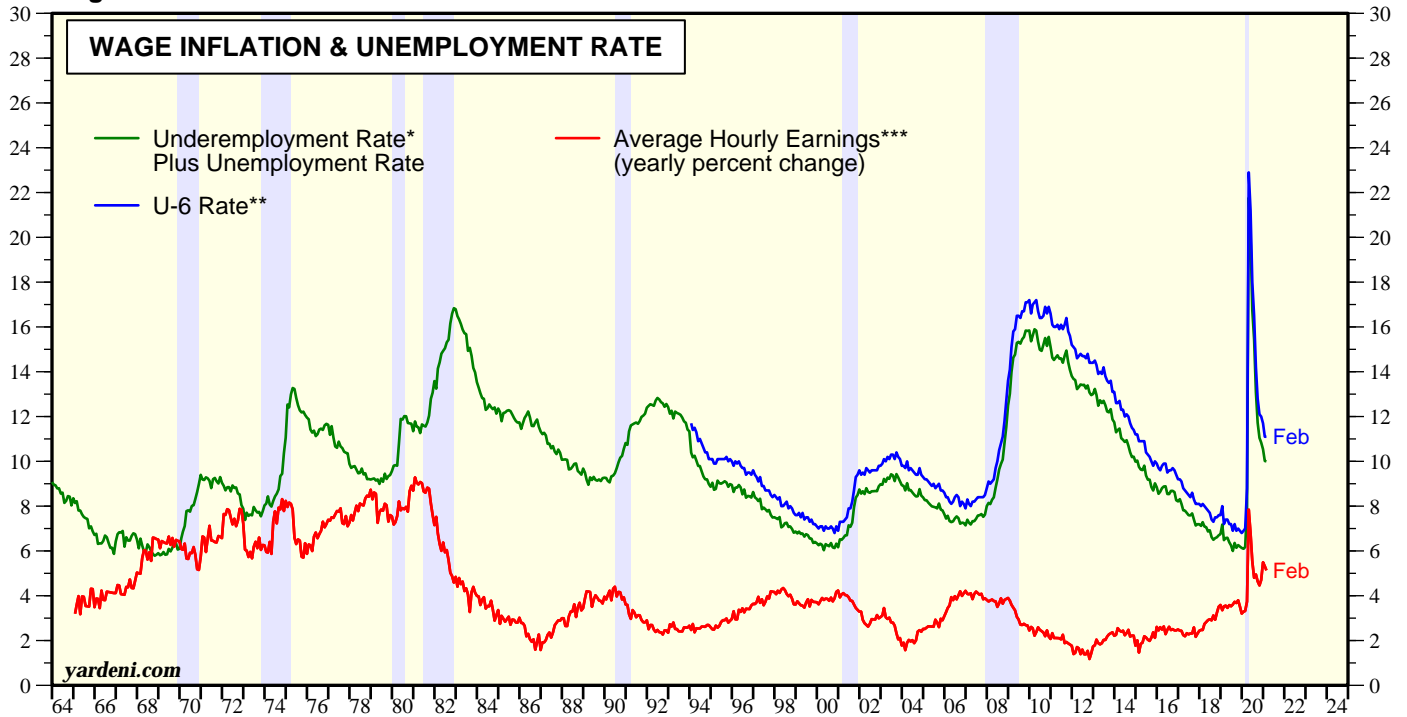

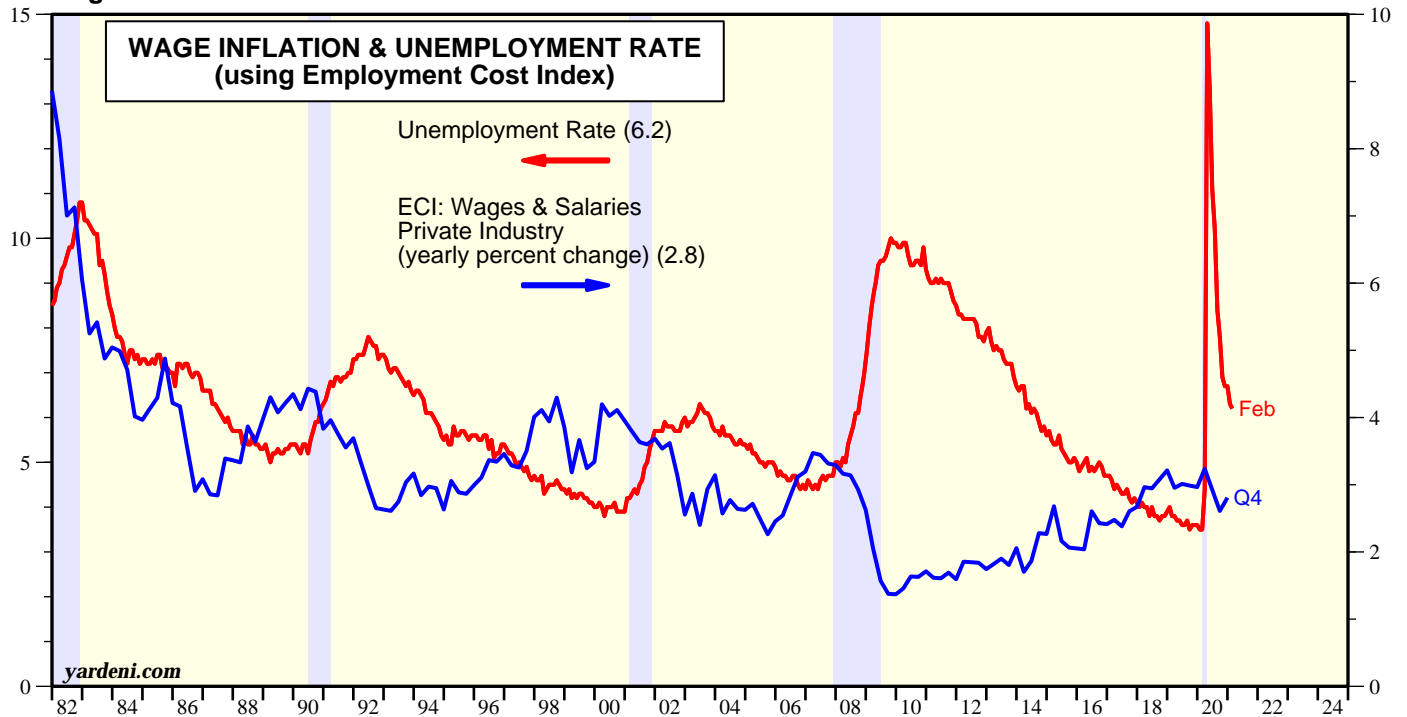

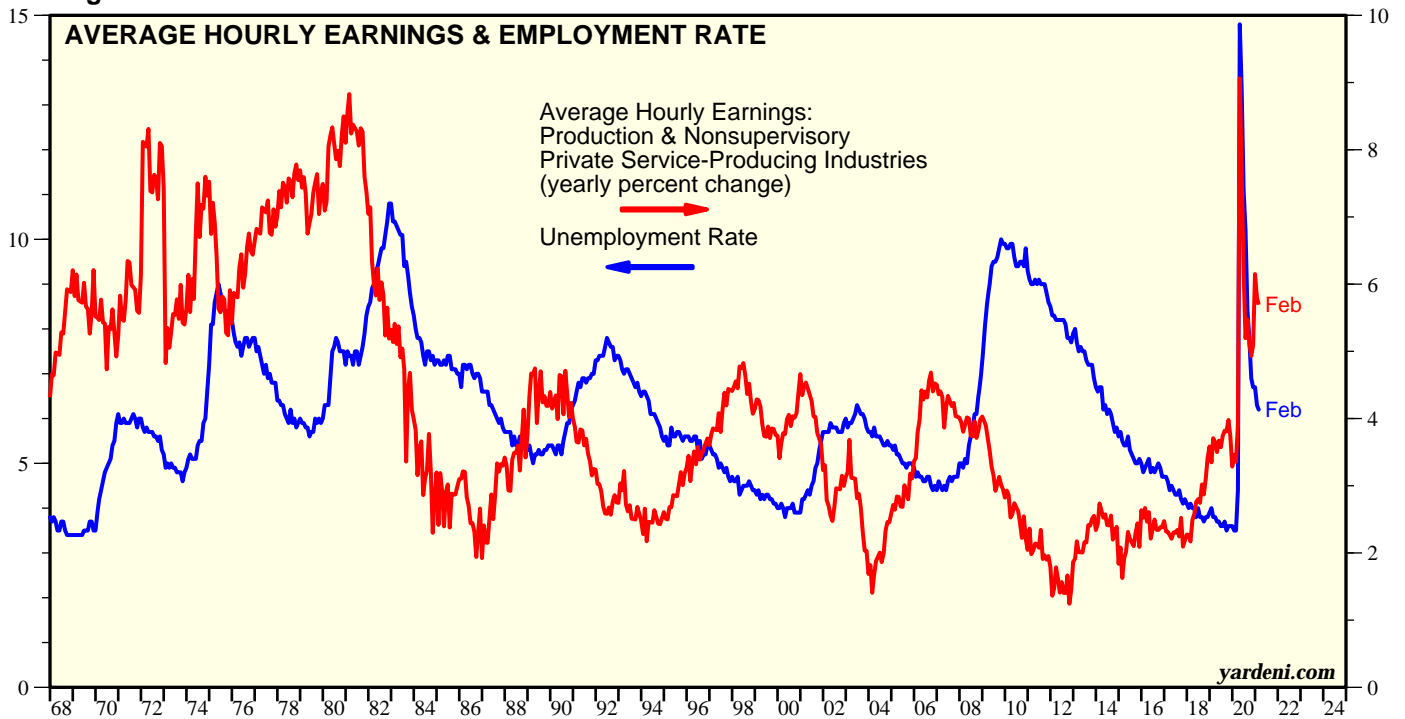

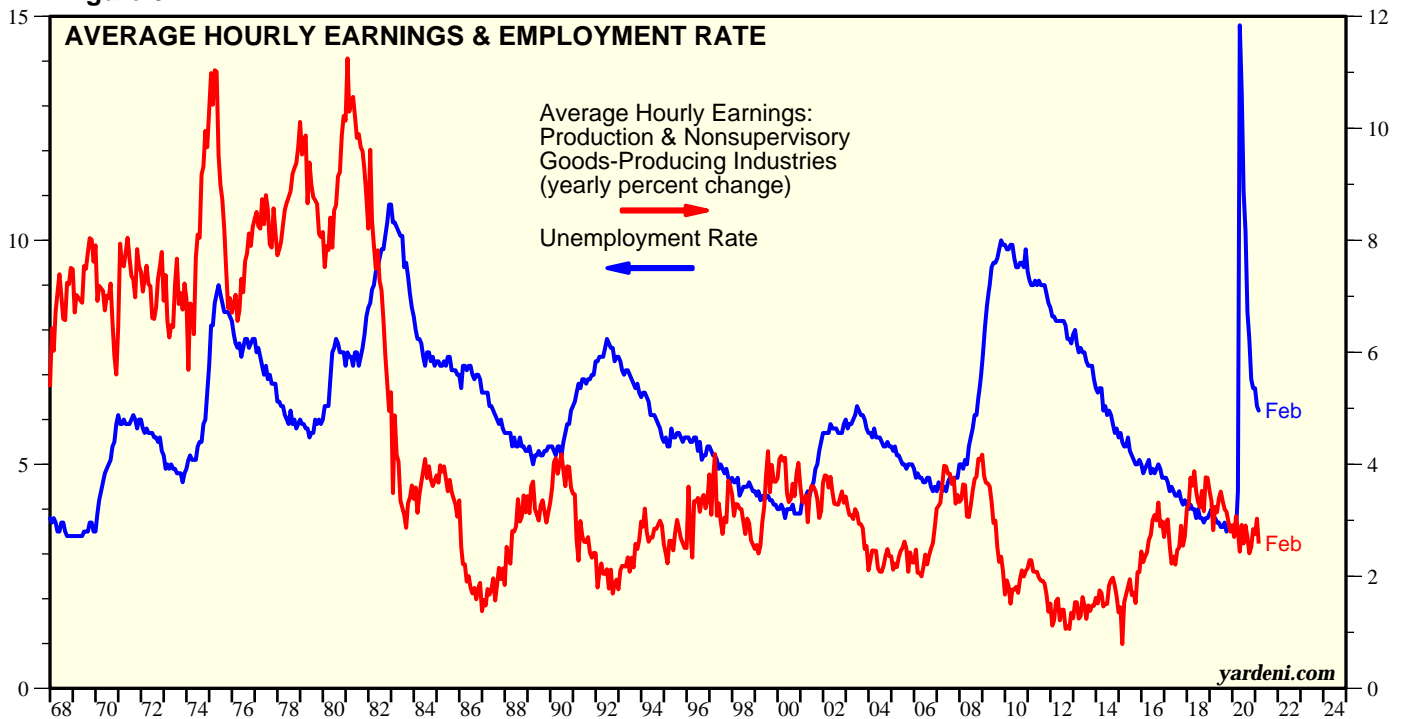

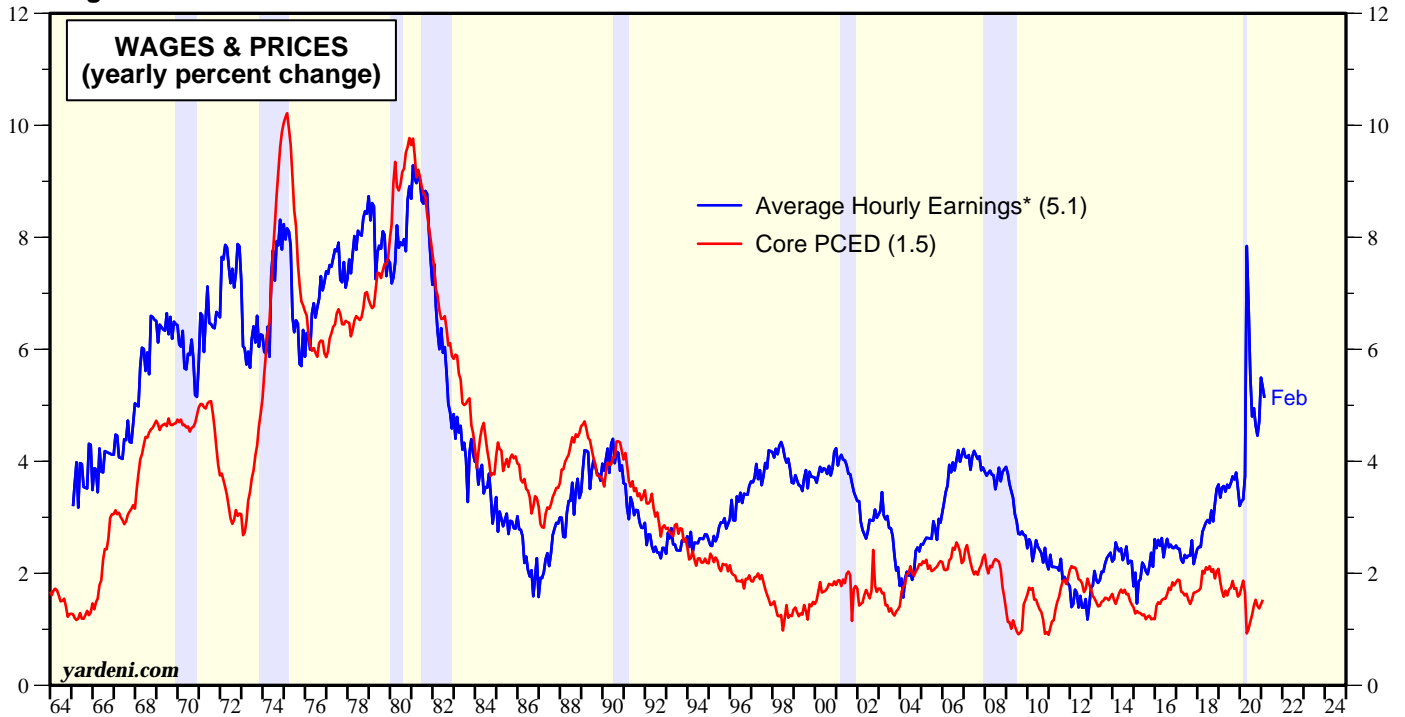

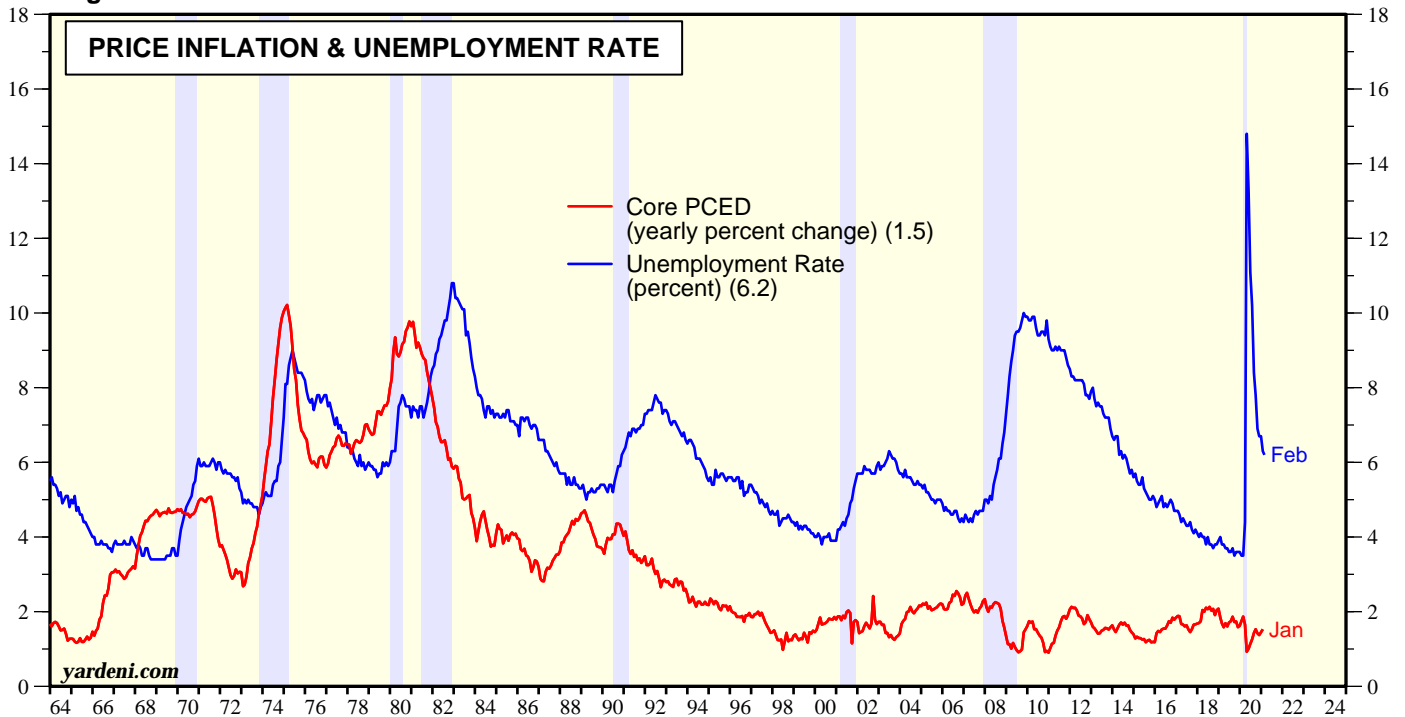

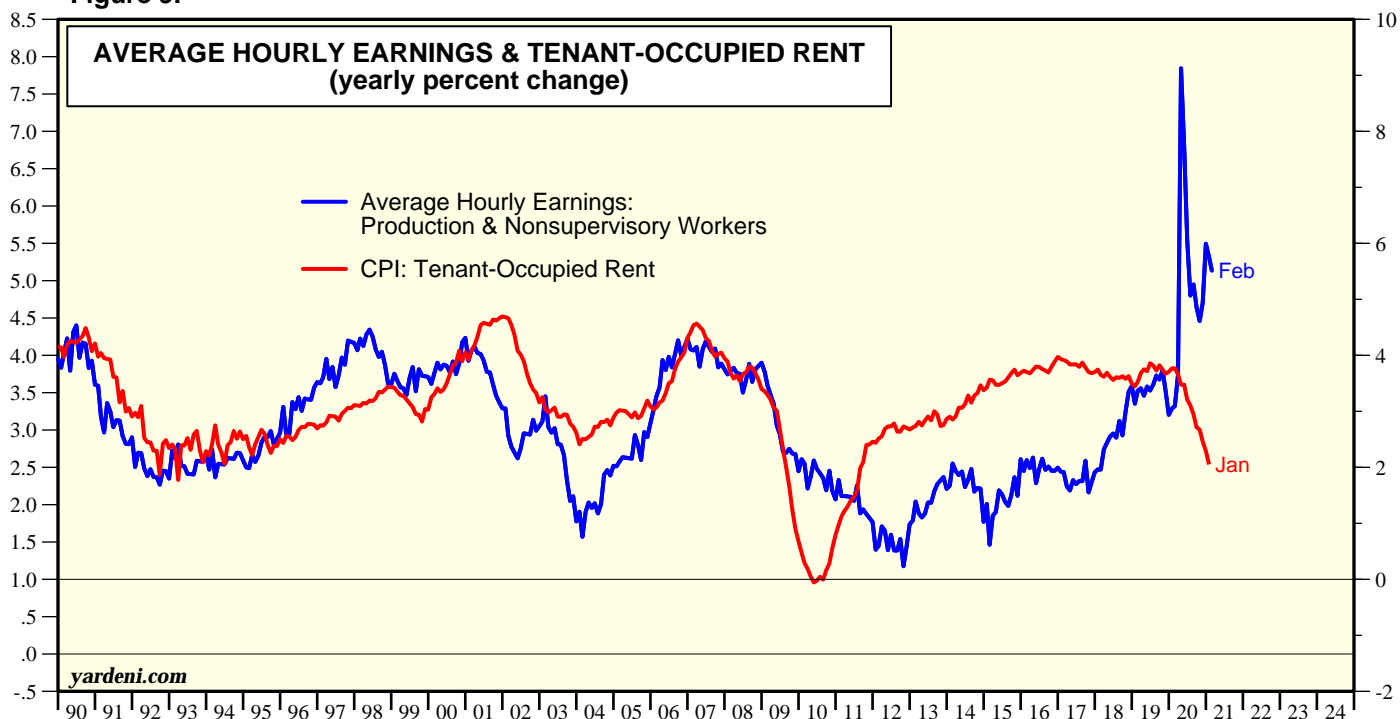

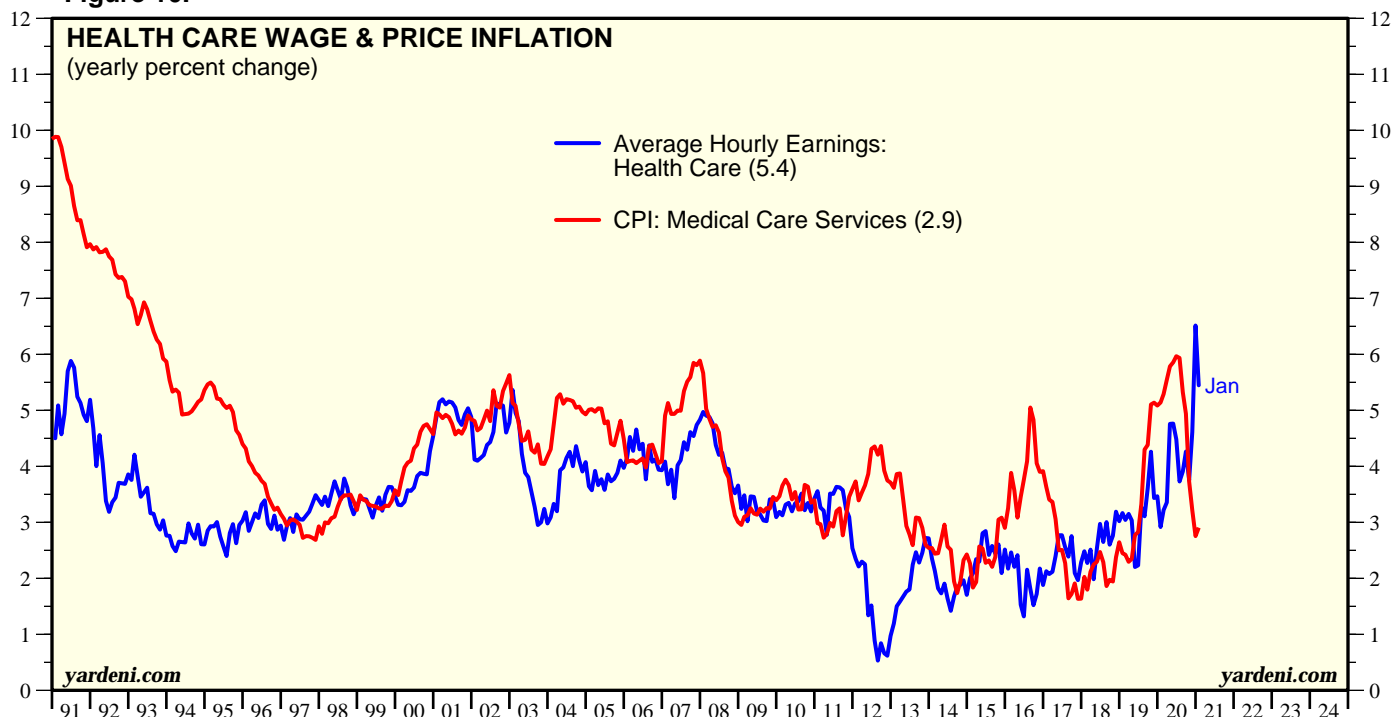
Average Hourly Earnings

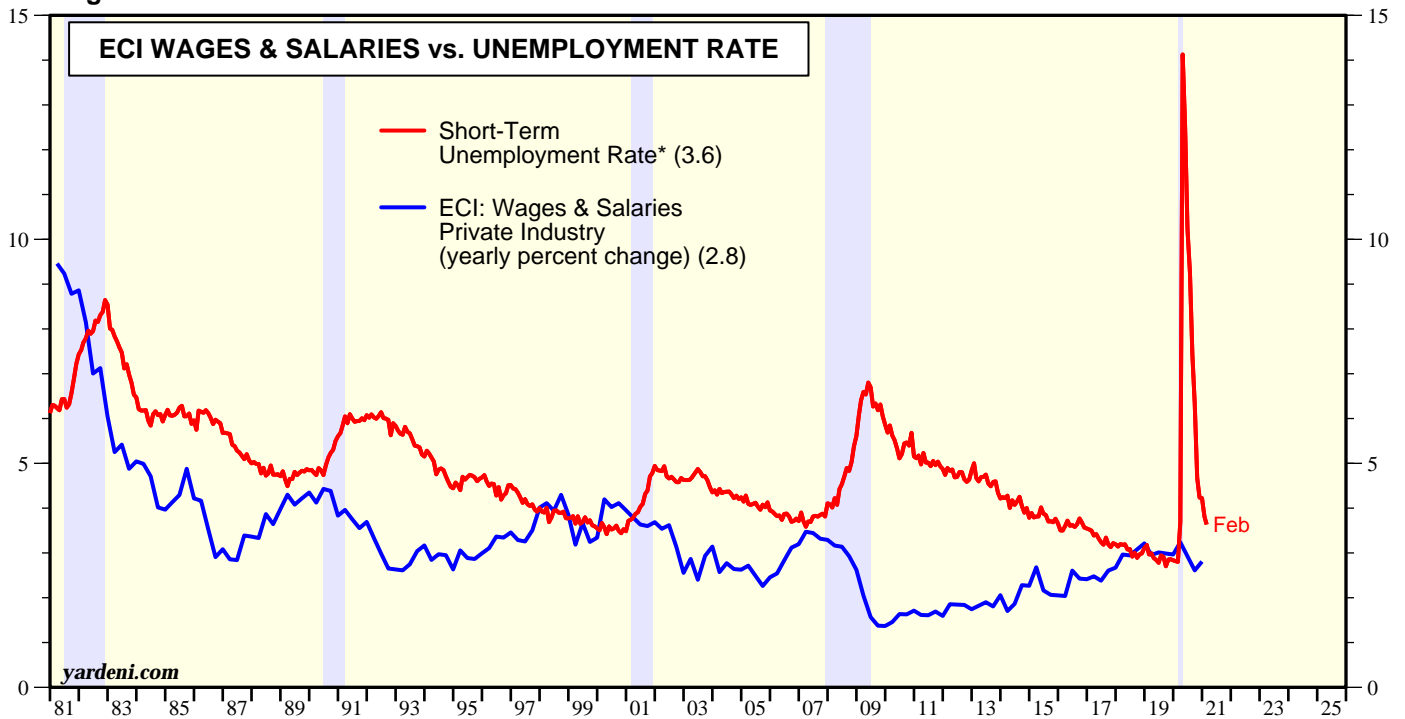

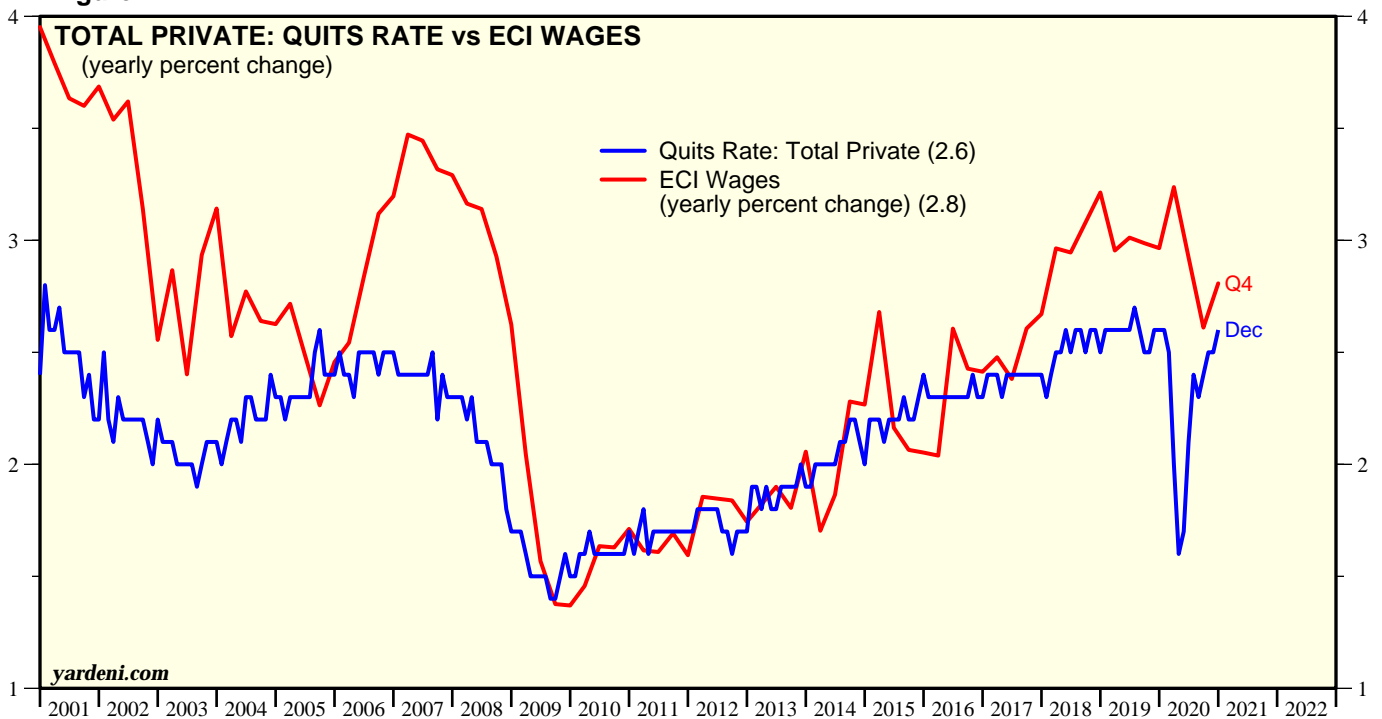

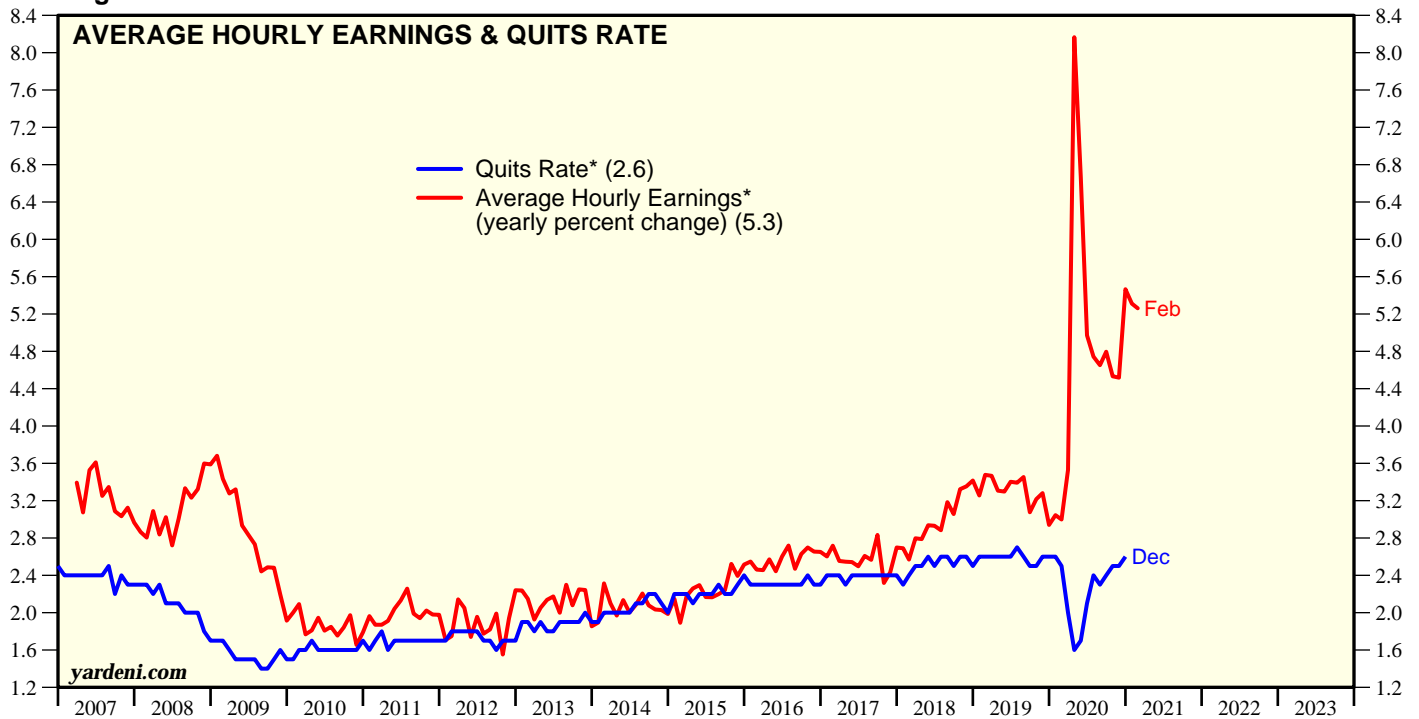

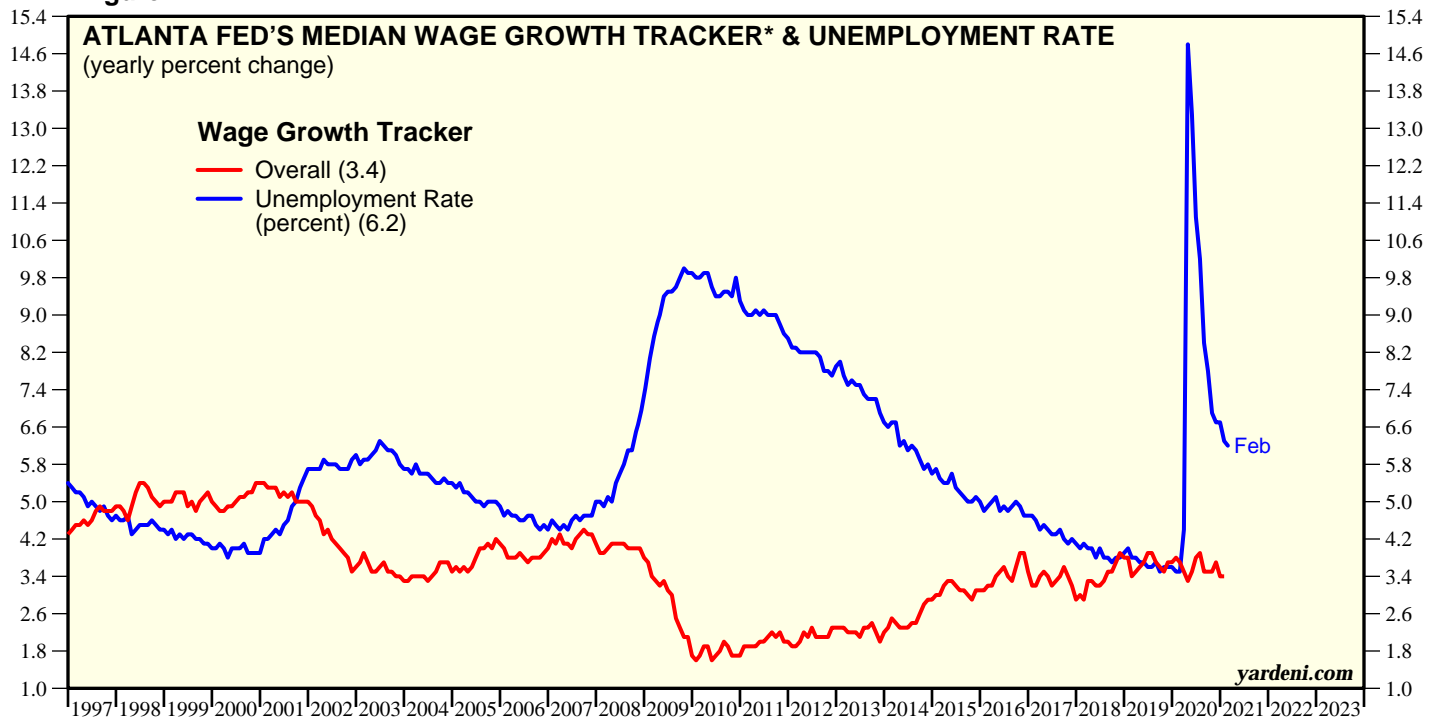

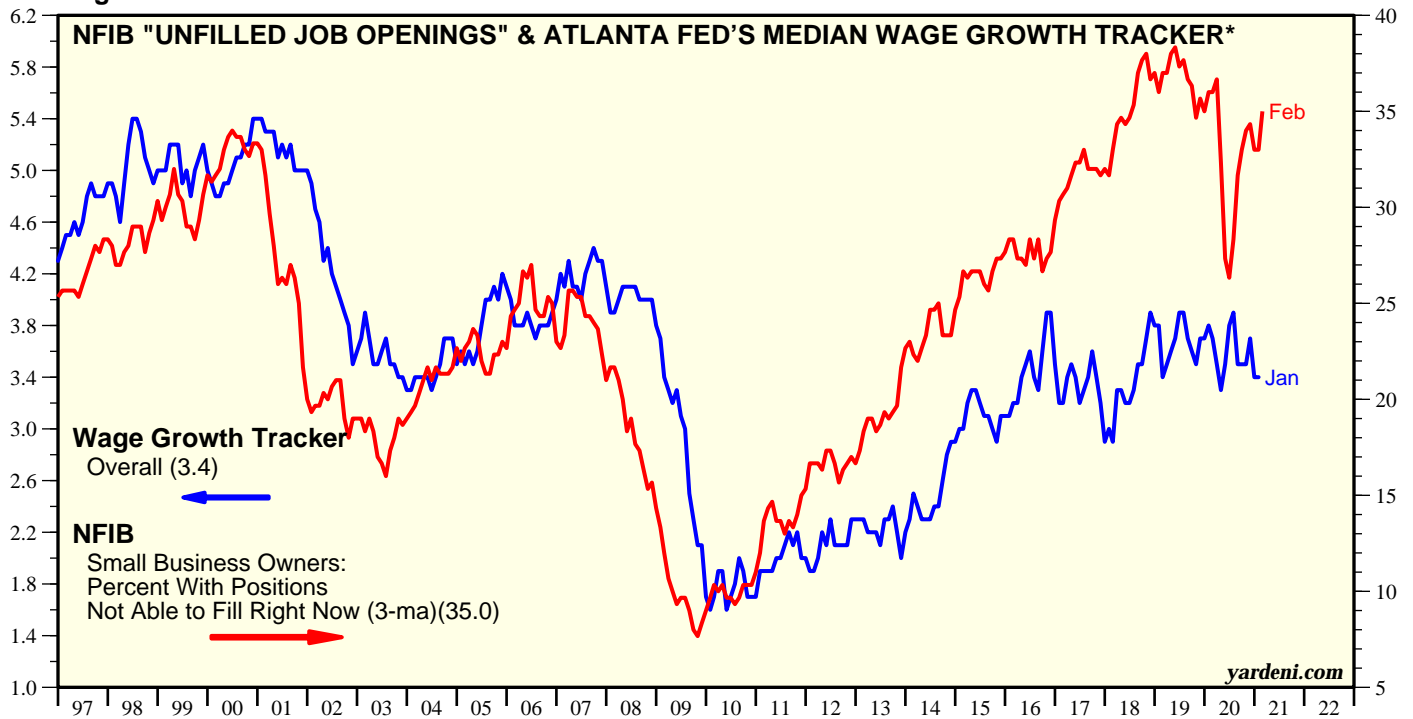

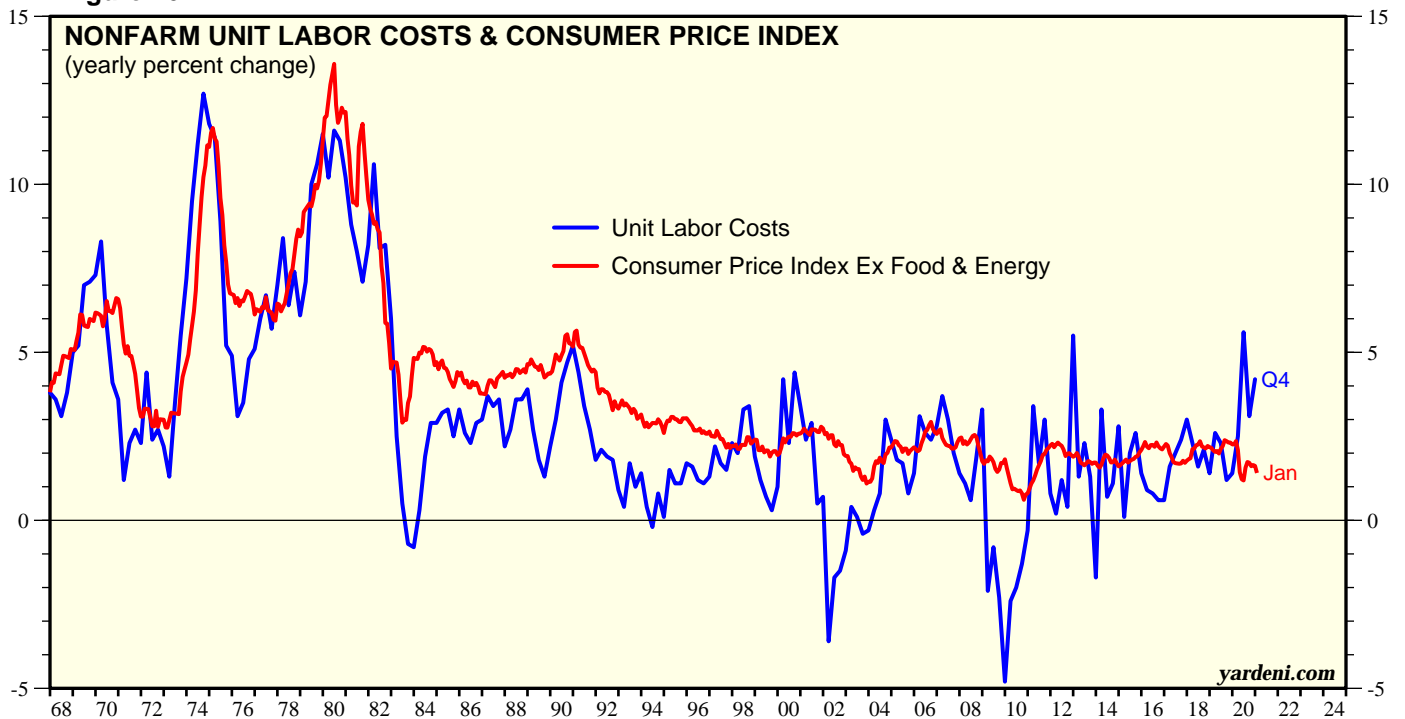
Unit Labor Costs & Inflation

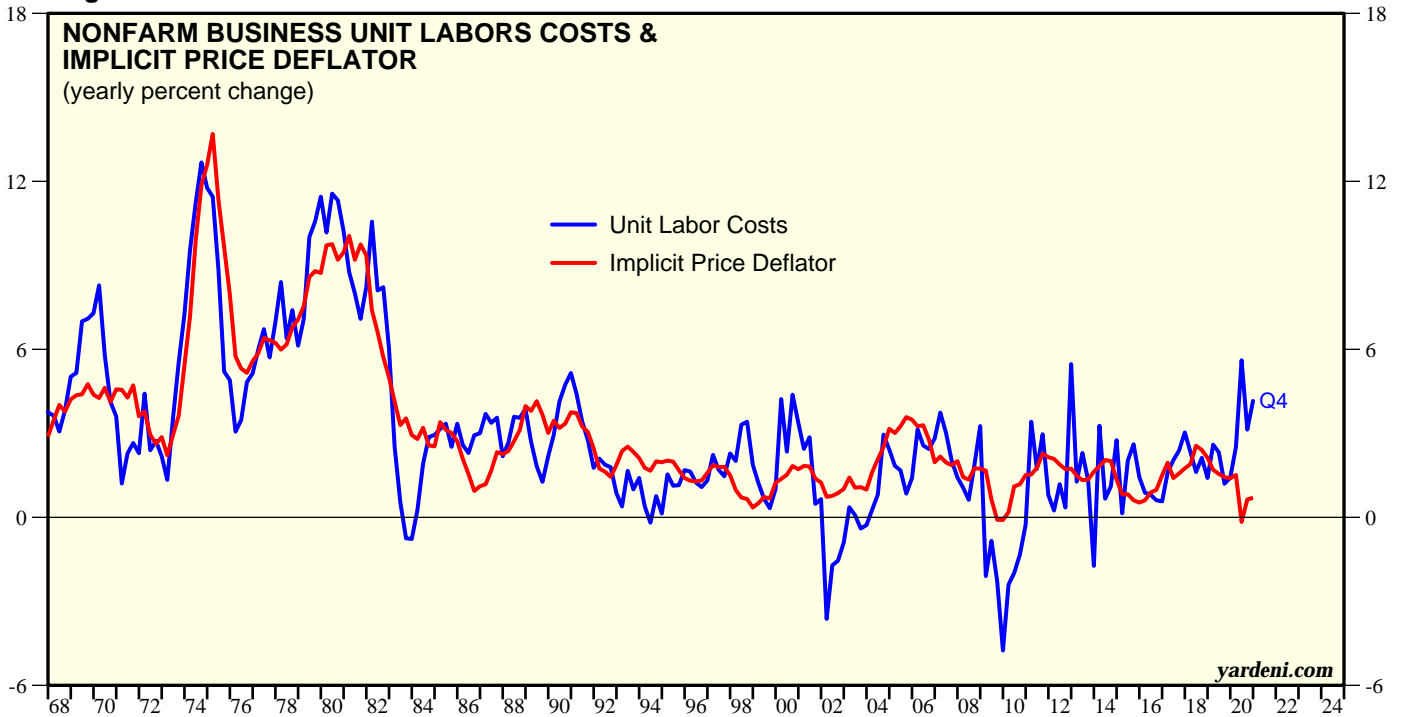

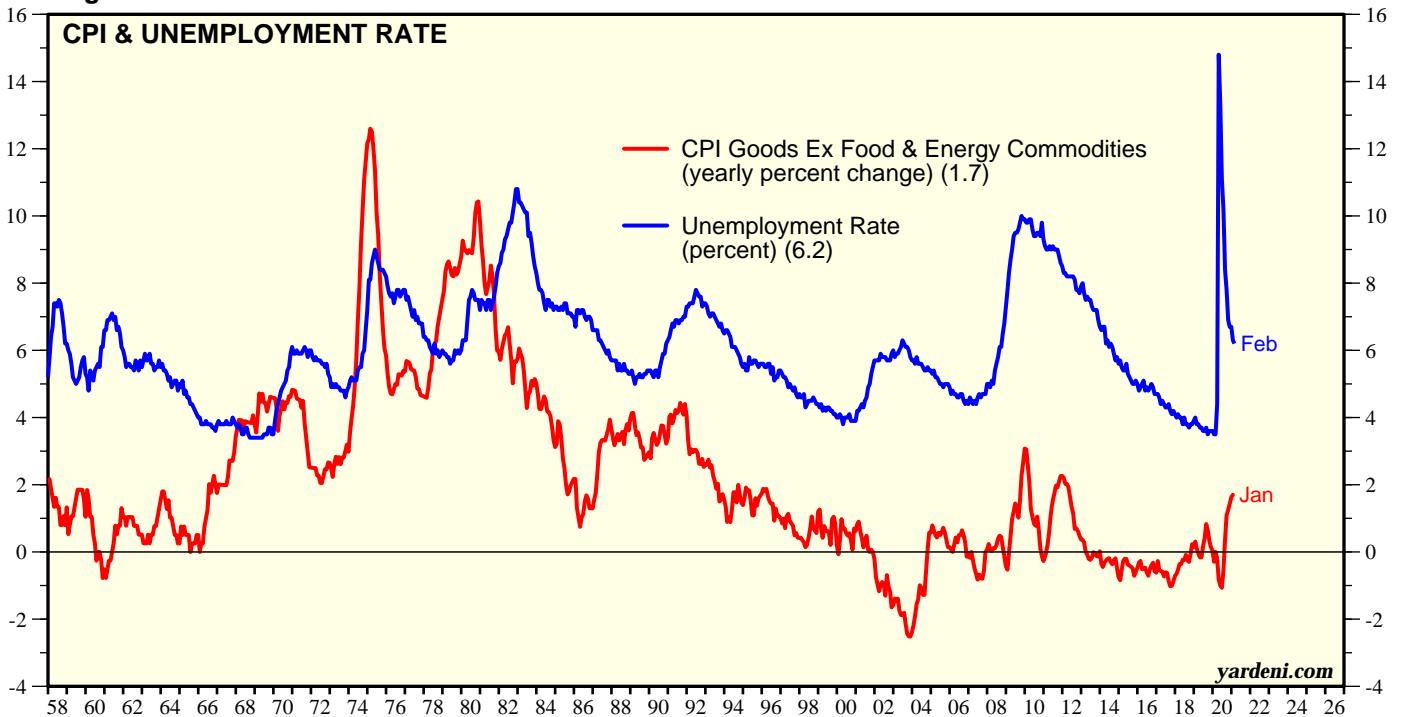

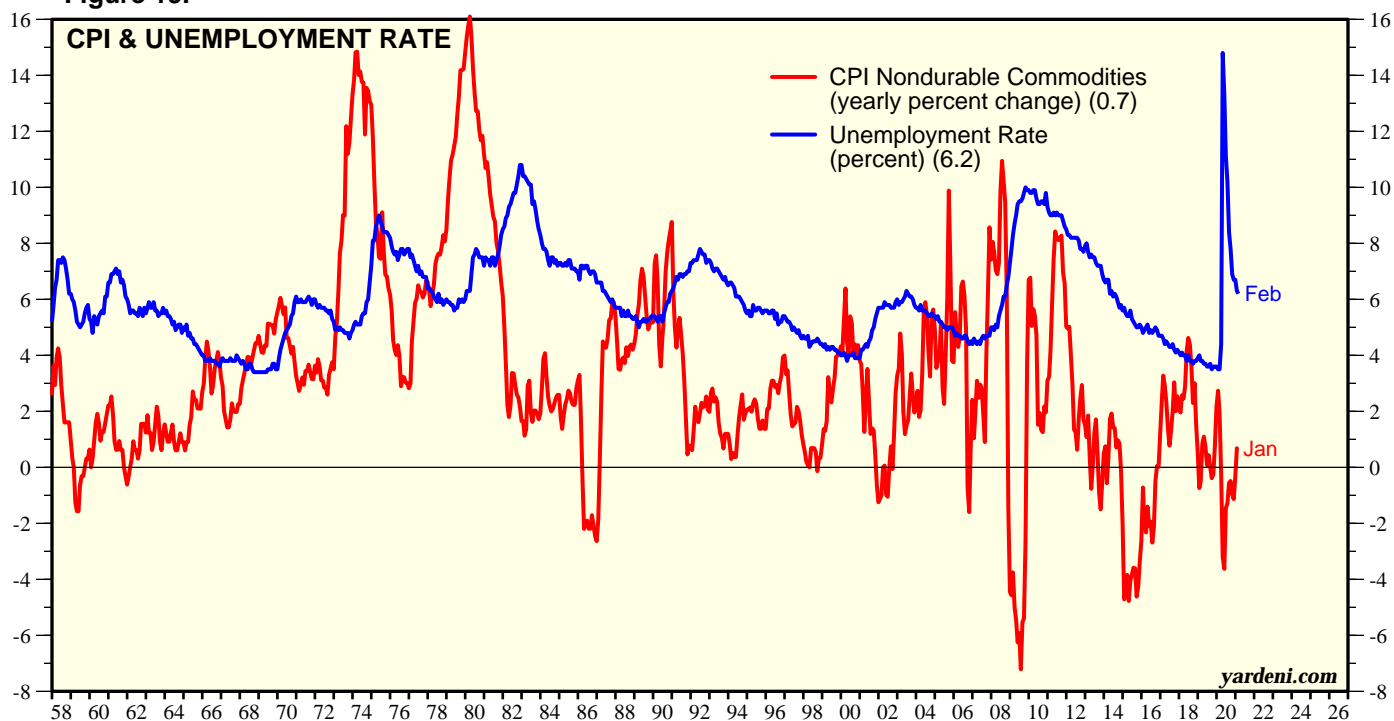

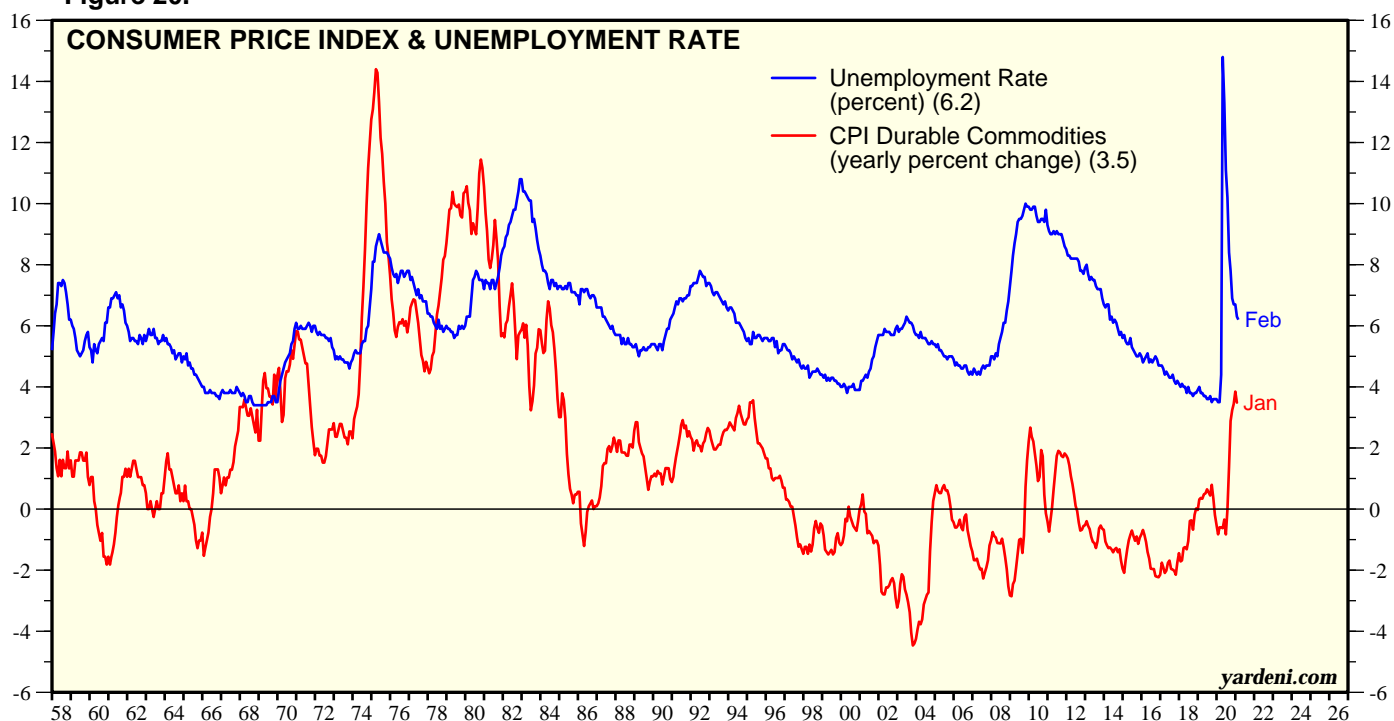

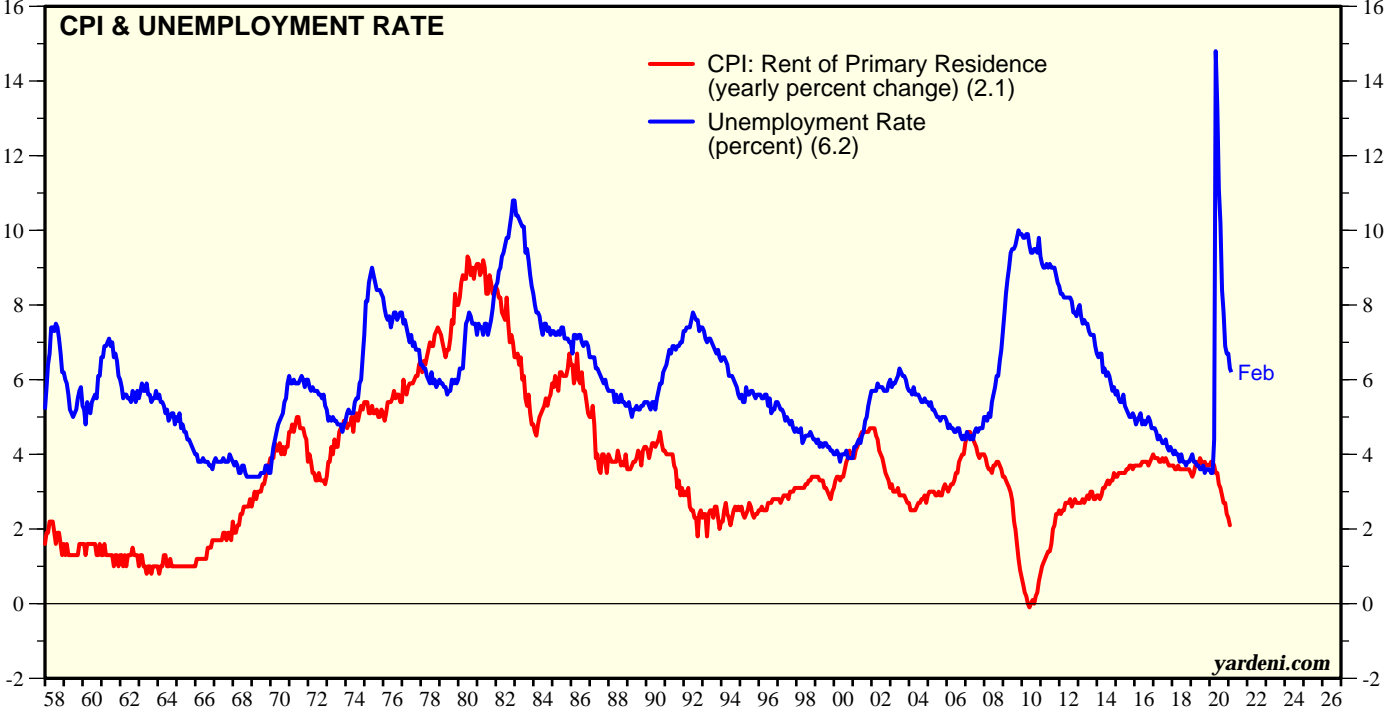

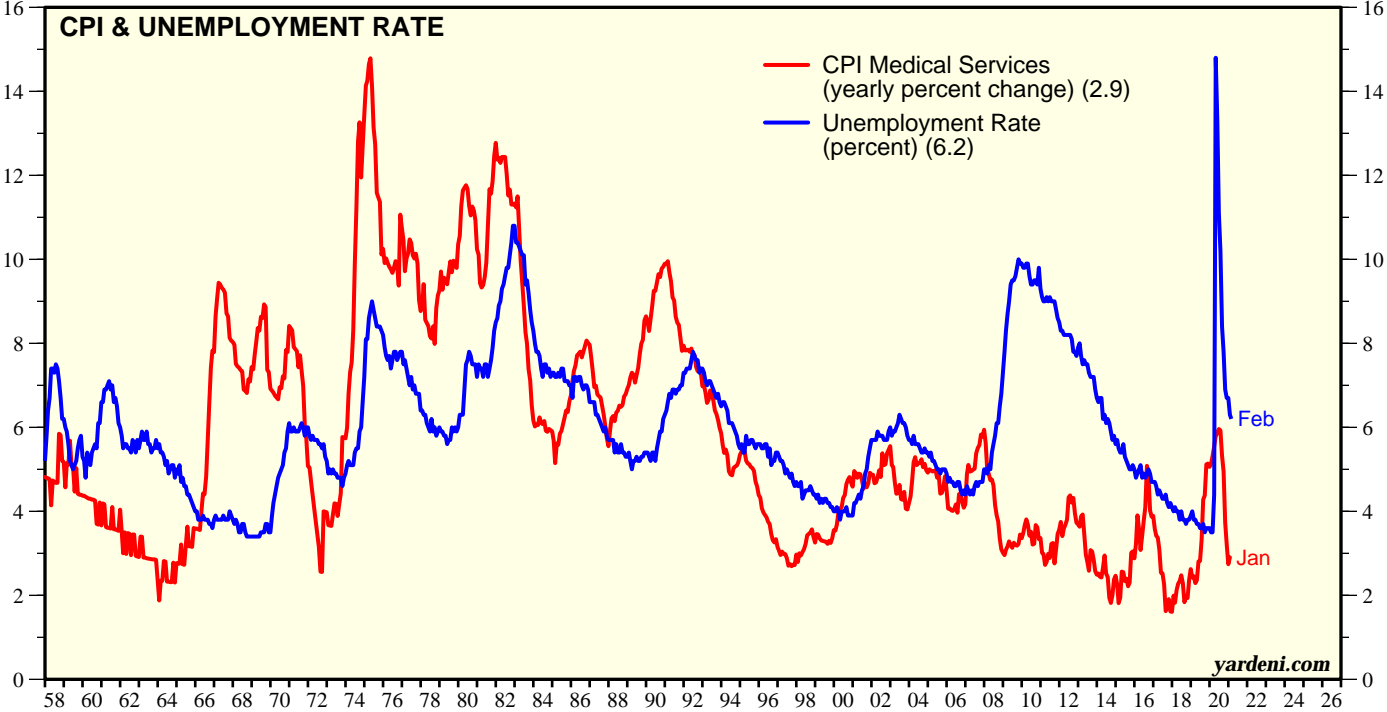

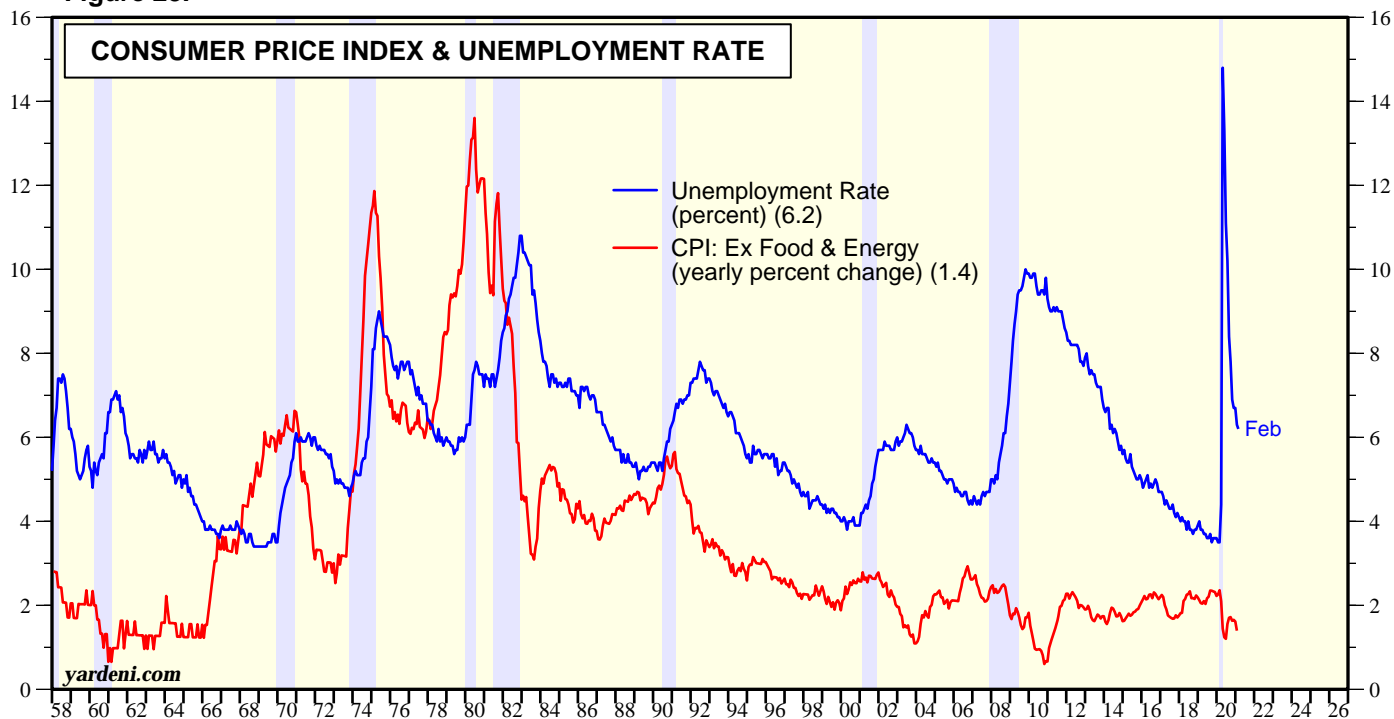

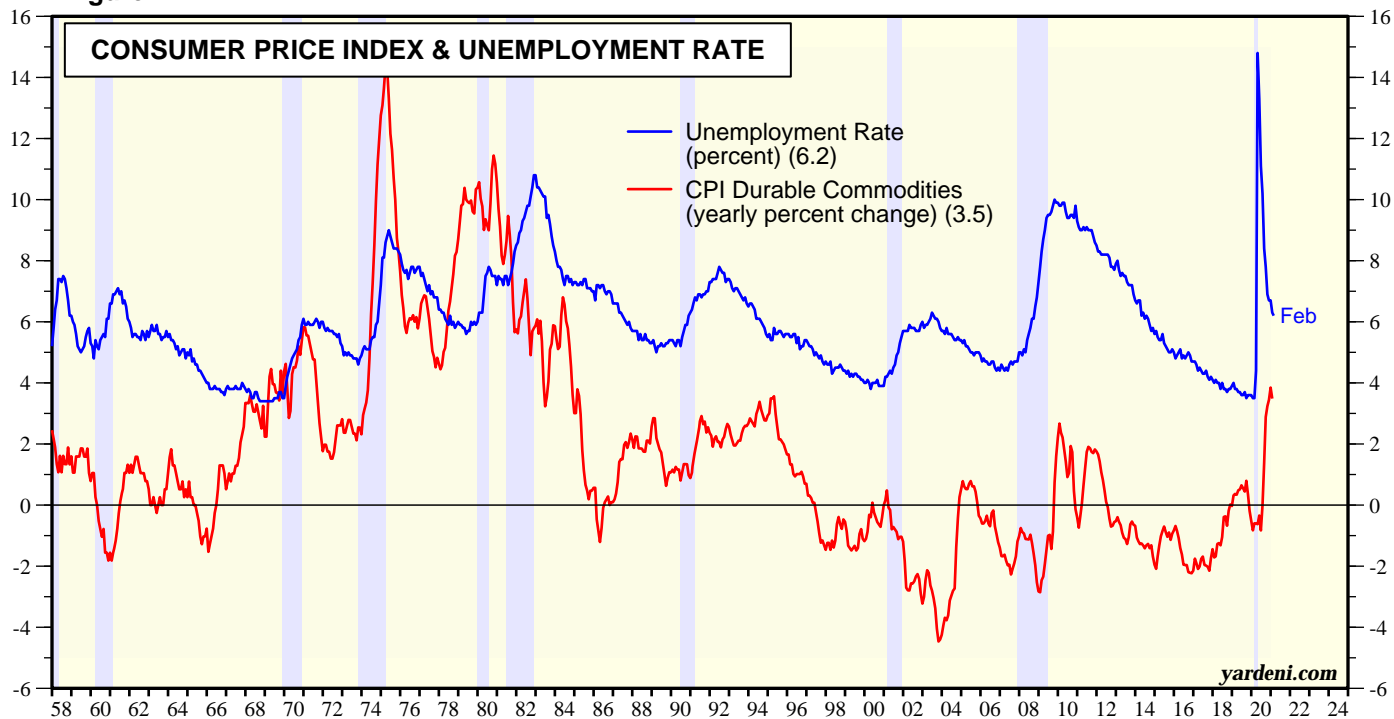

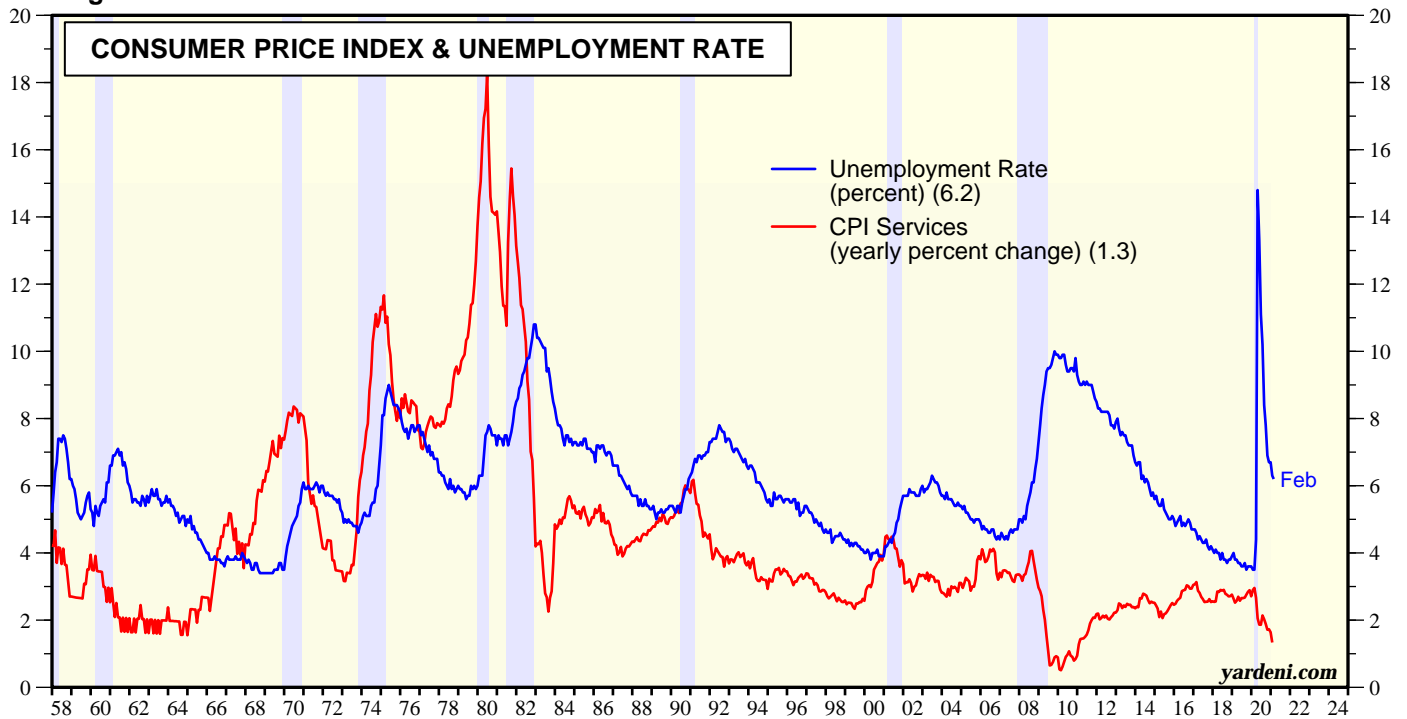

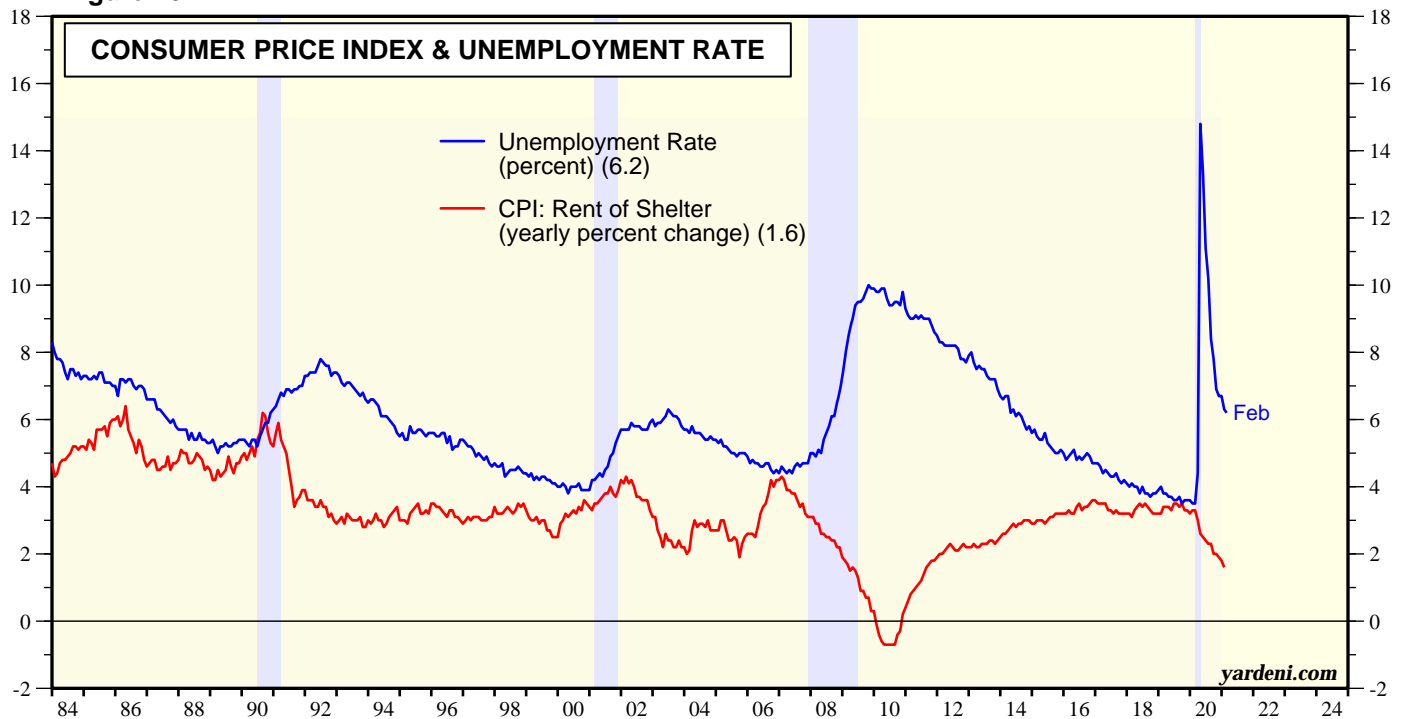

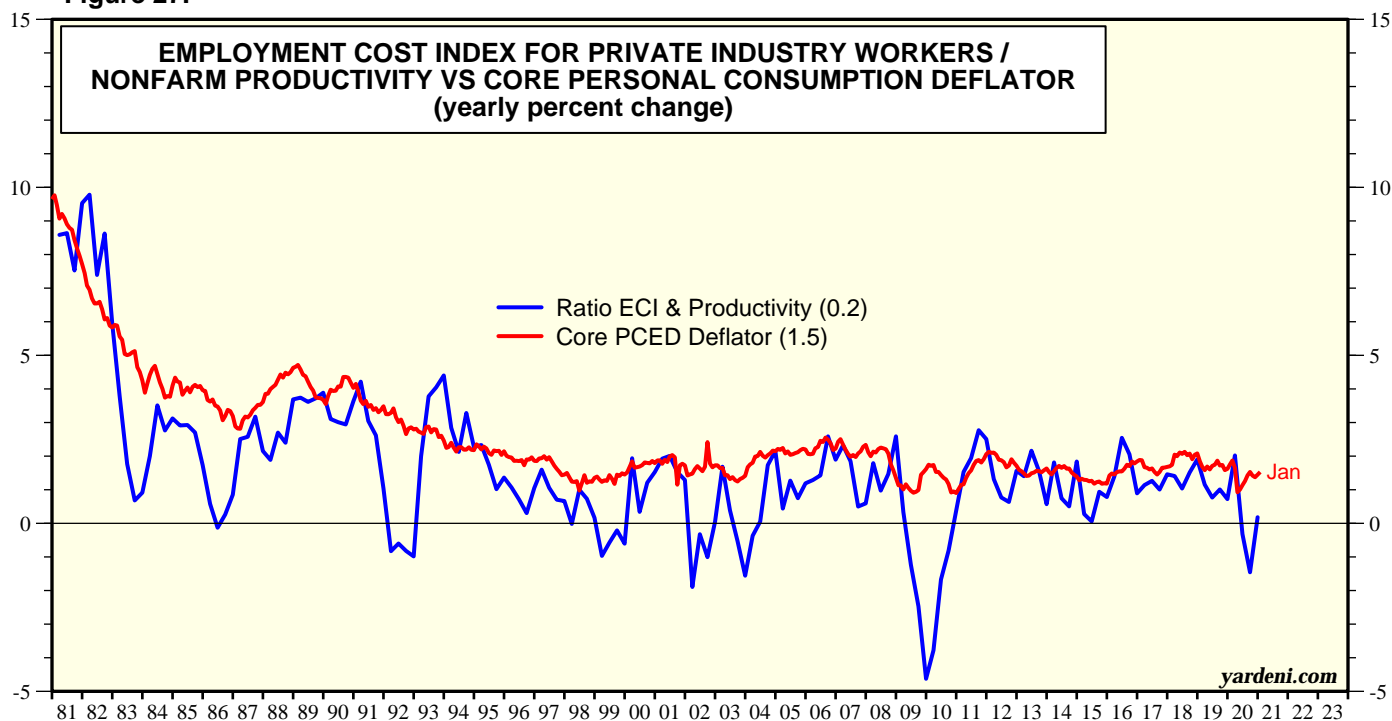

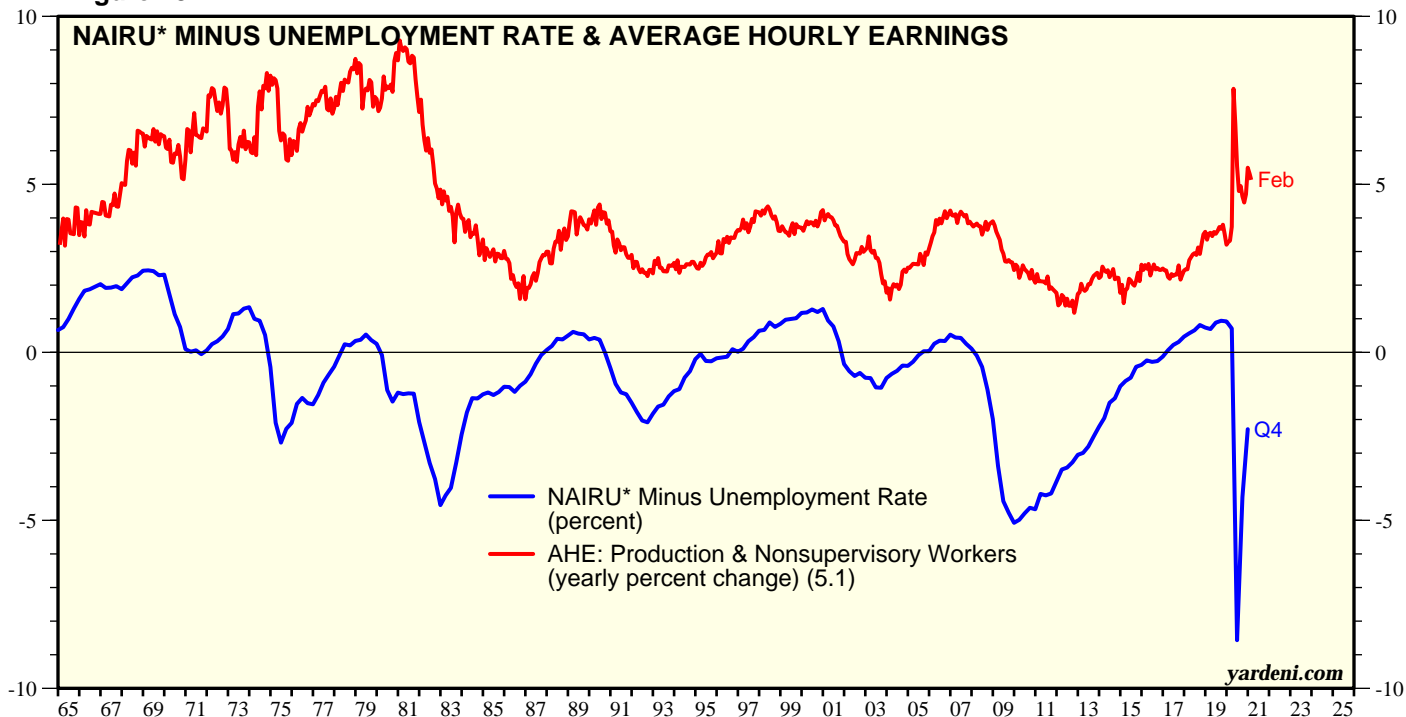

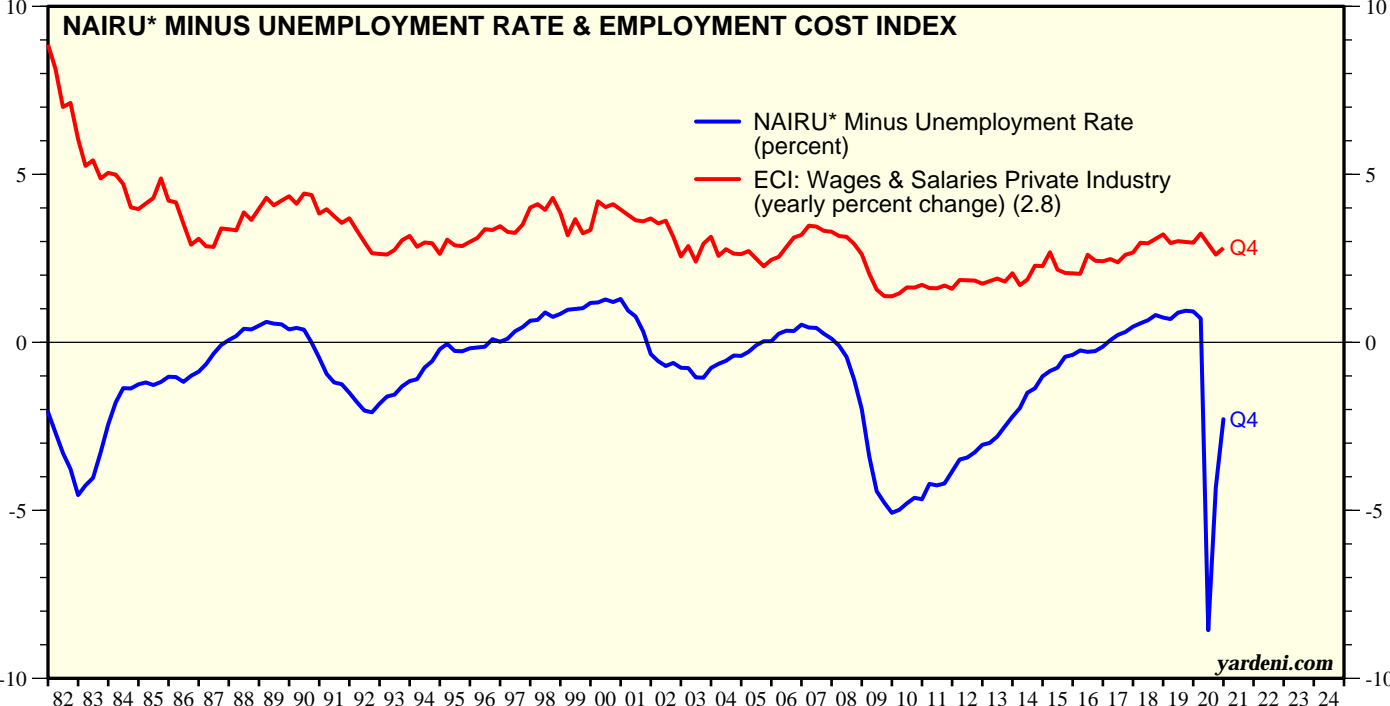
