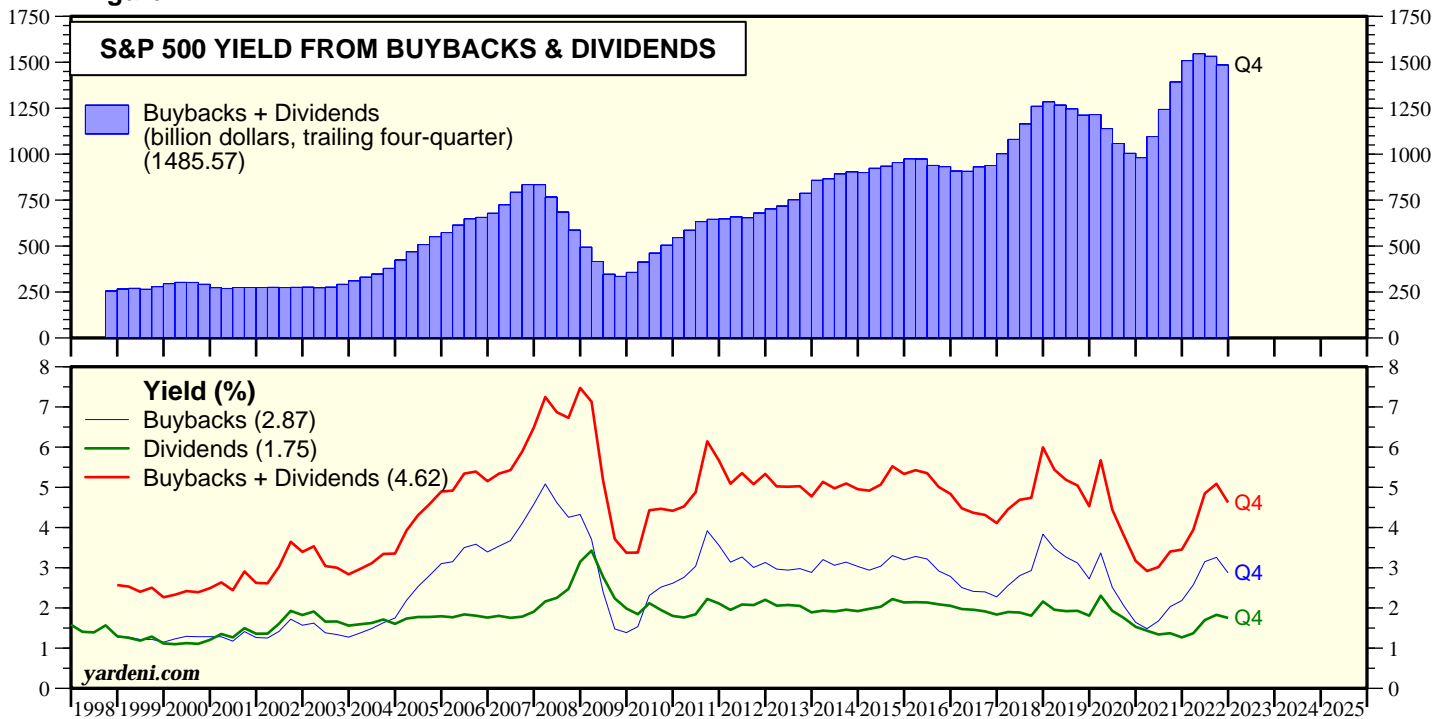

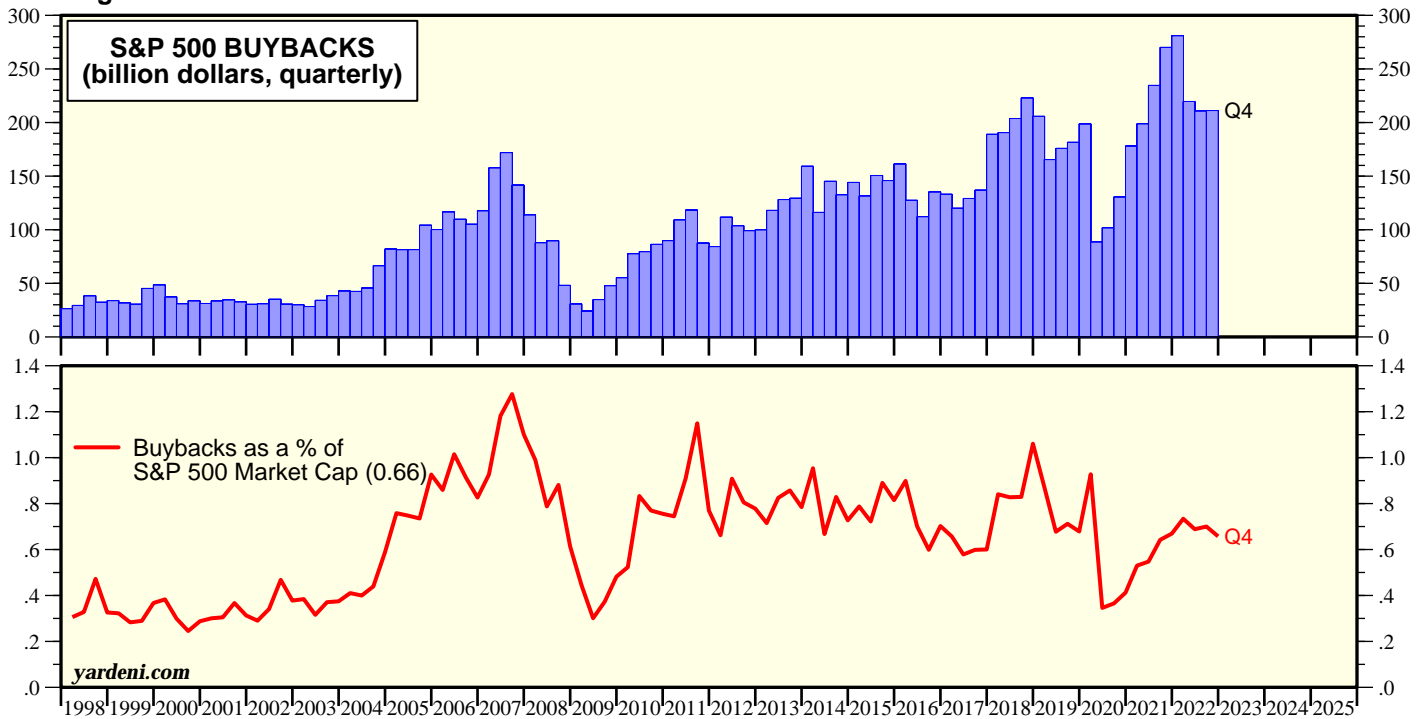

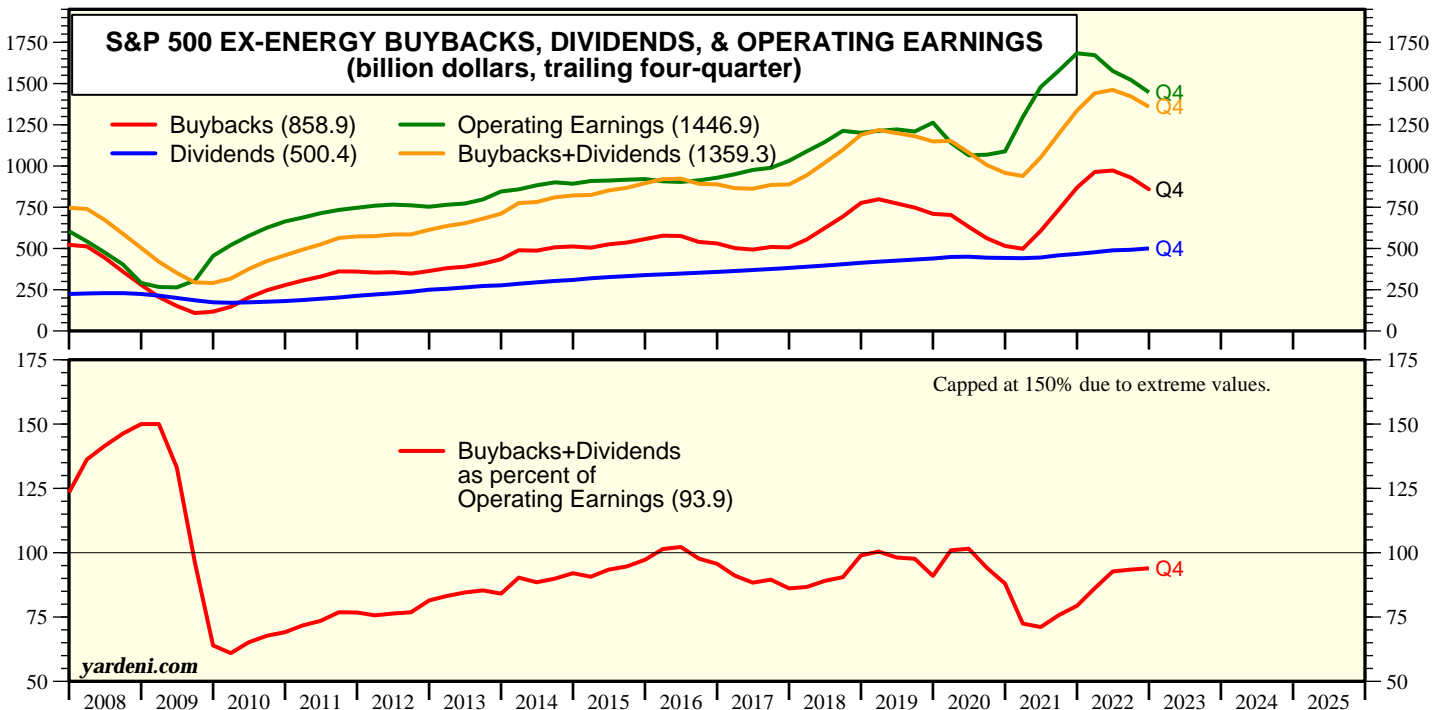
S&P 500 and Ex-Energy

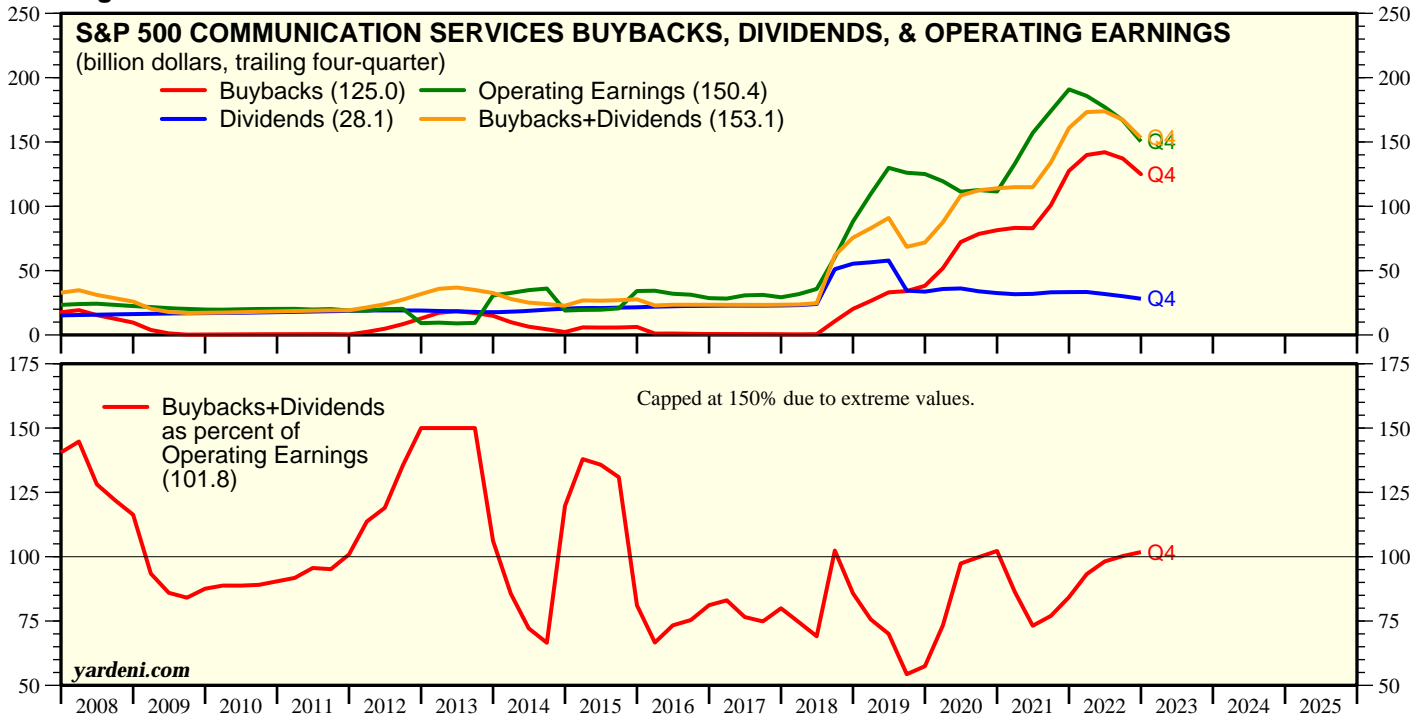

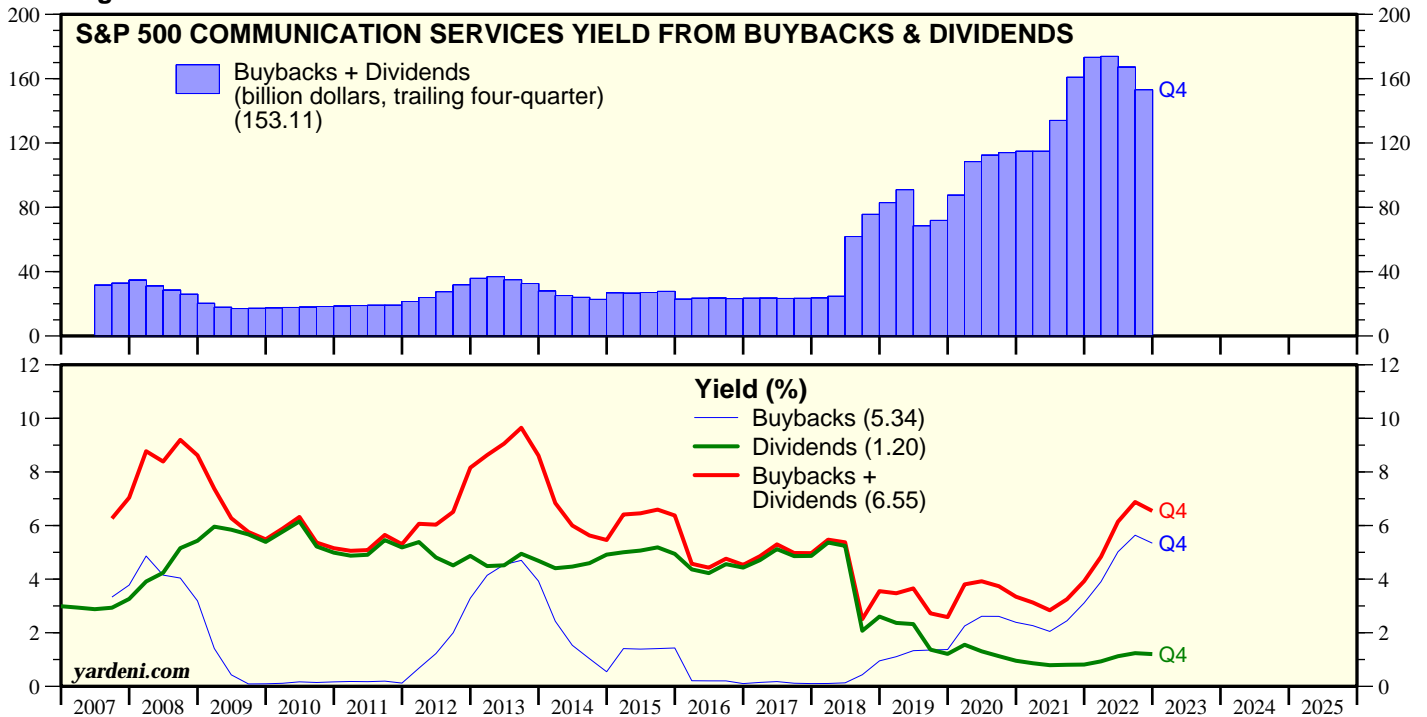
S&P 500 Communication Services

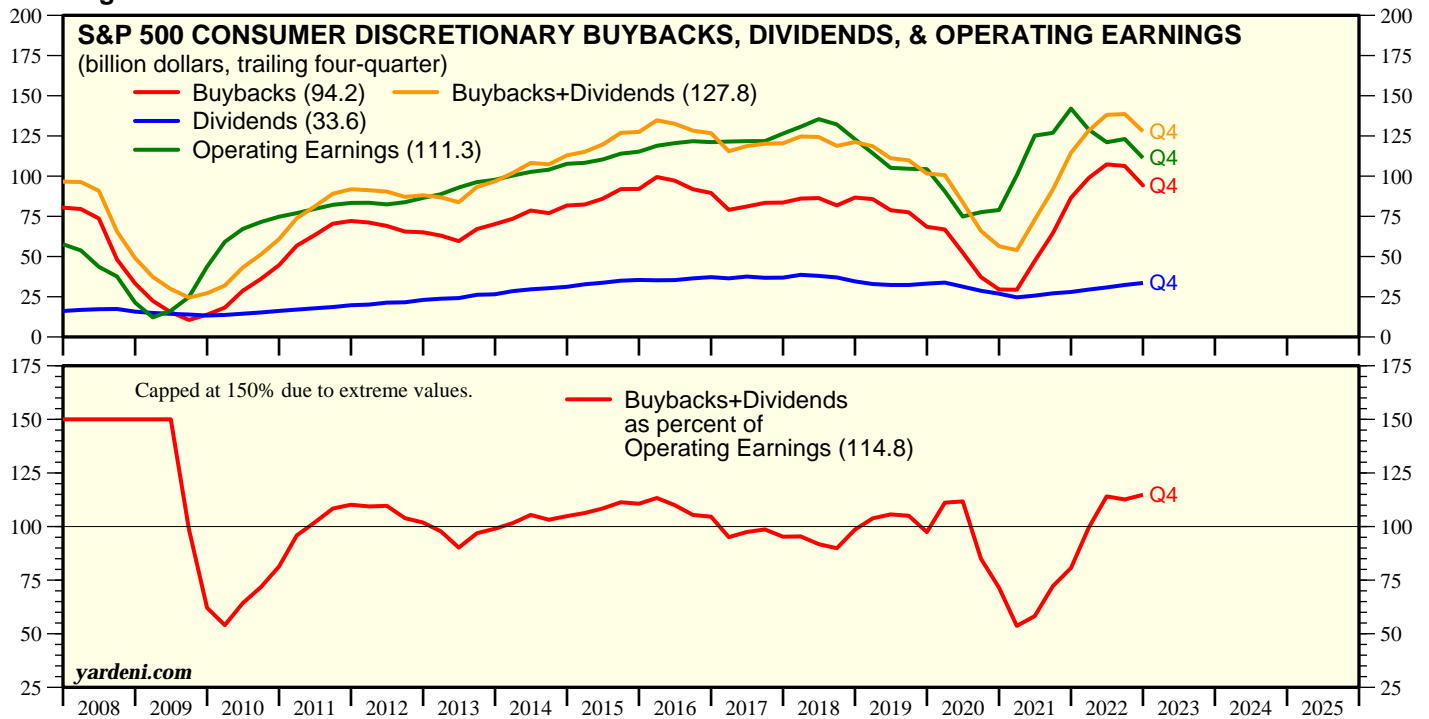

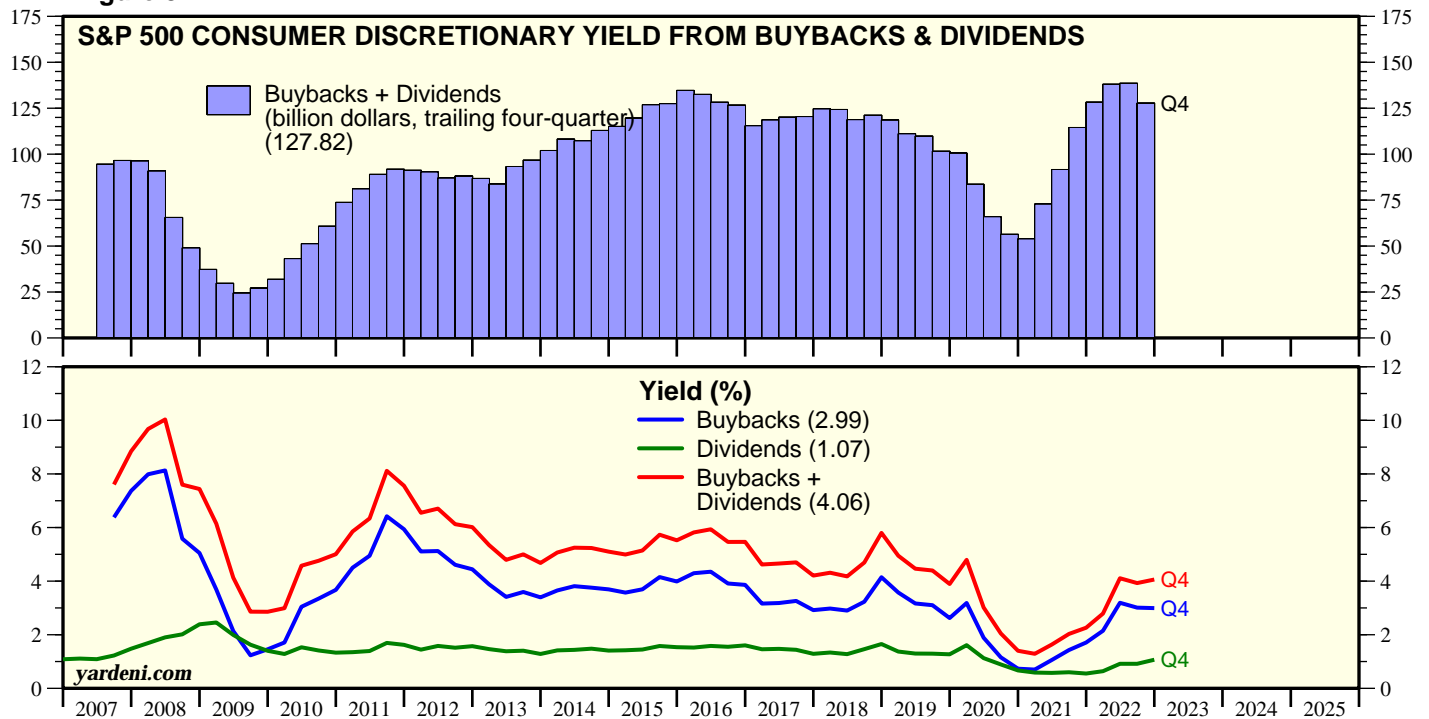
S&P 500 Consumer Discretionary

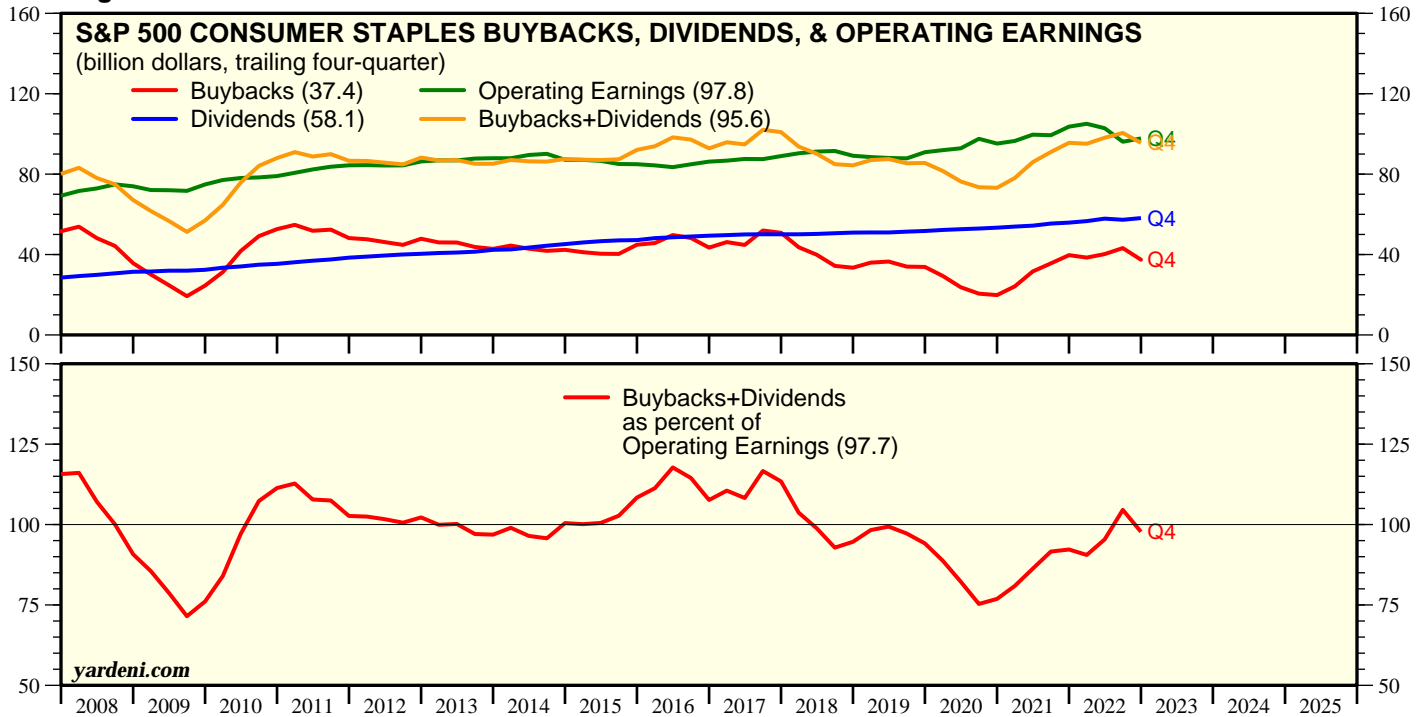

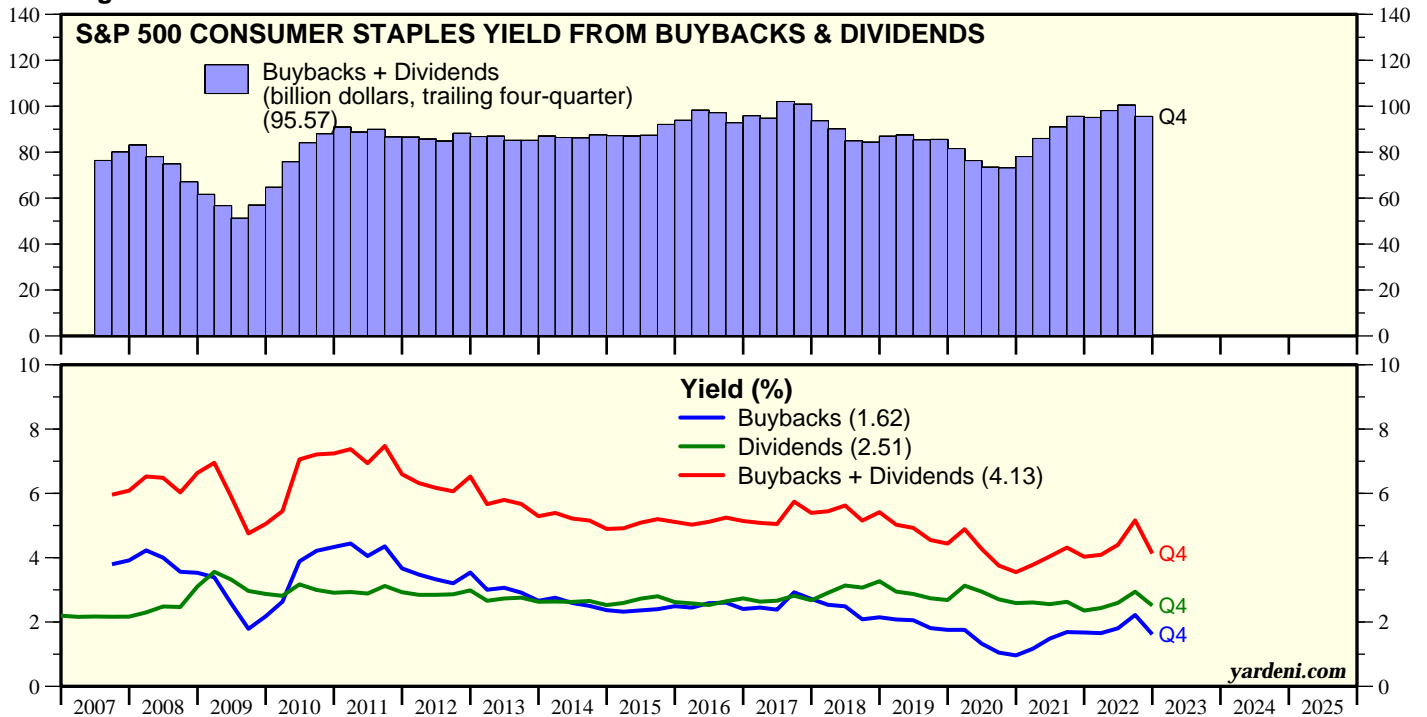
S&P 500 Consumer Staples

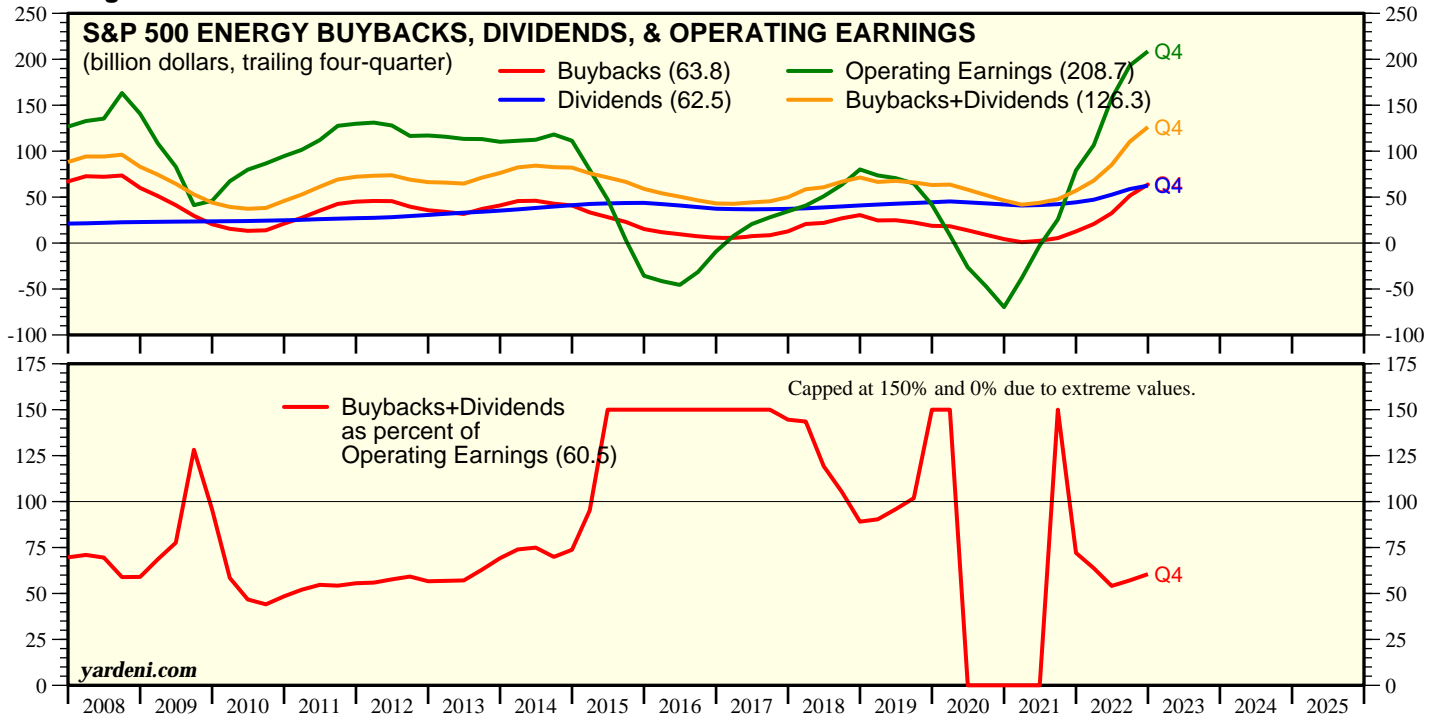

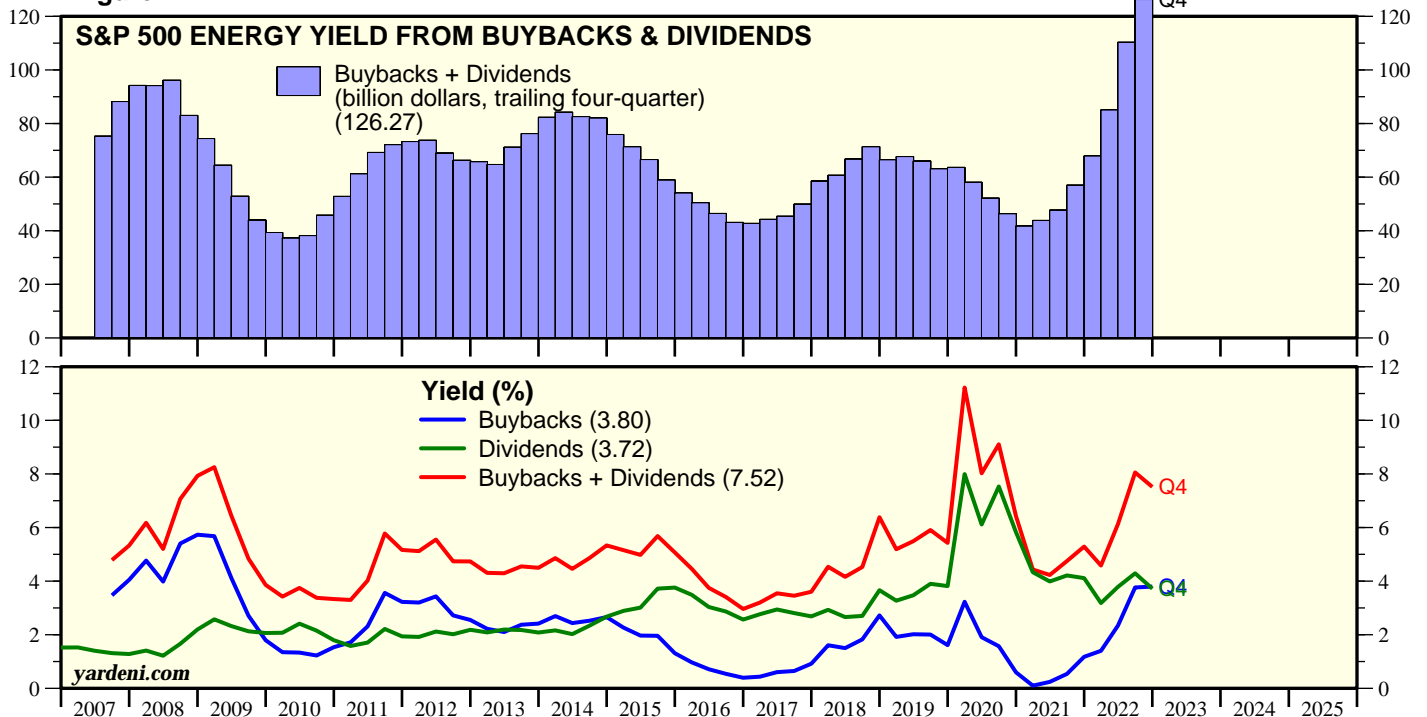
S&P 500 Energy

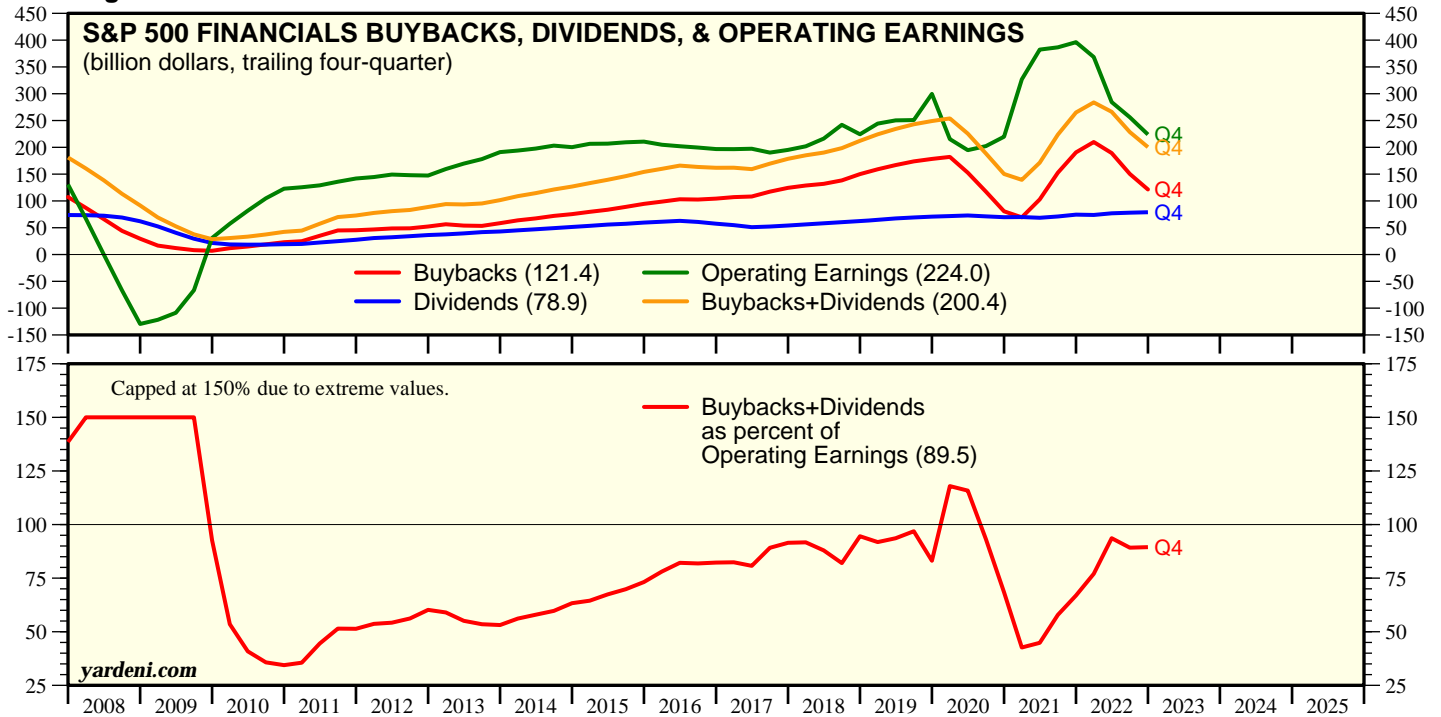

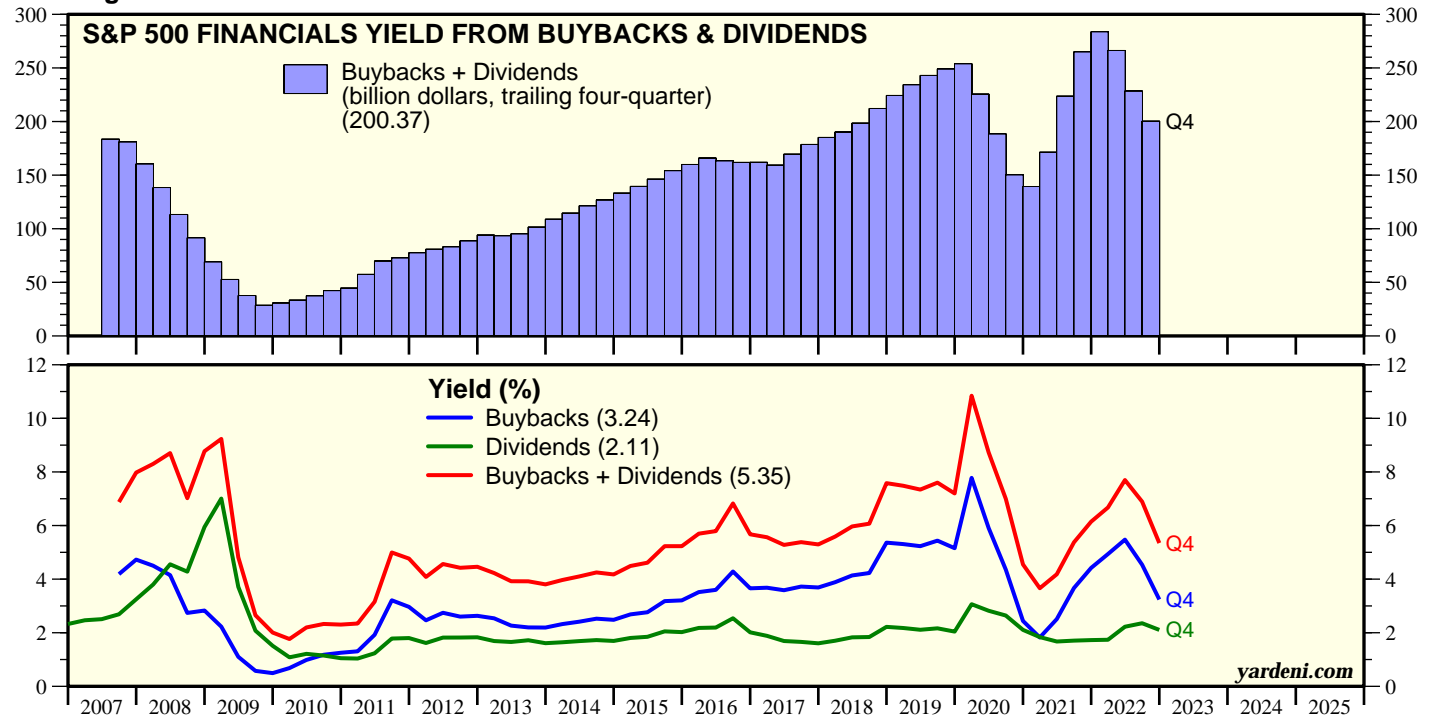
S&P 500 Financials

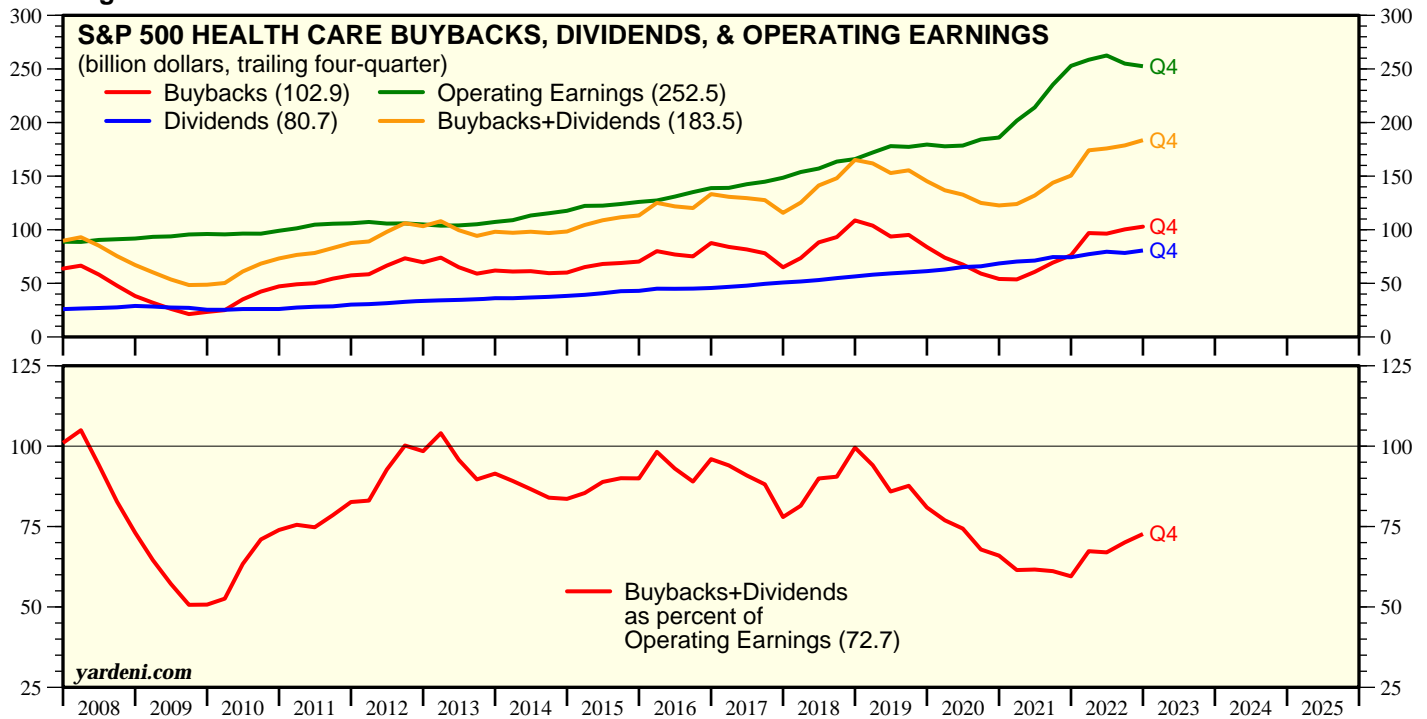

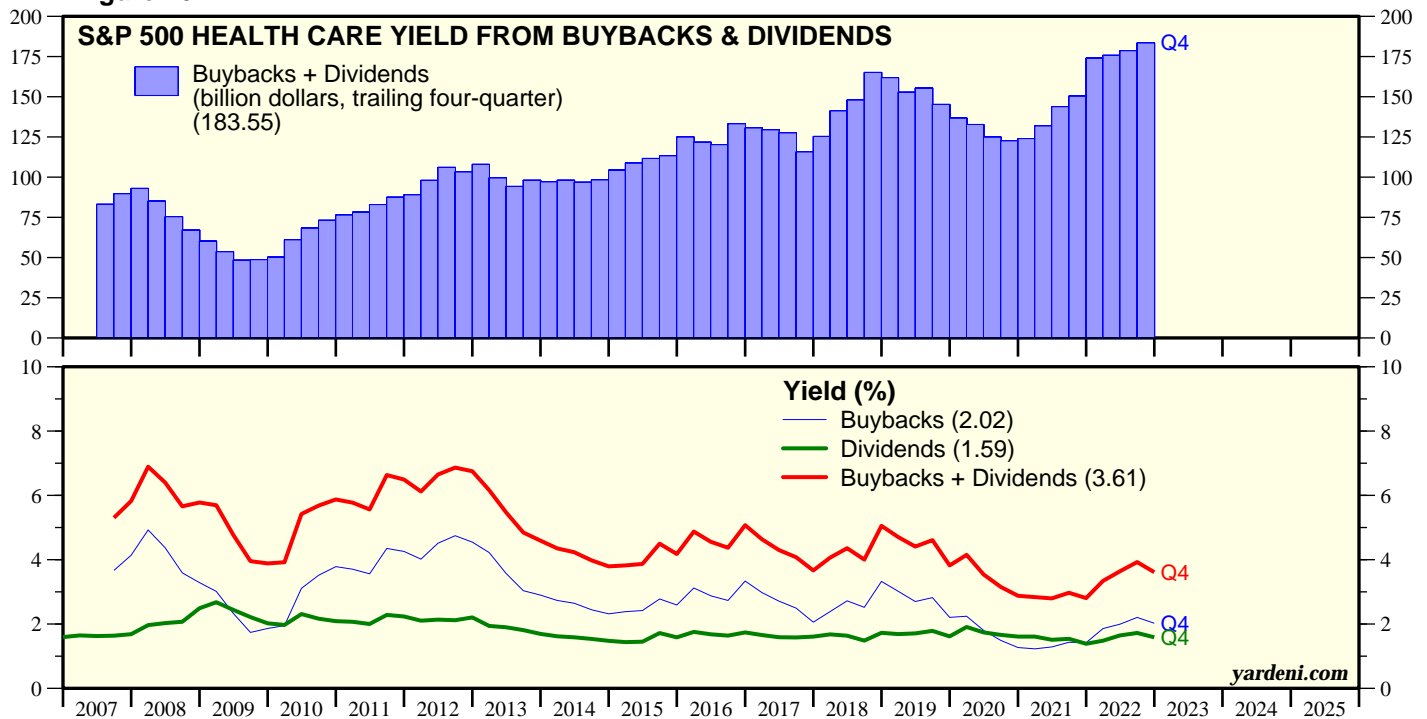
S&P 500 Health Care

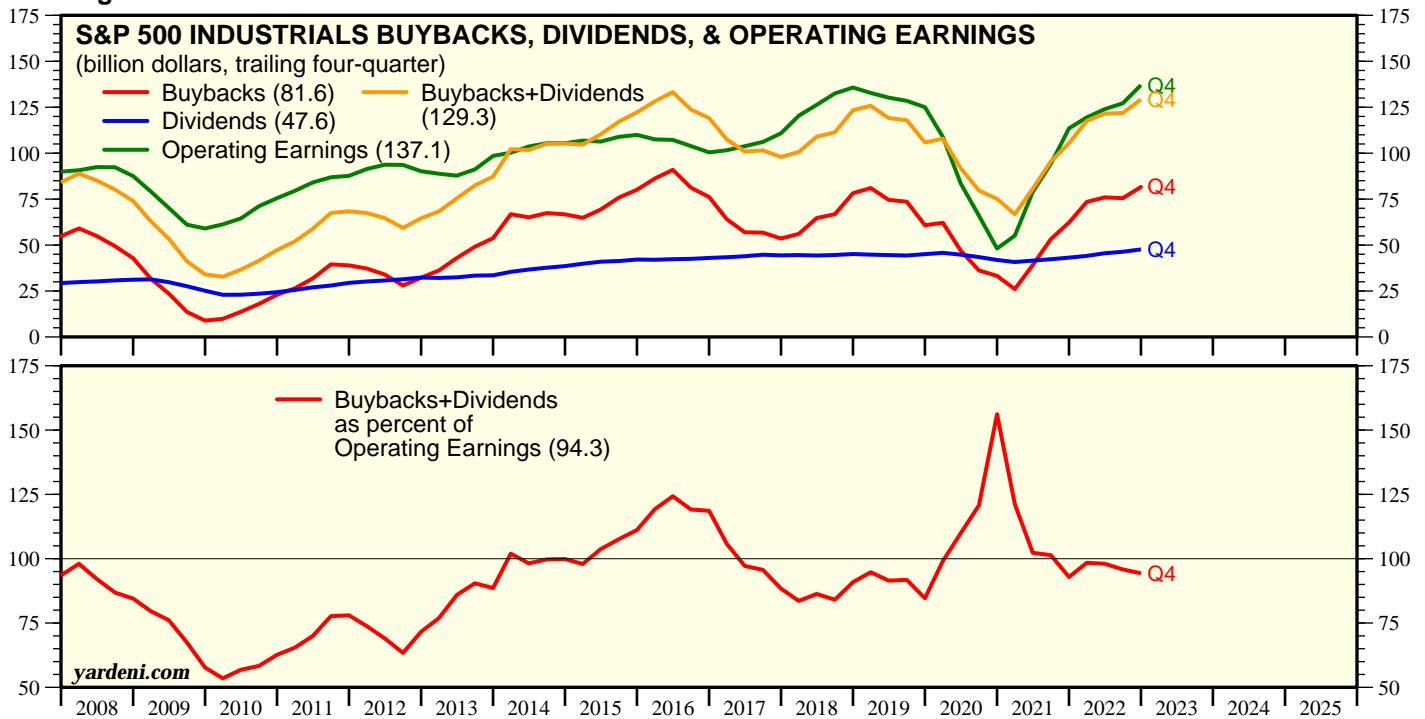

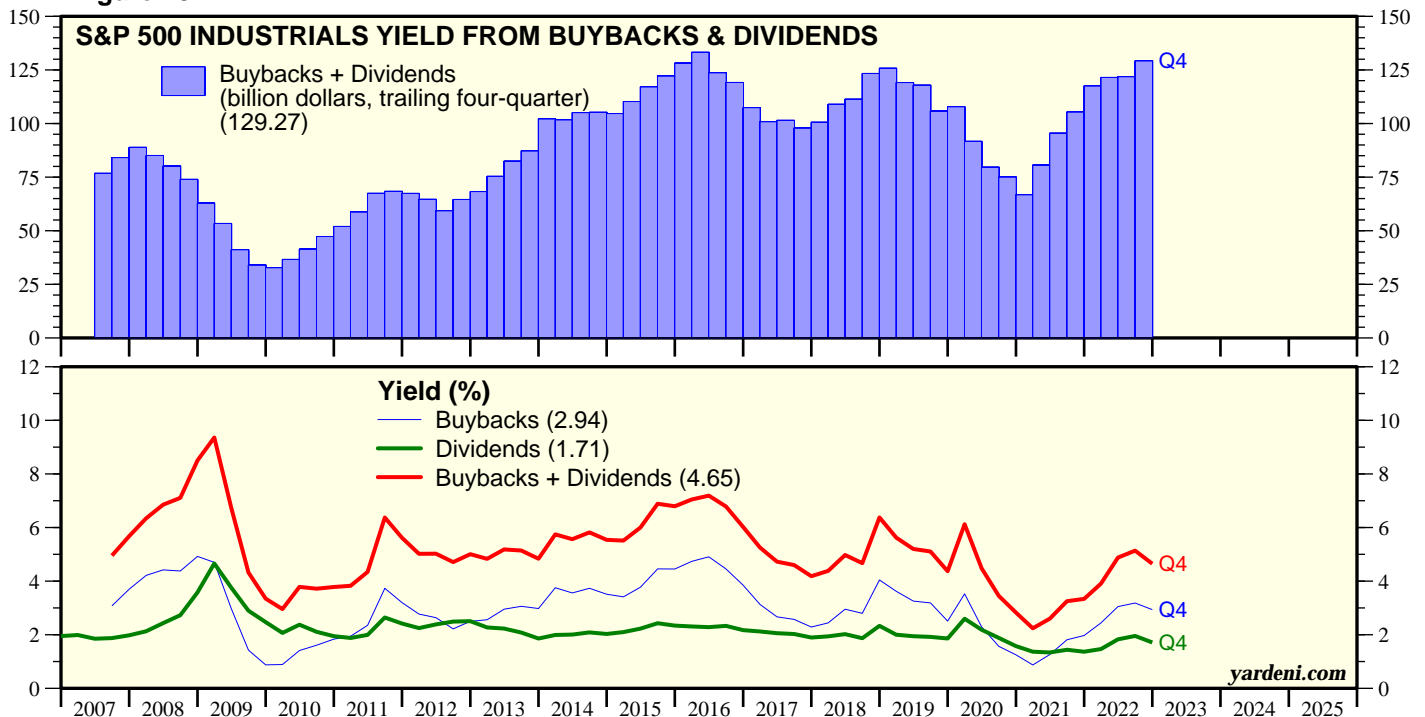
S&P 500 Industrials

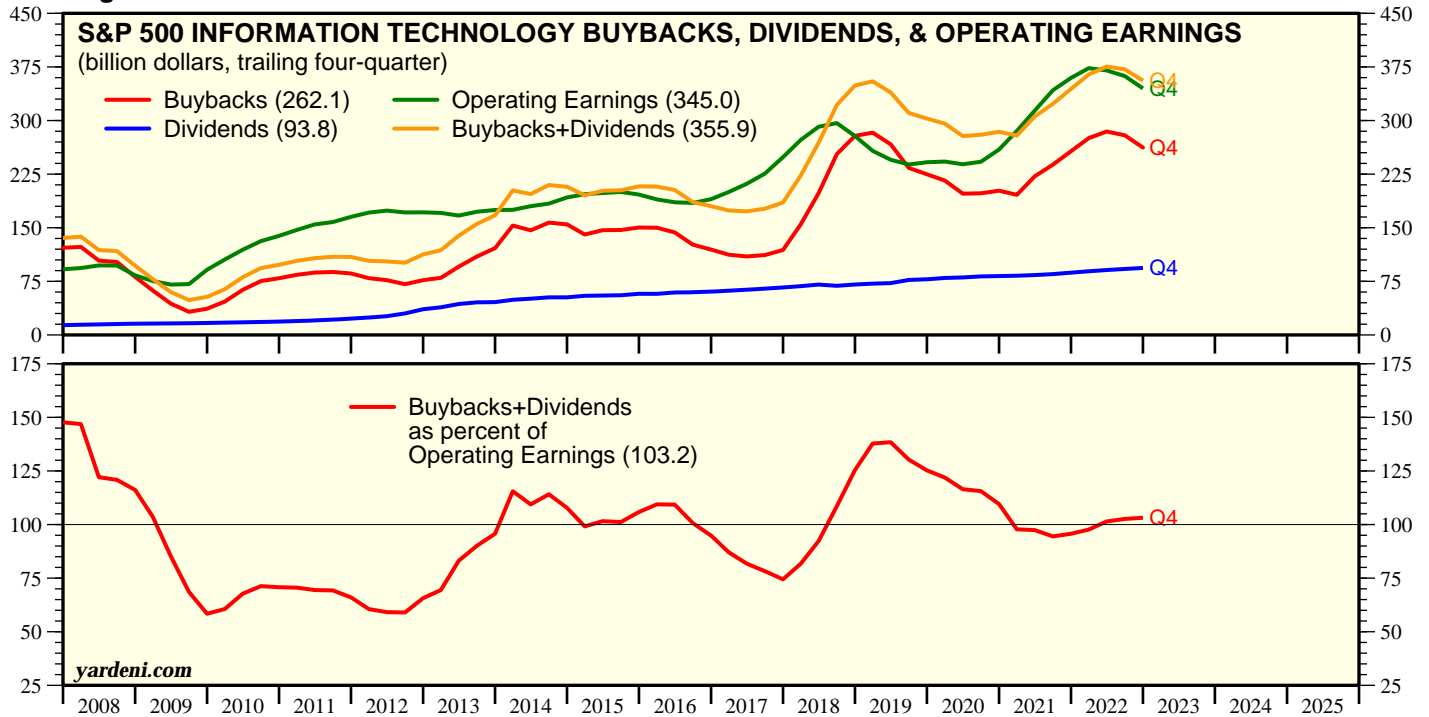

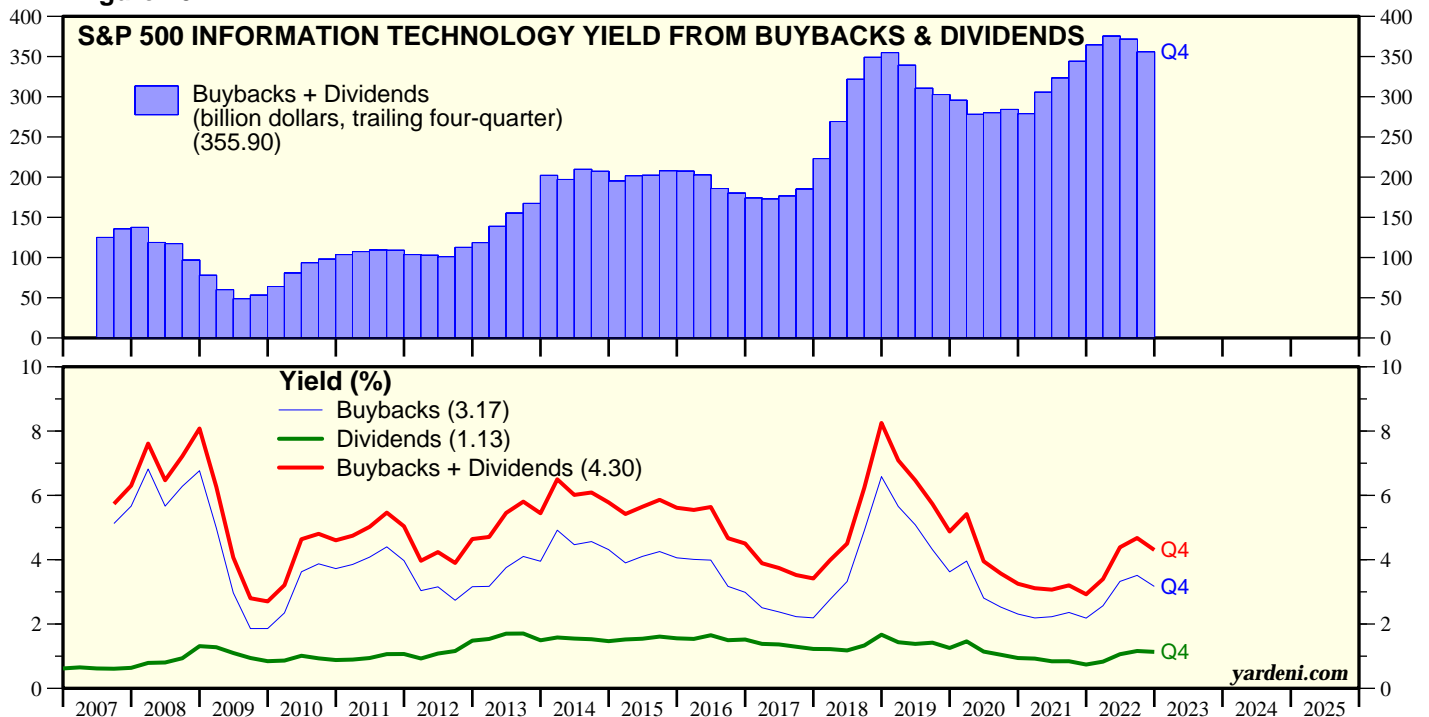
S&P 500 Information Technology

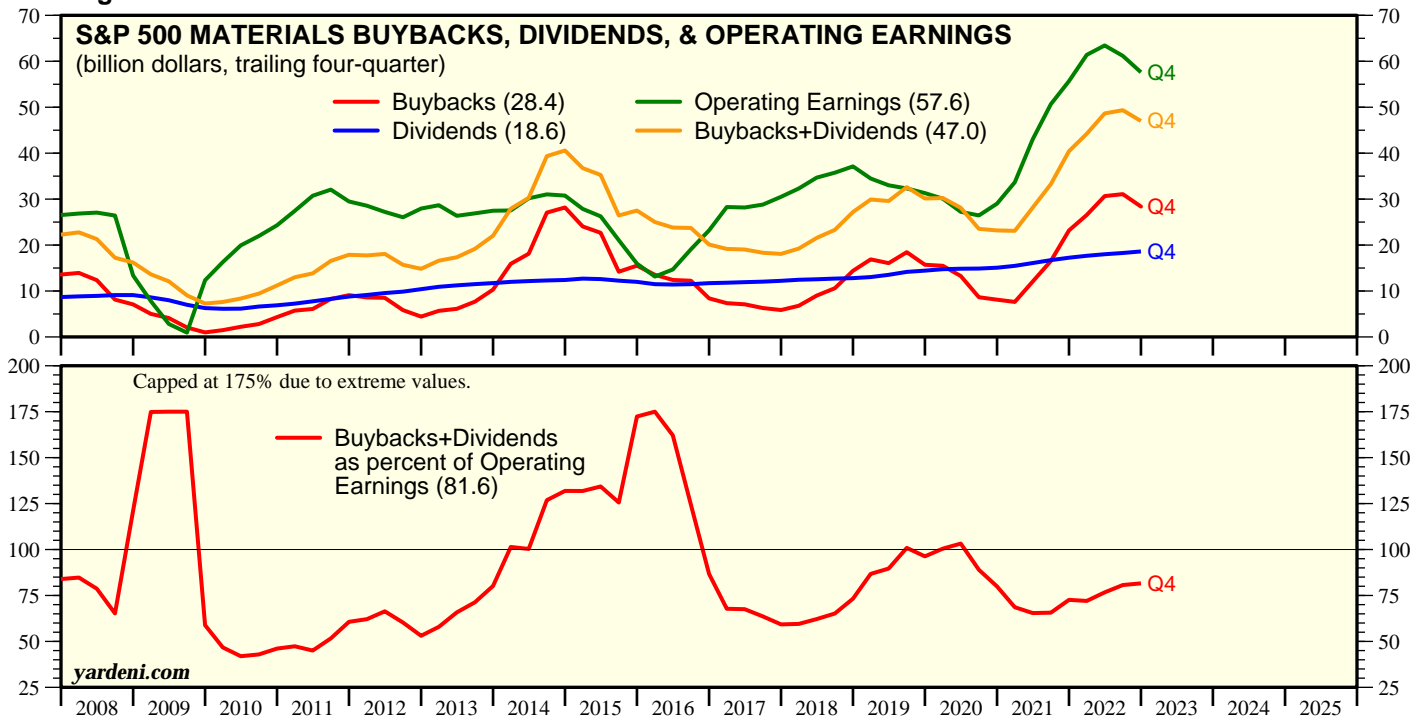

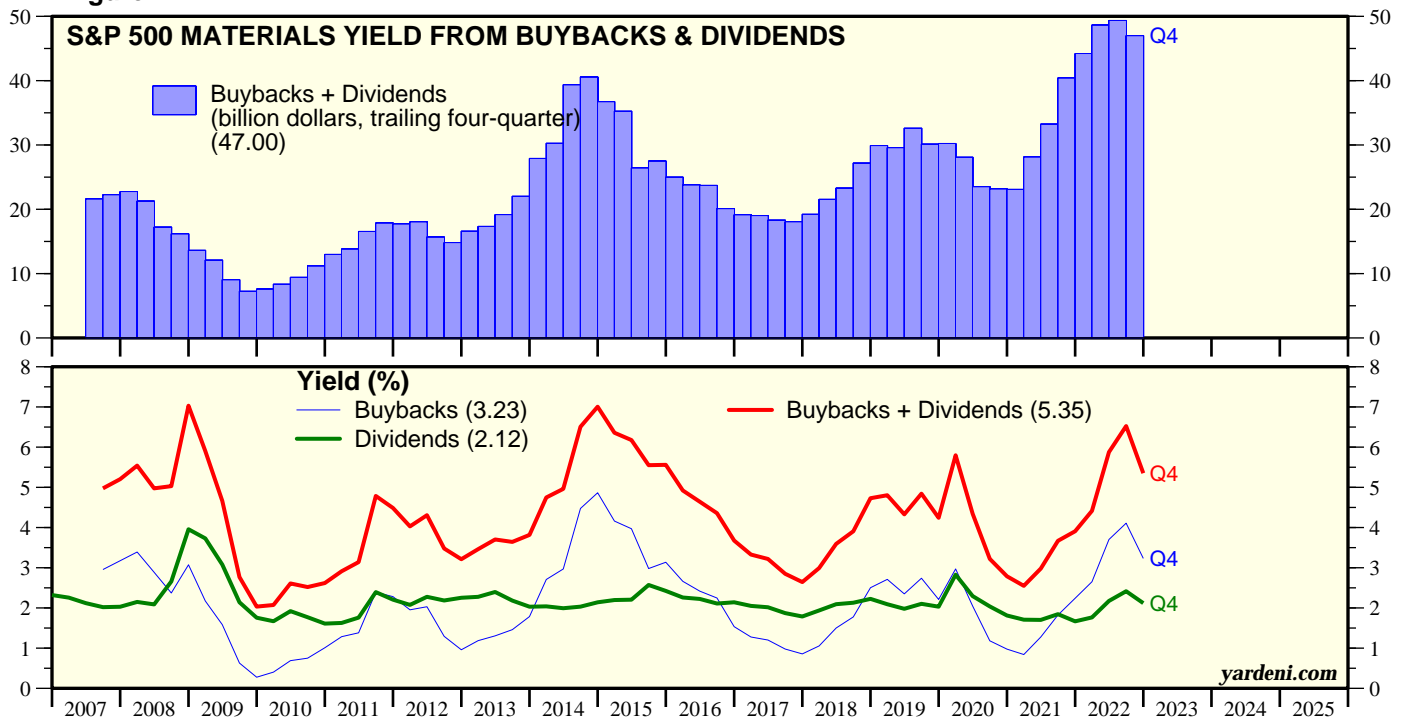

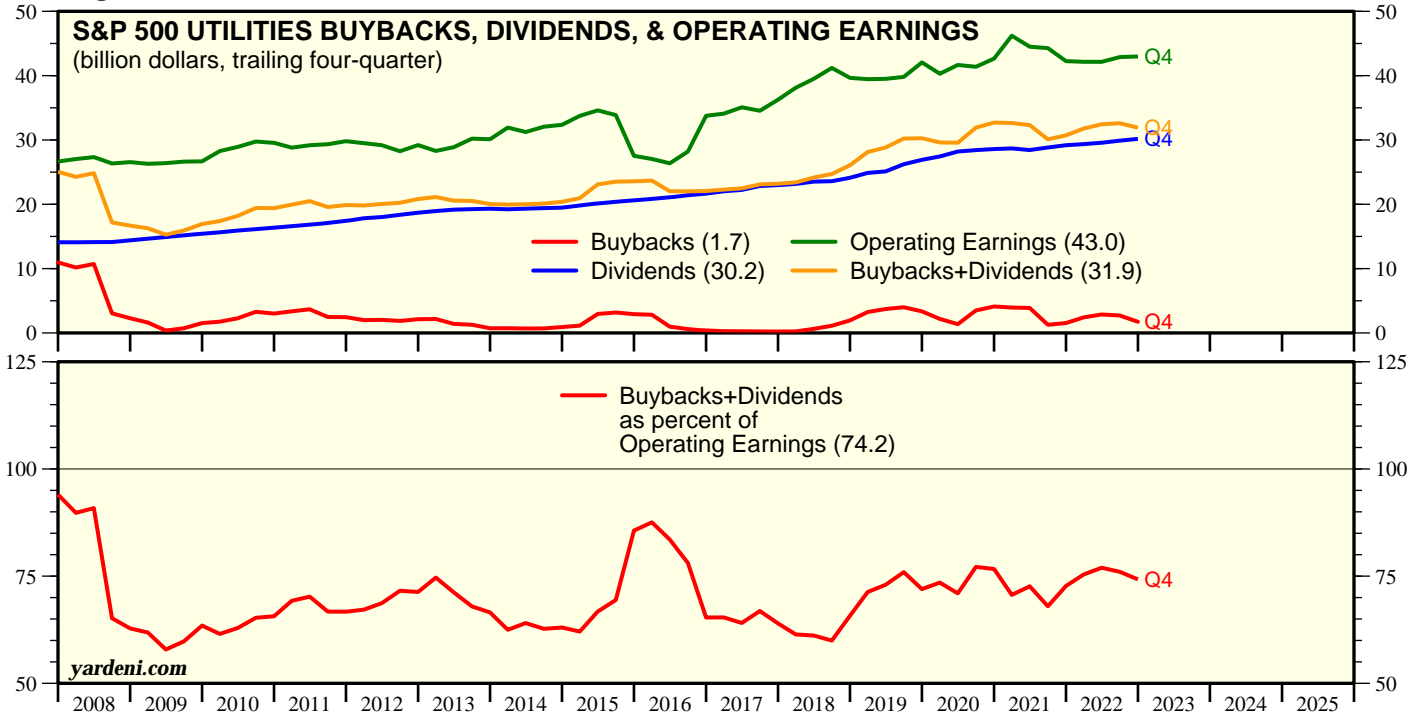

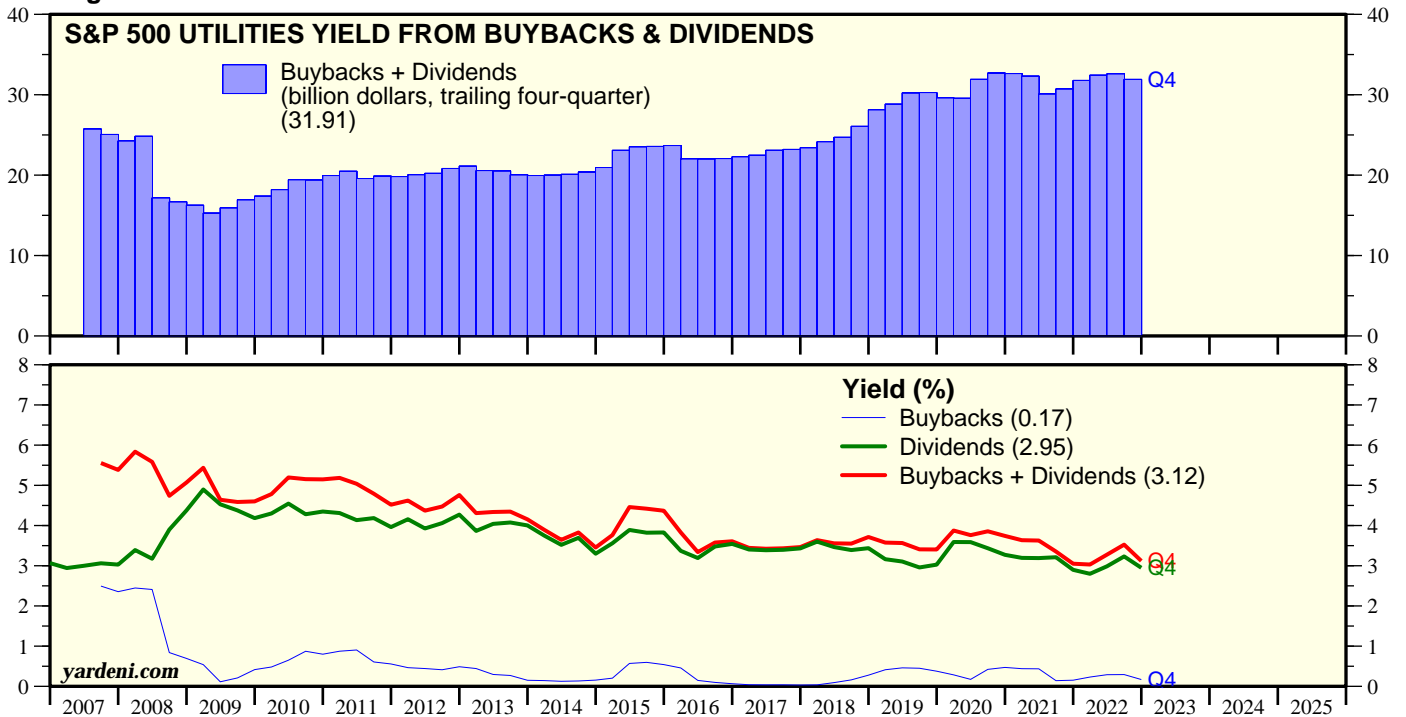
S&P 500 Utilities

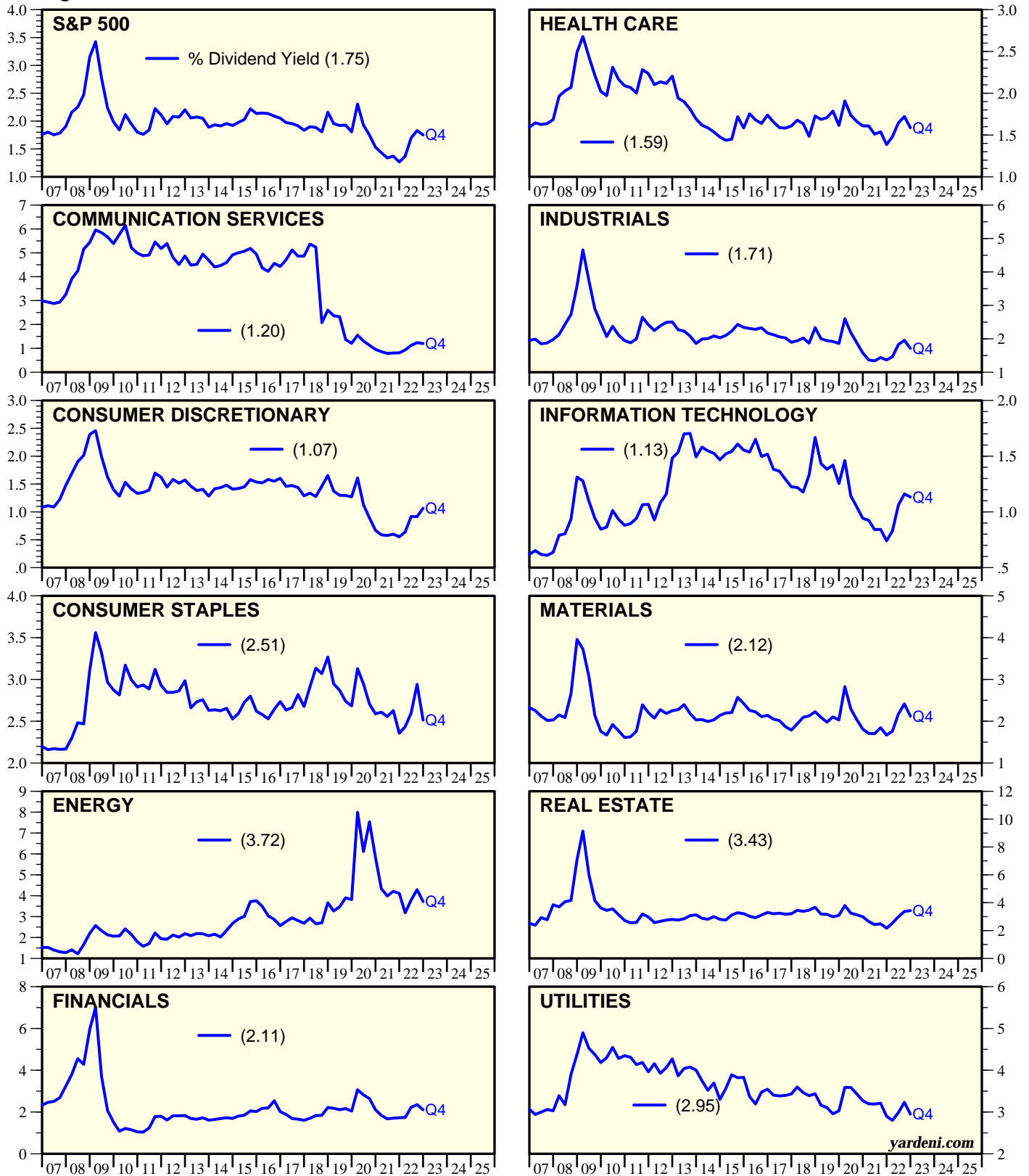

S&P 500 Sectors Dividend Yield

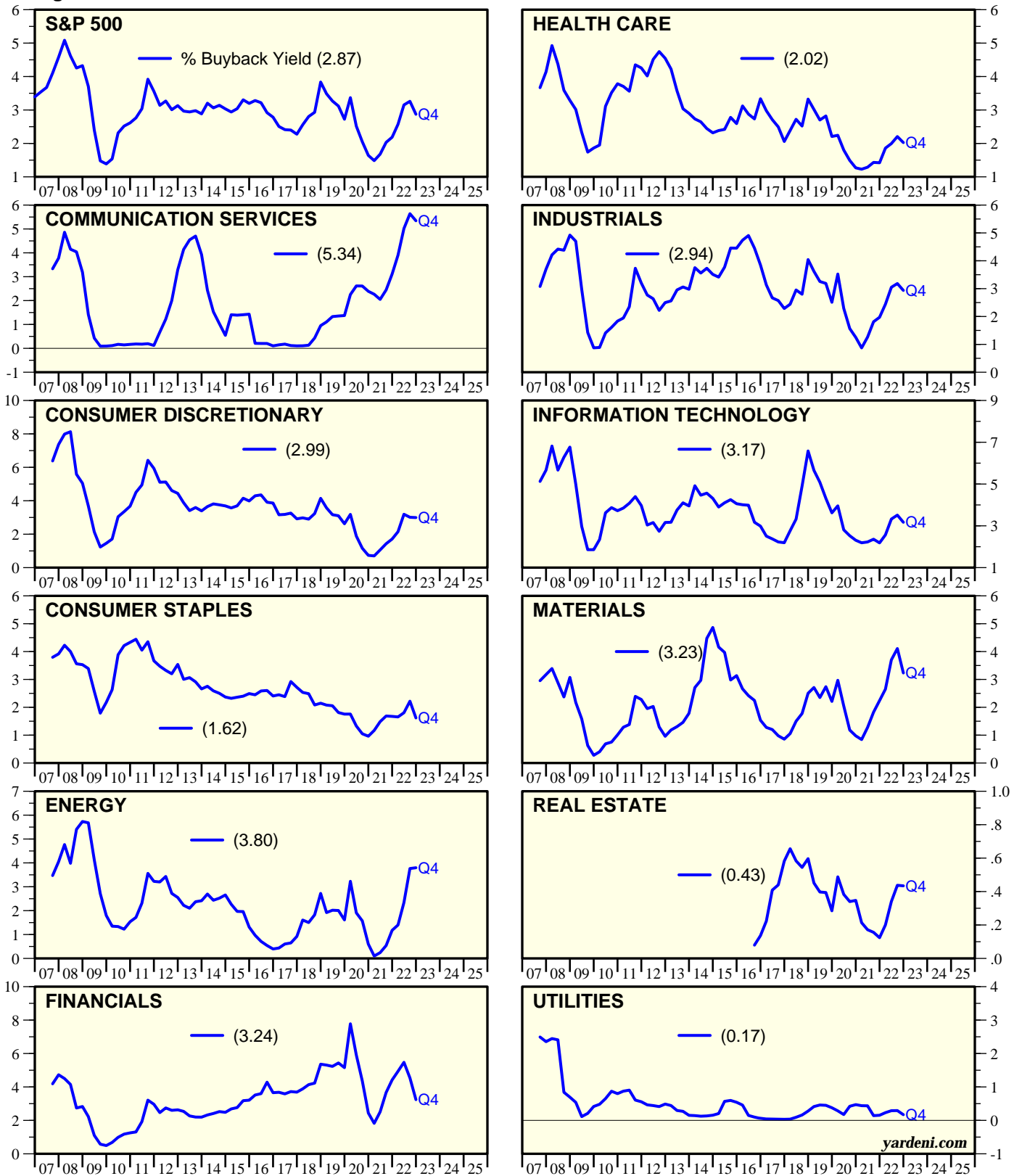

S&P 500 Sectors Buyback Yield

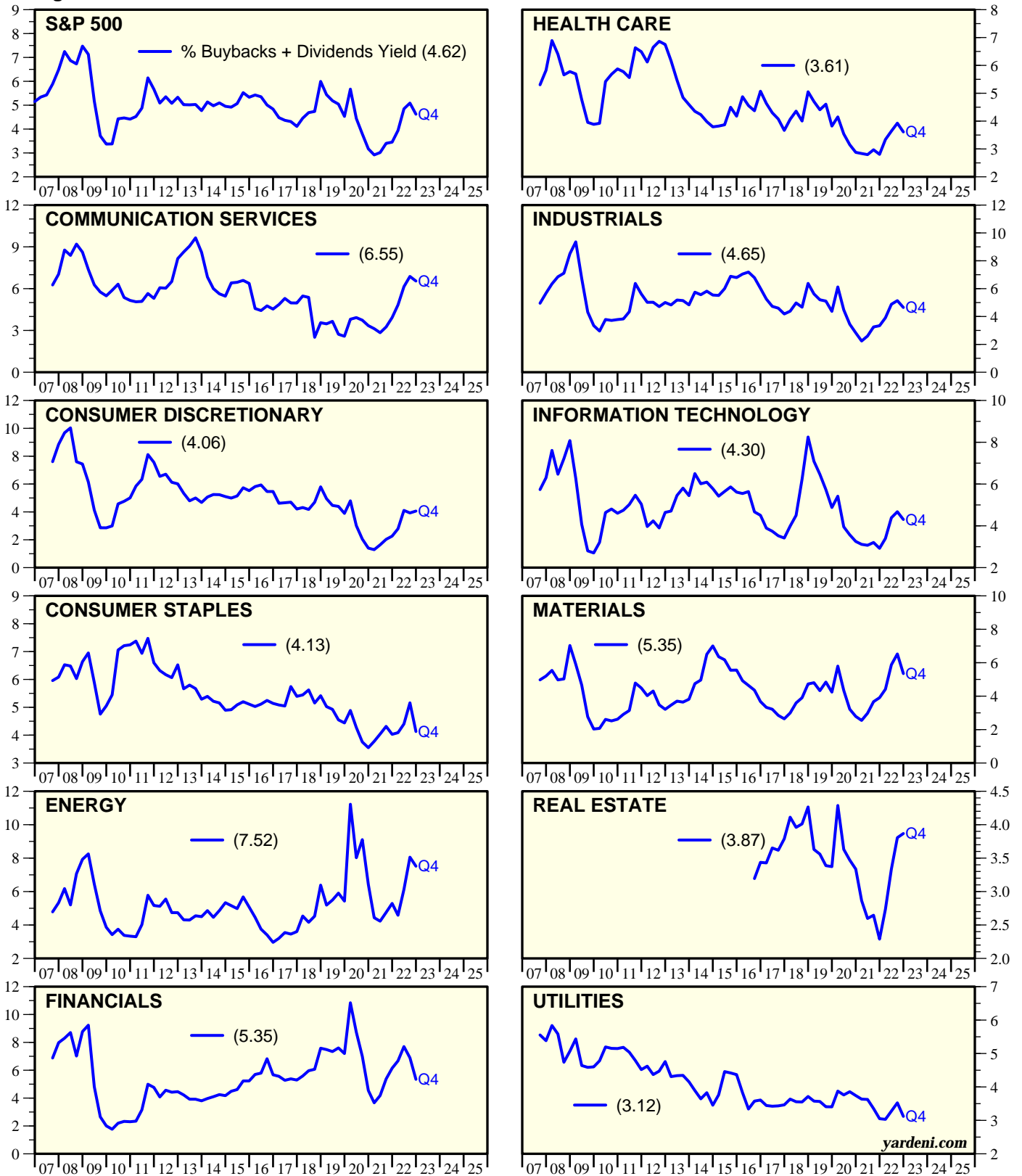

S&P 500 Sectors Dividends + Buybacks Yield

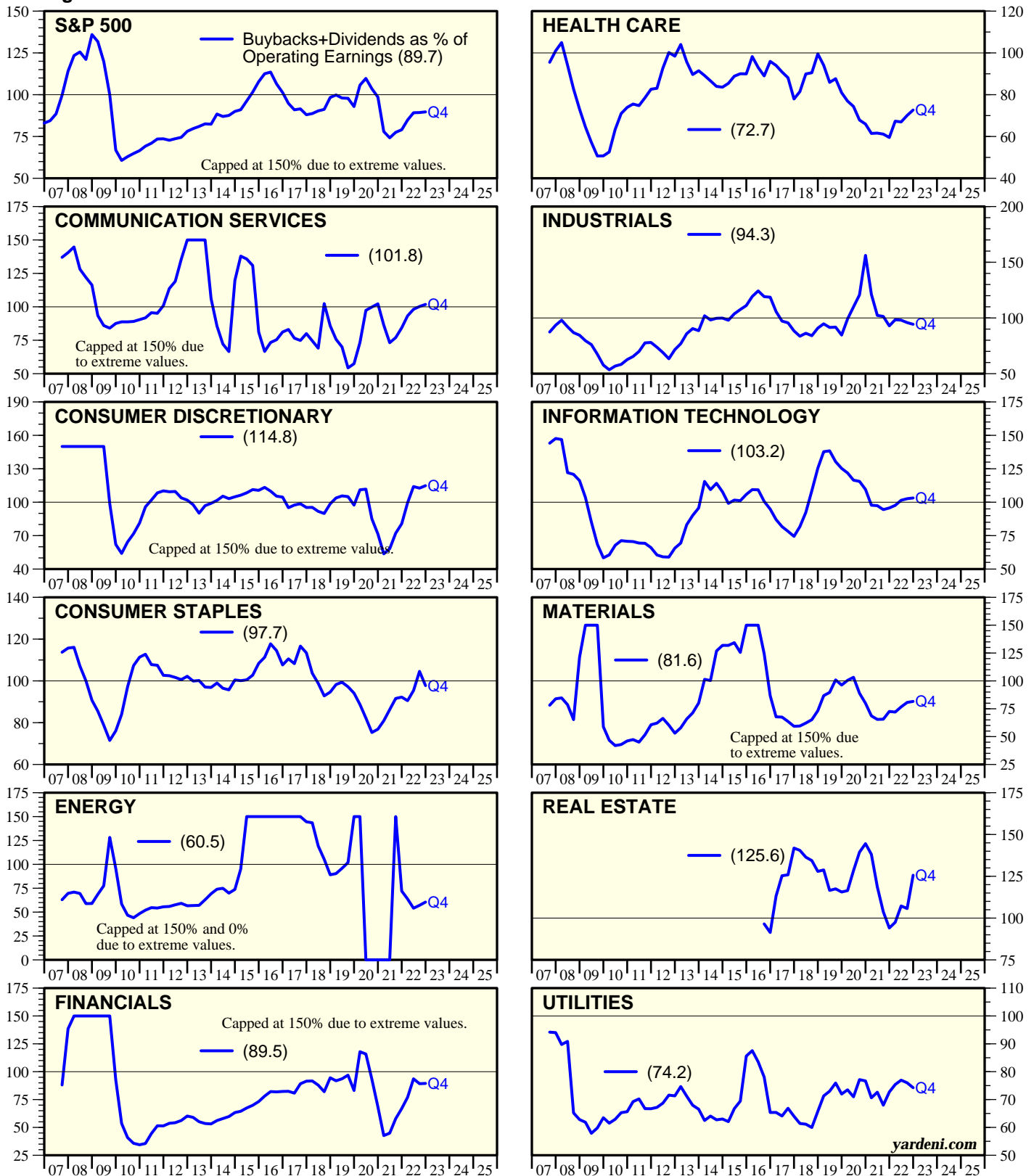

Dividends + Buybacks as % of Operating Earnings

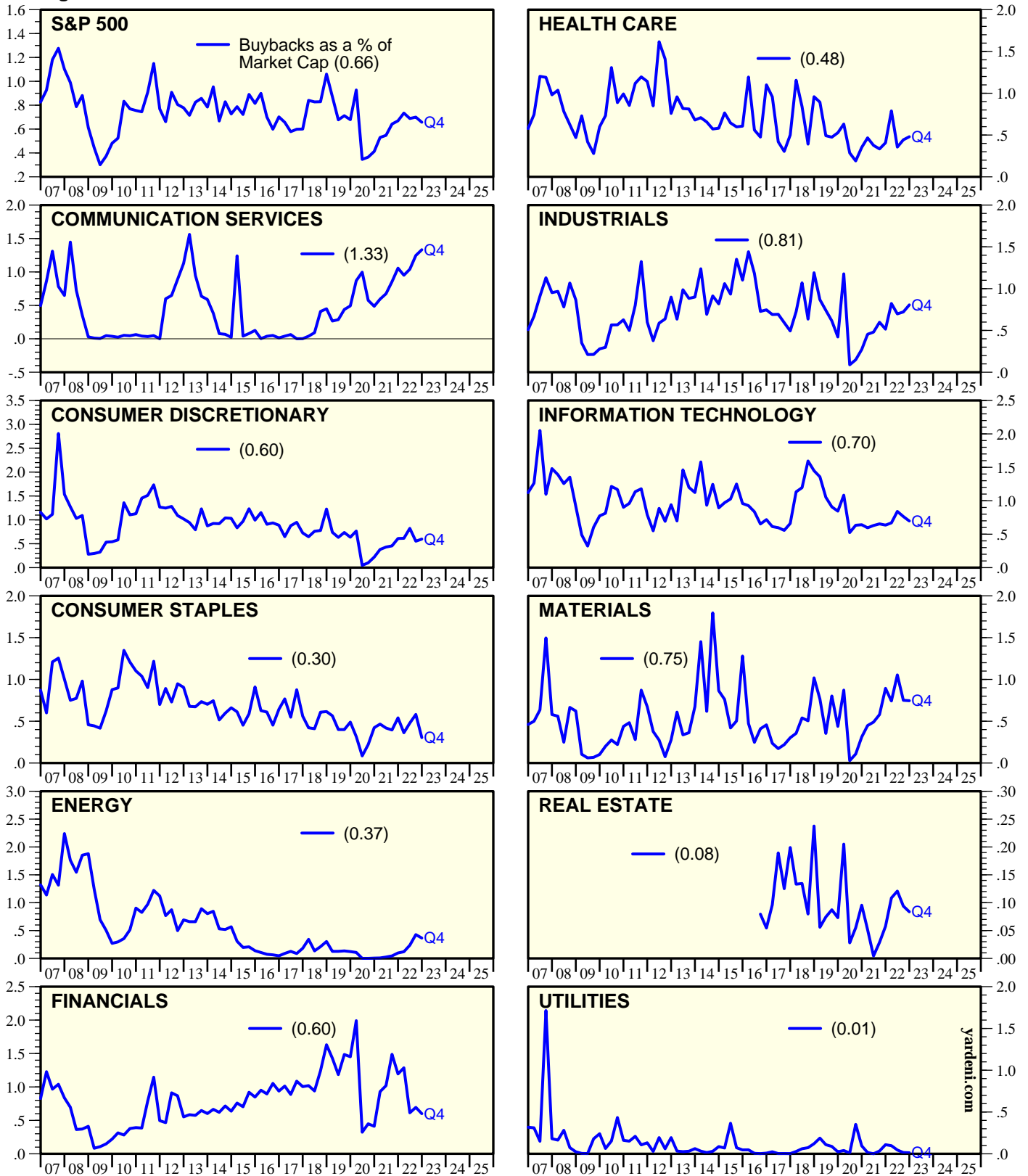

Buybacks as % of Market Cap

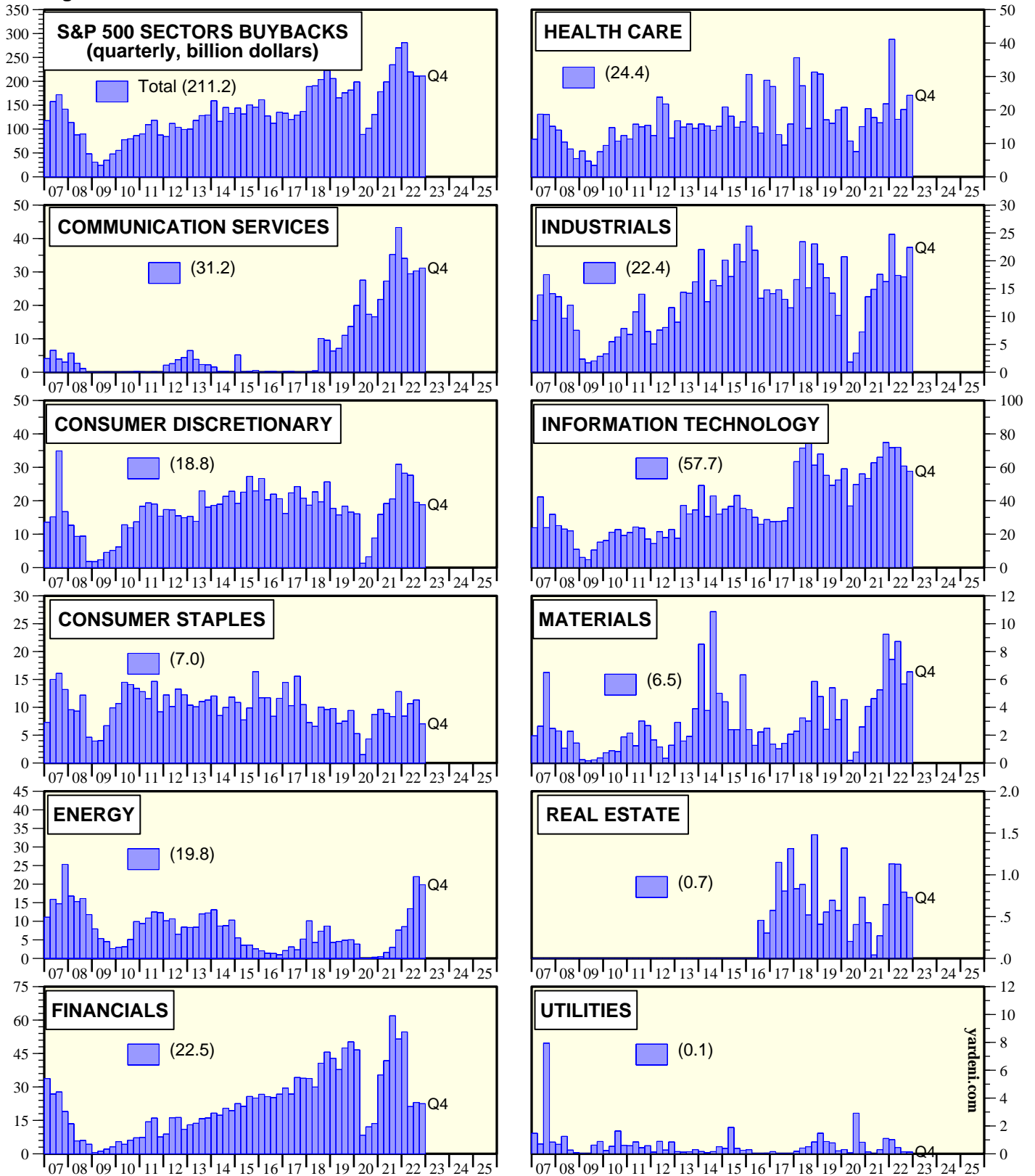

S&P 500 Sectors Buybacks

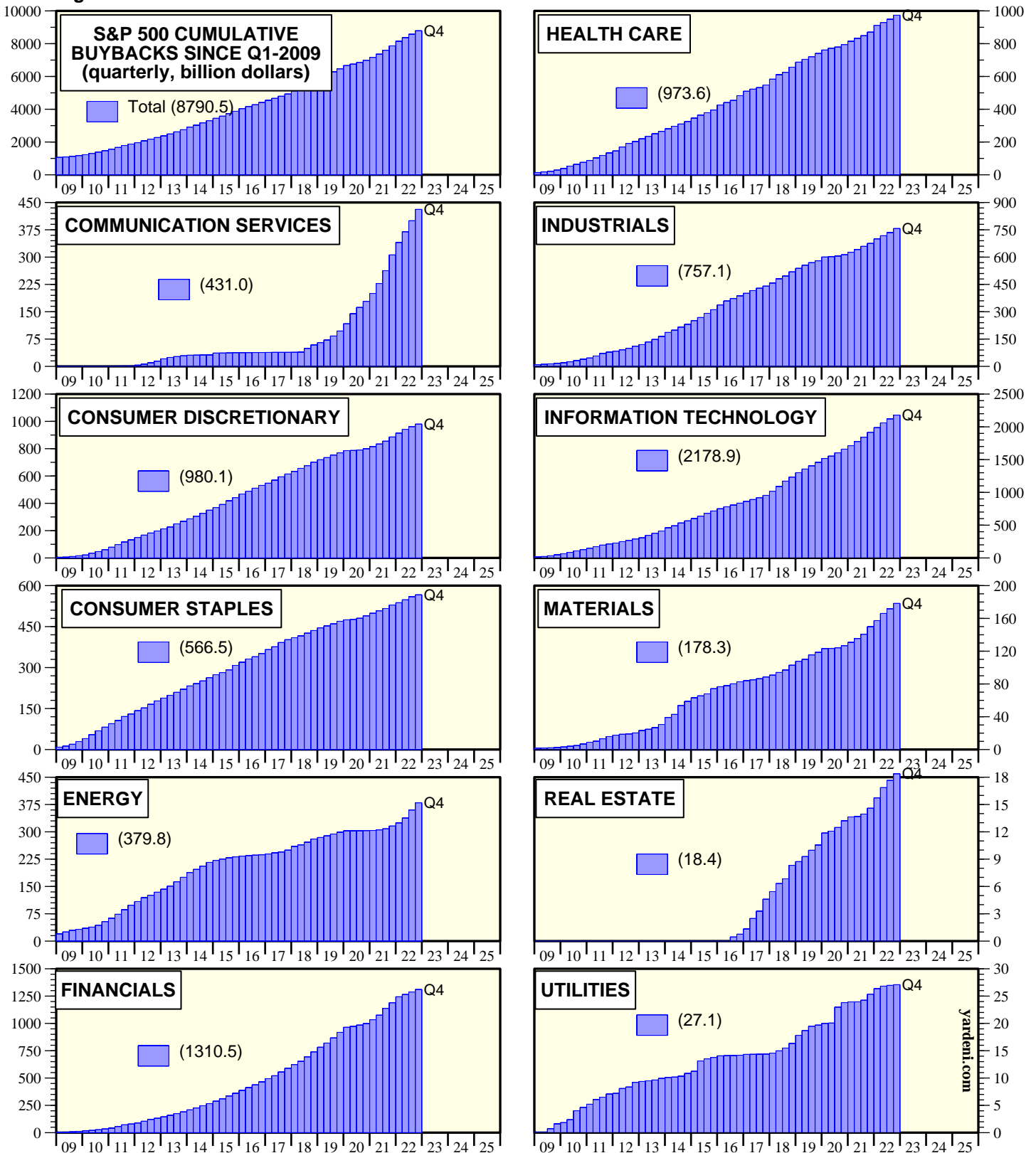
