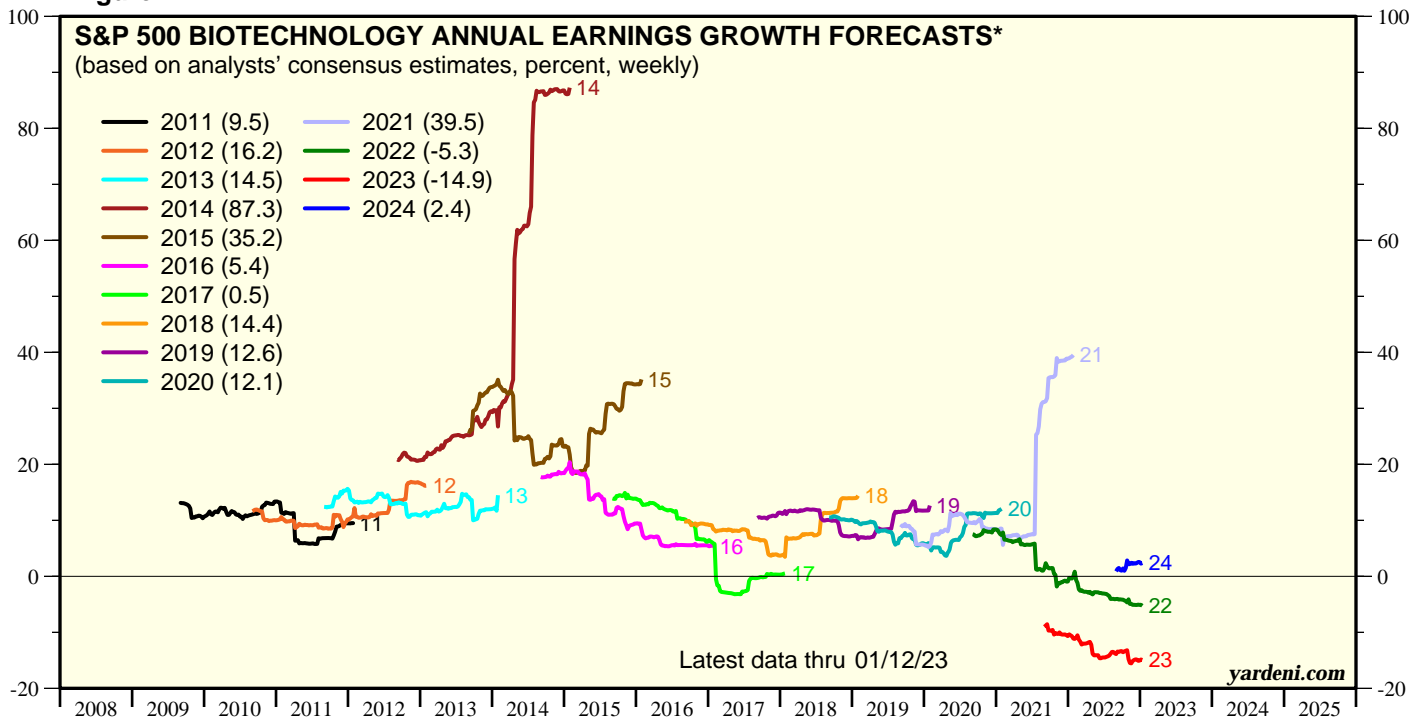

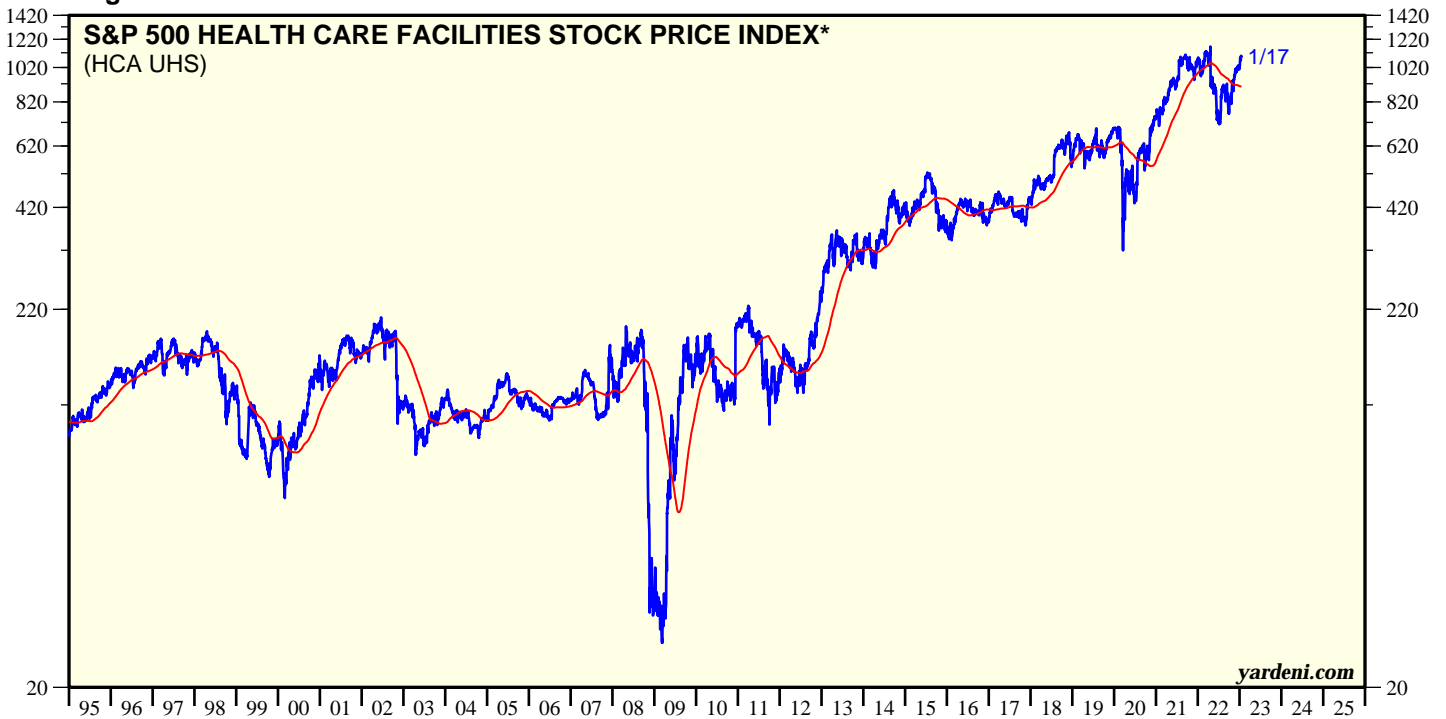

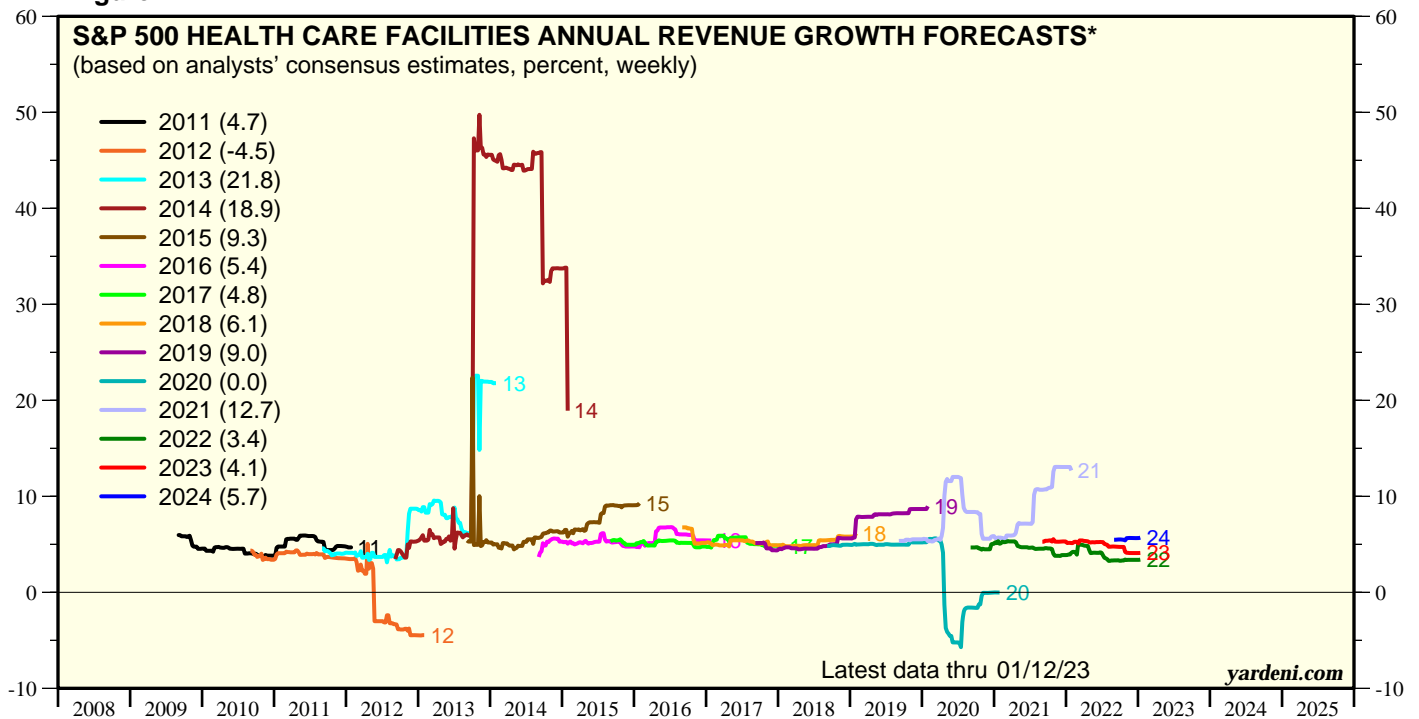

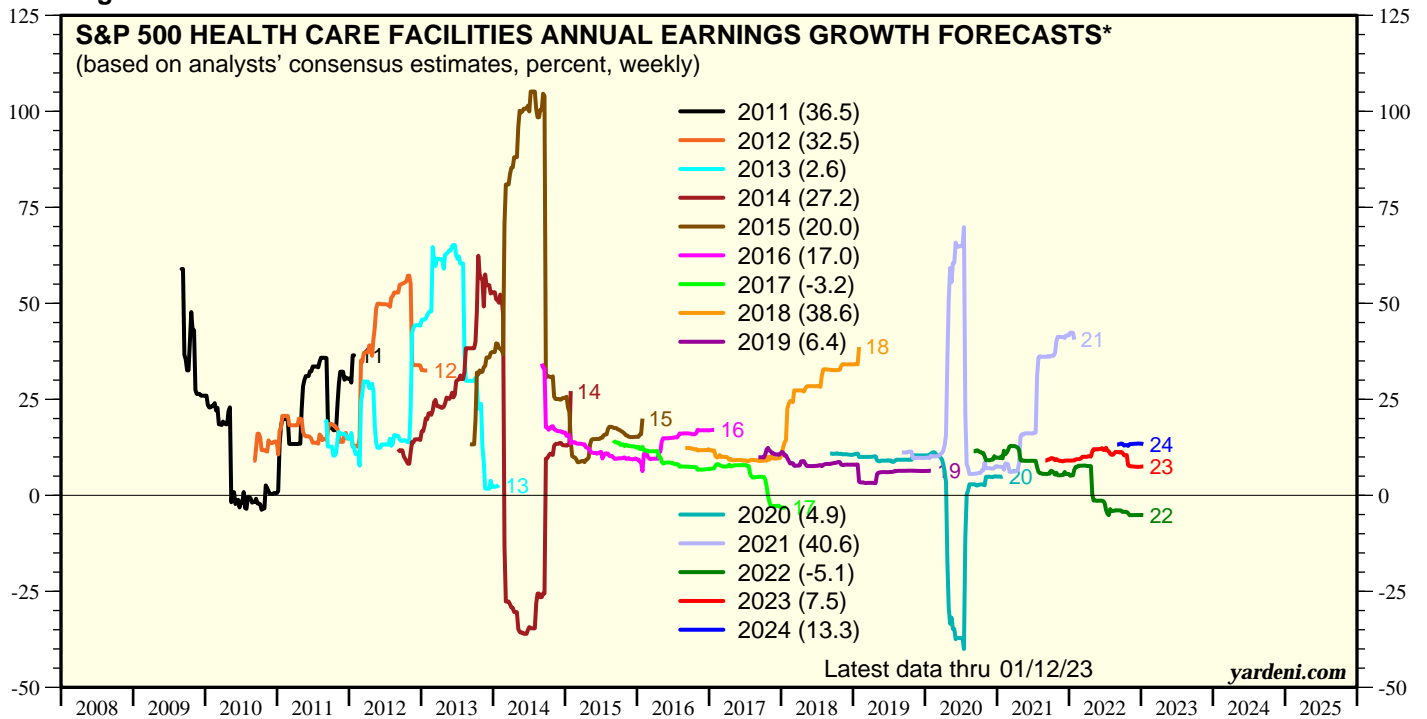

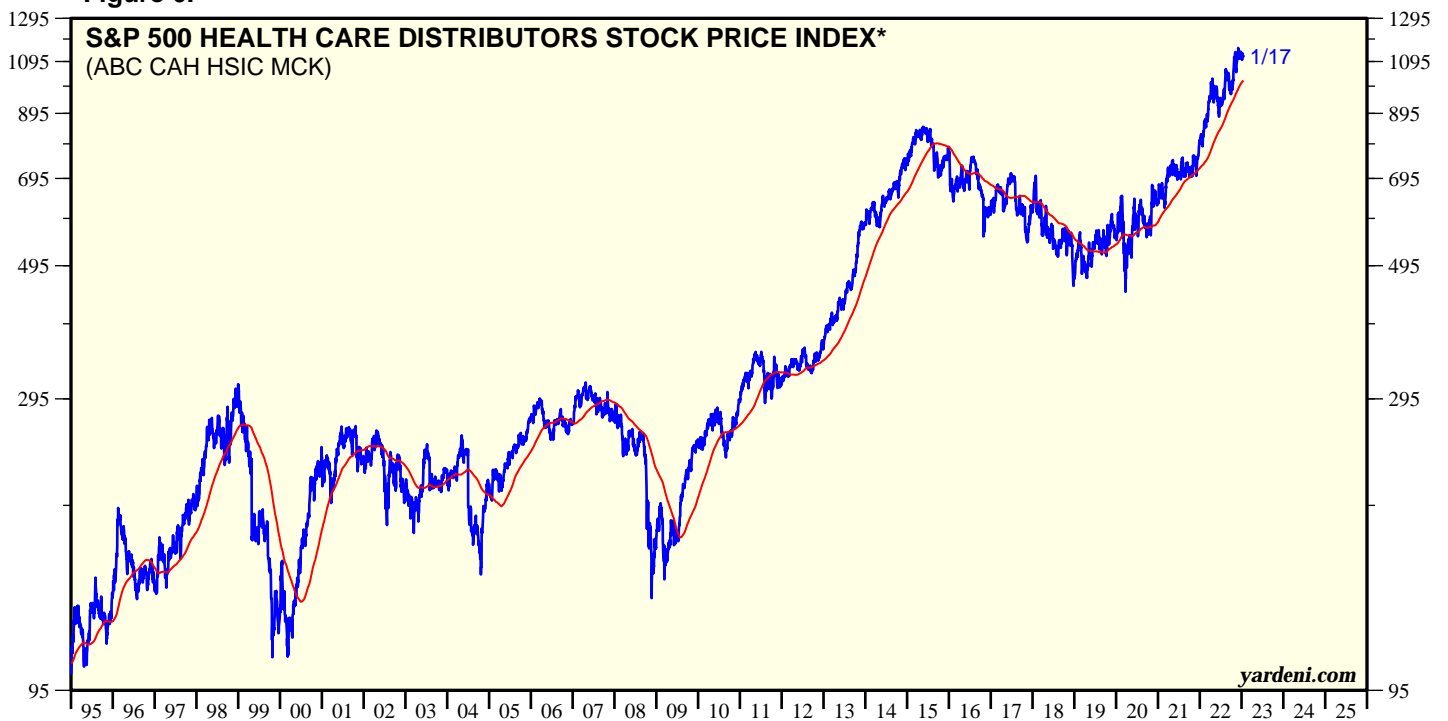

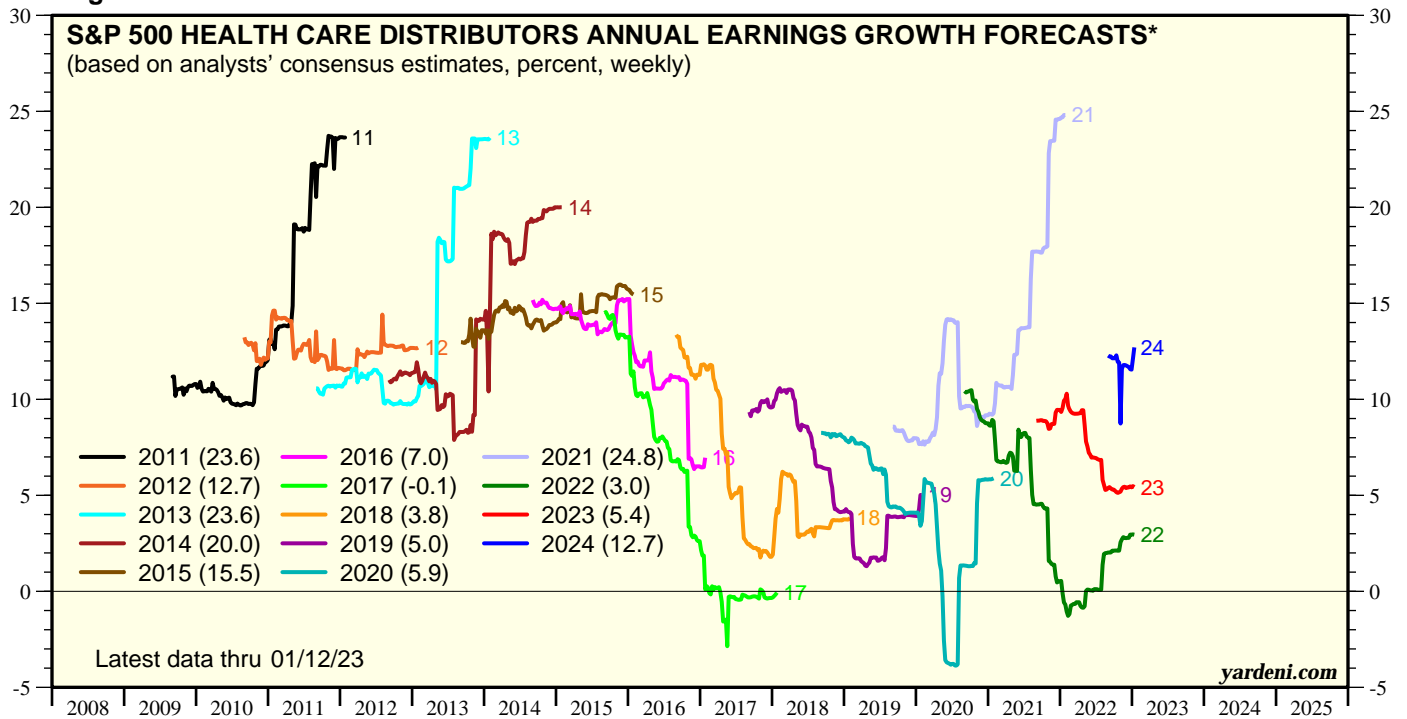

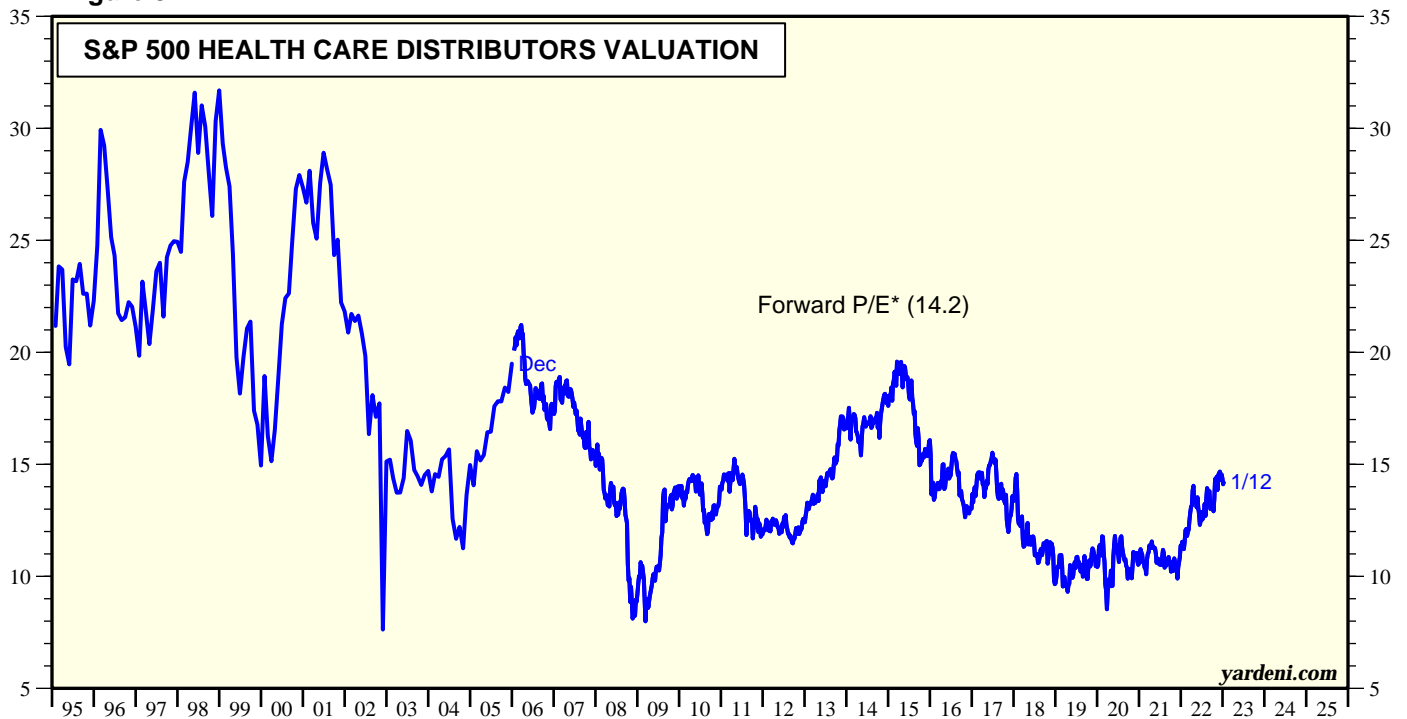

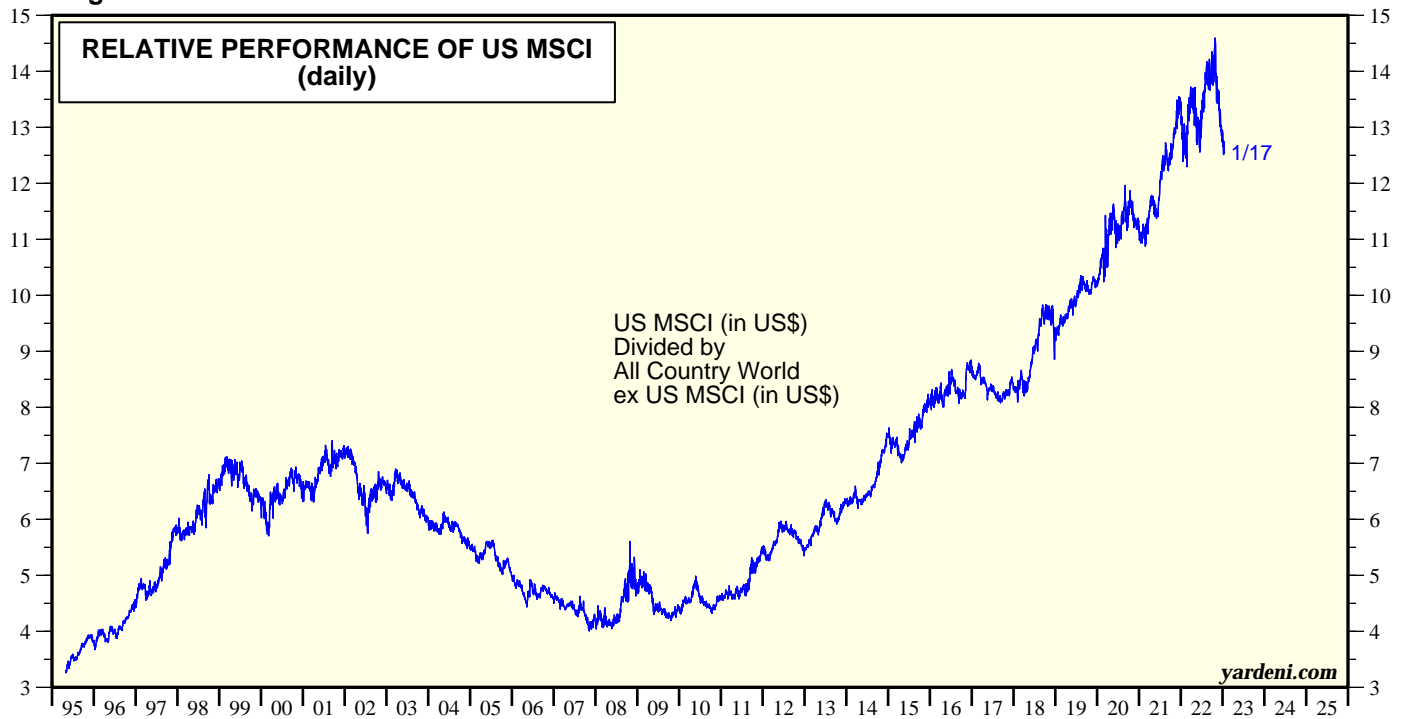

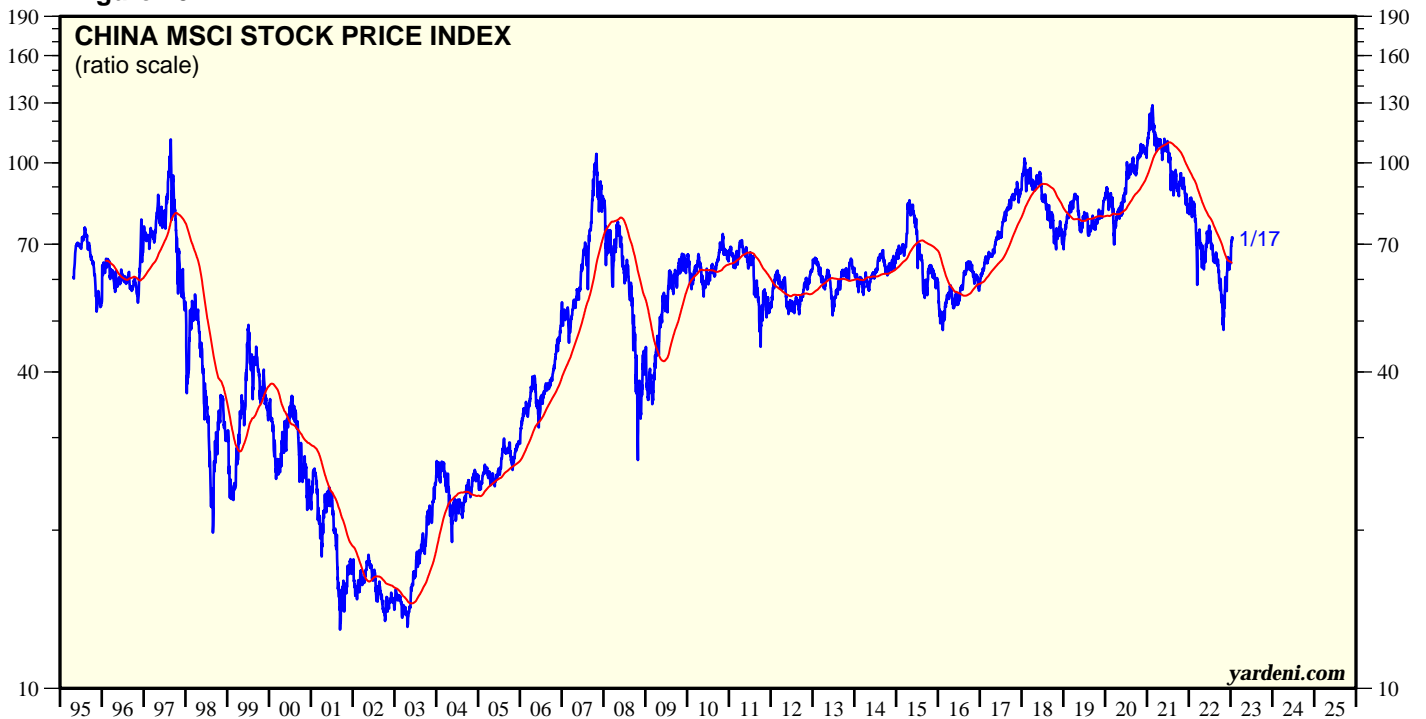

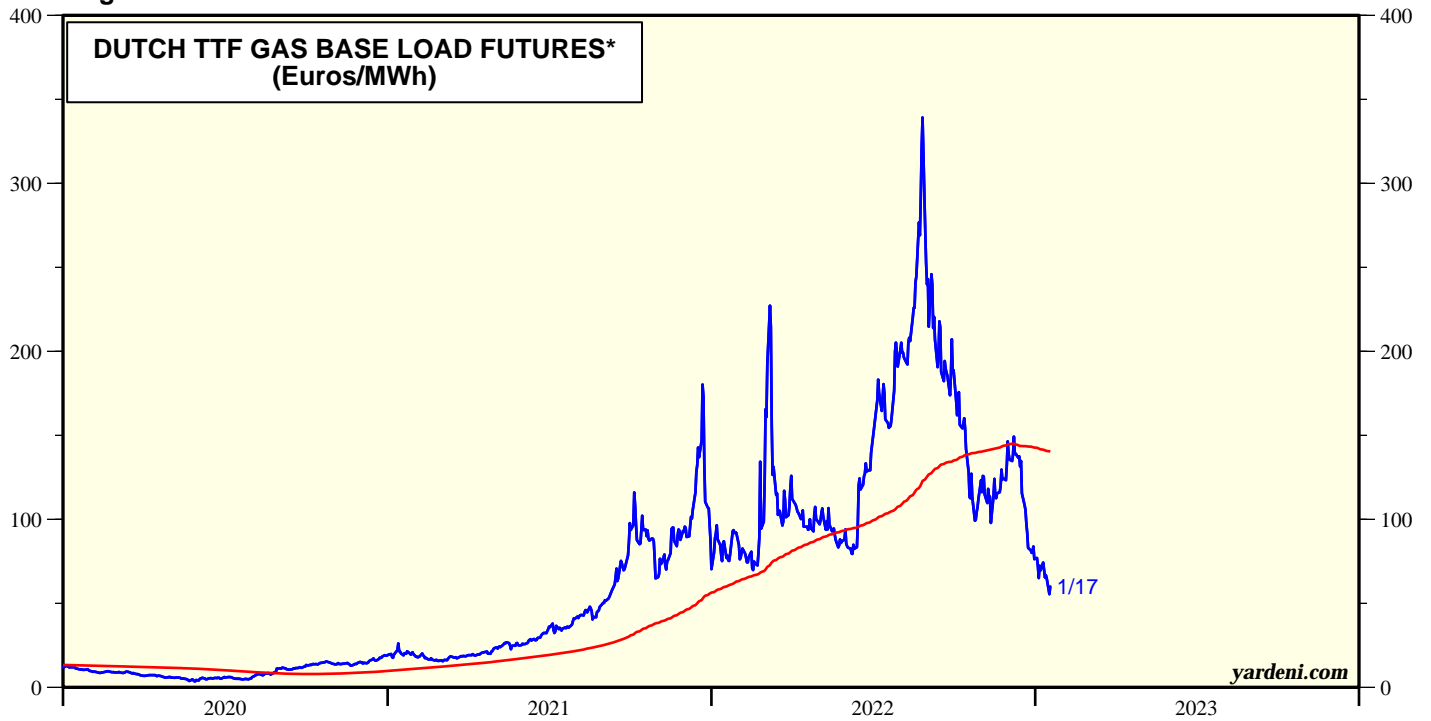

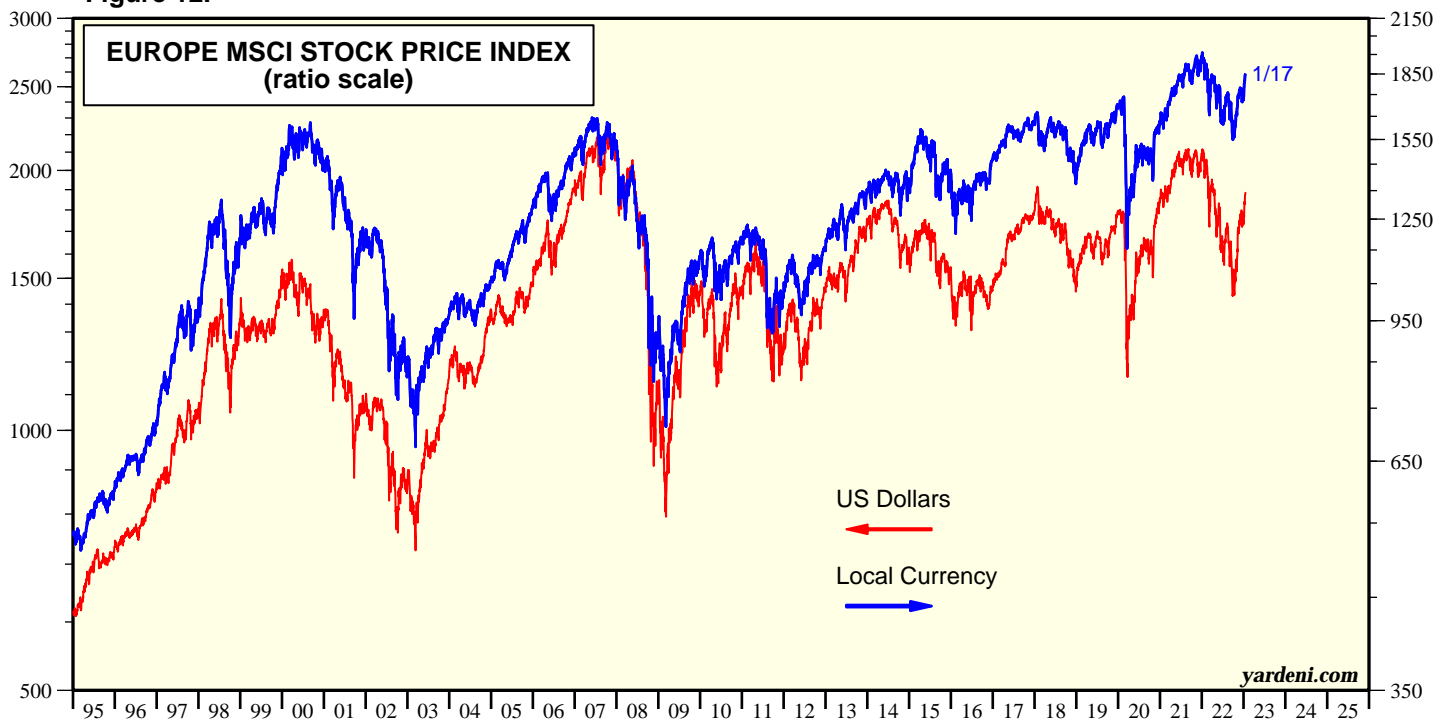

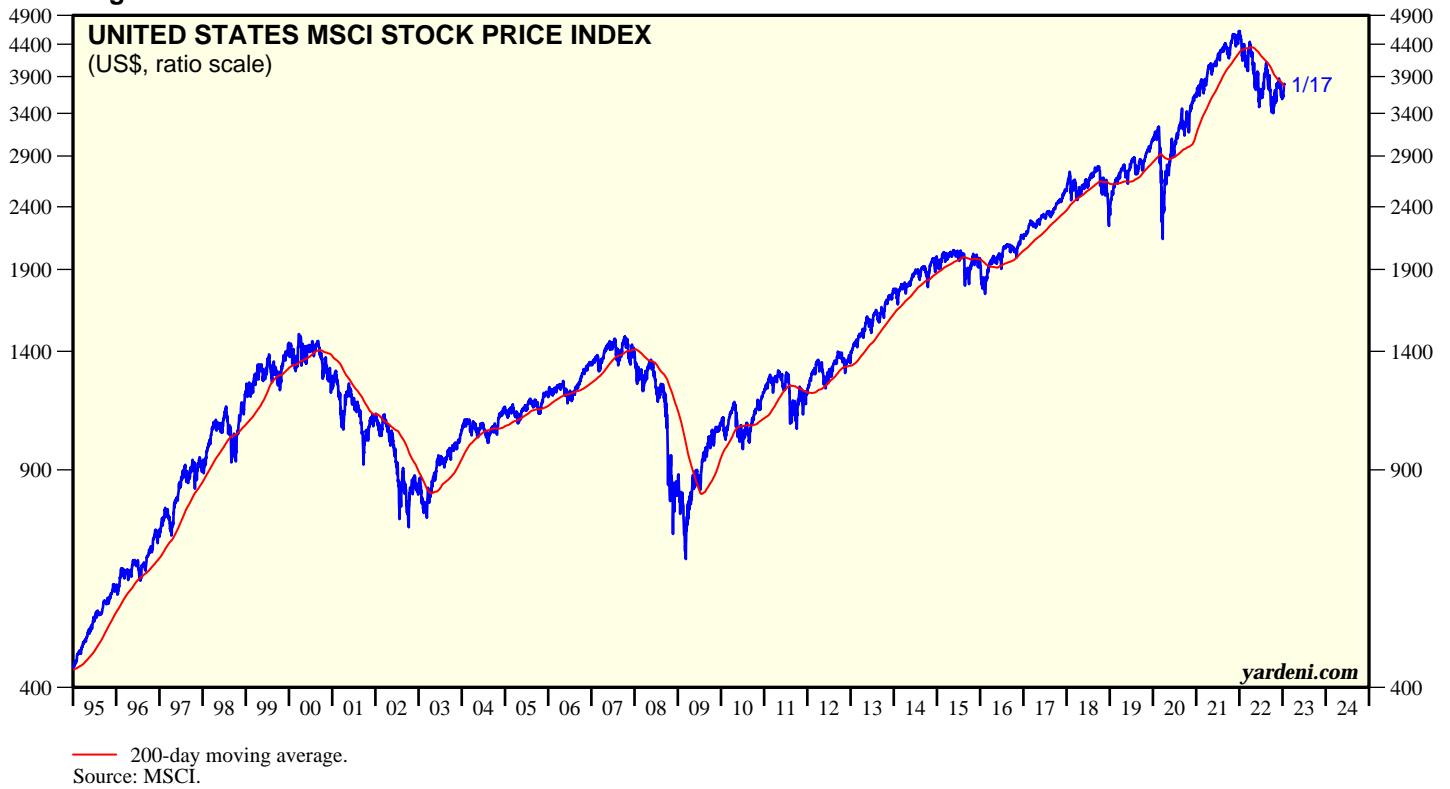
— 200-day moving average

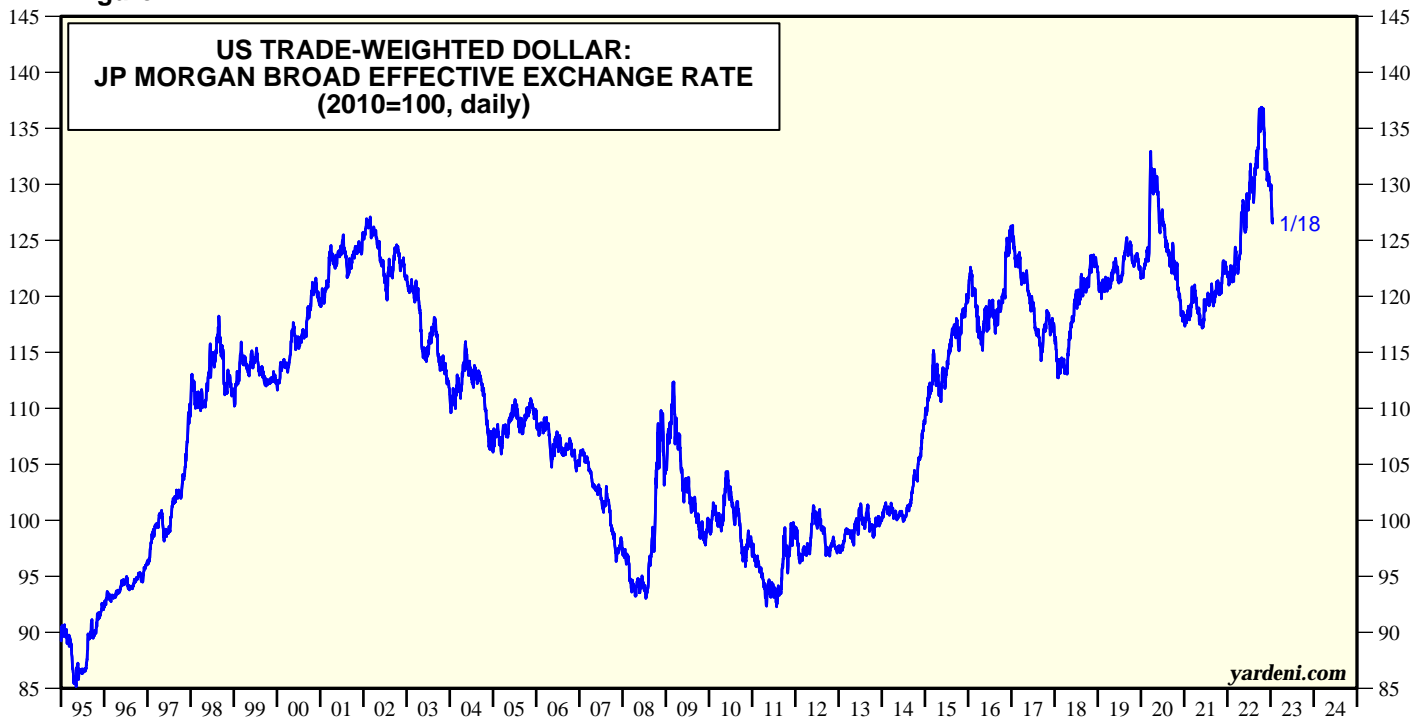

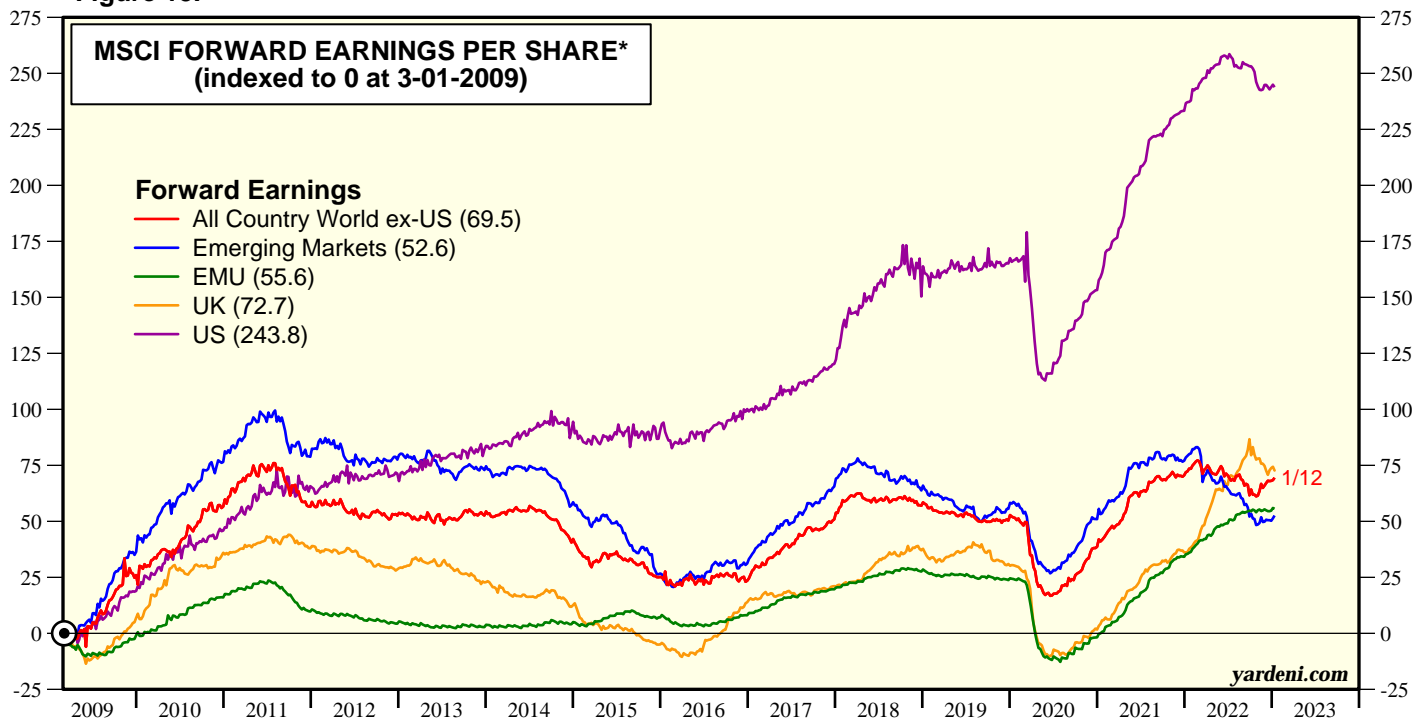
**Figure 14.**

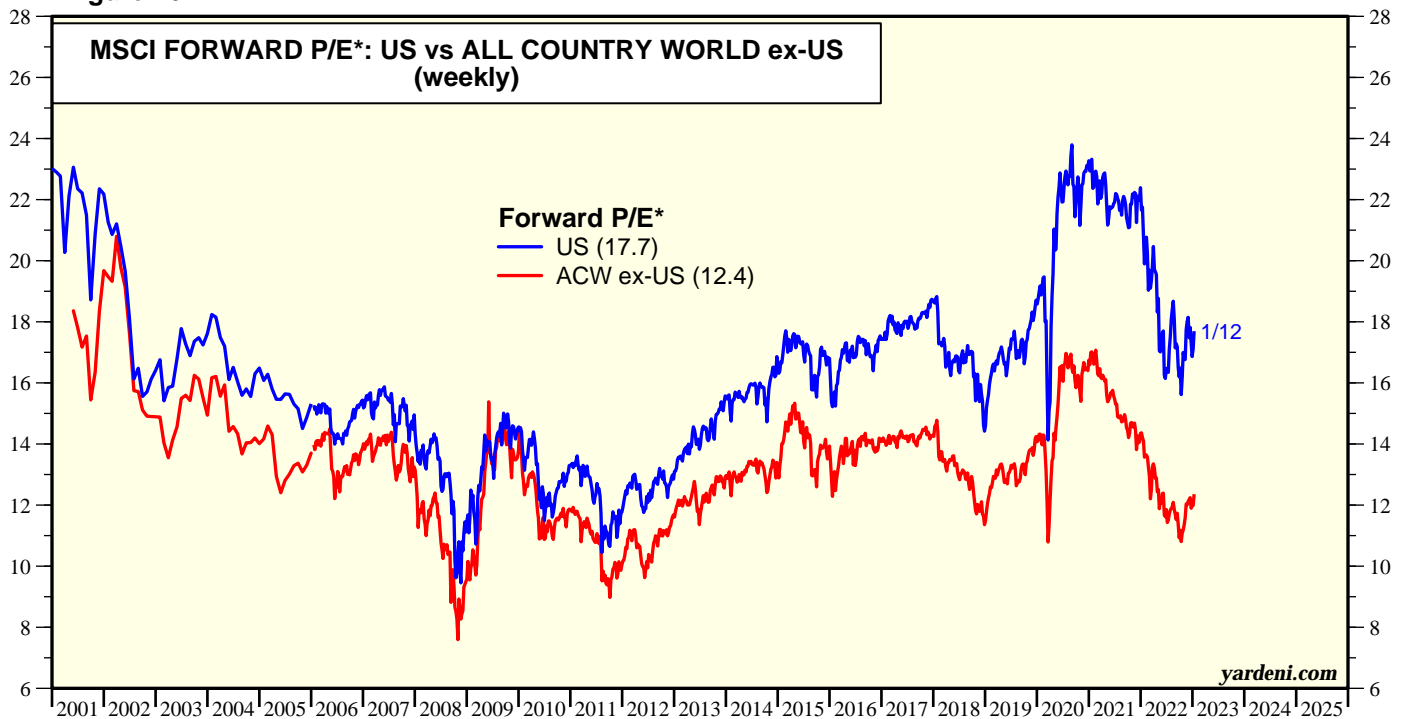
