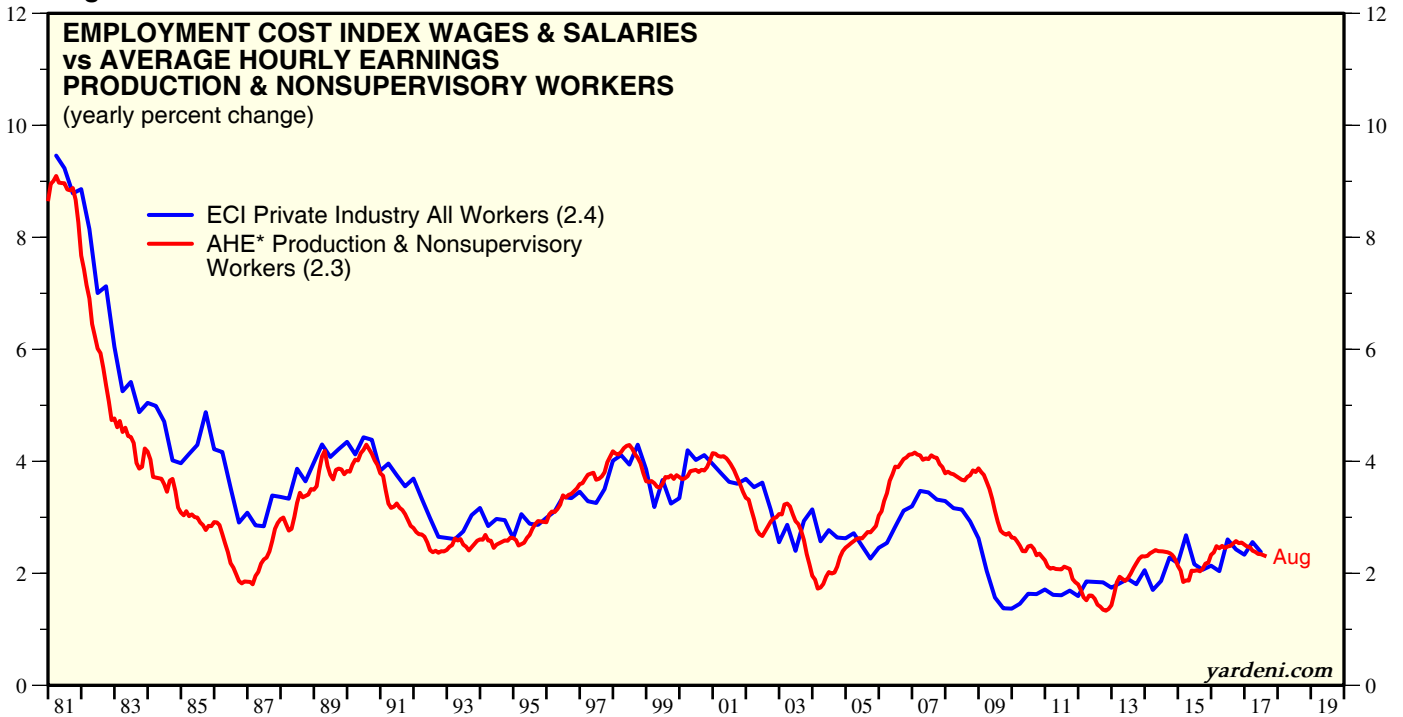

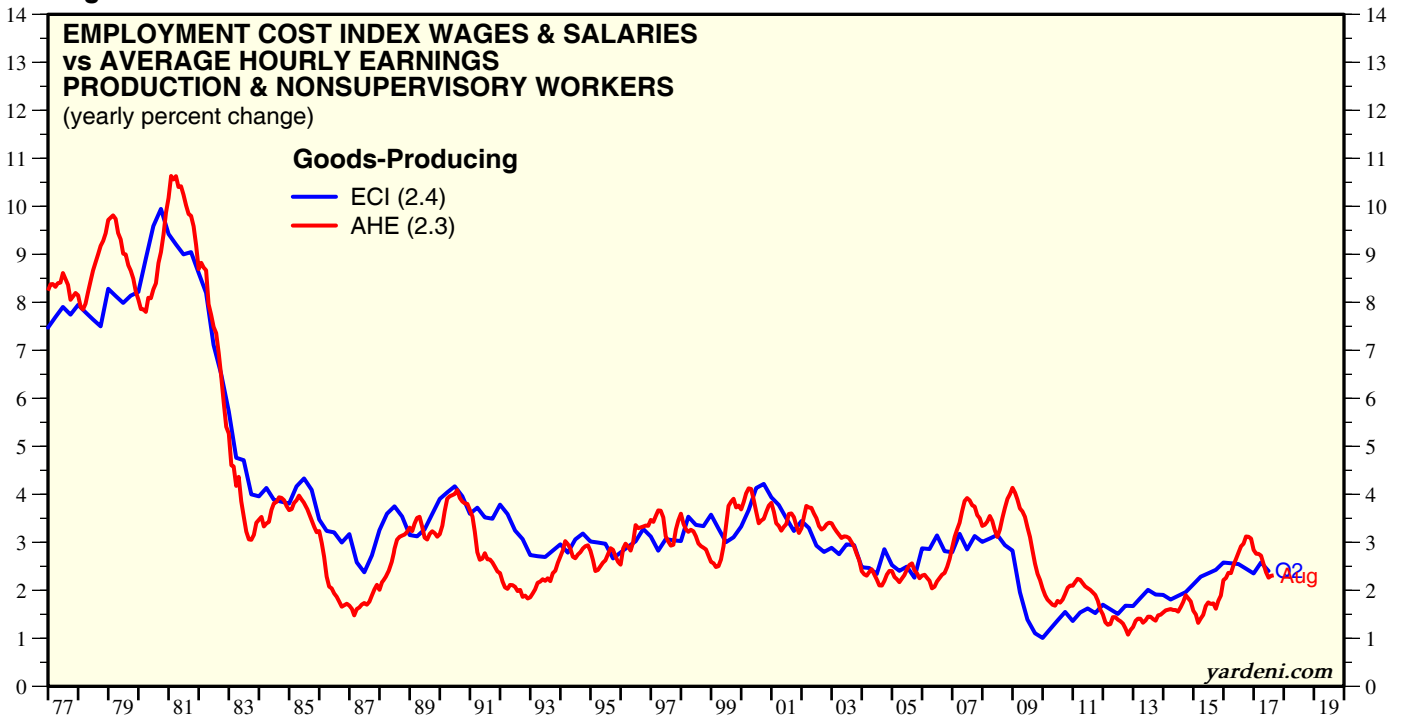

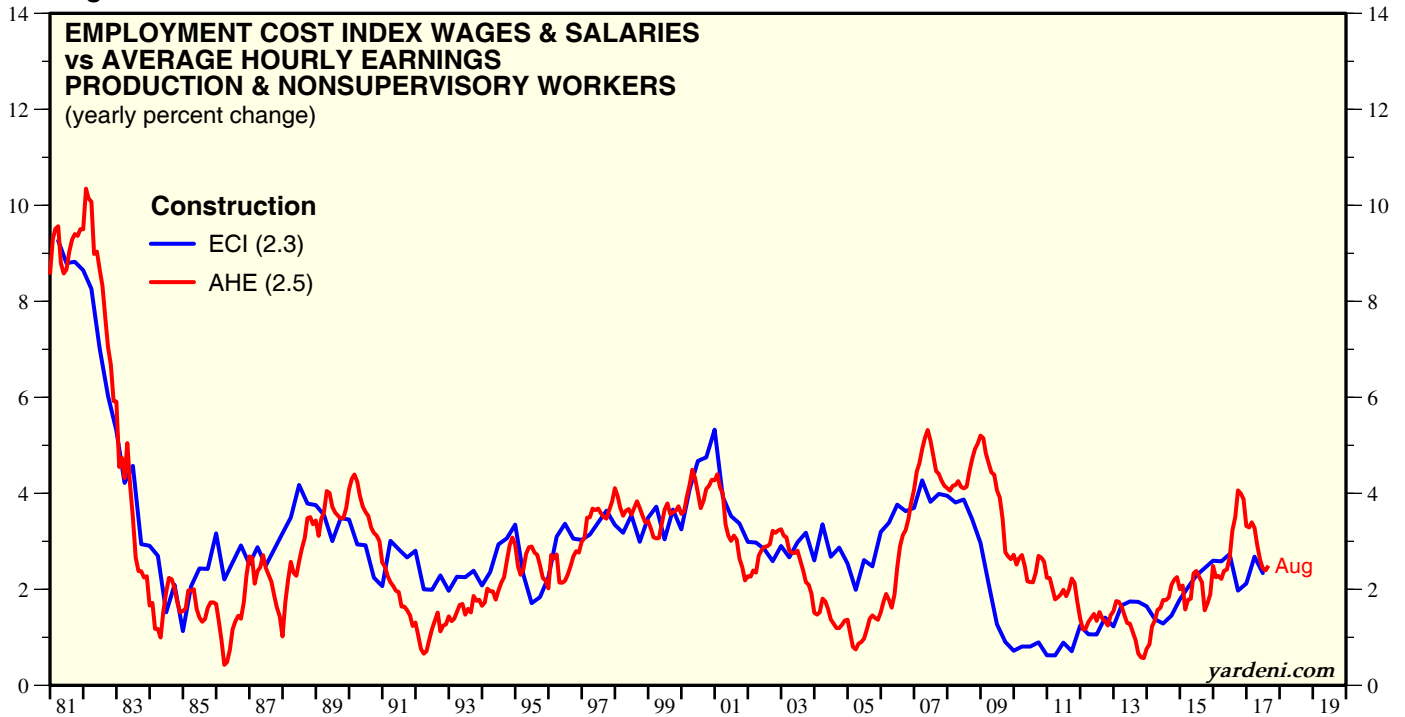

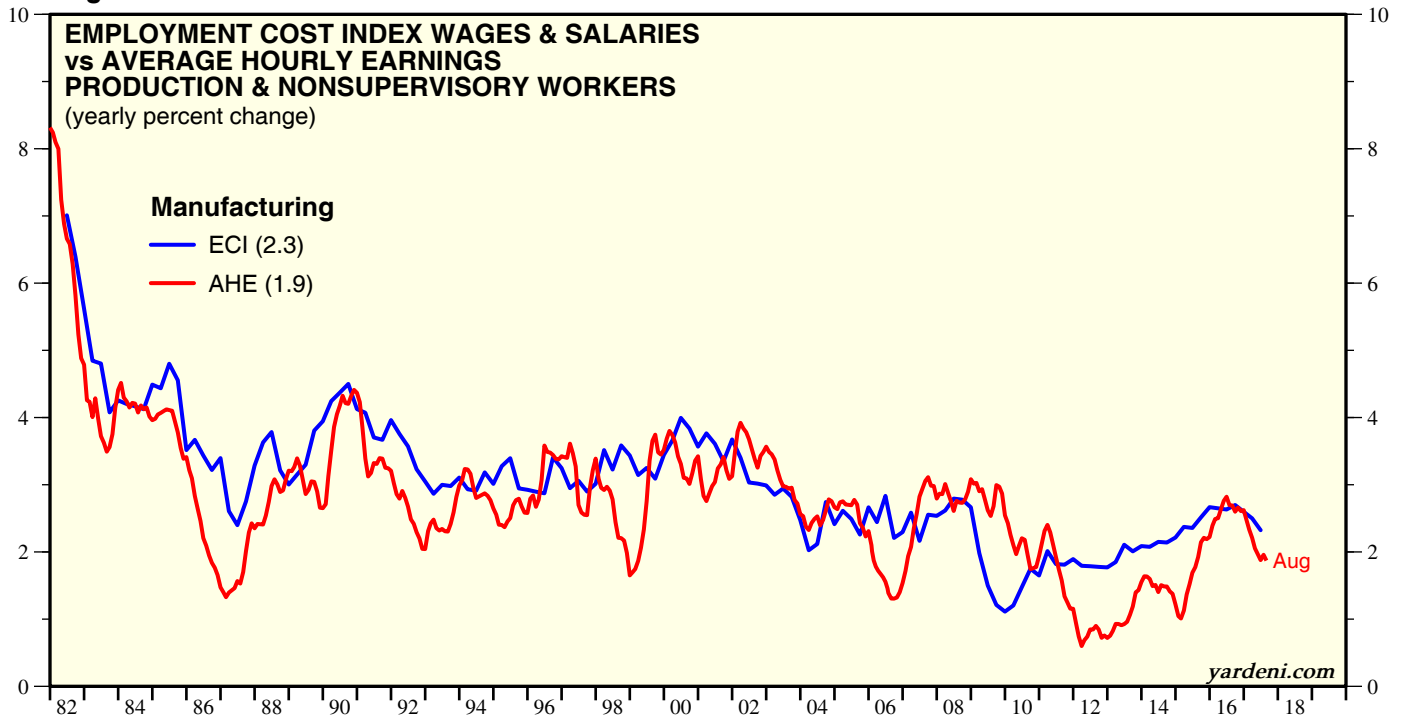

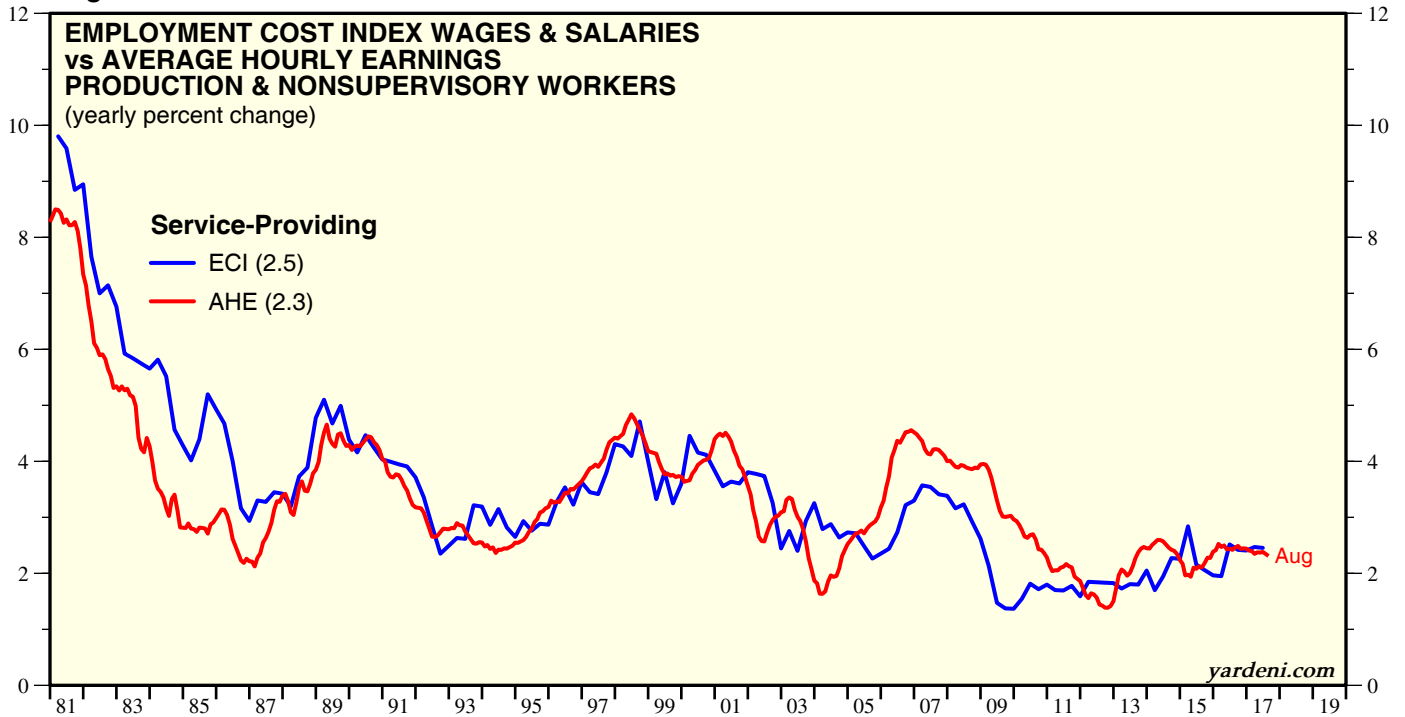

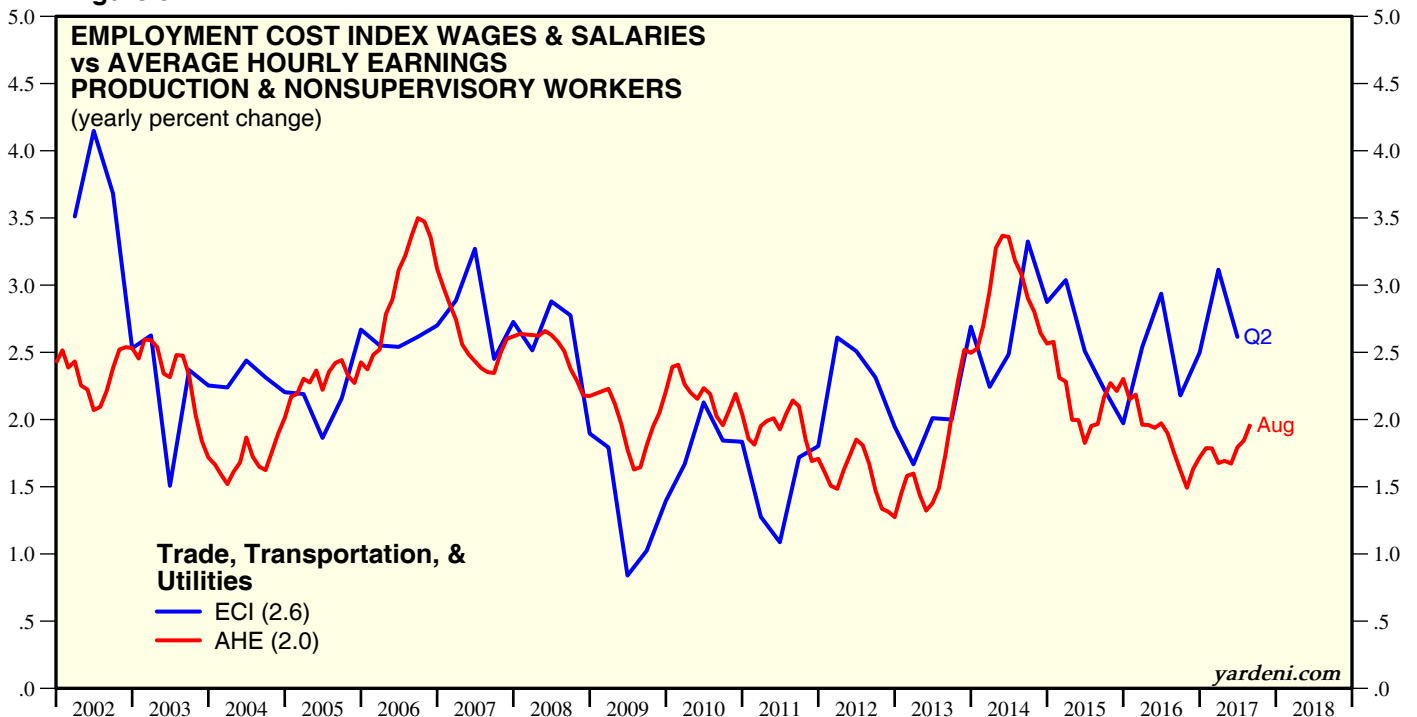

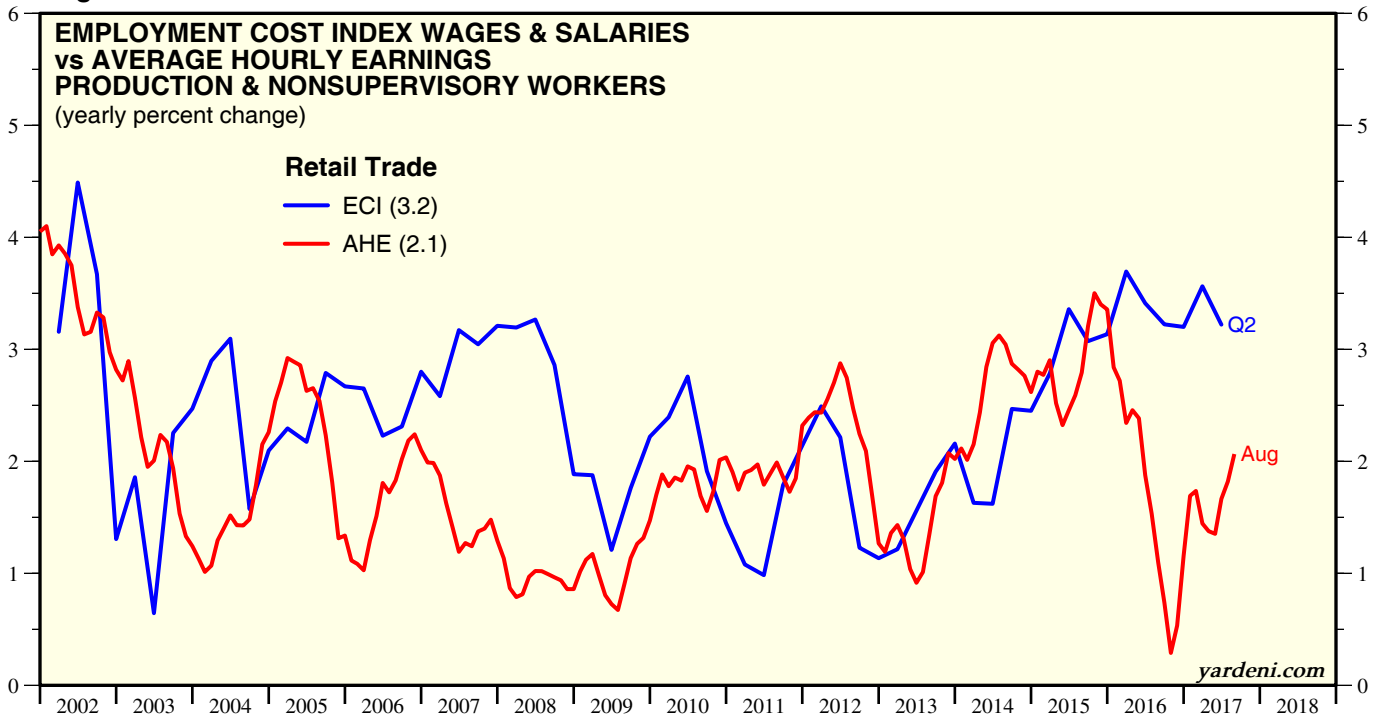

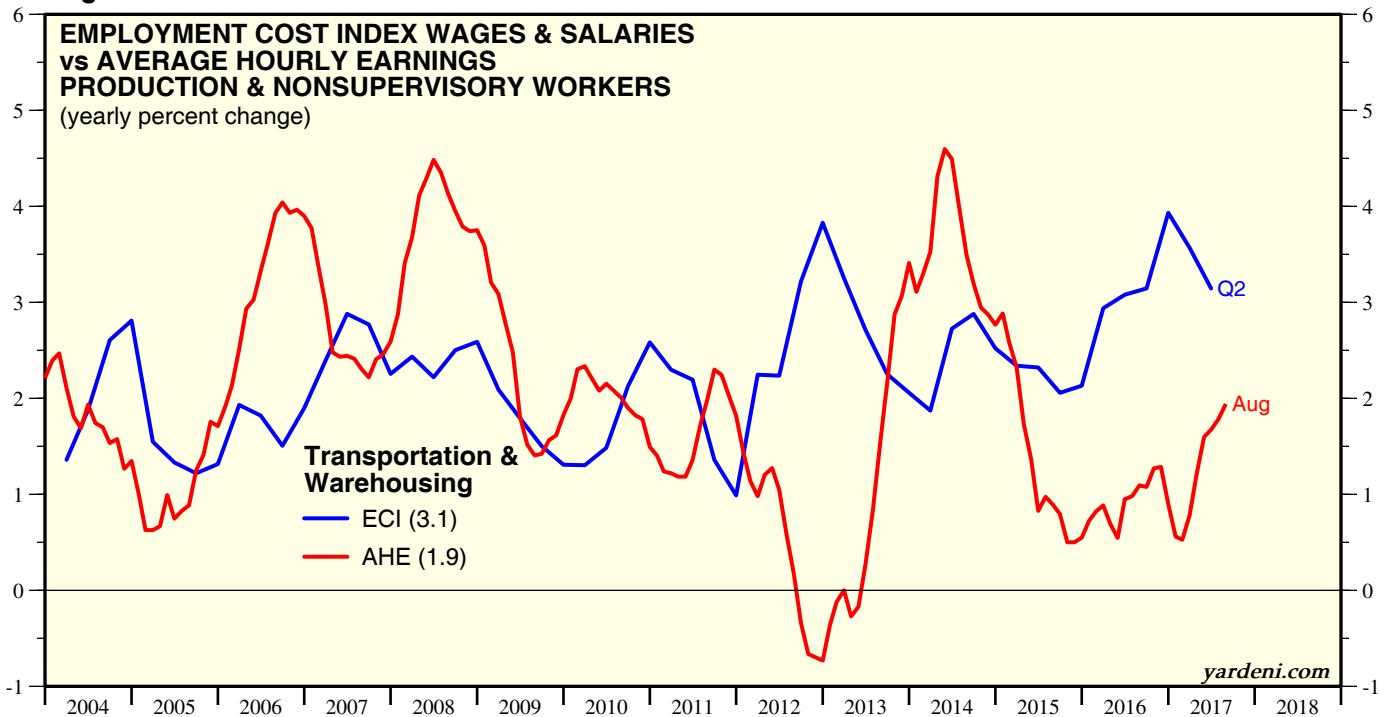

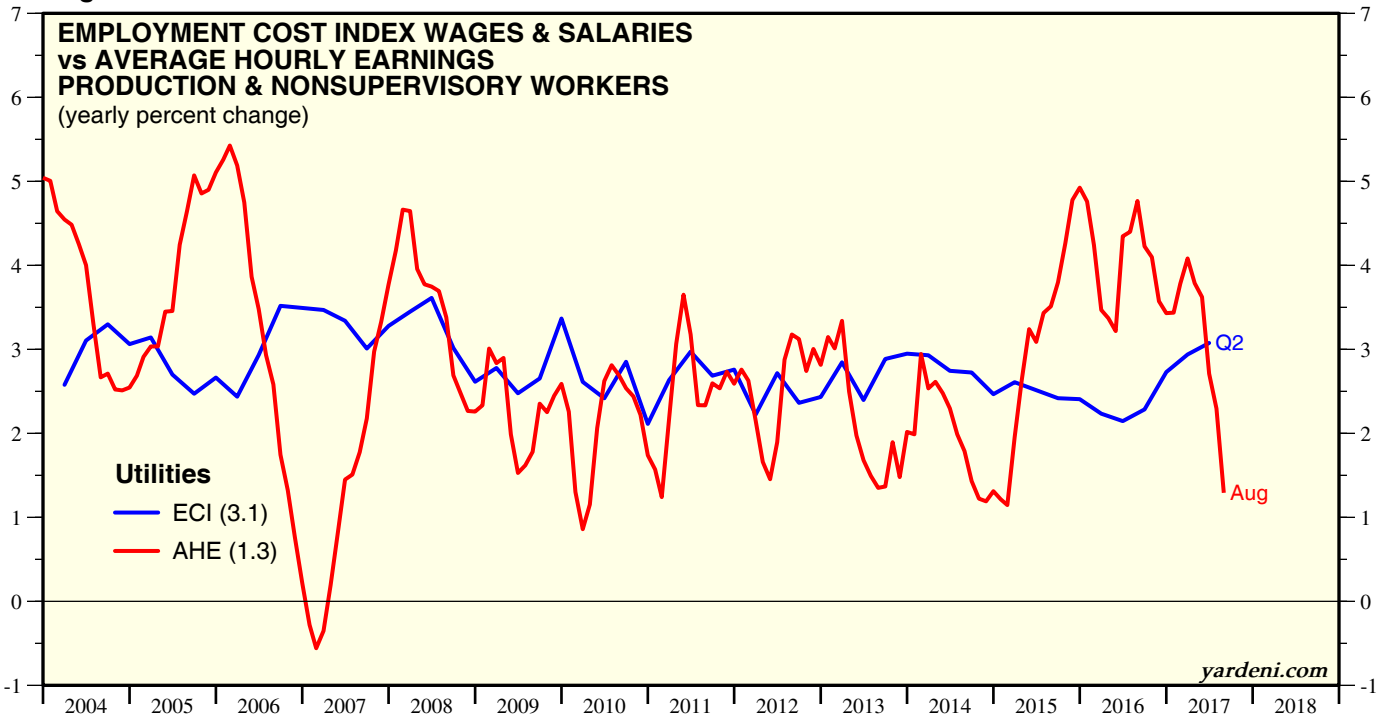

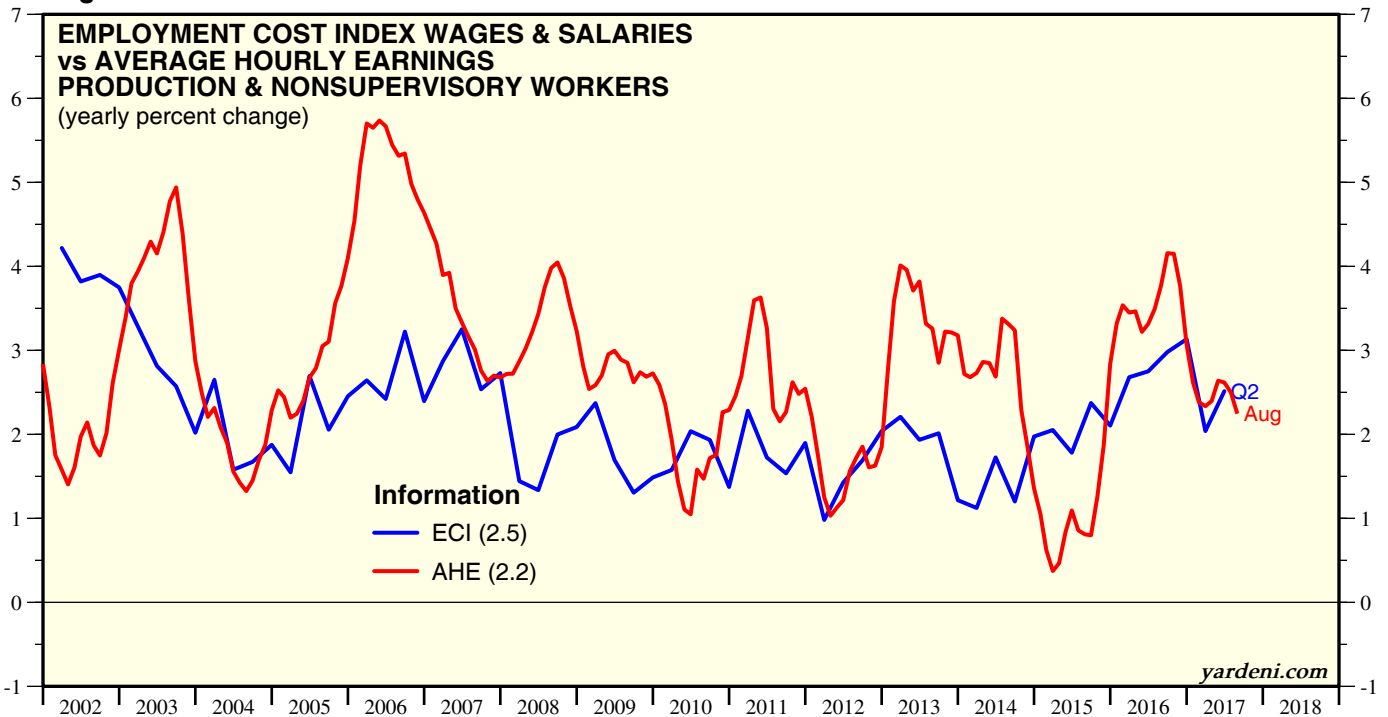

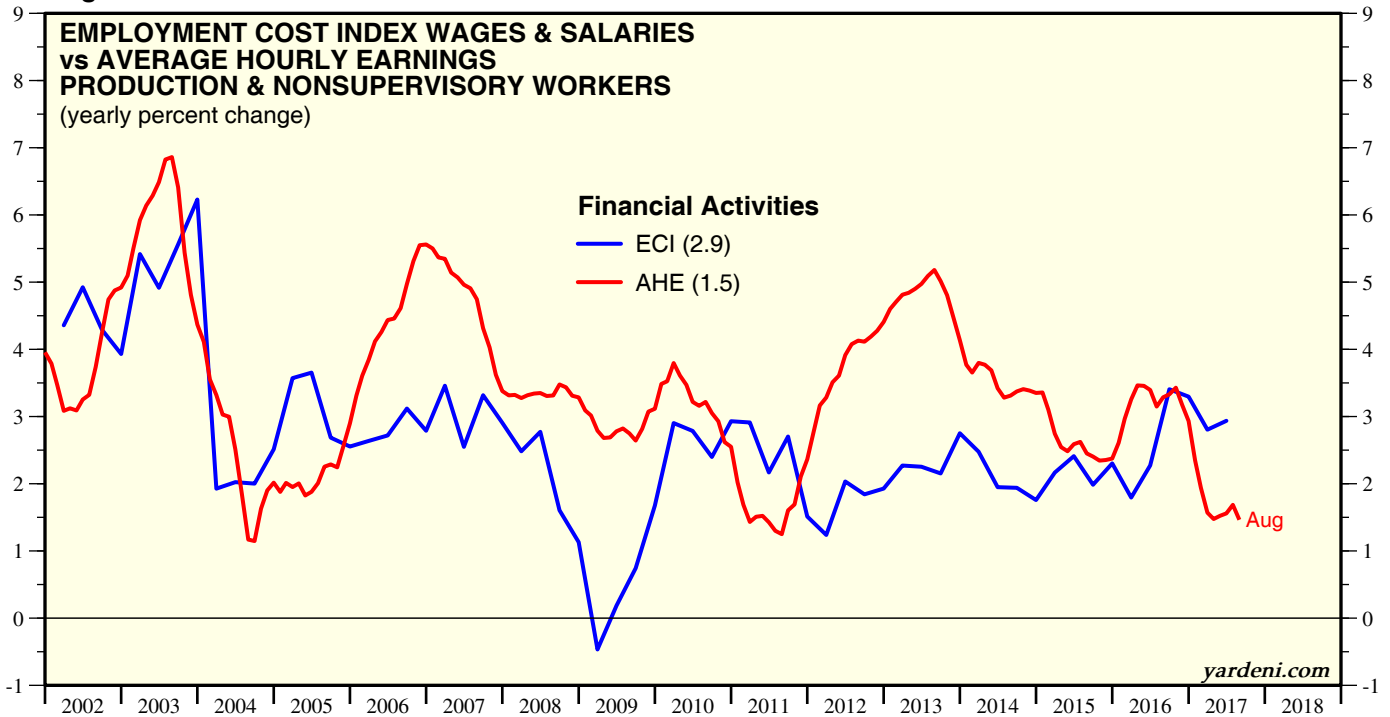

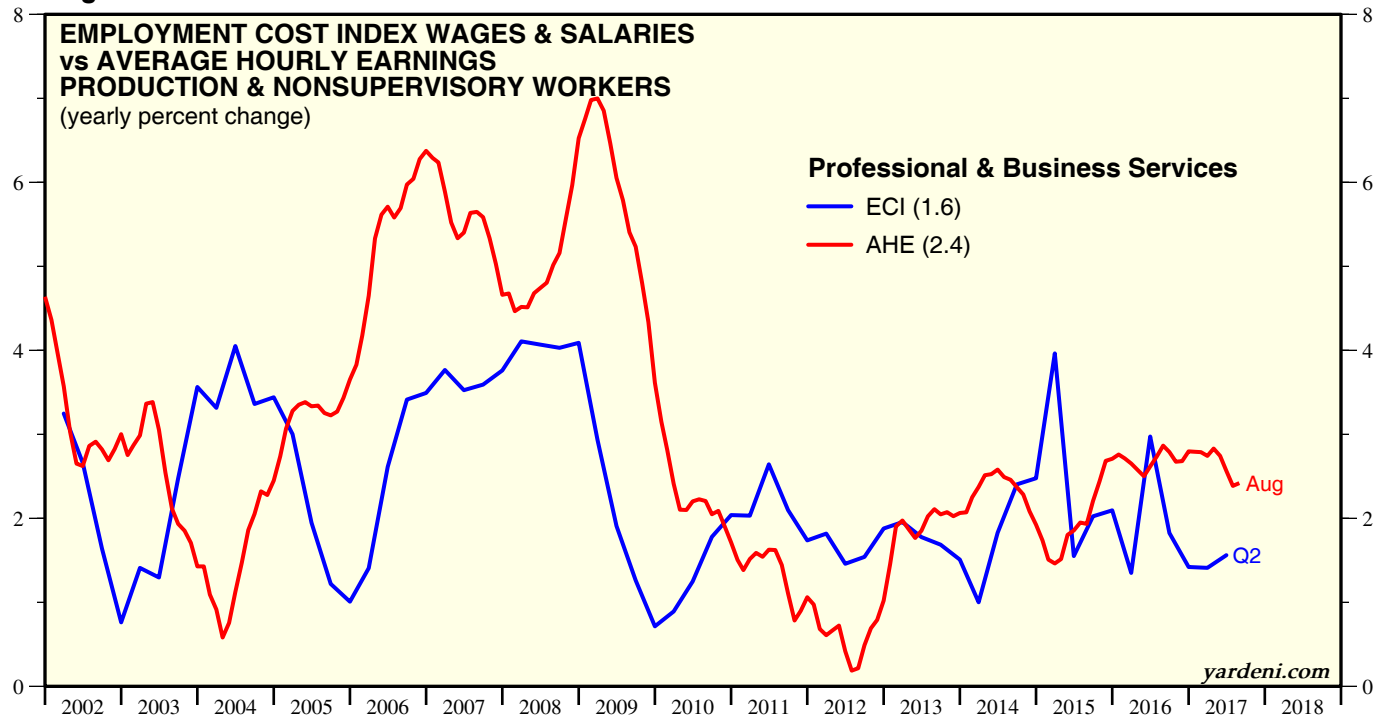

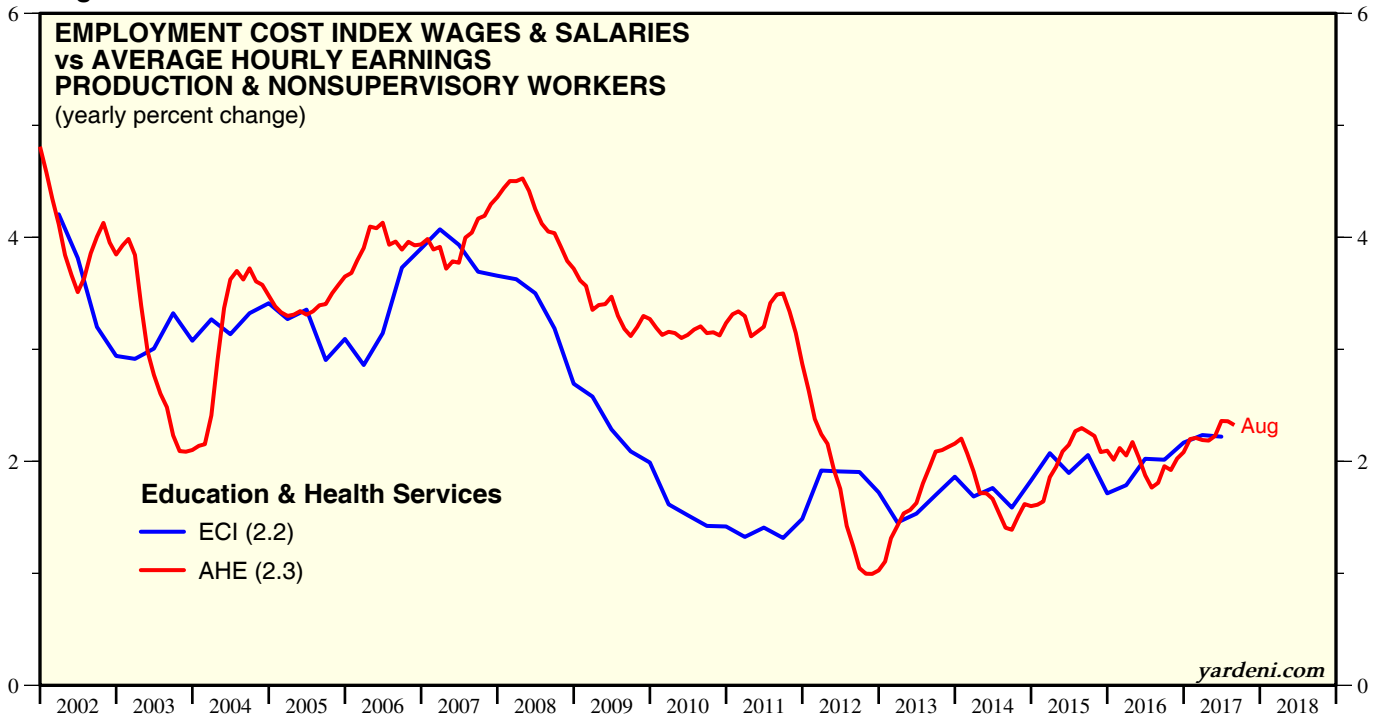


\* Yearly percent change using three-month average.

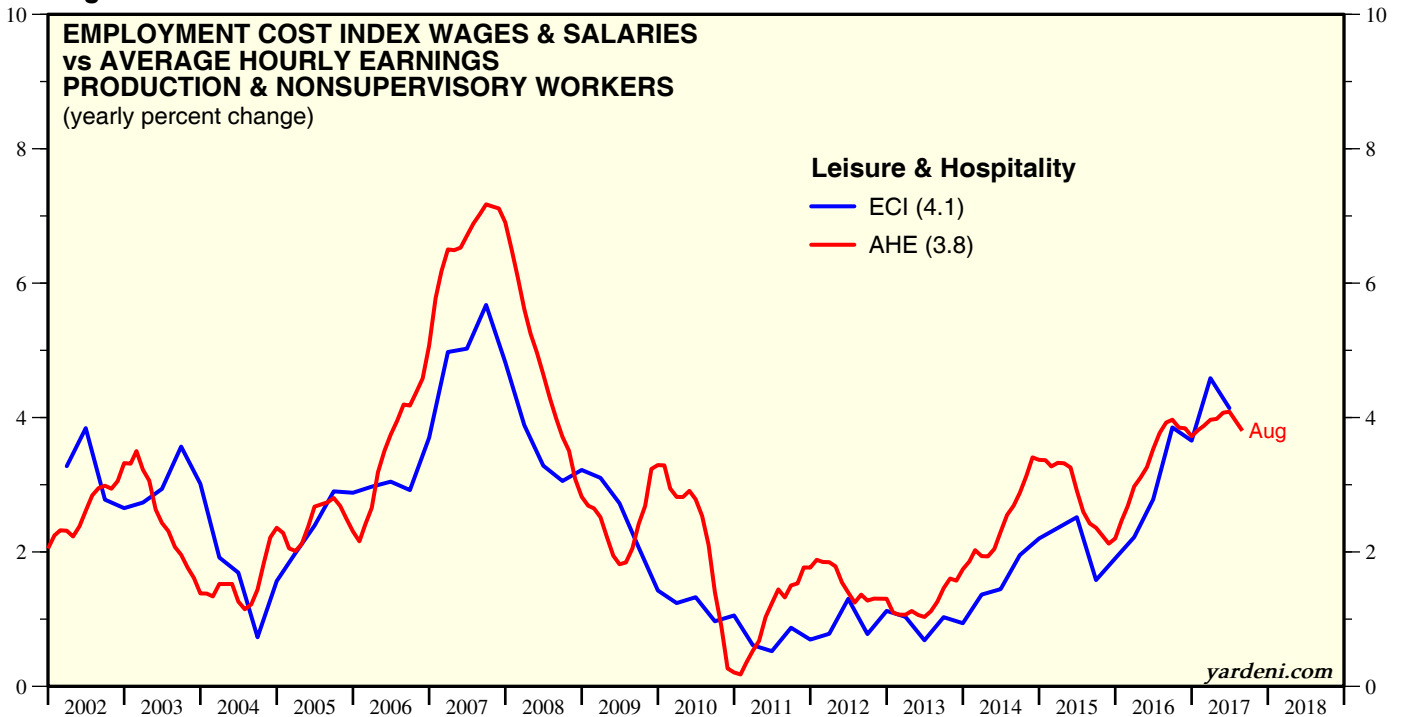

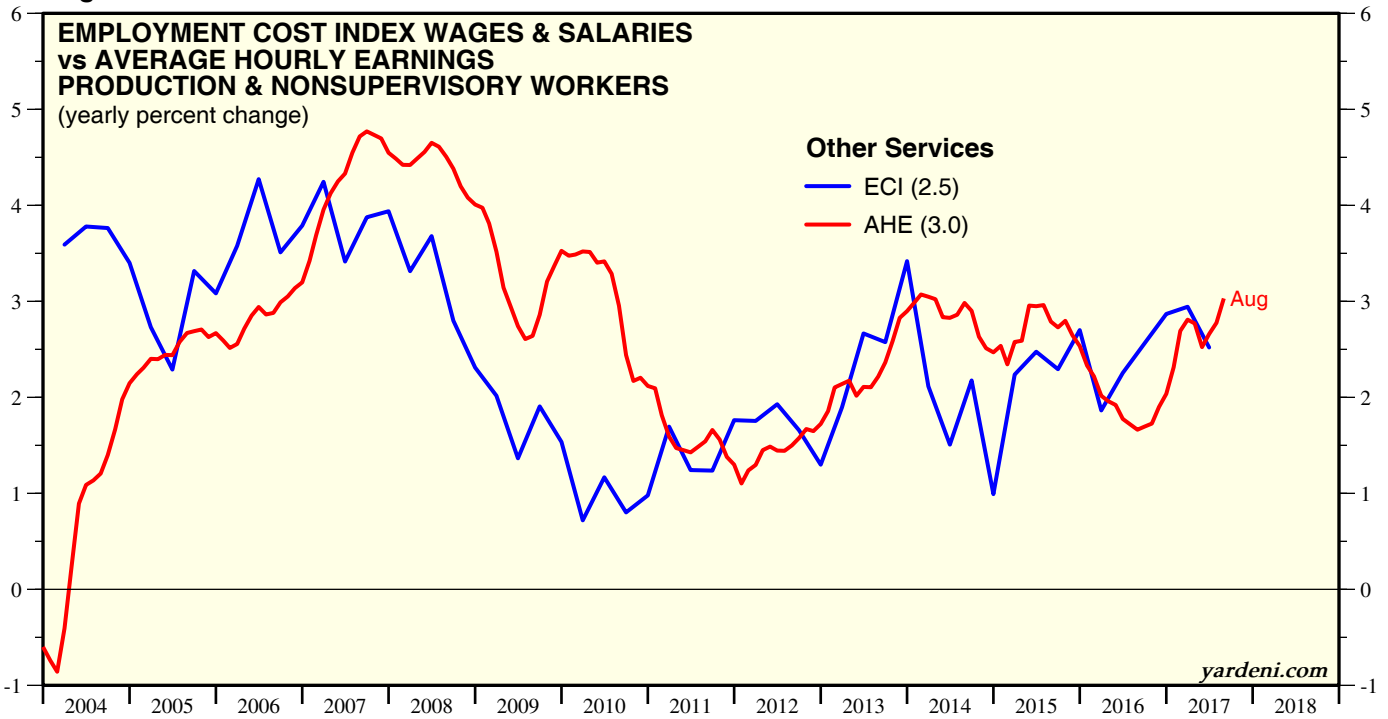

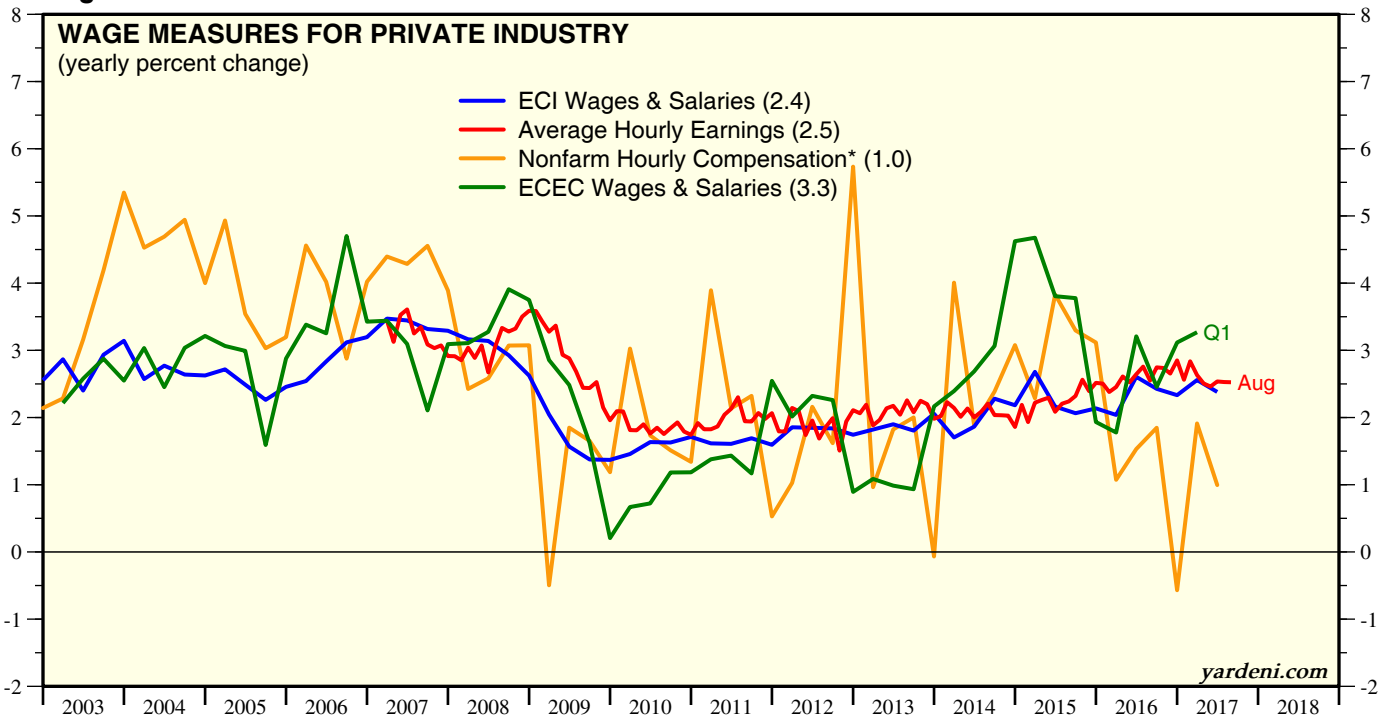
