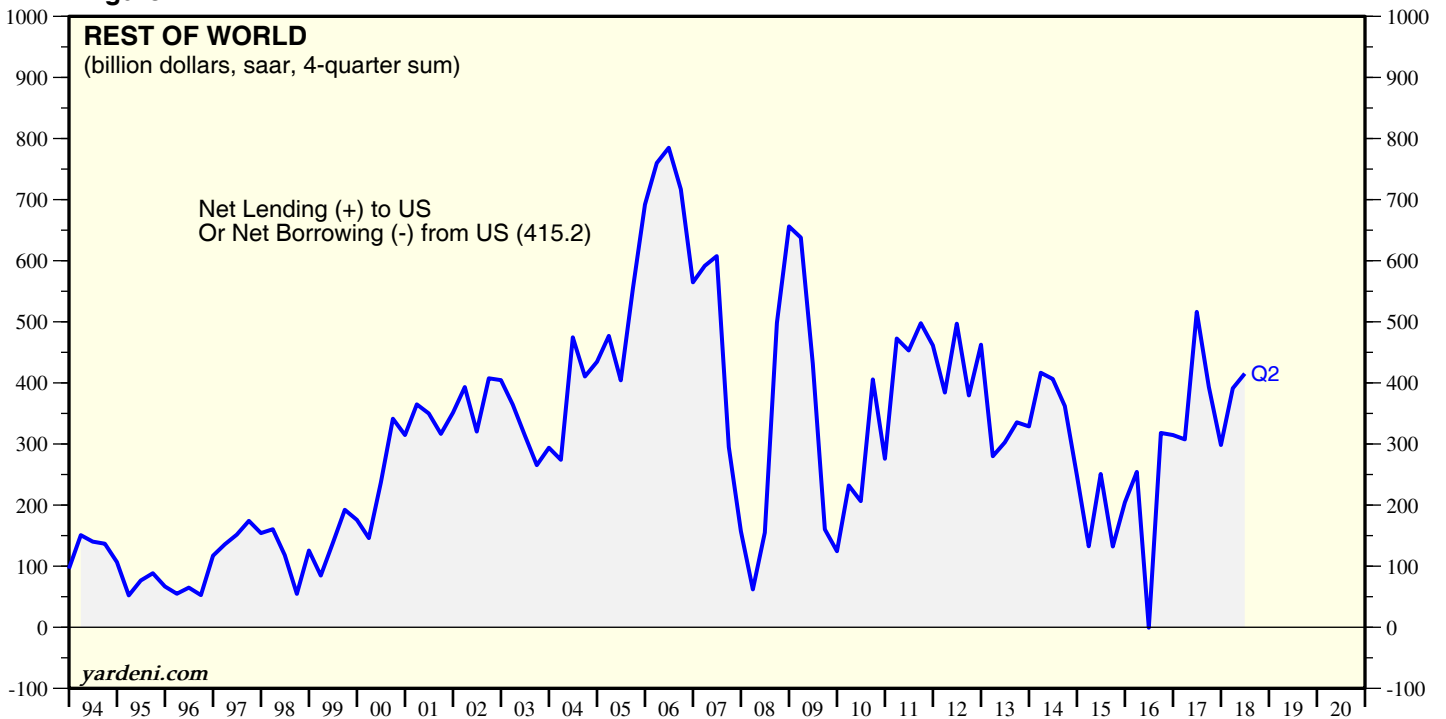

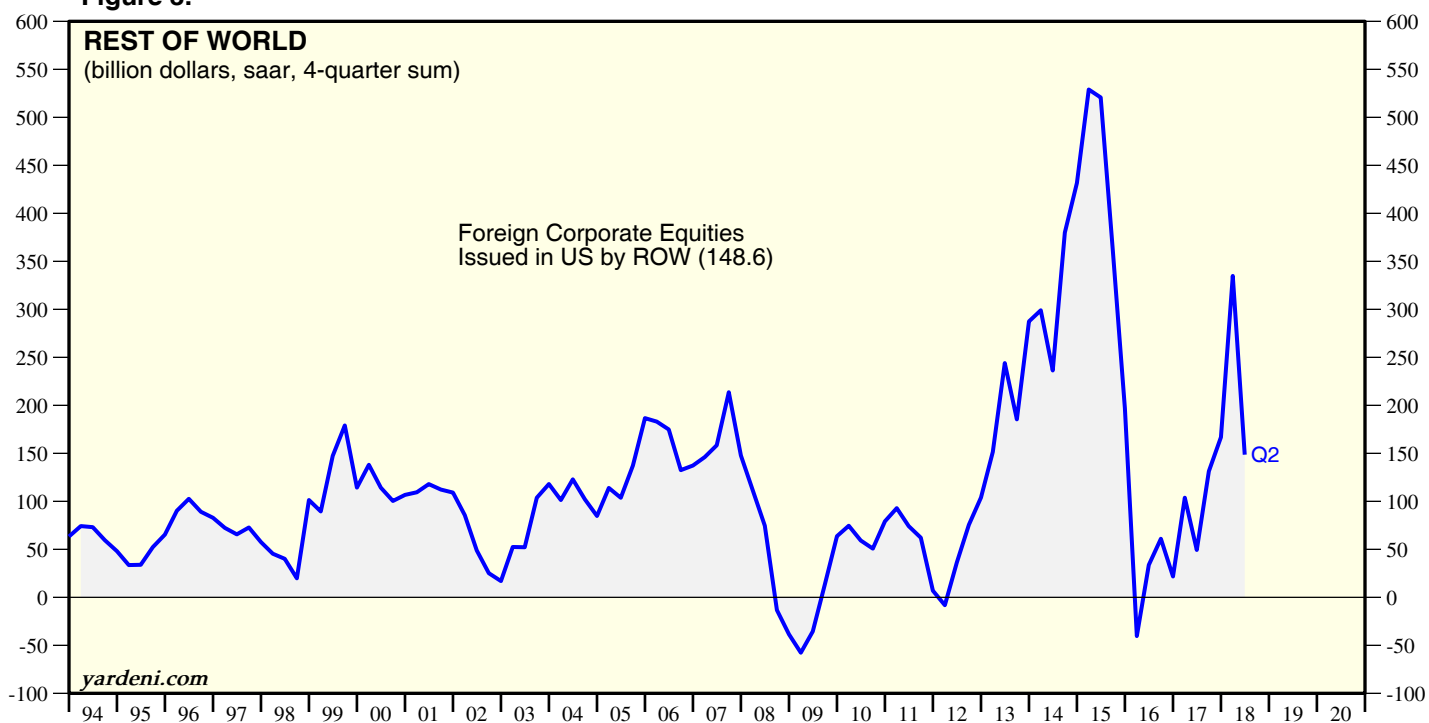

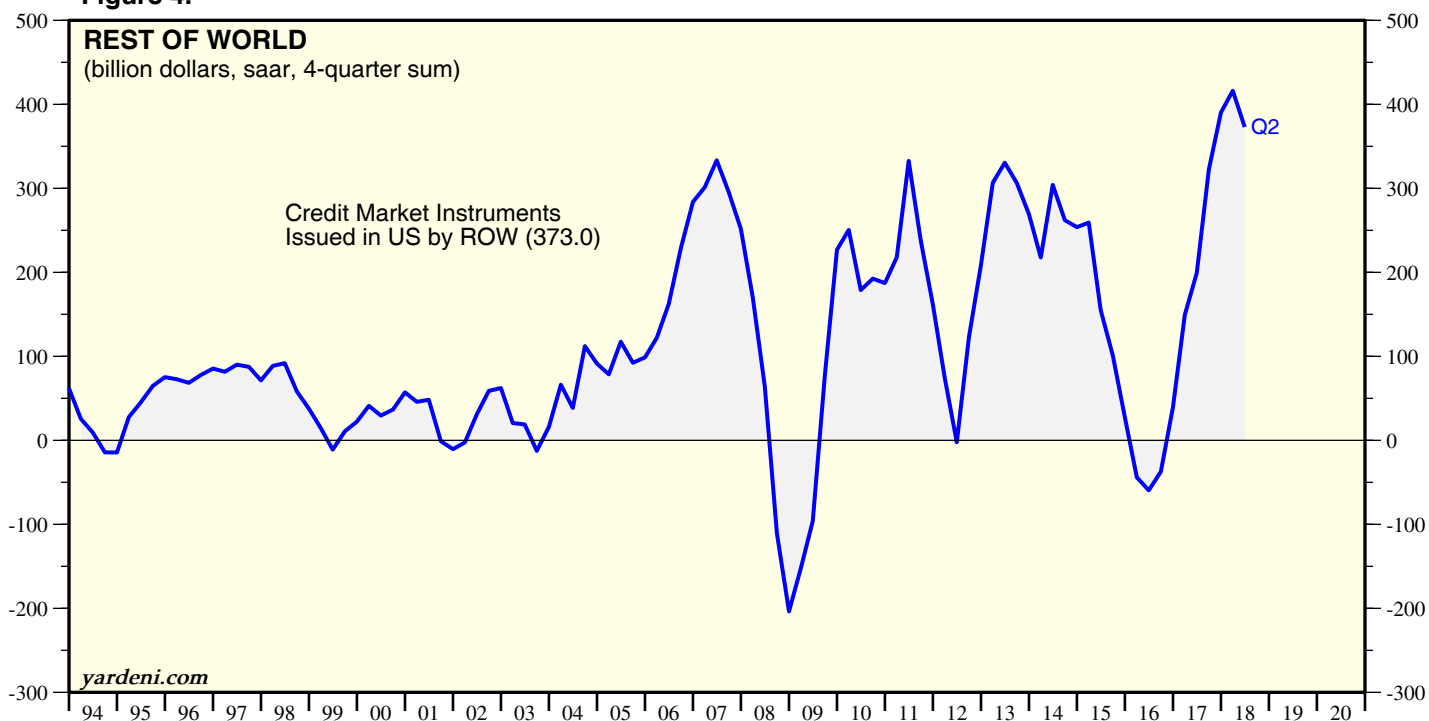

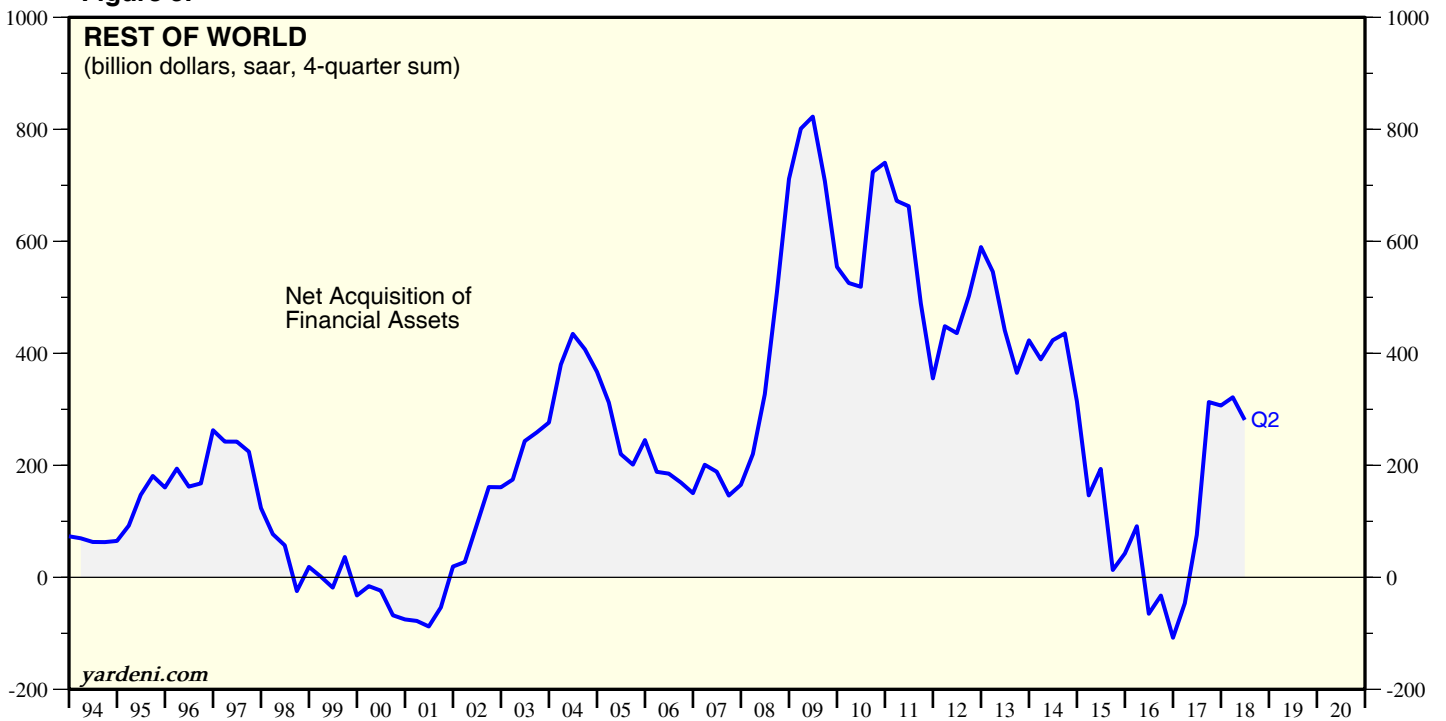

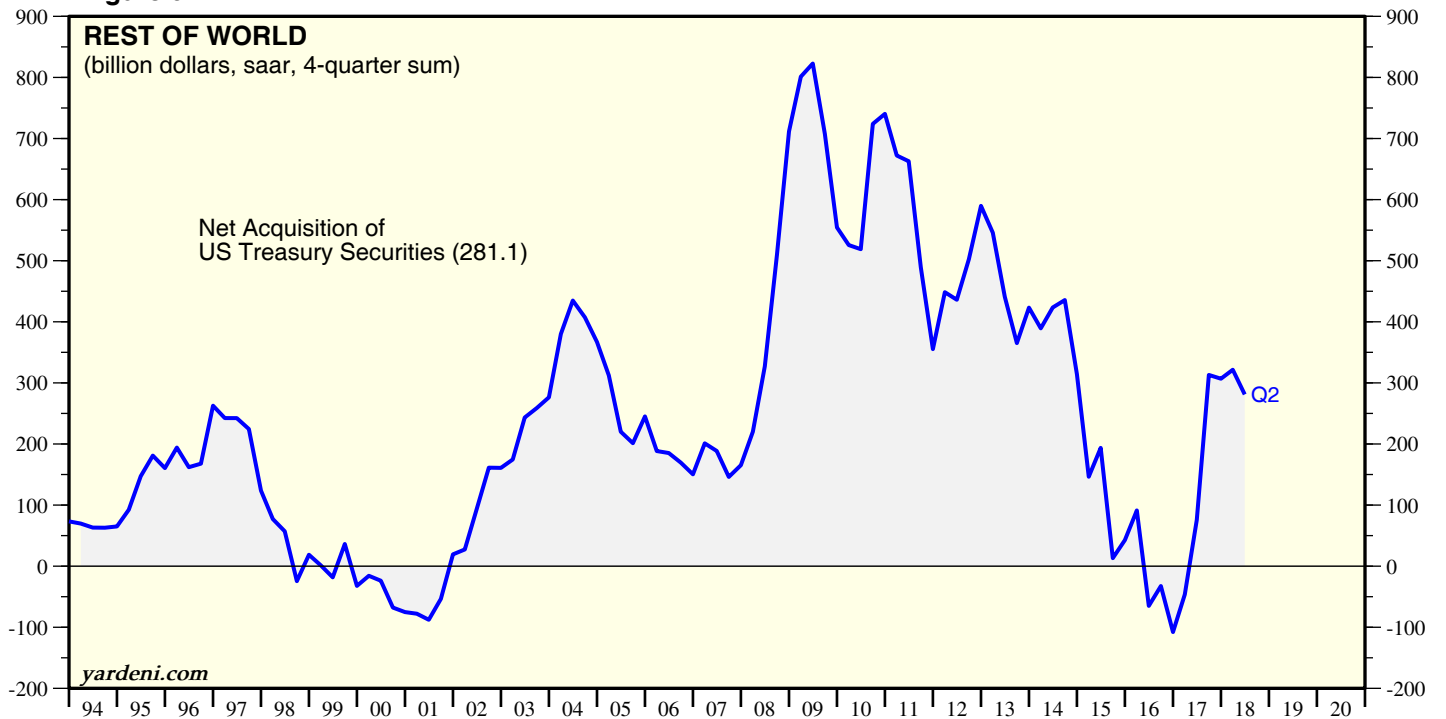
Net Acquisition: Total & Treasuries

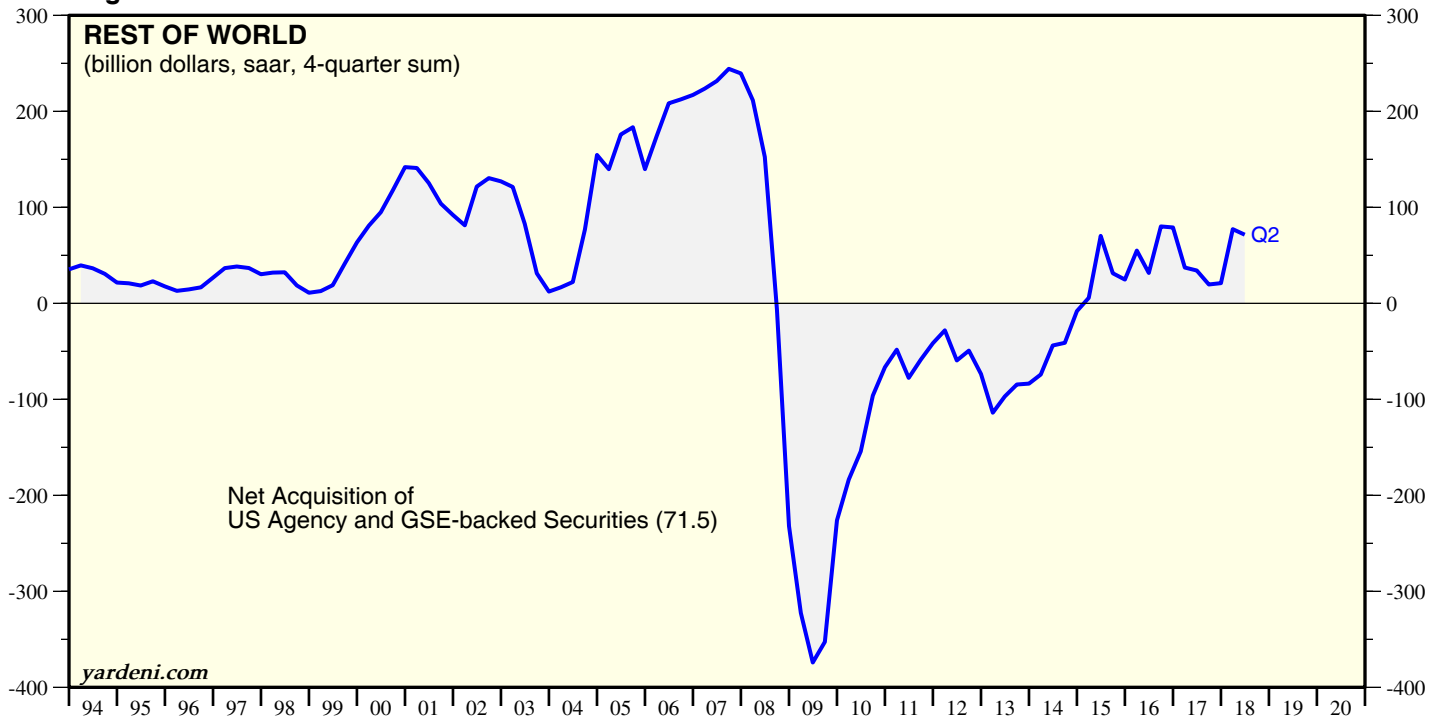

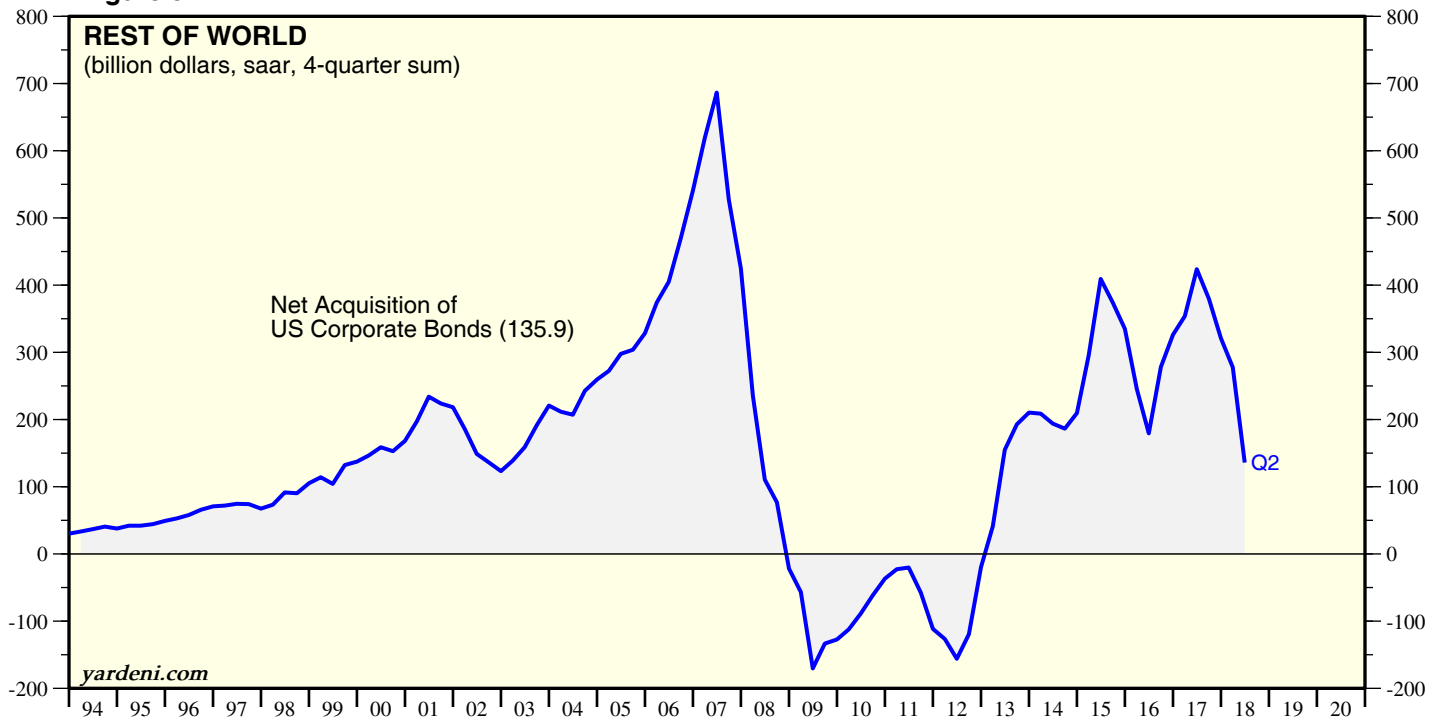

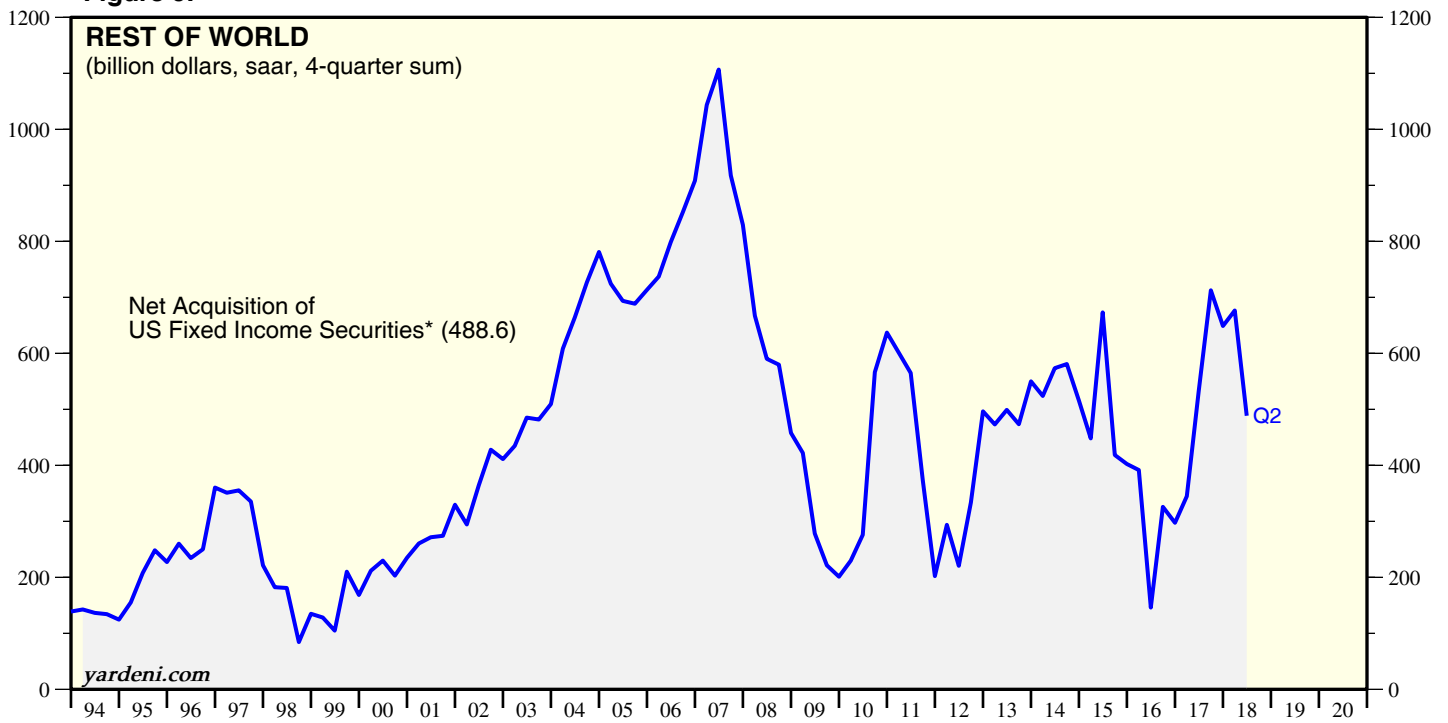

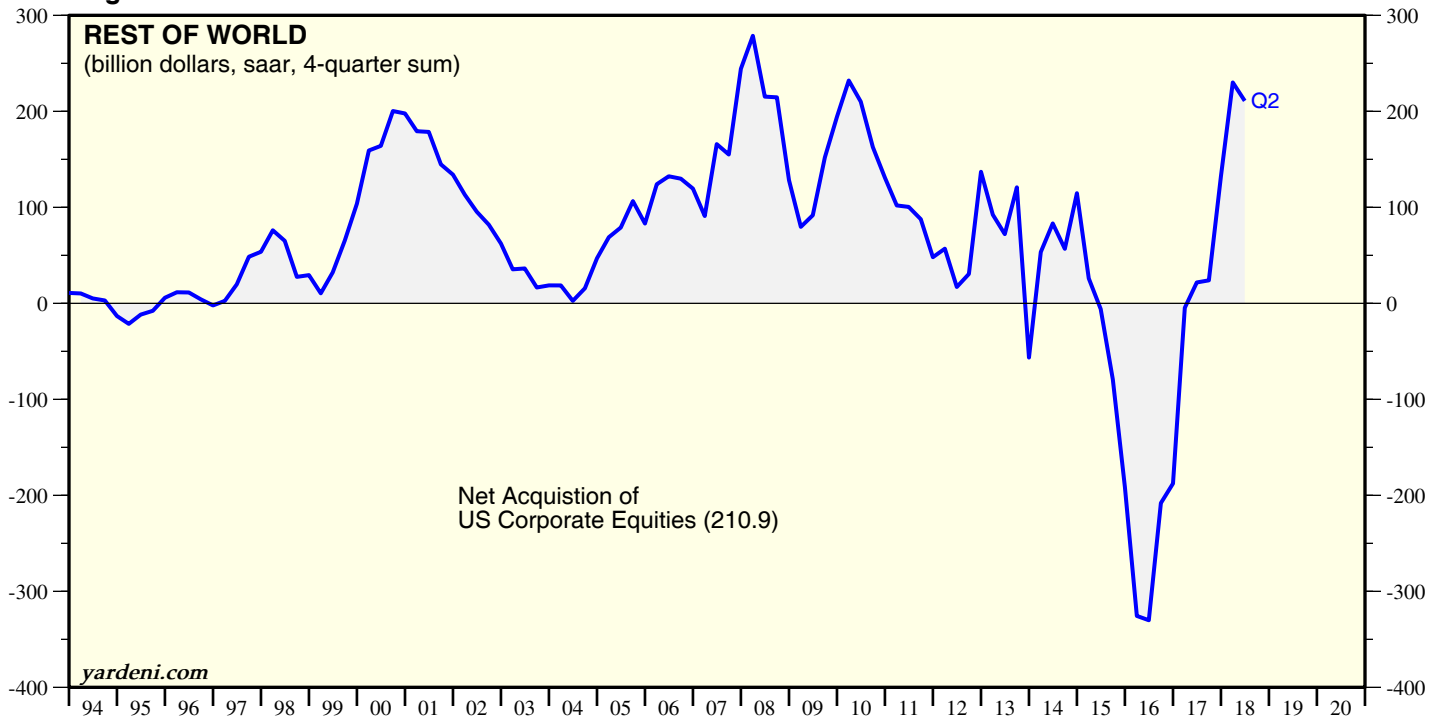

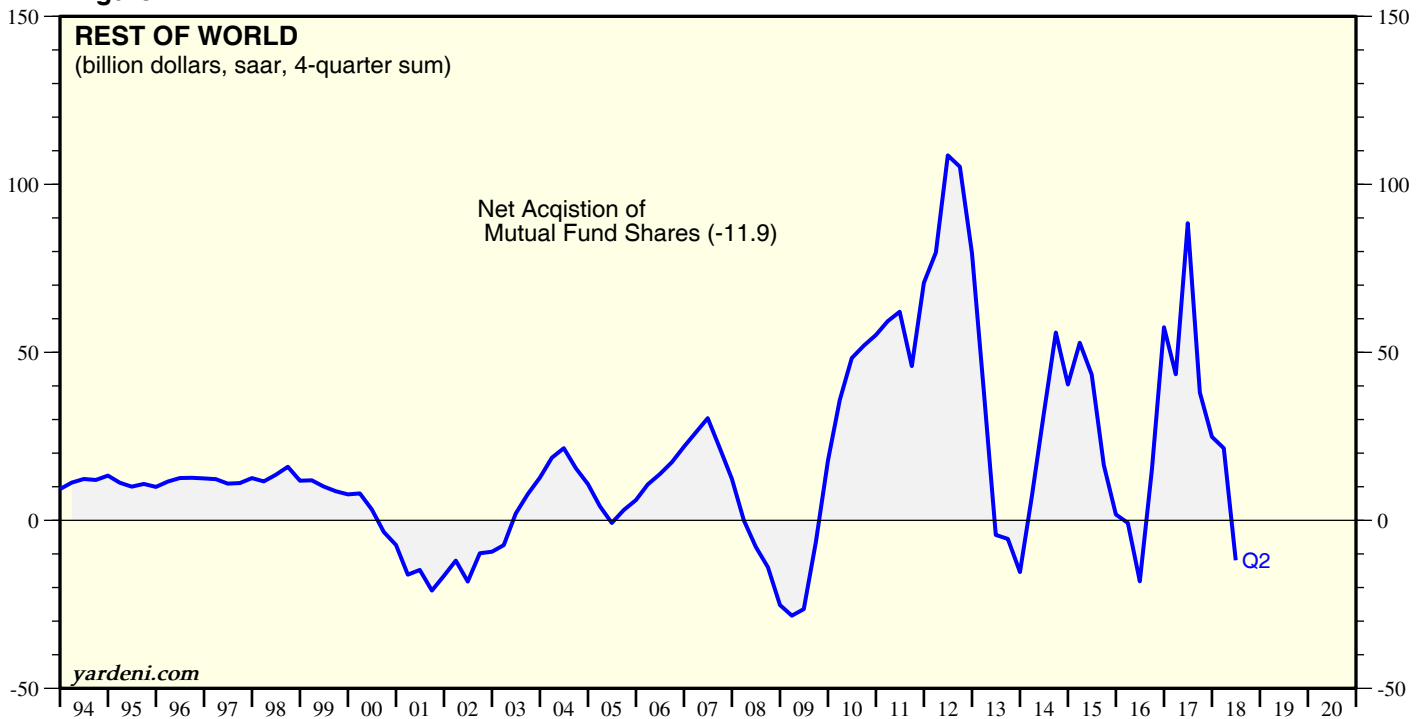

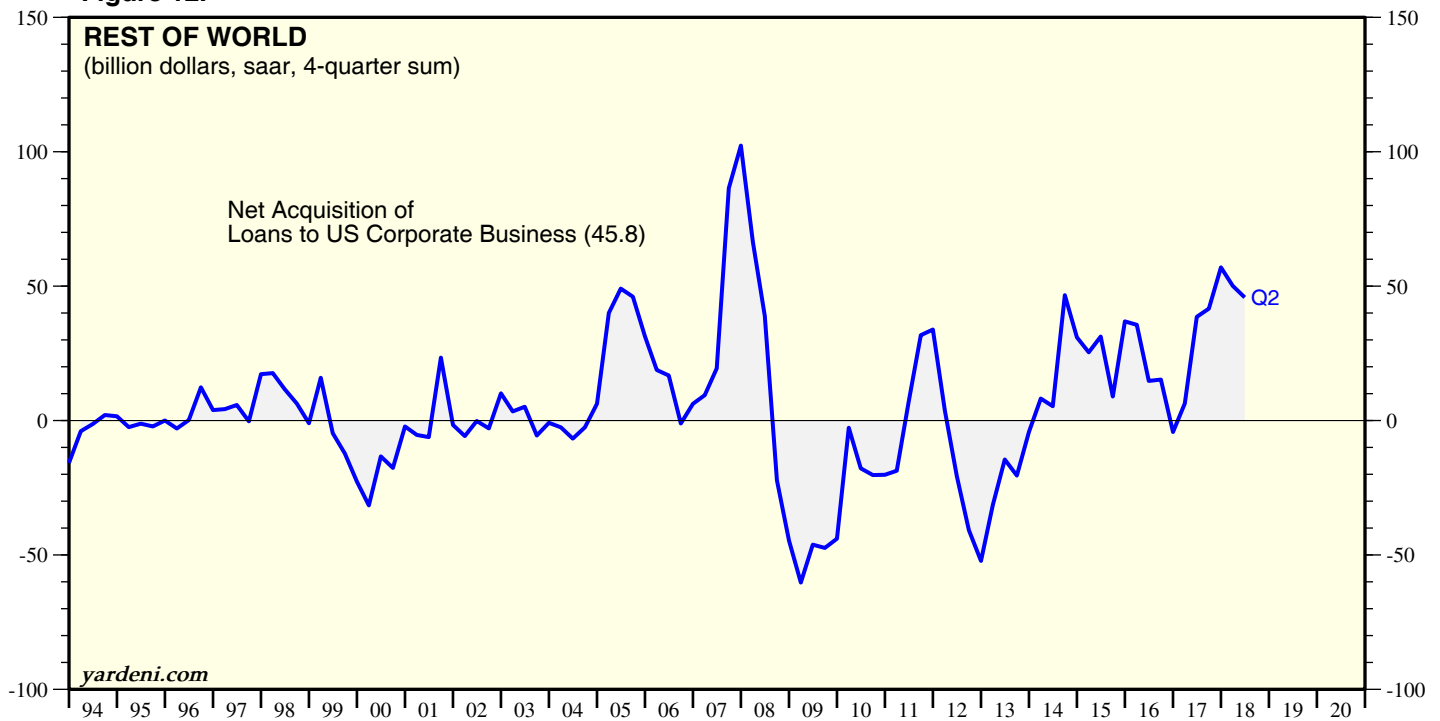

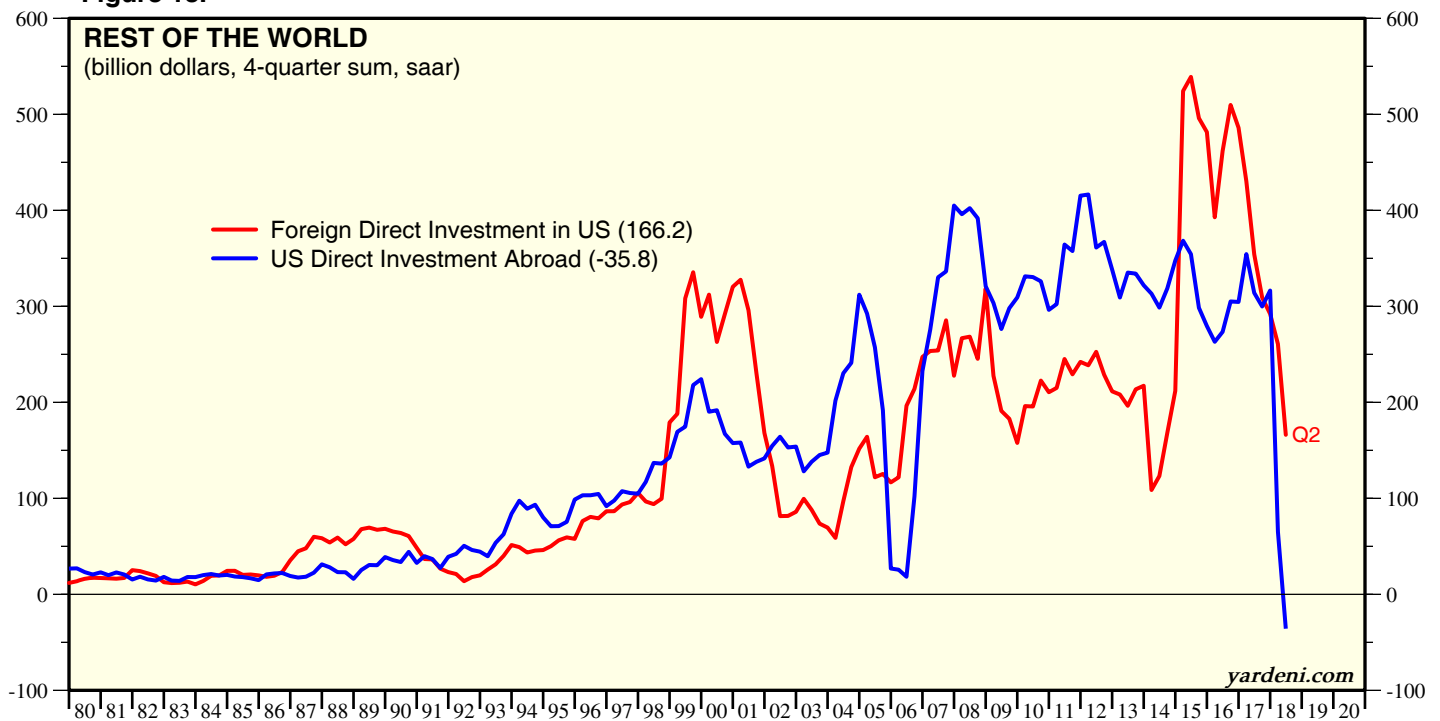
Net Acquisition: Loans & Direct Investments
