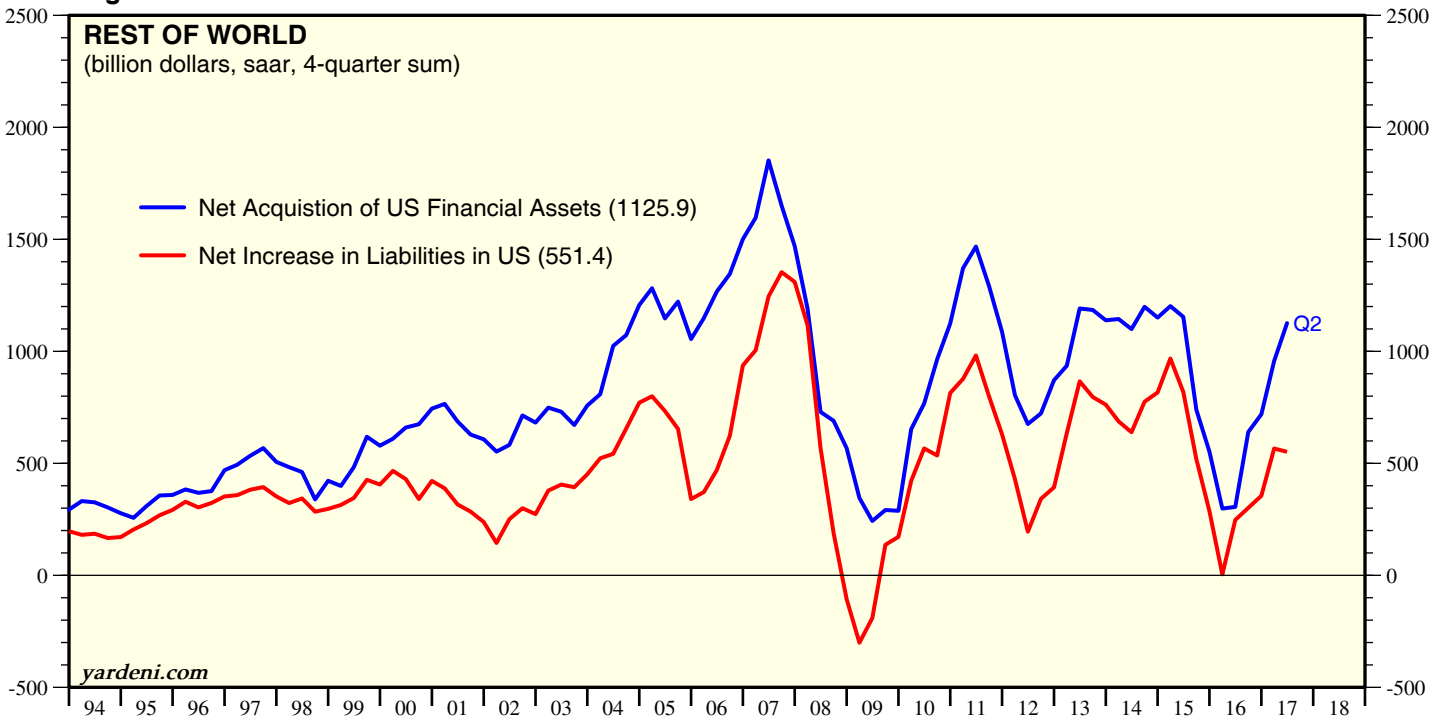

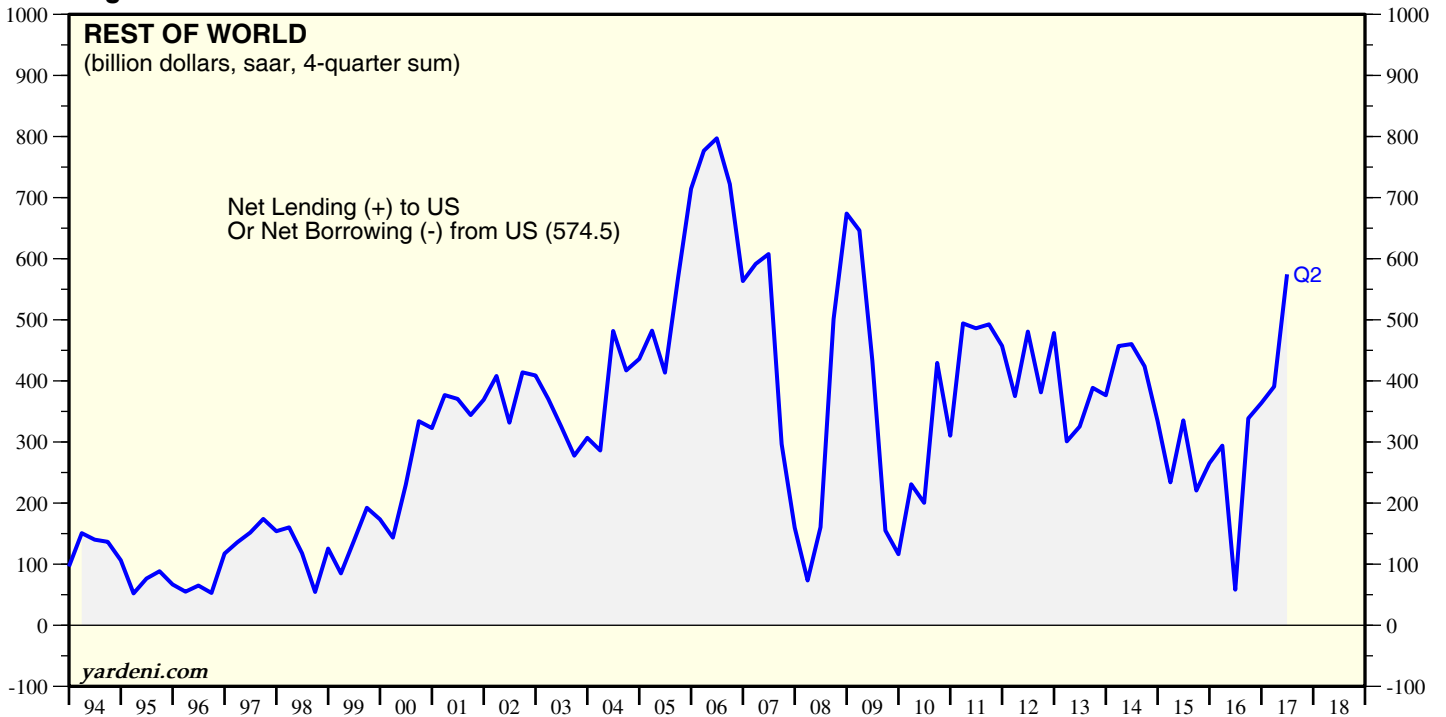

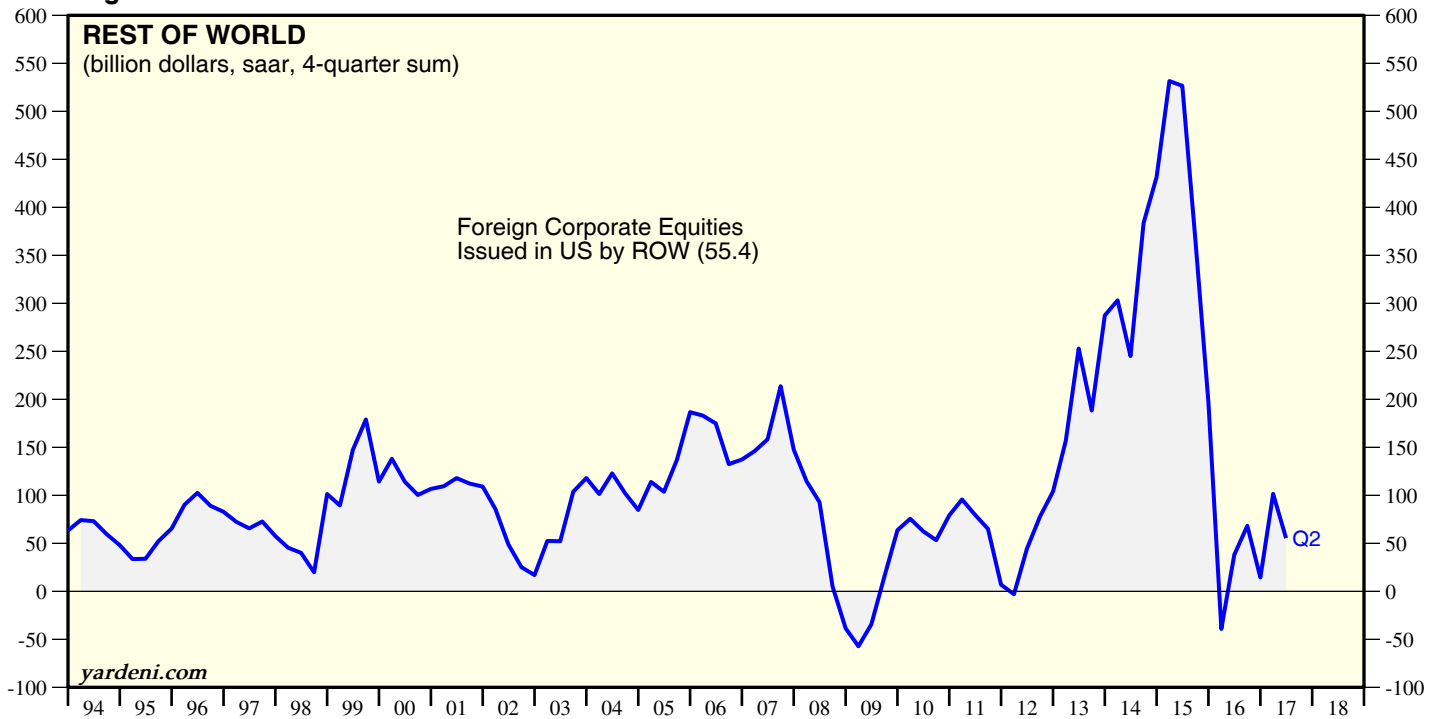

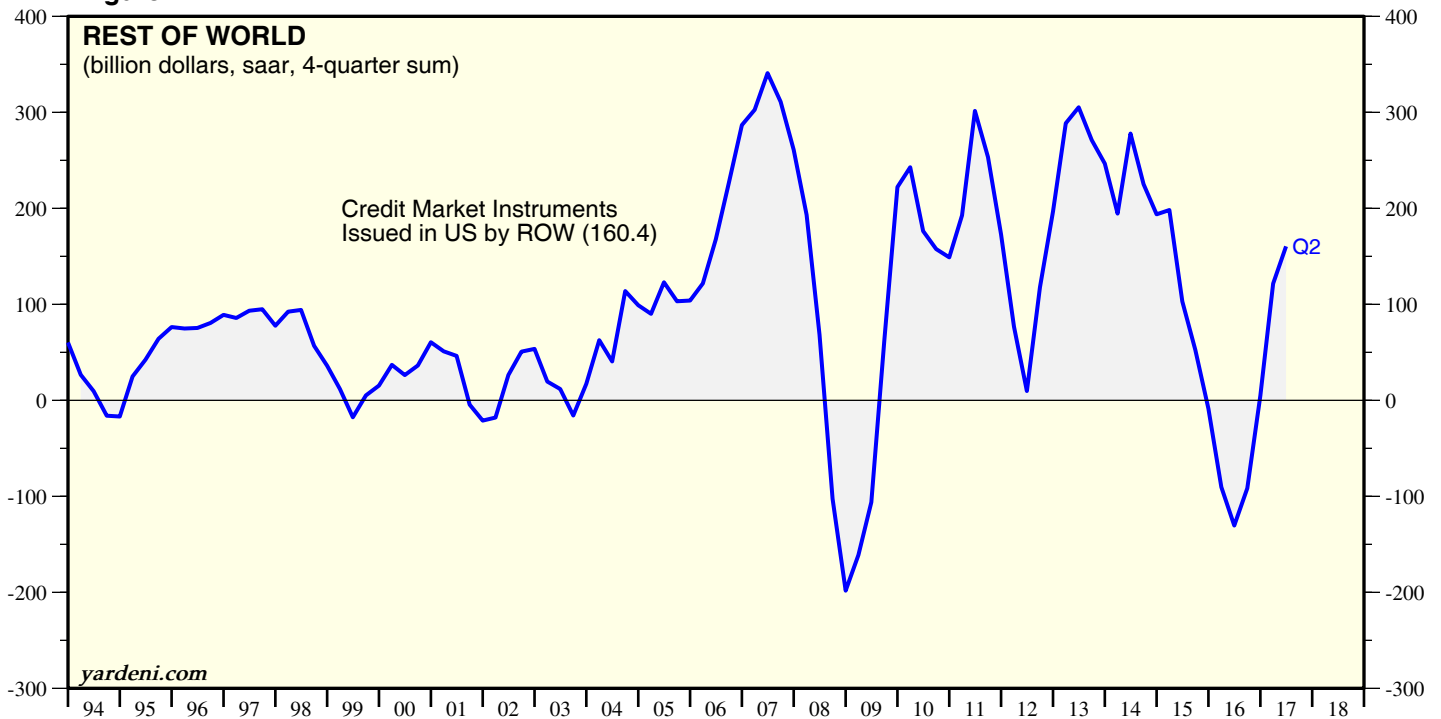

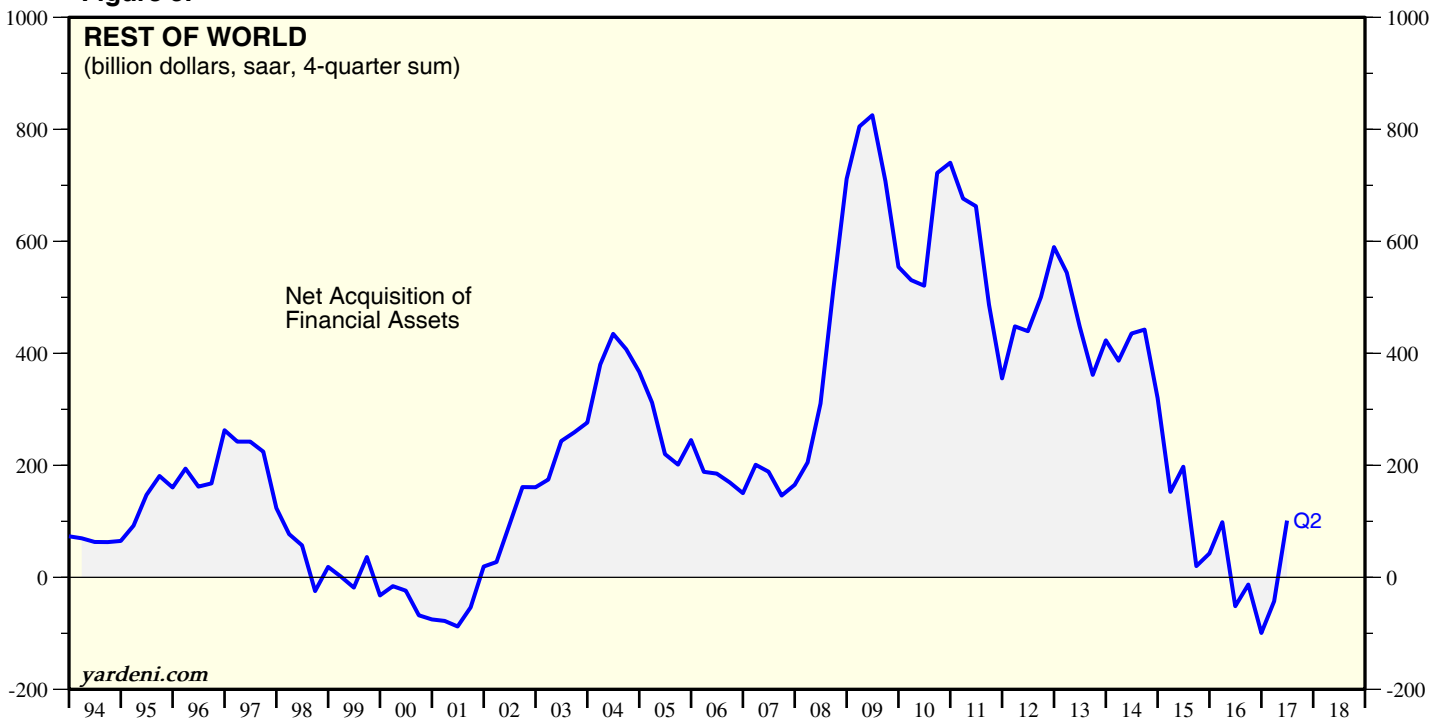

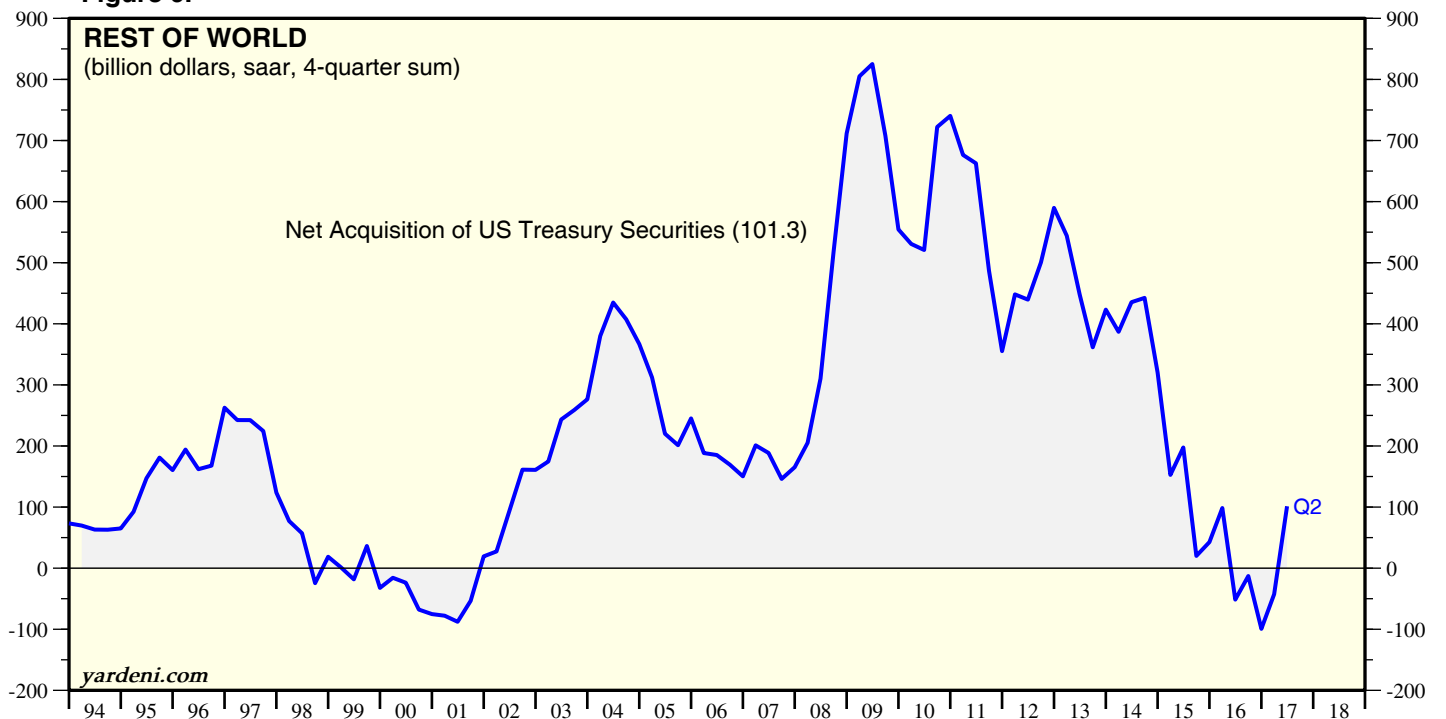
Net Acquisition: Total & Treasuries

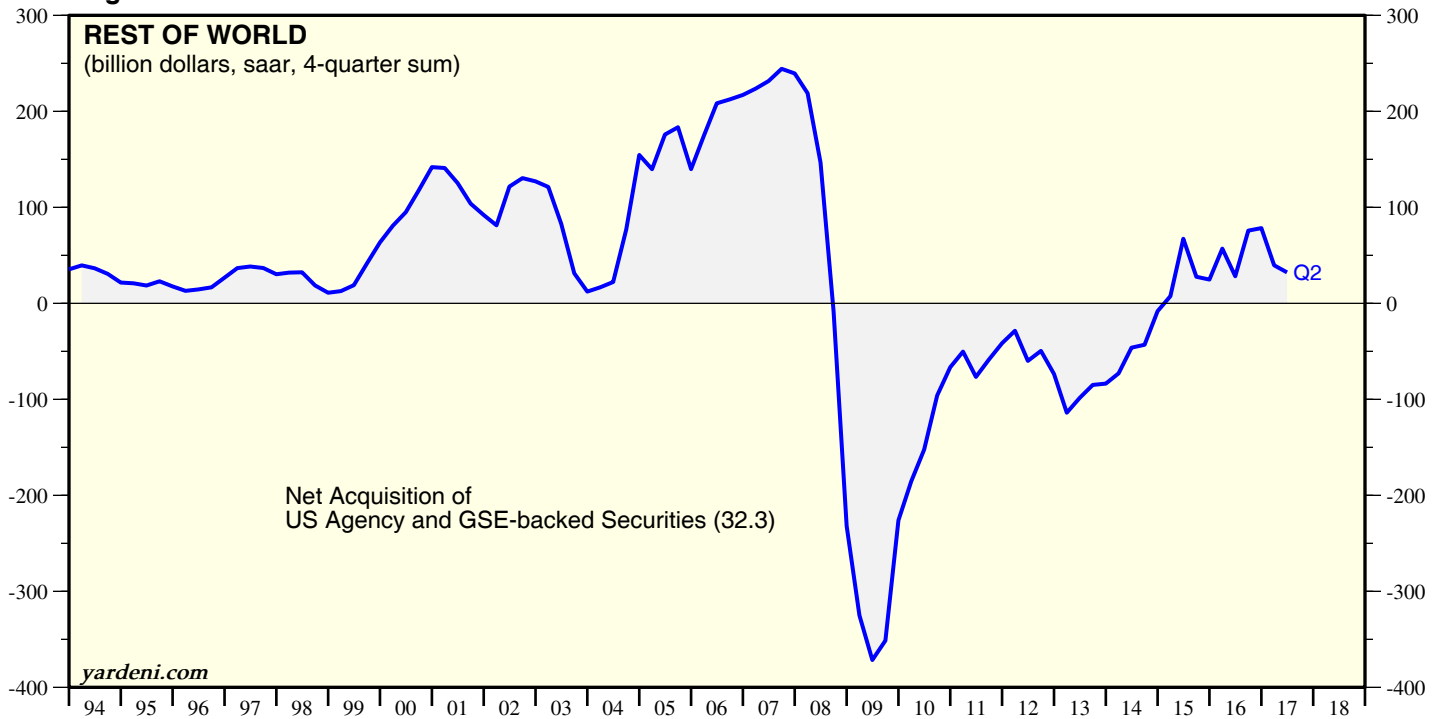

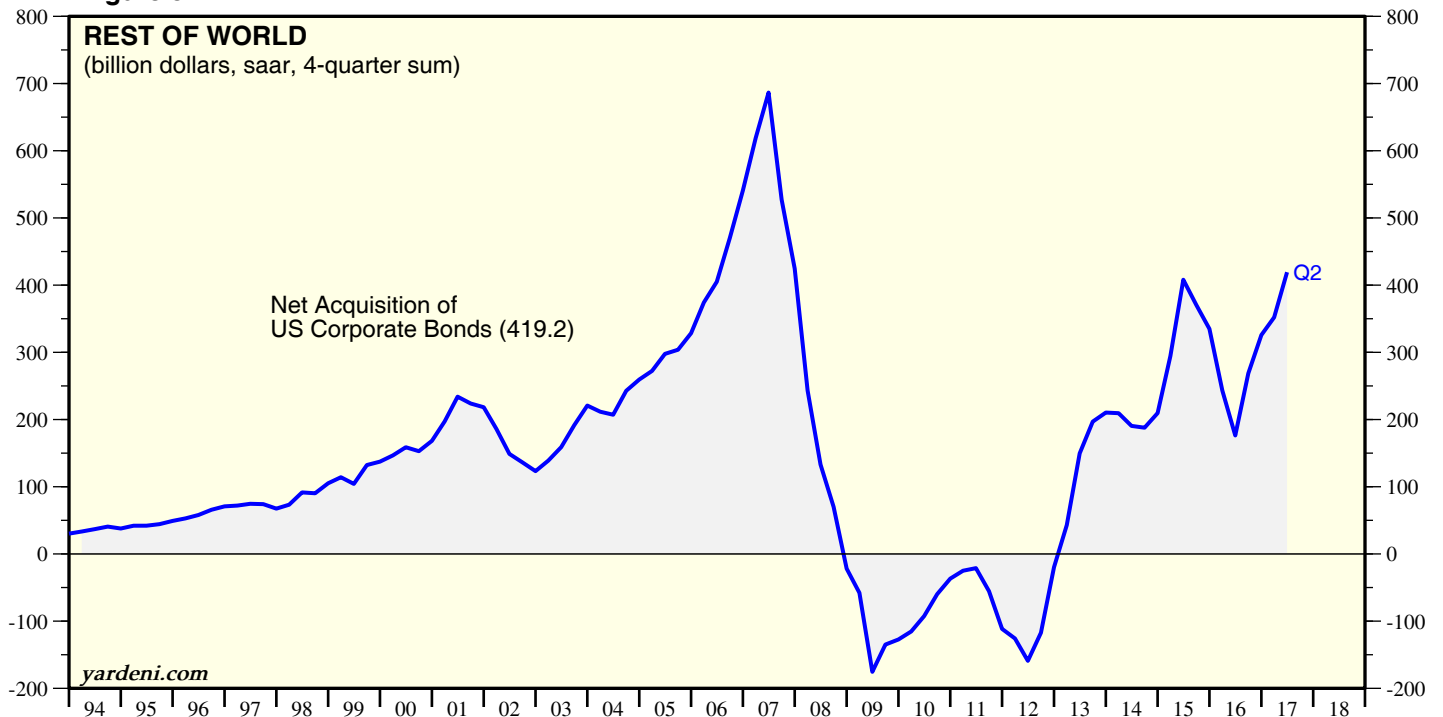
Net Acquisition: Agencies & Corporate Bonds

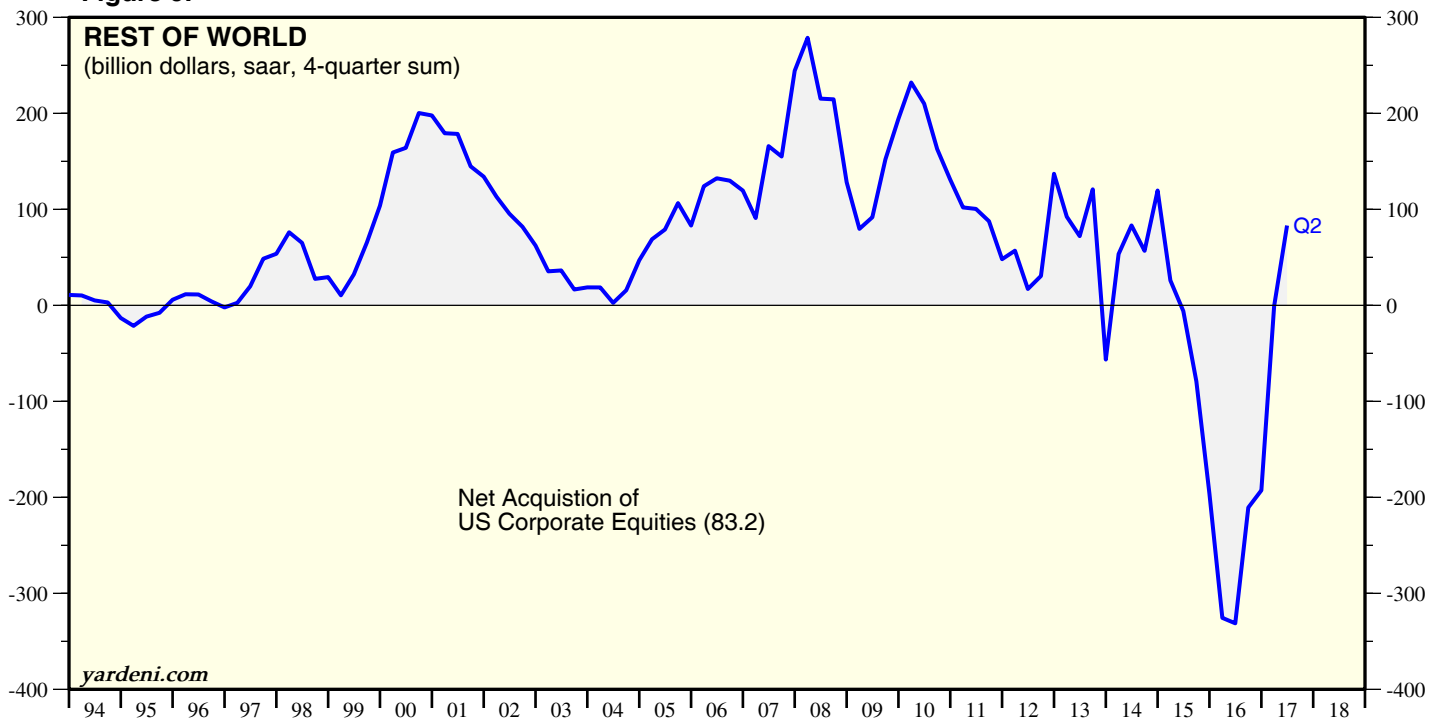

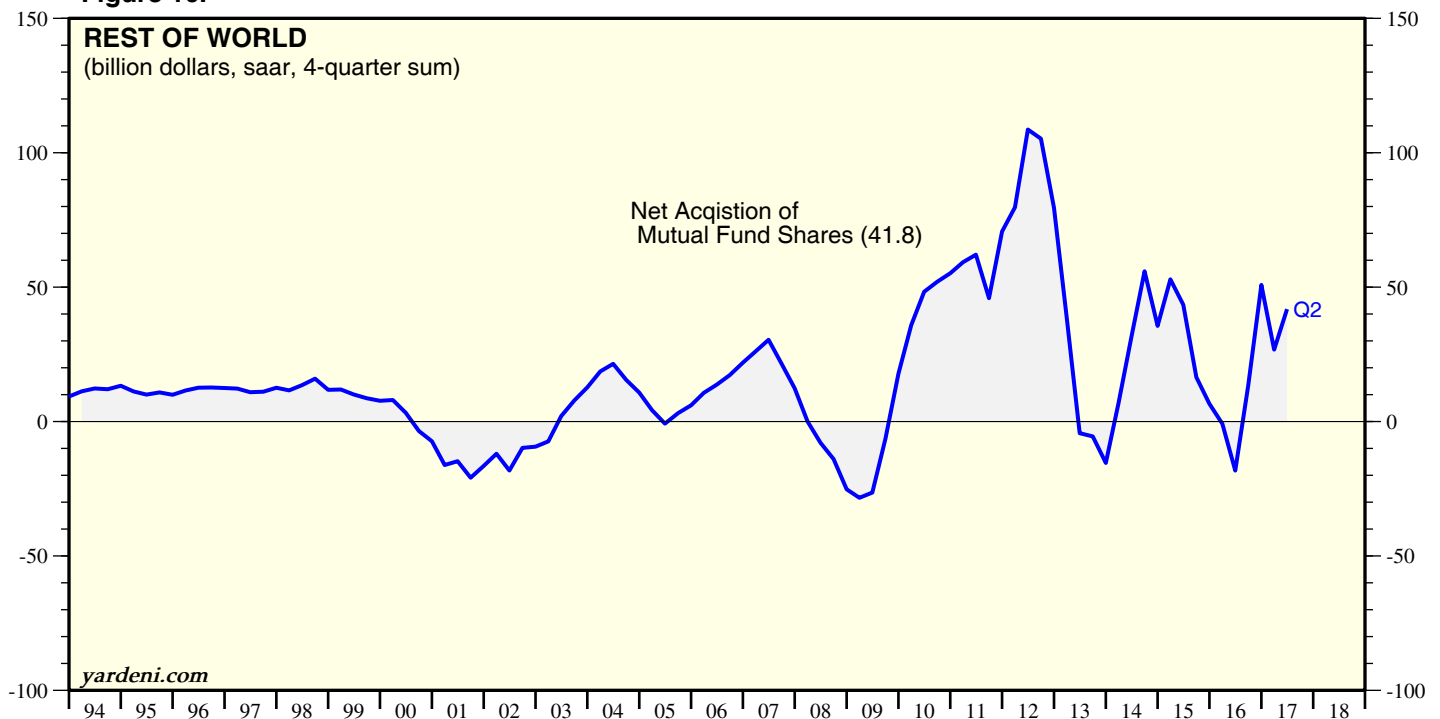
Net Acquisition: Equities & Mutual Funds

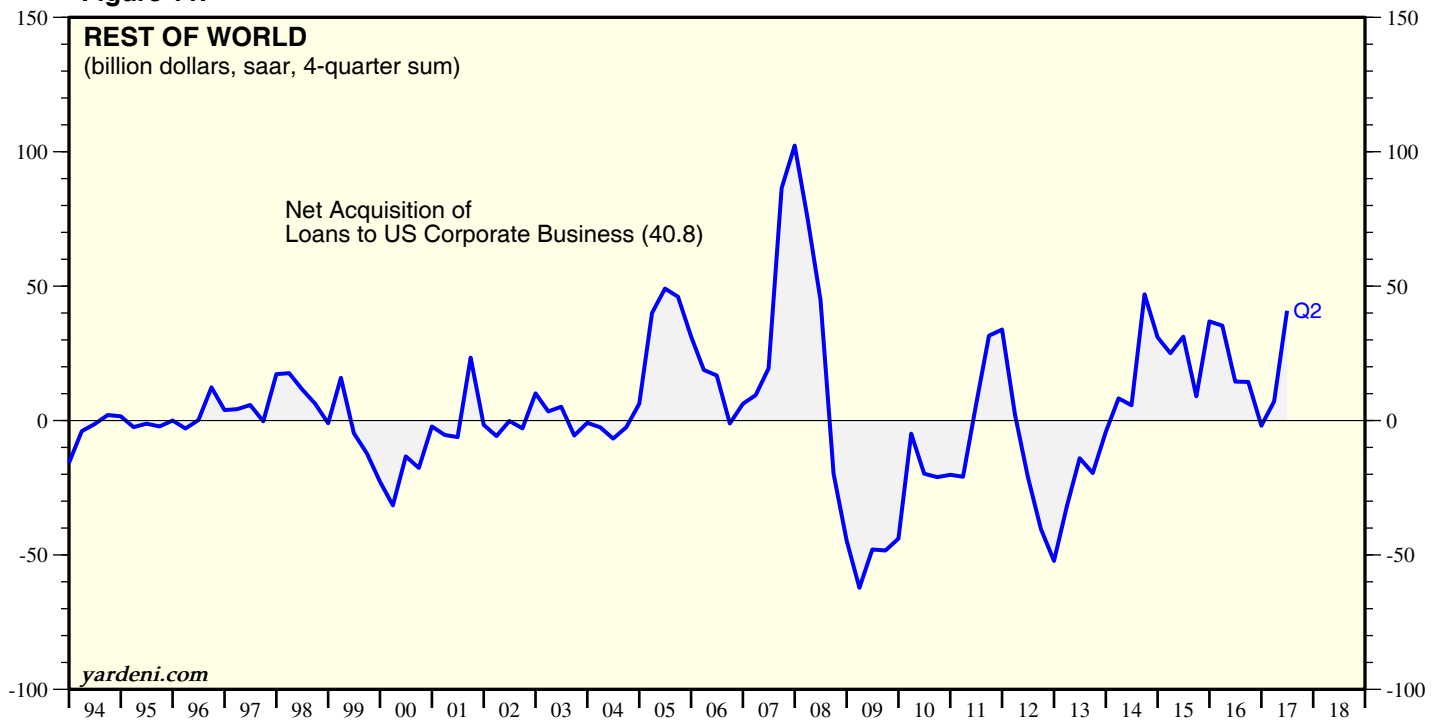

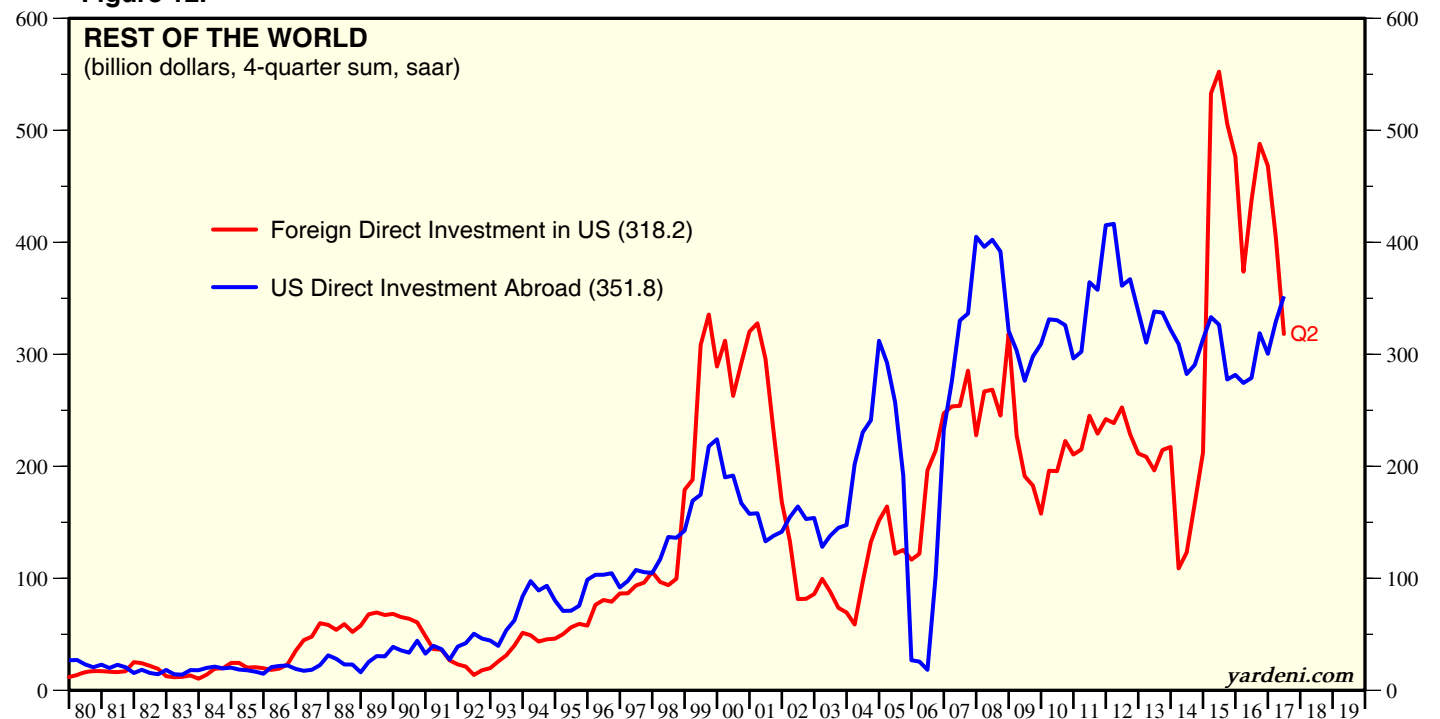
Net Acquisition: Loans & Direct Investments

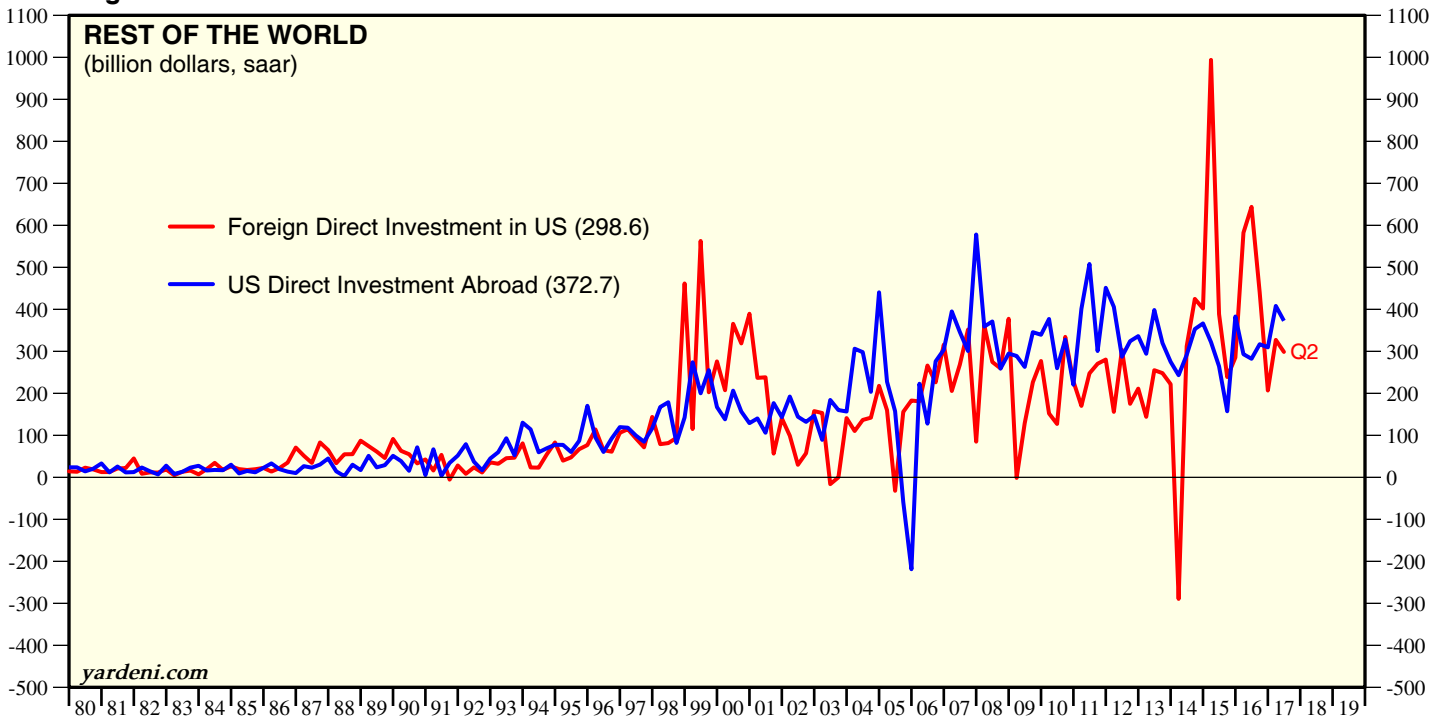

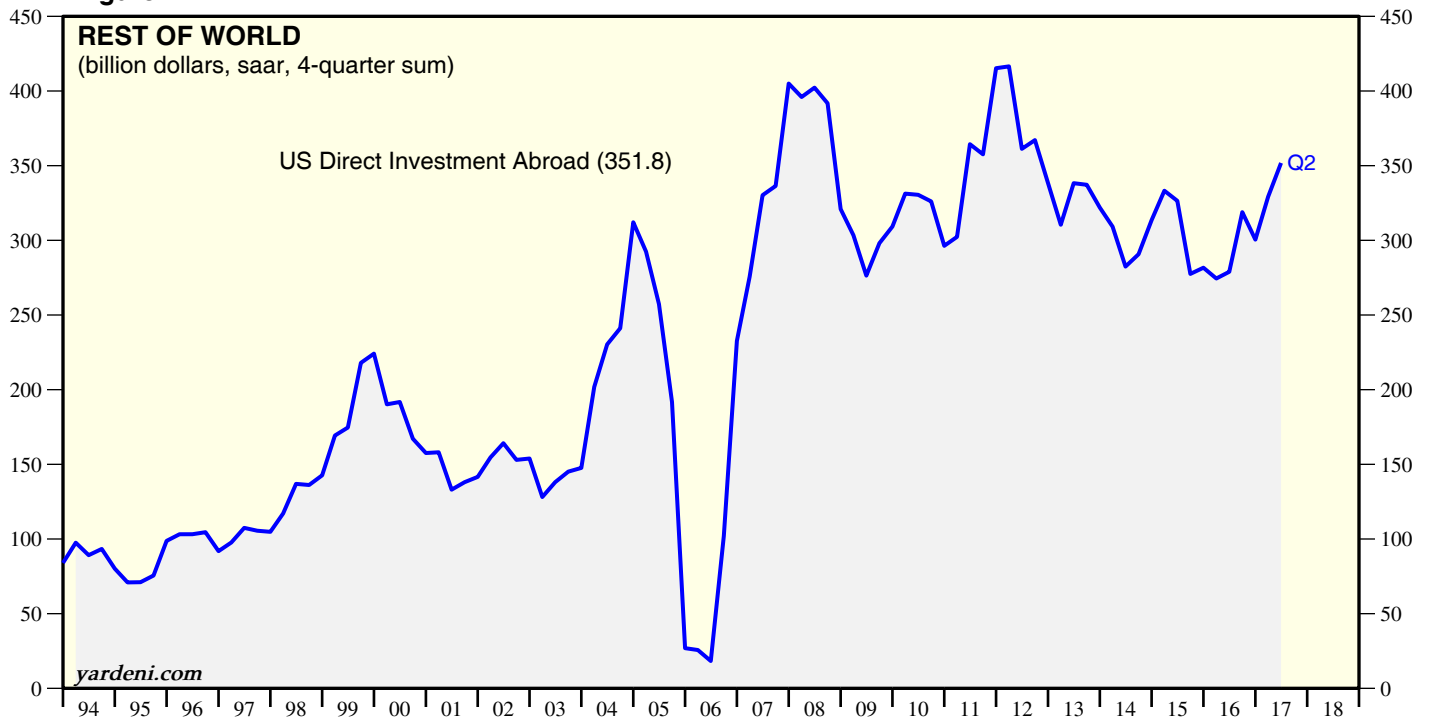
