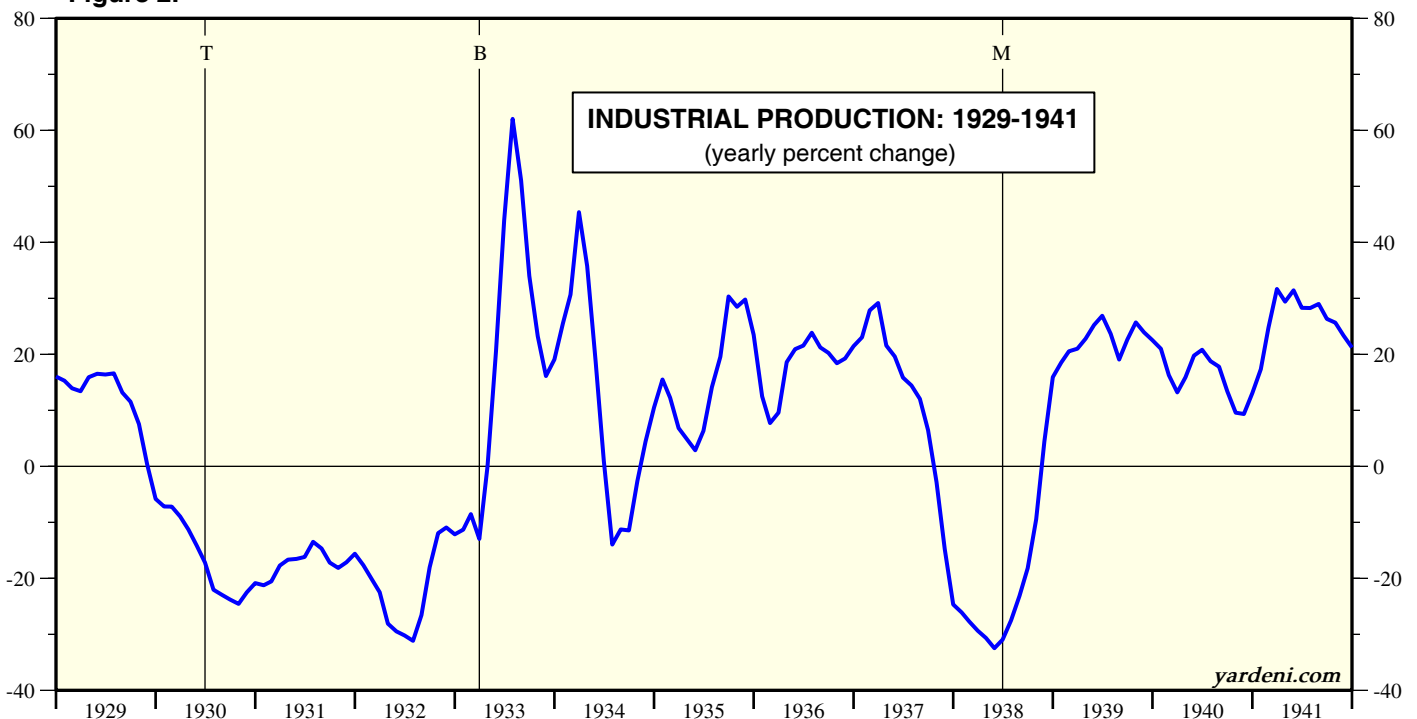

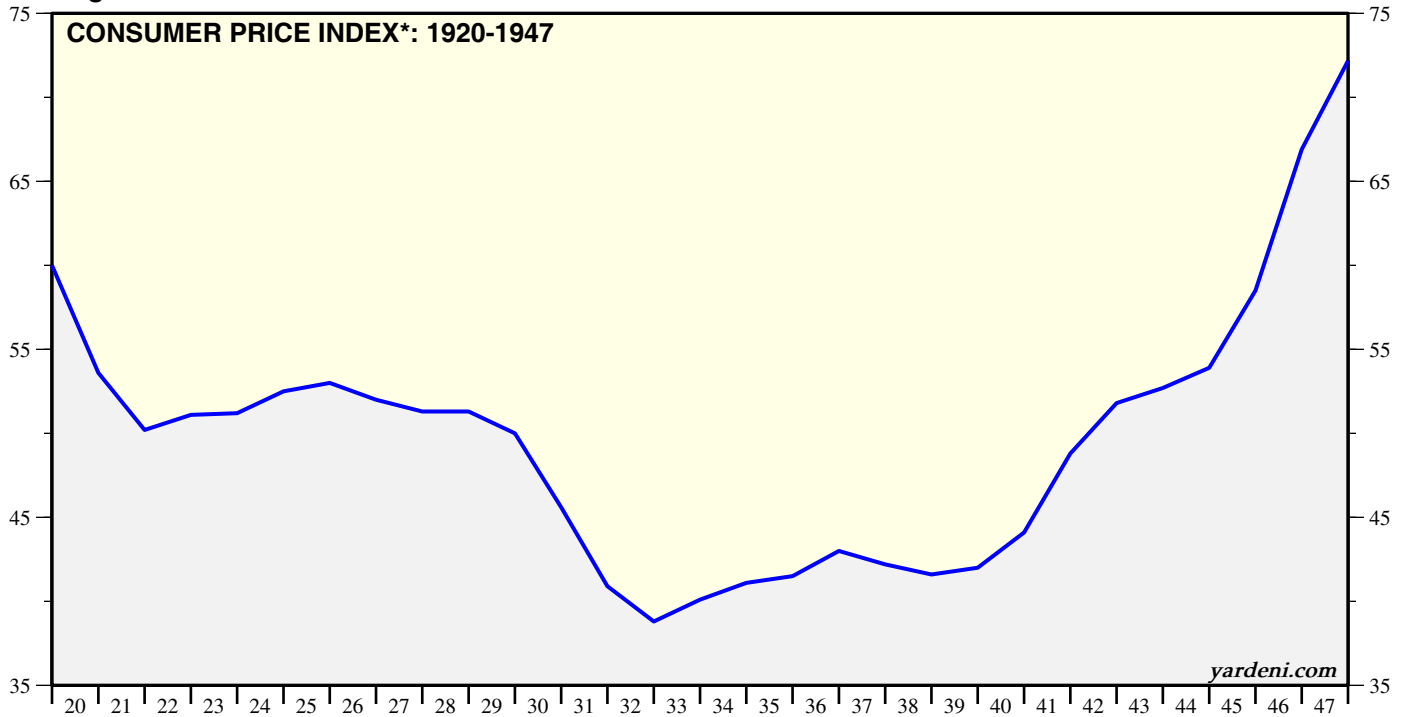

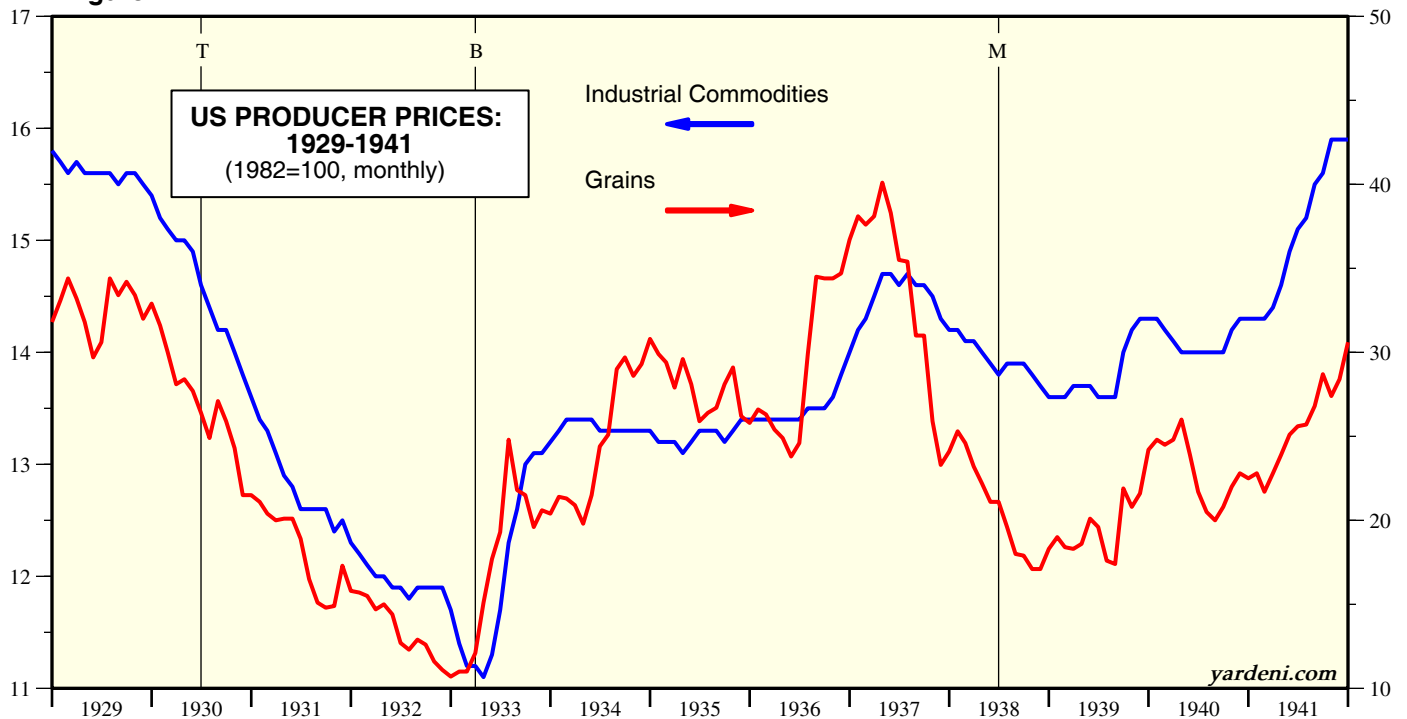

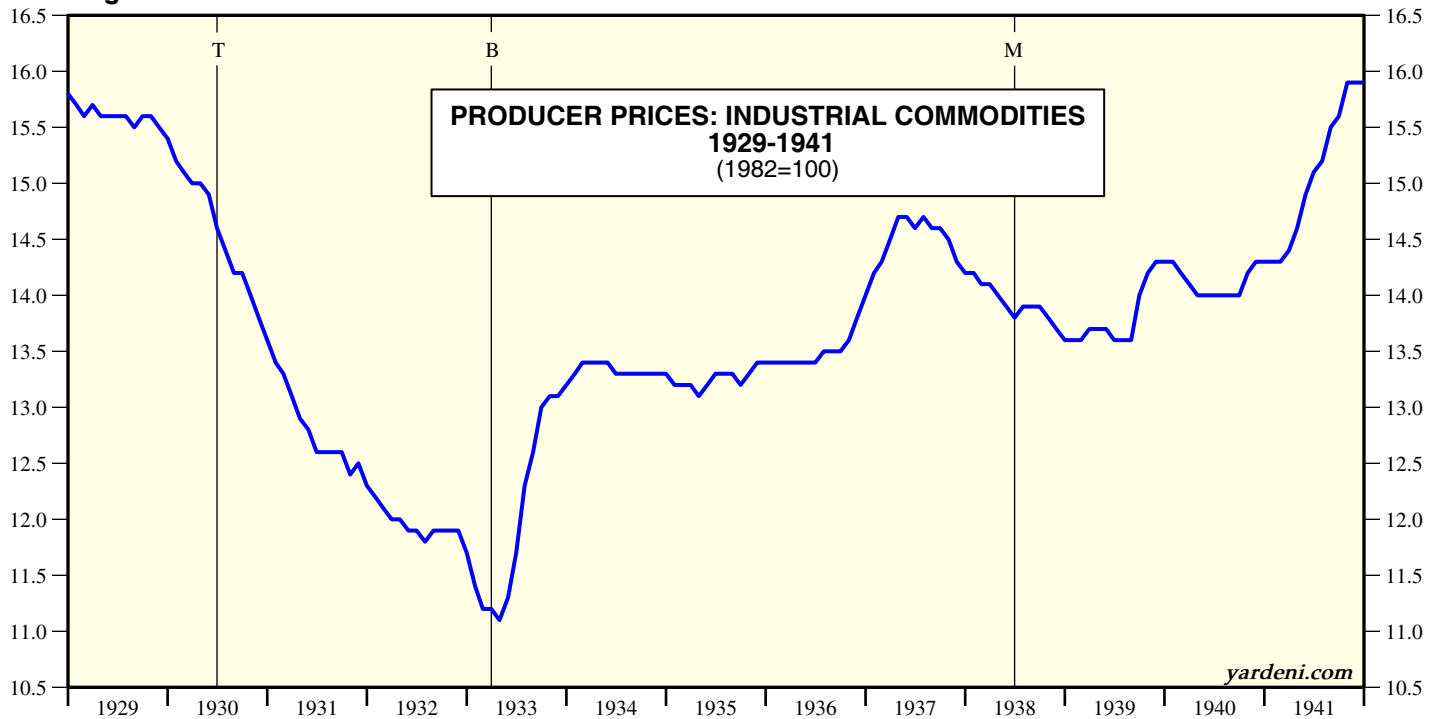

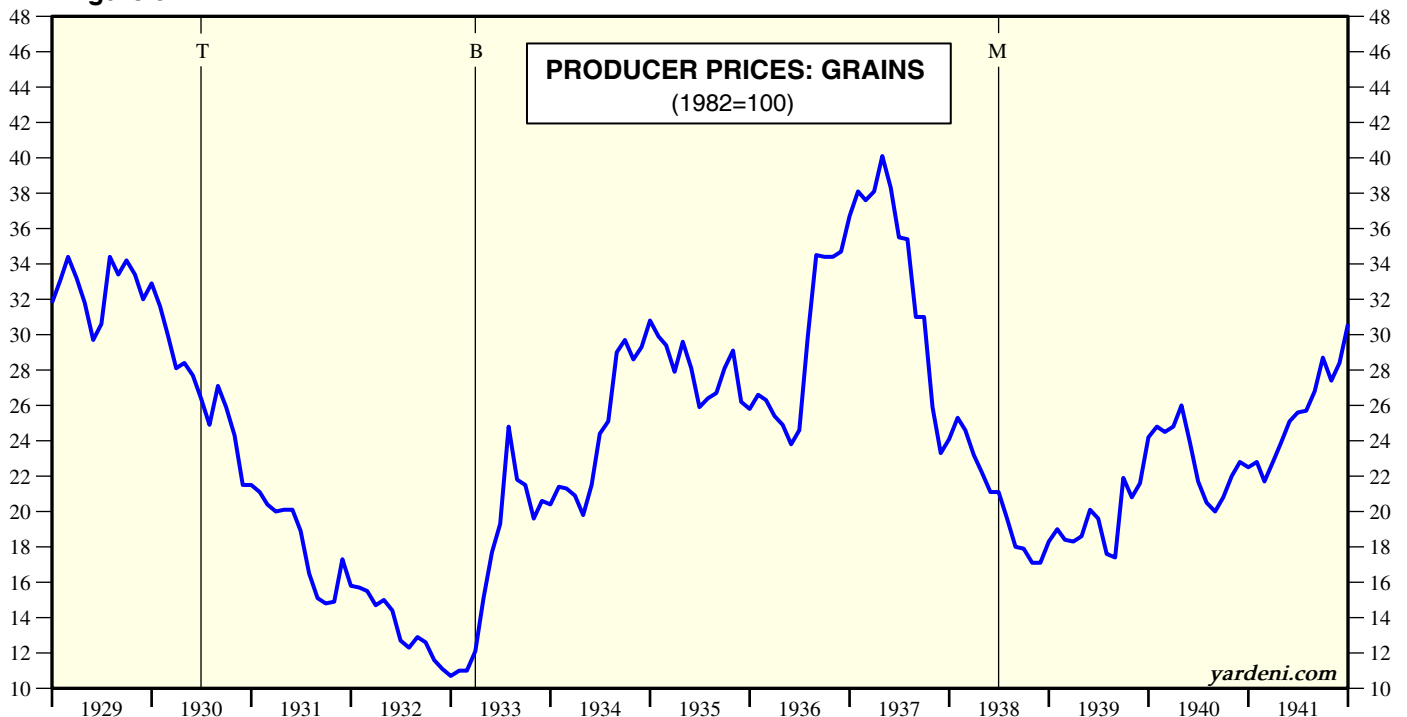

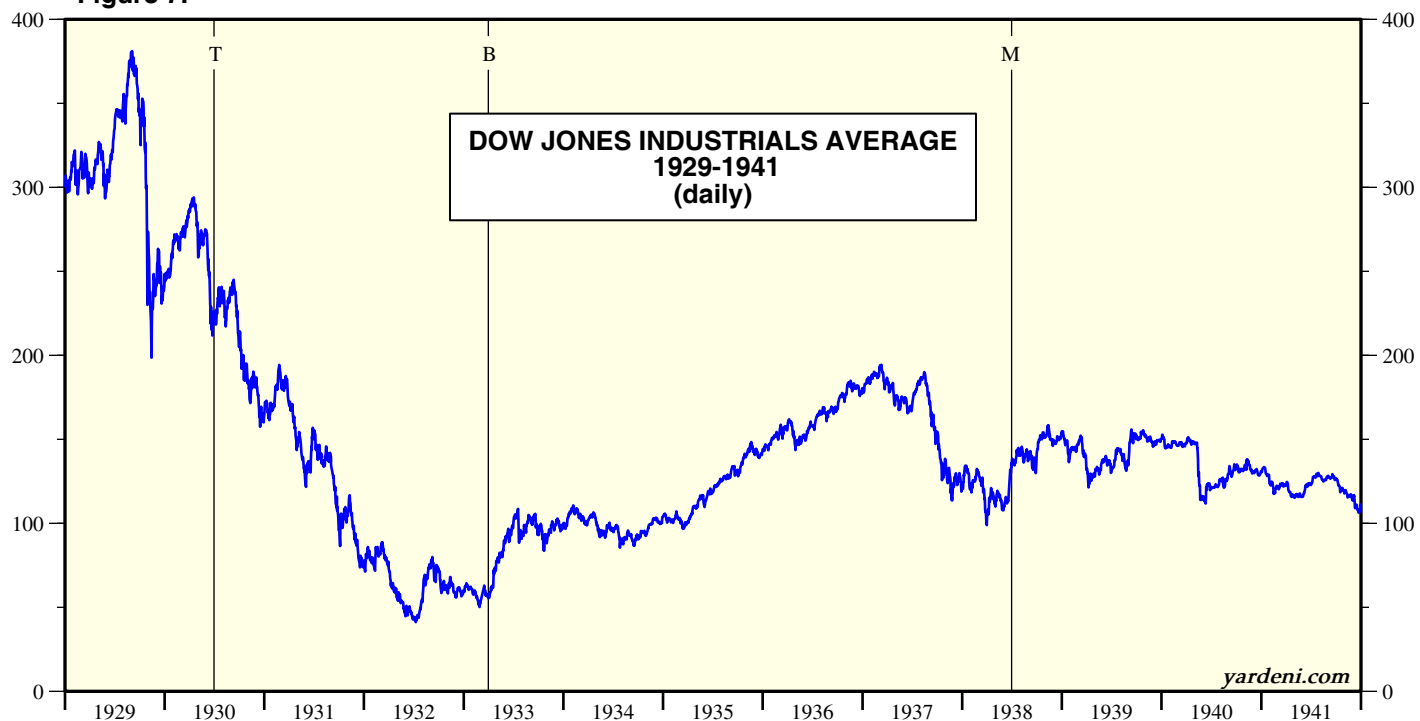

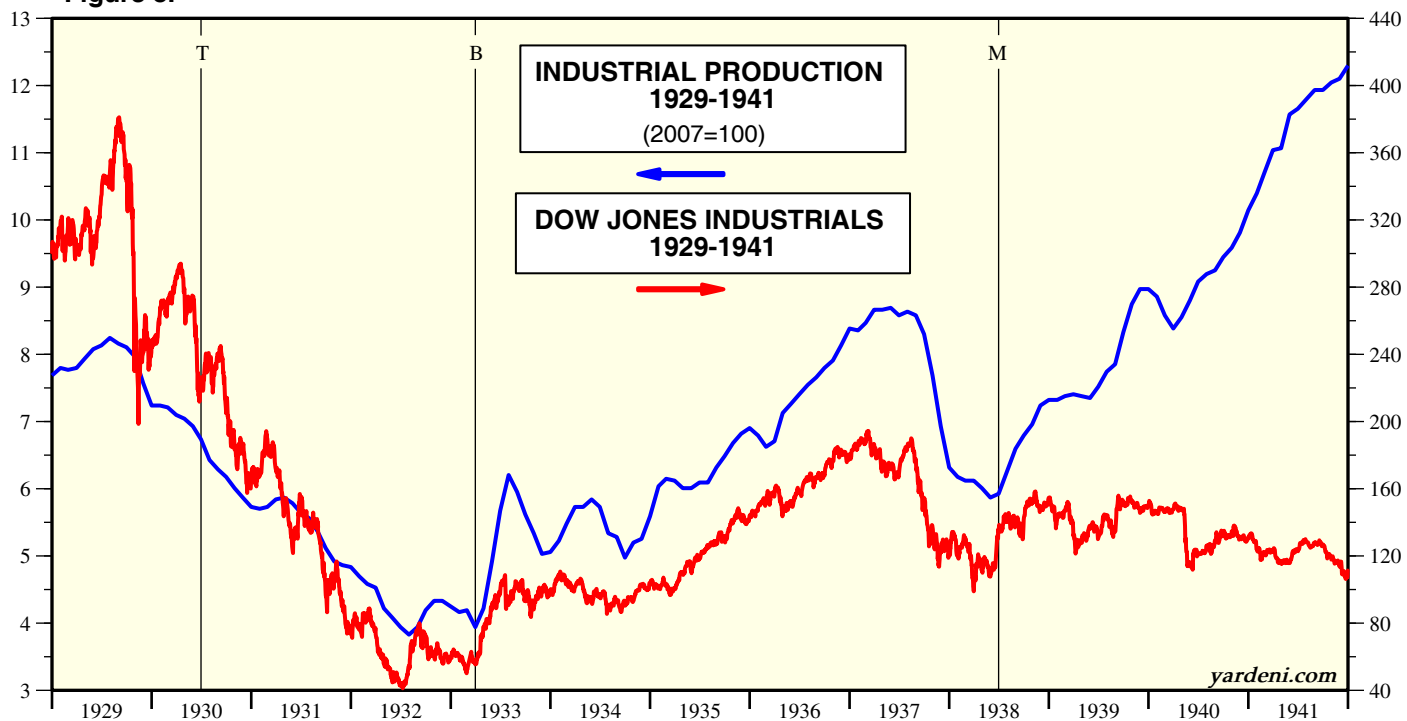

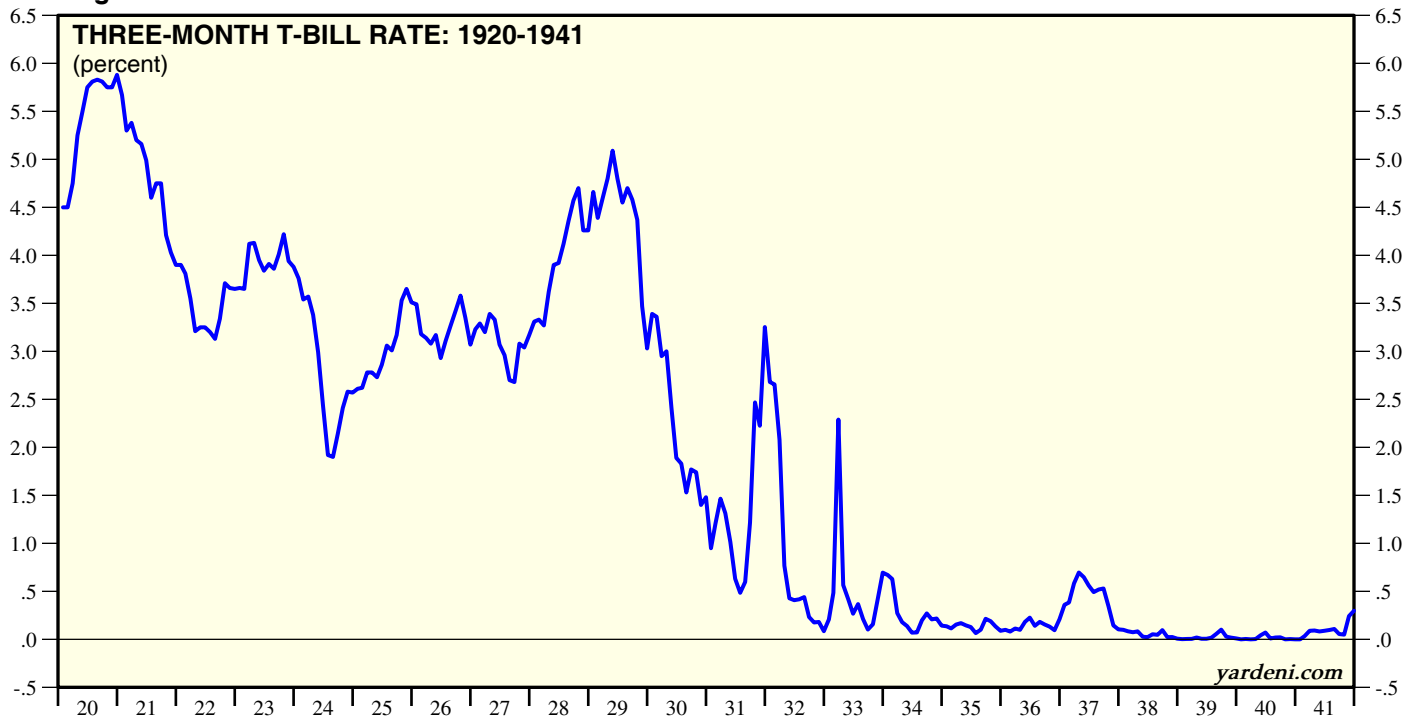

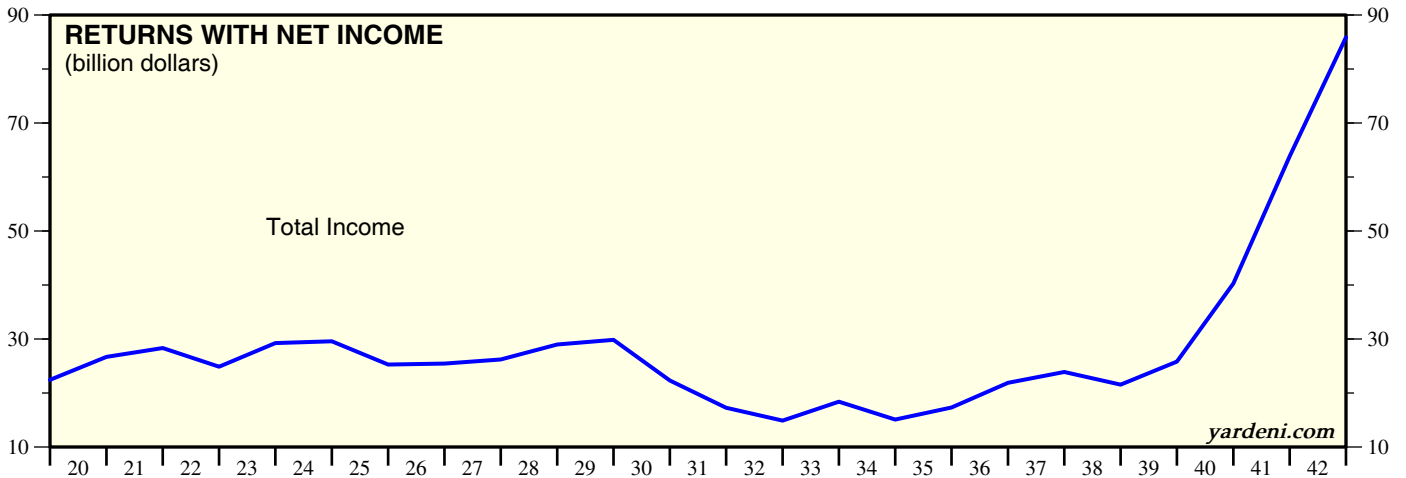
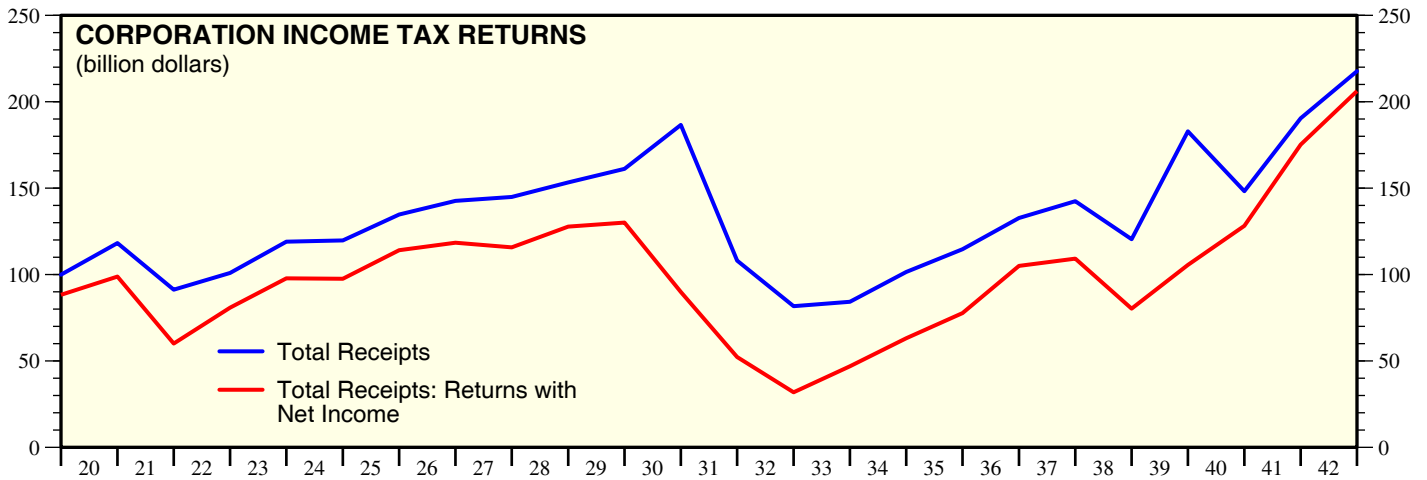
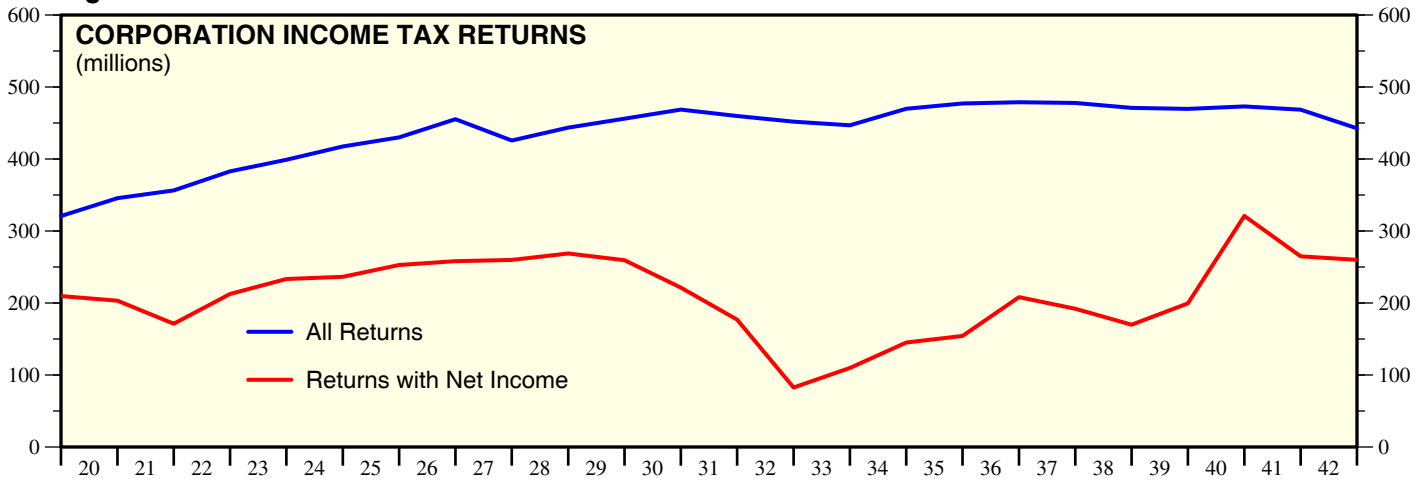

Income Tax Returns: 1920-1942

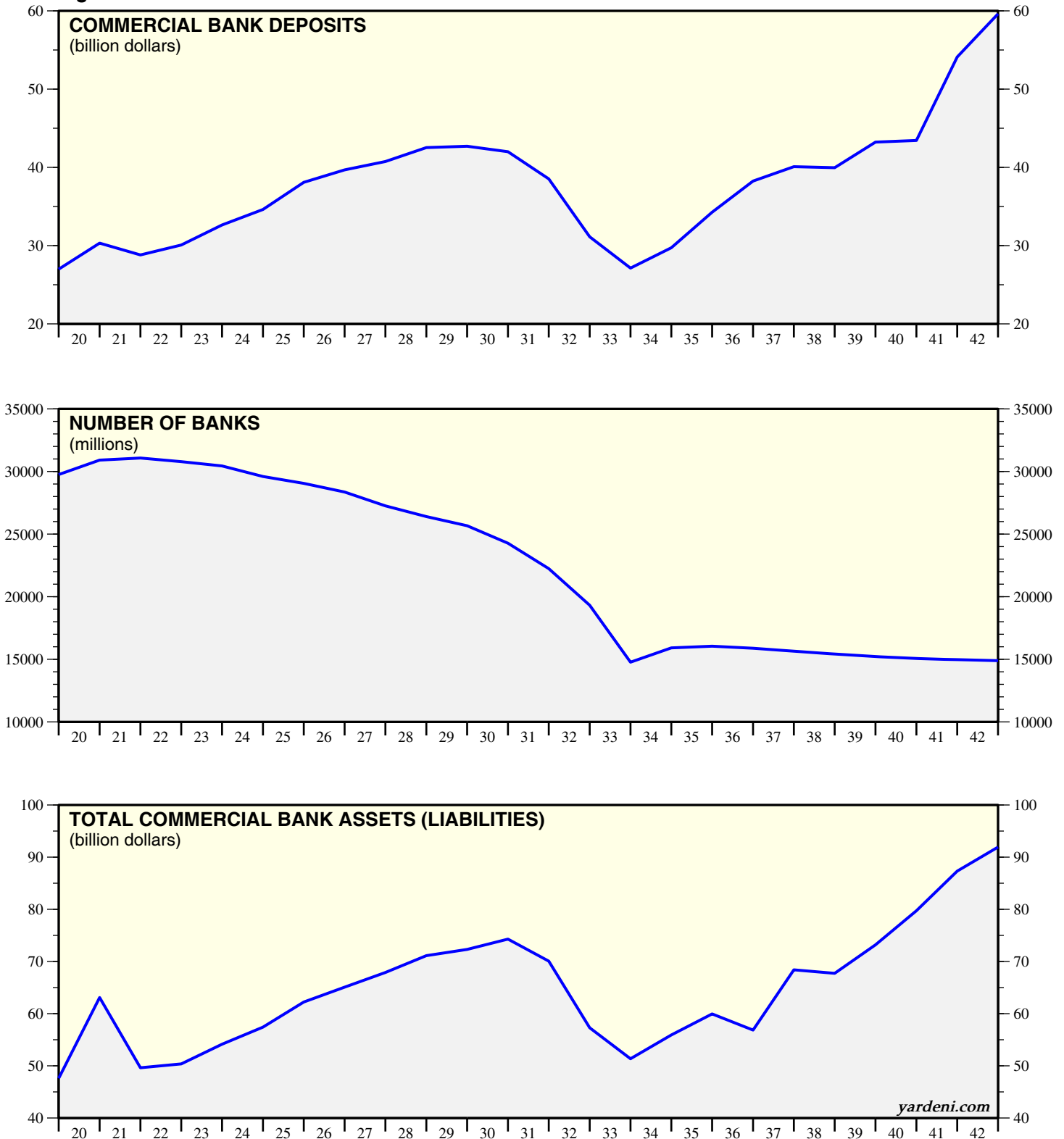

Bank Deposits & Assets: 1920-1942

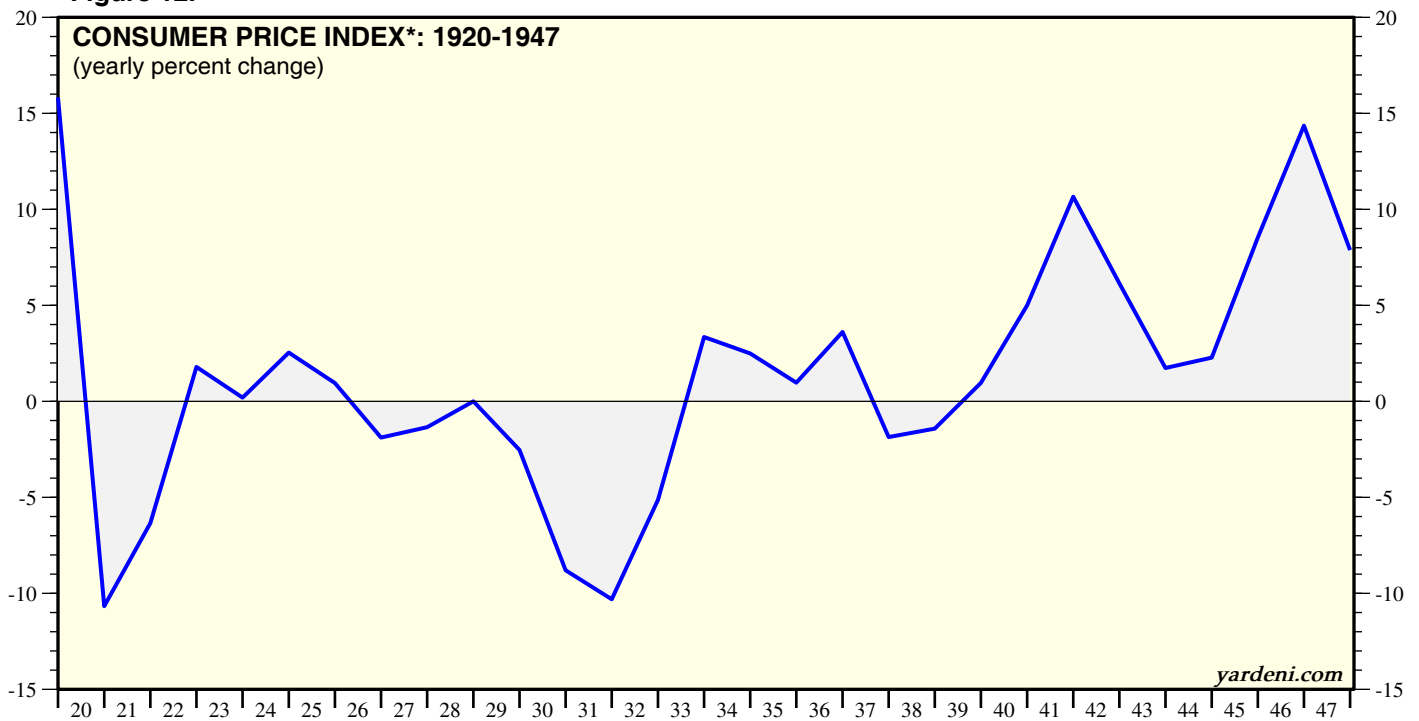

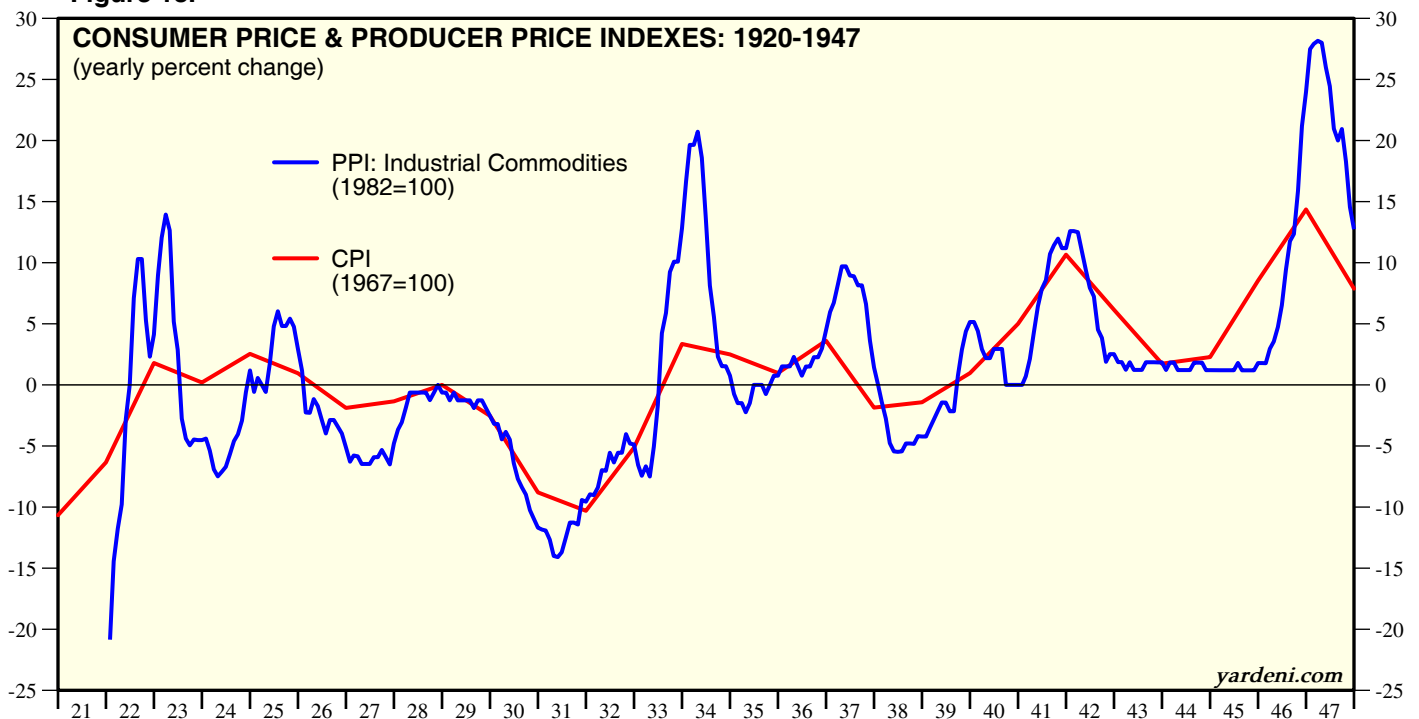

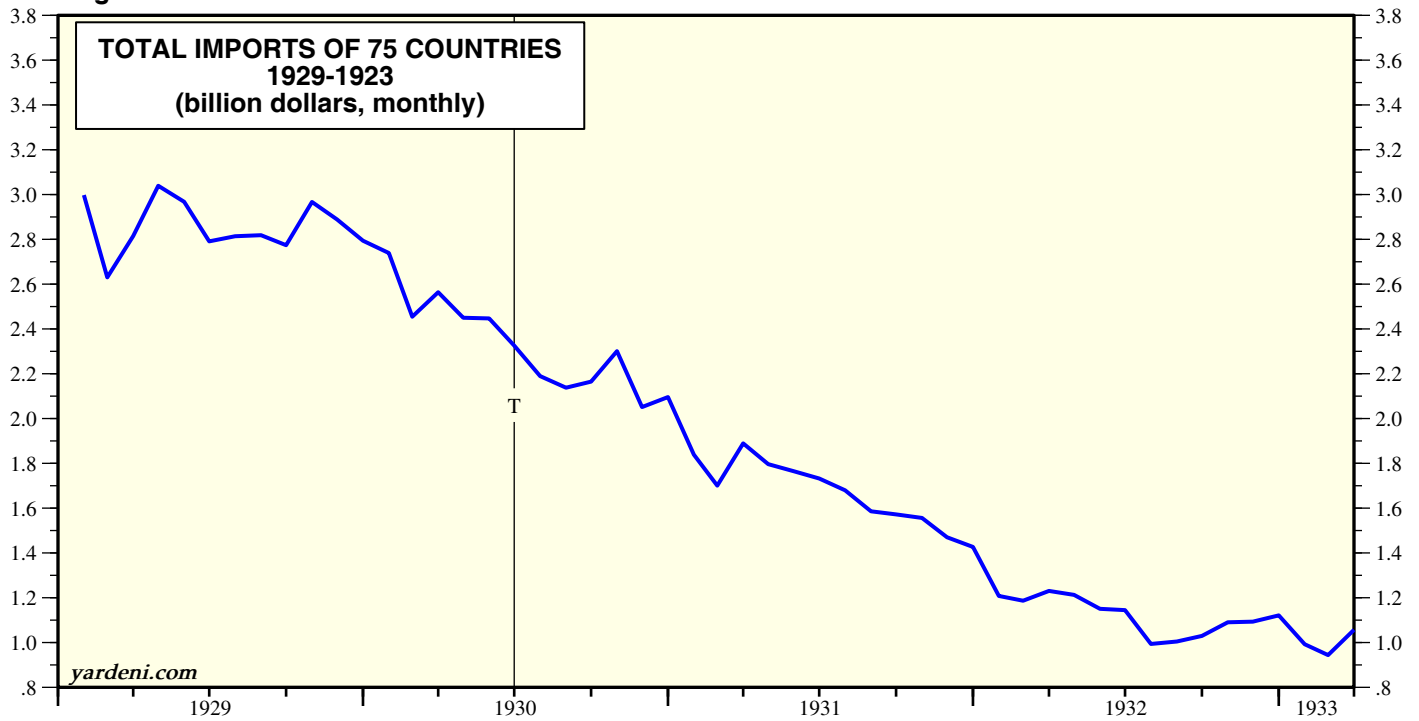

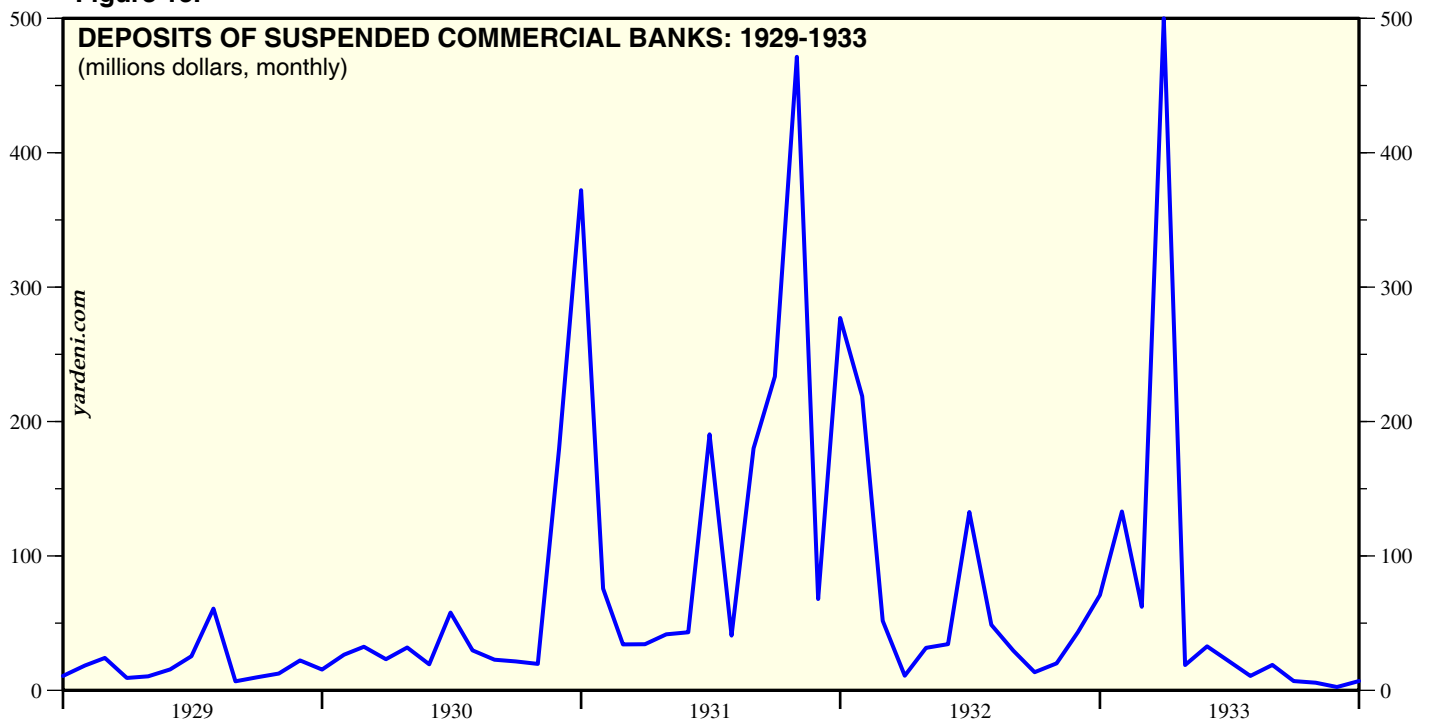

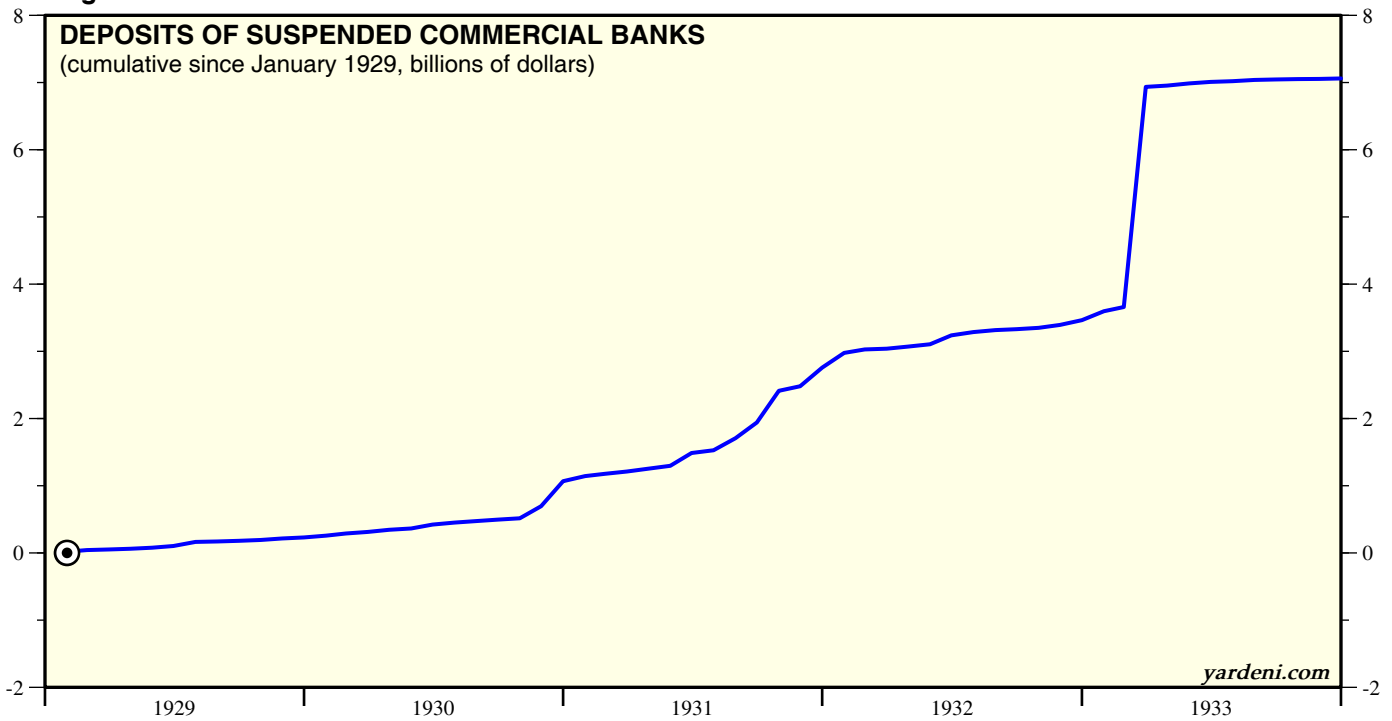

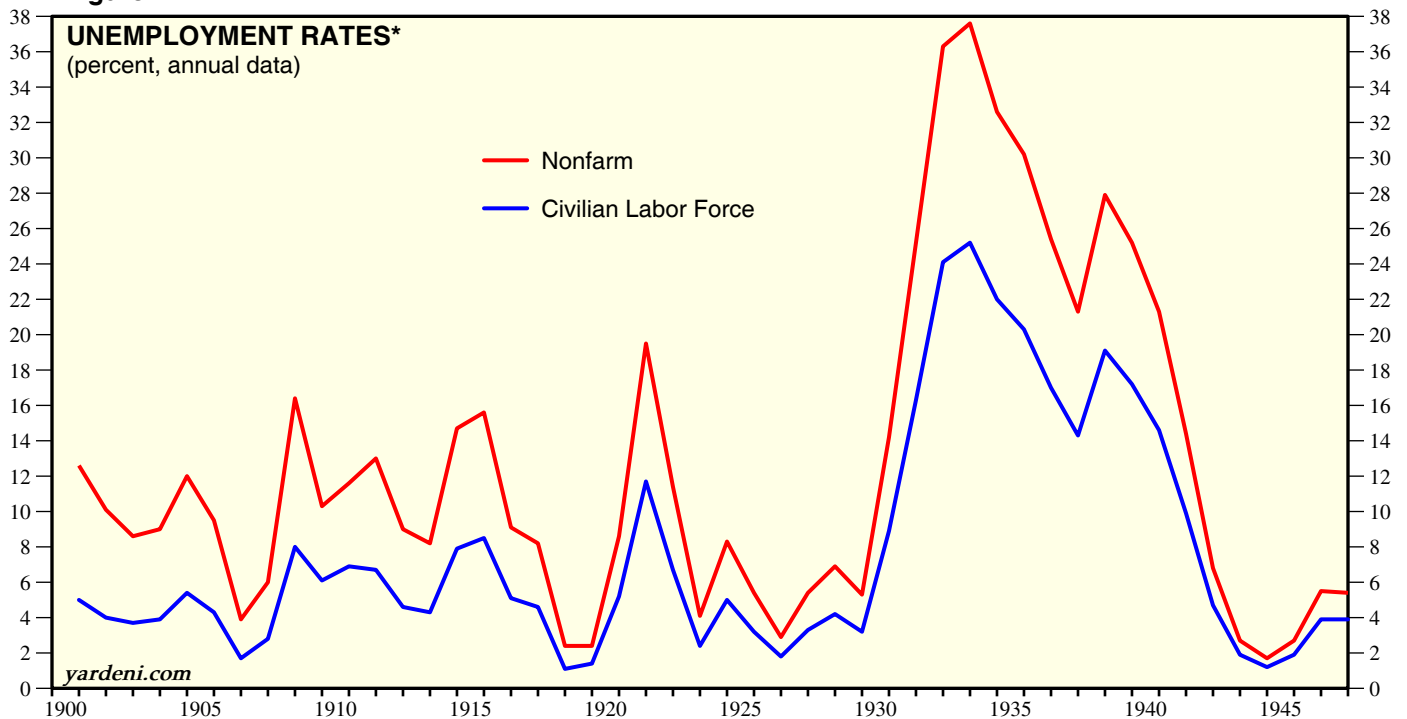
