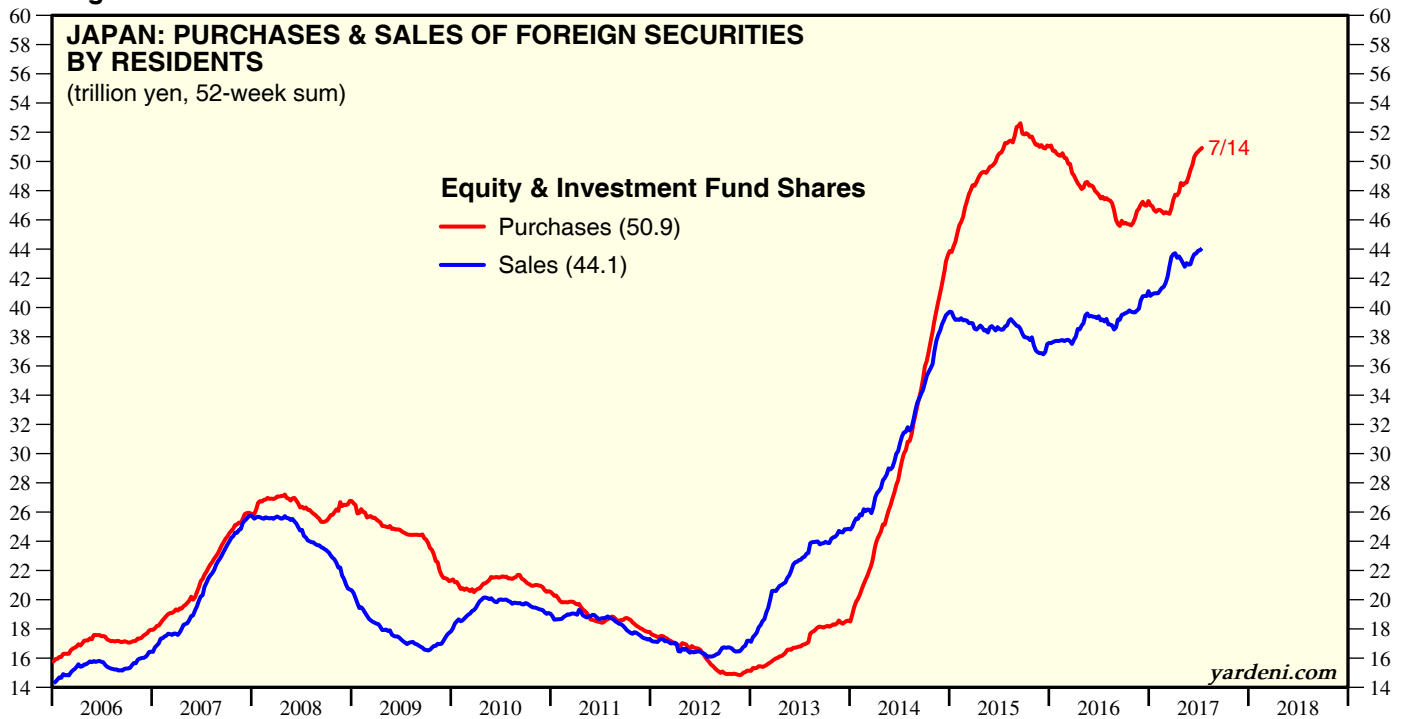

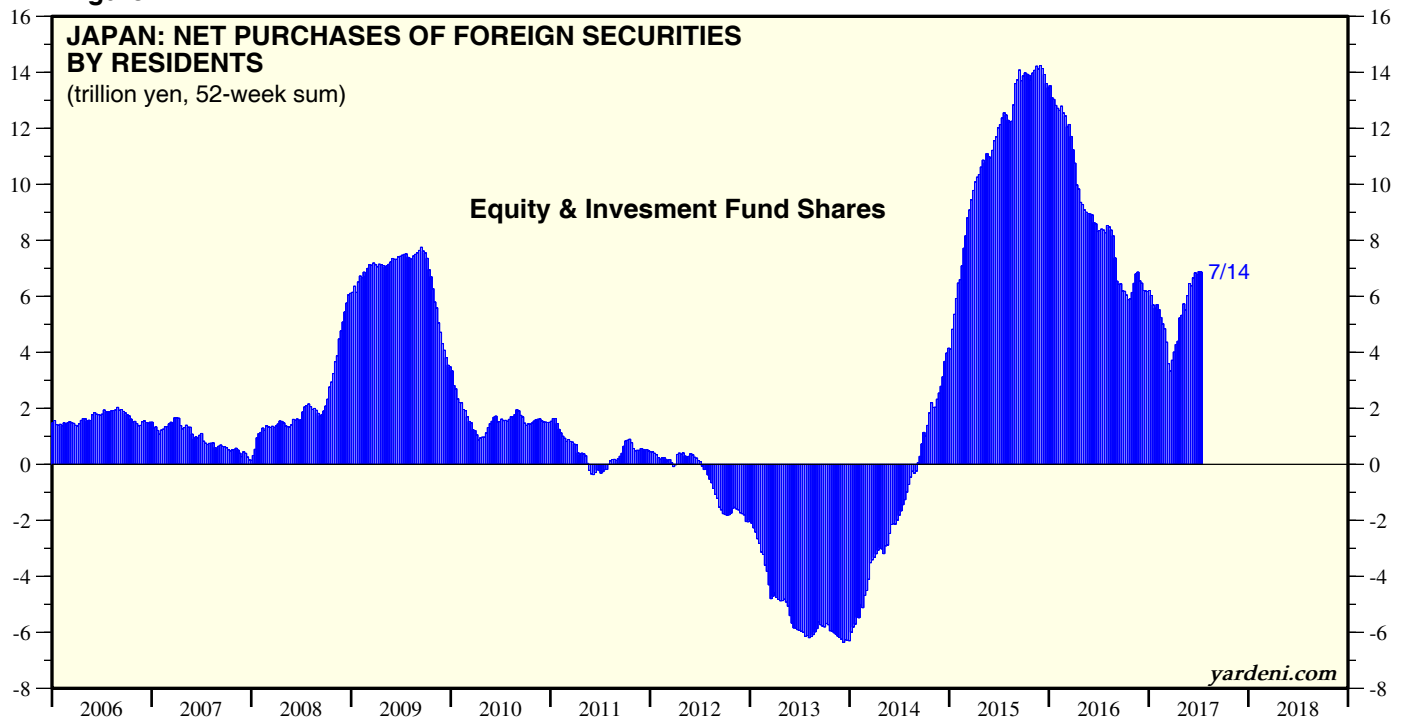

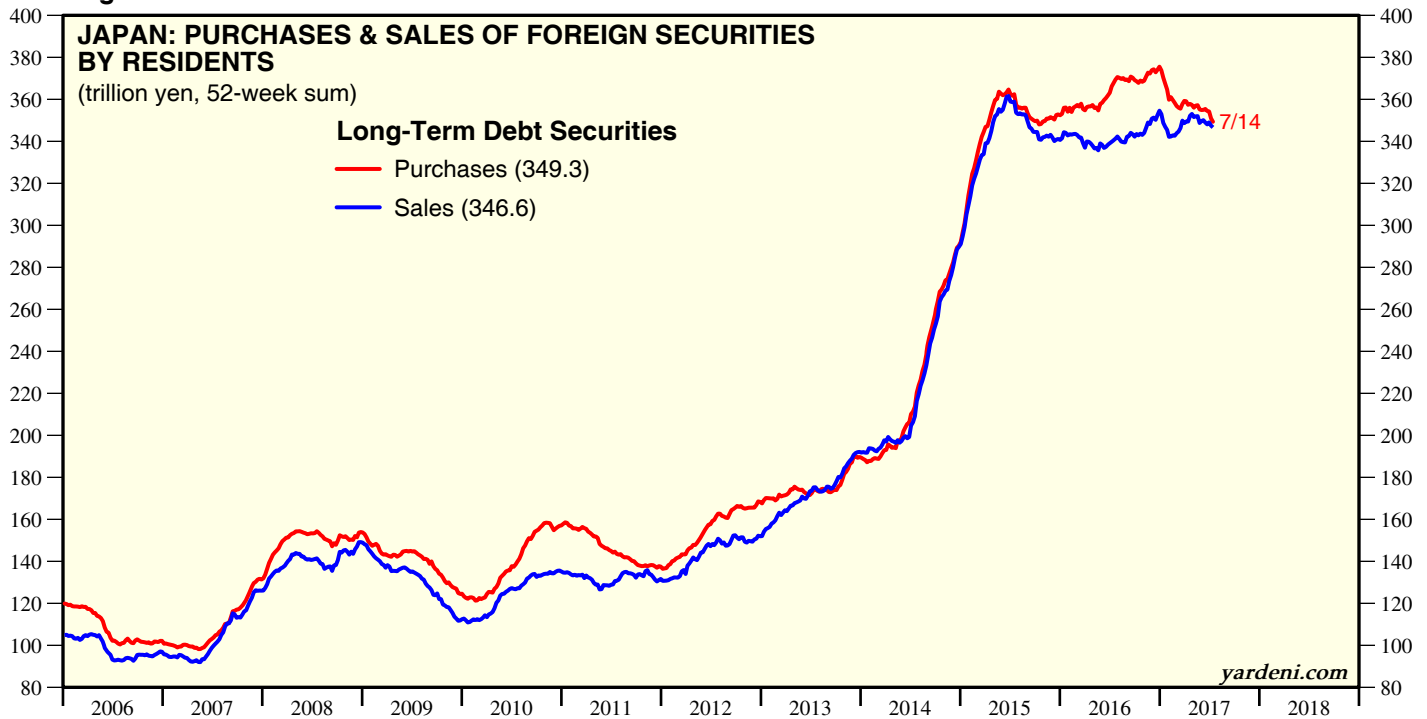

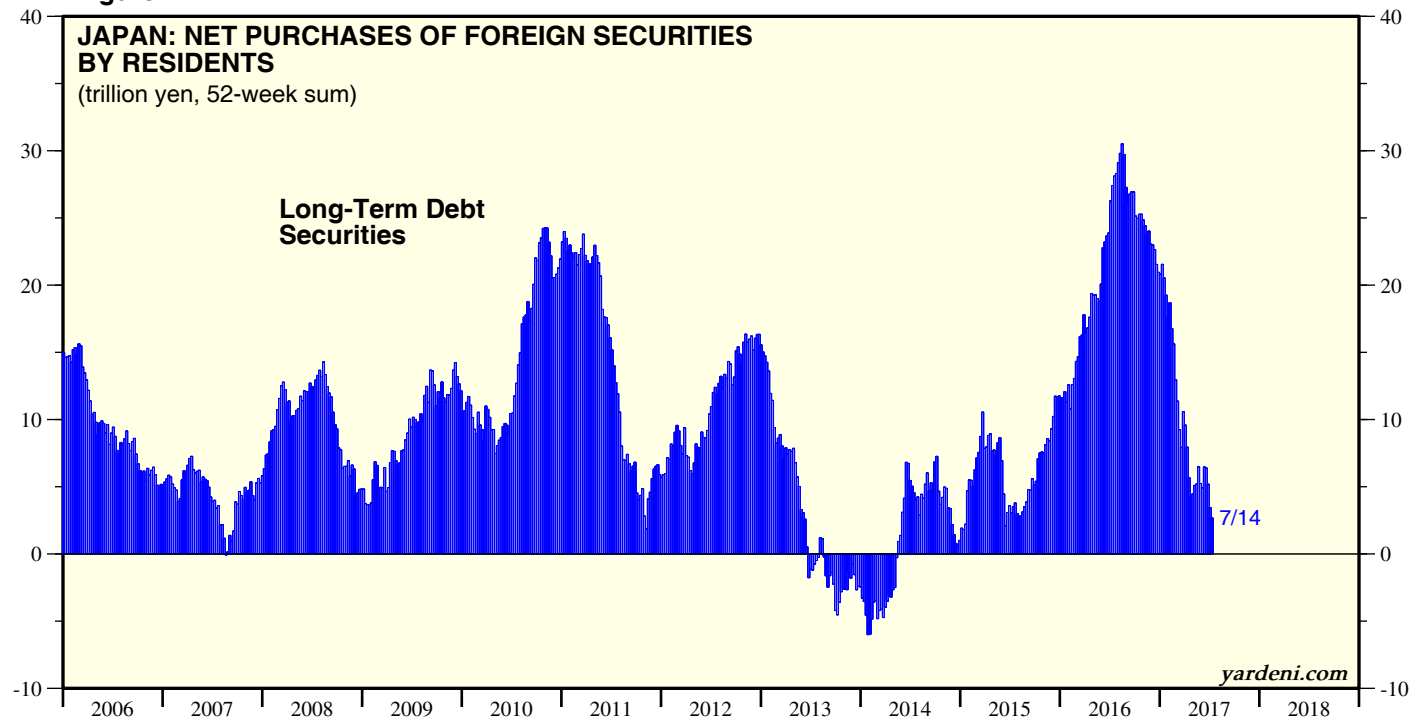

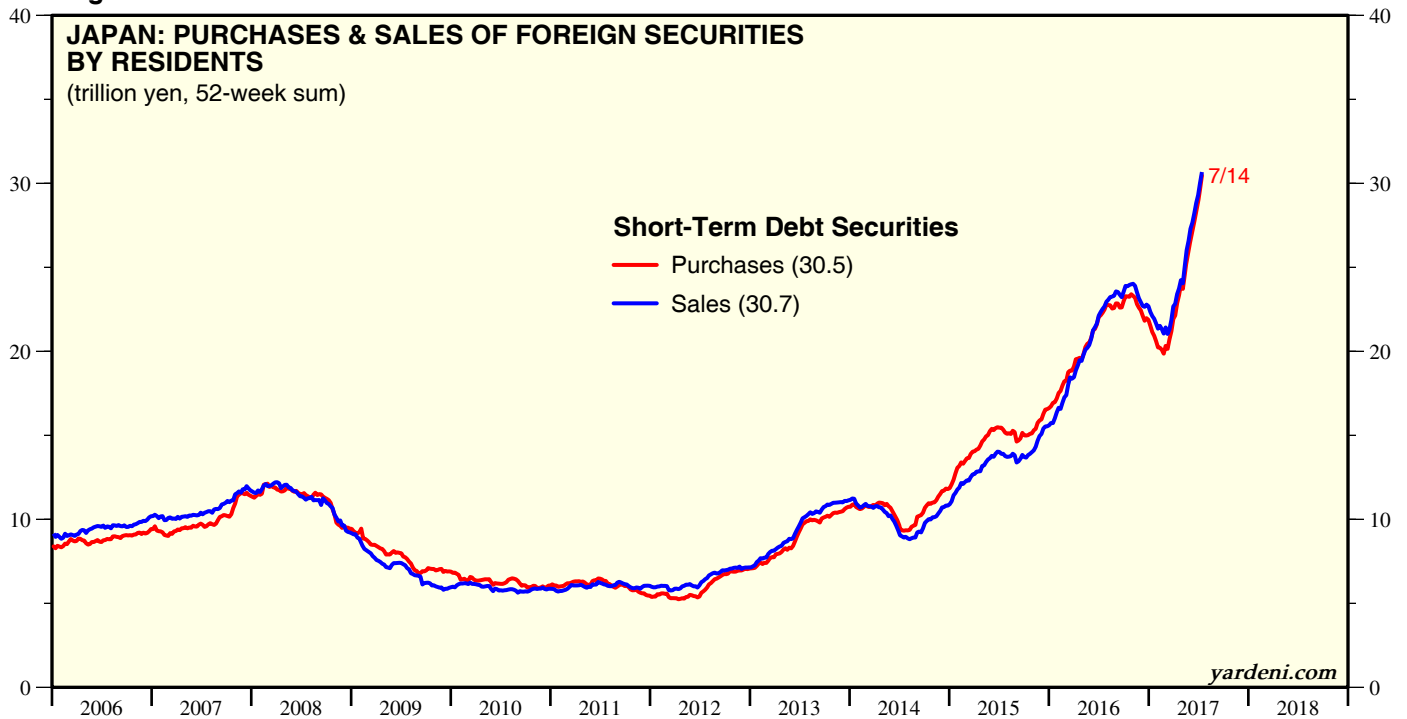

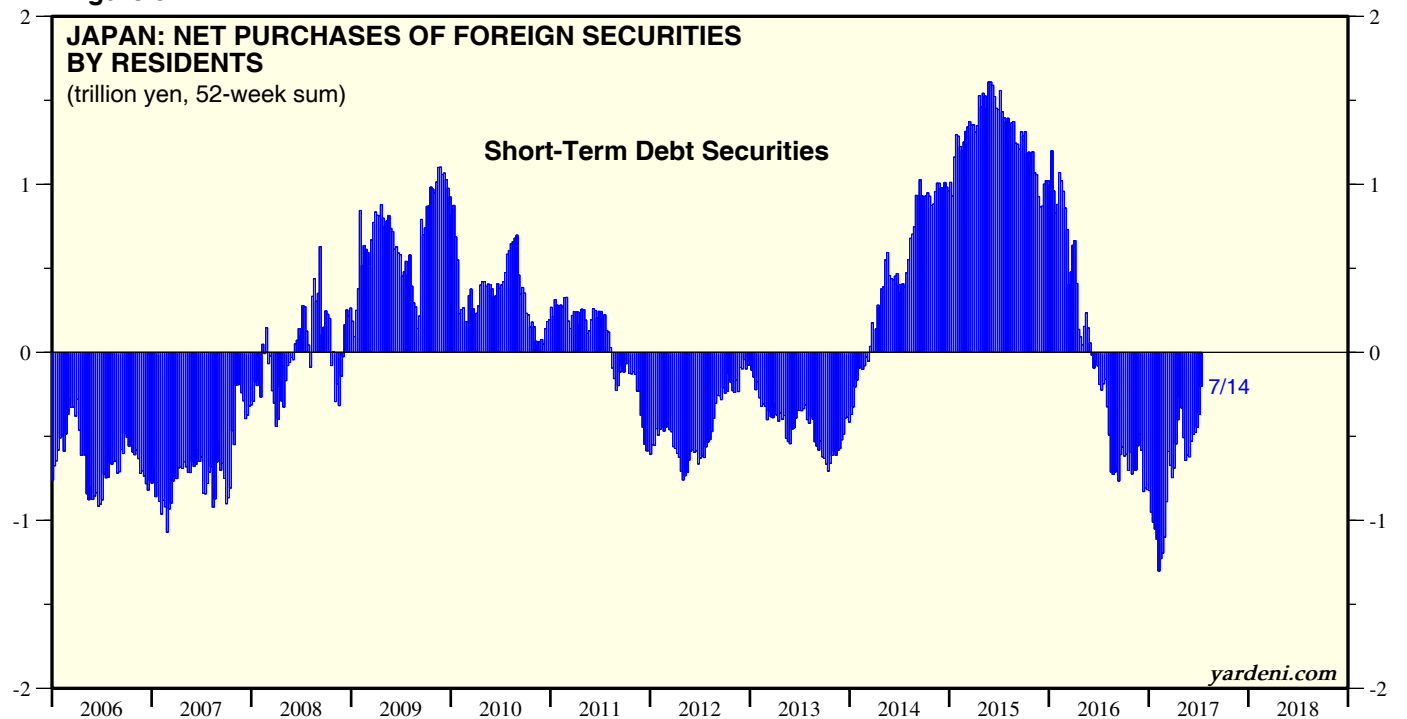

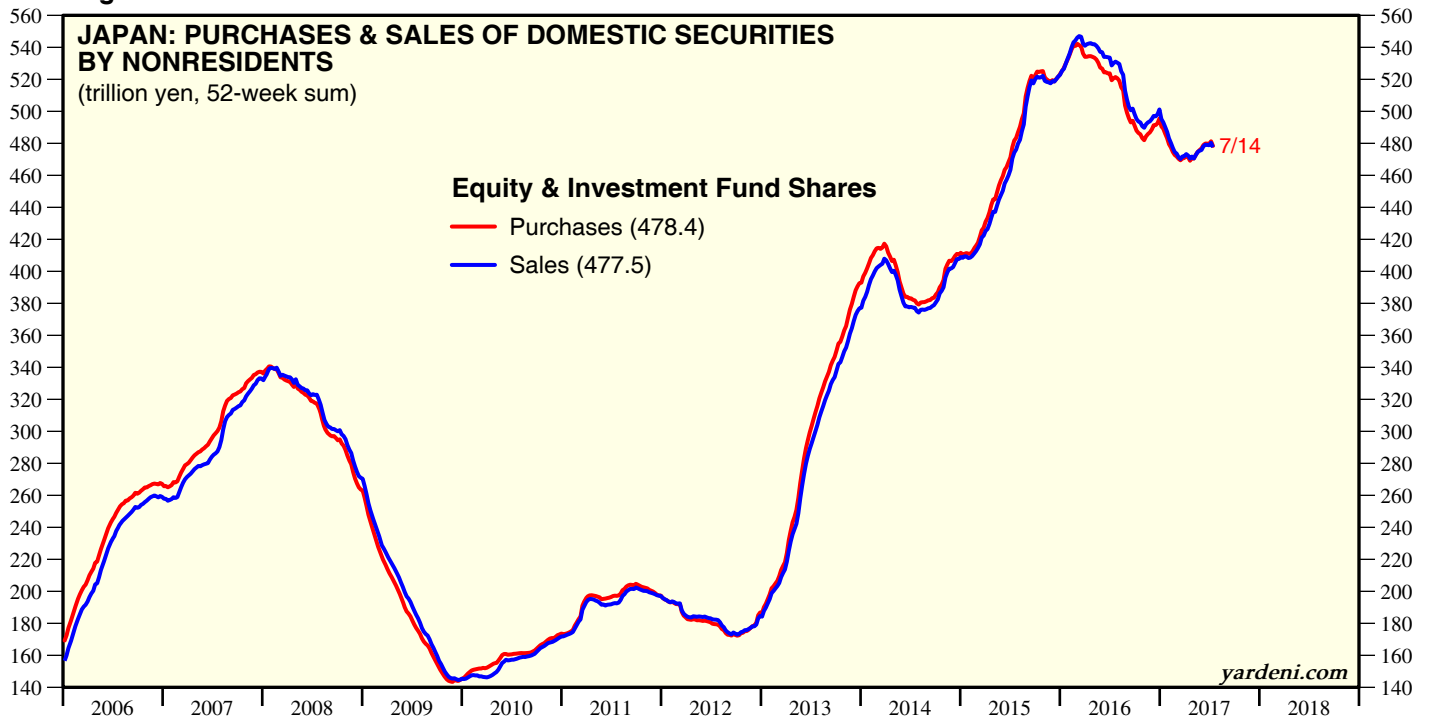

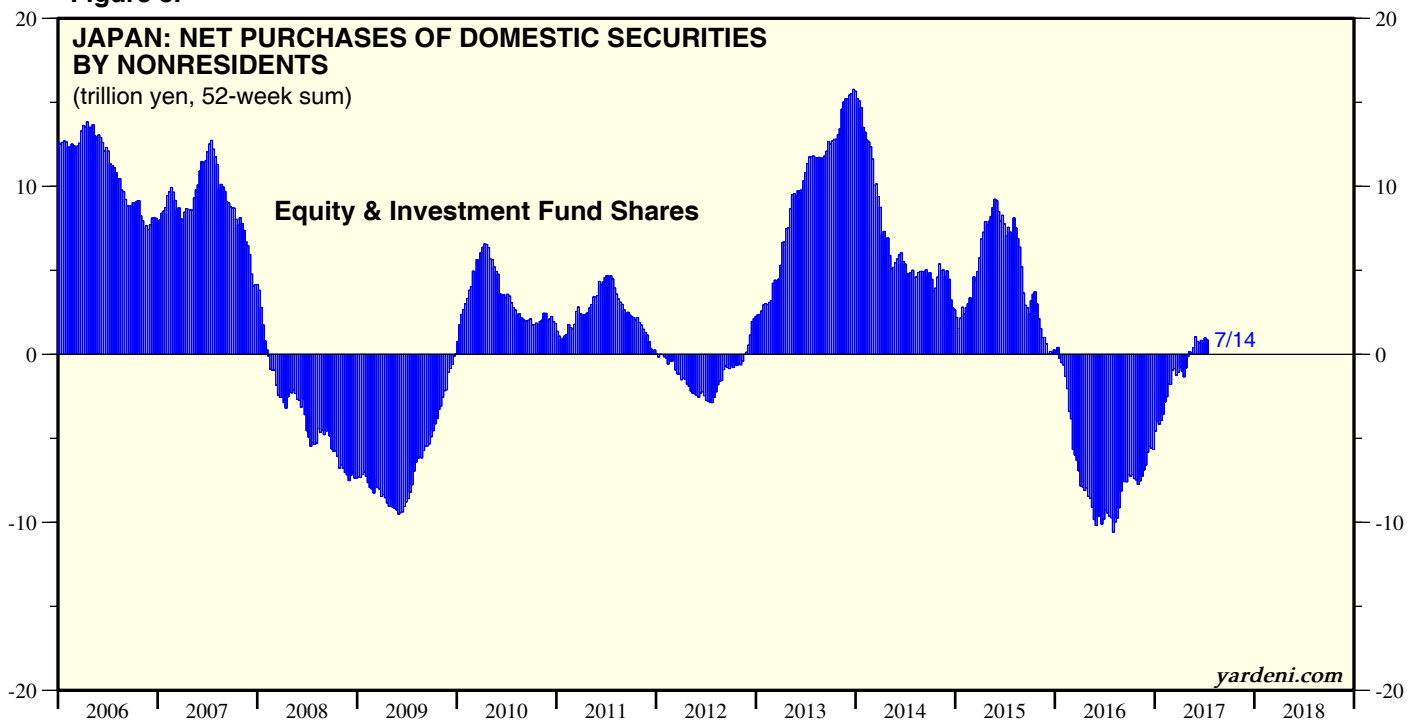
Purchases & Sales of Domestic Securities

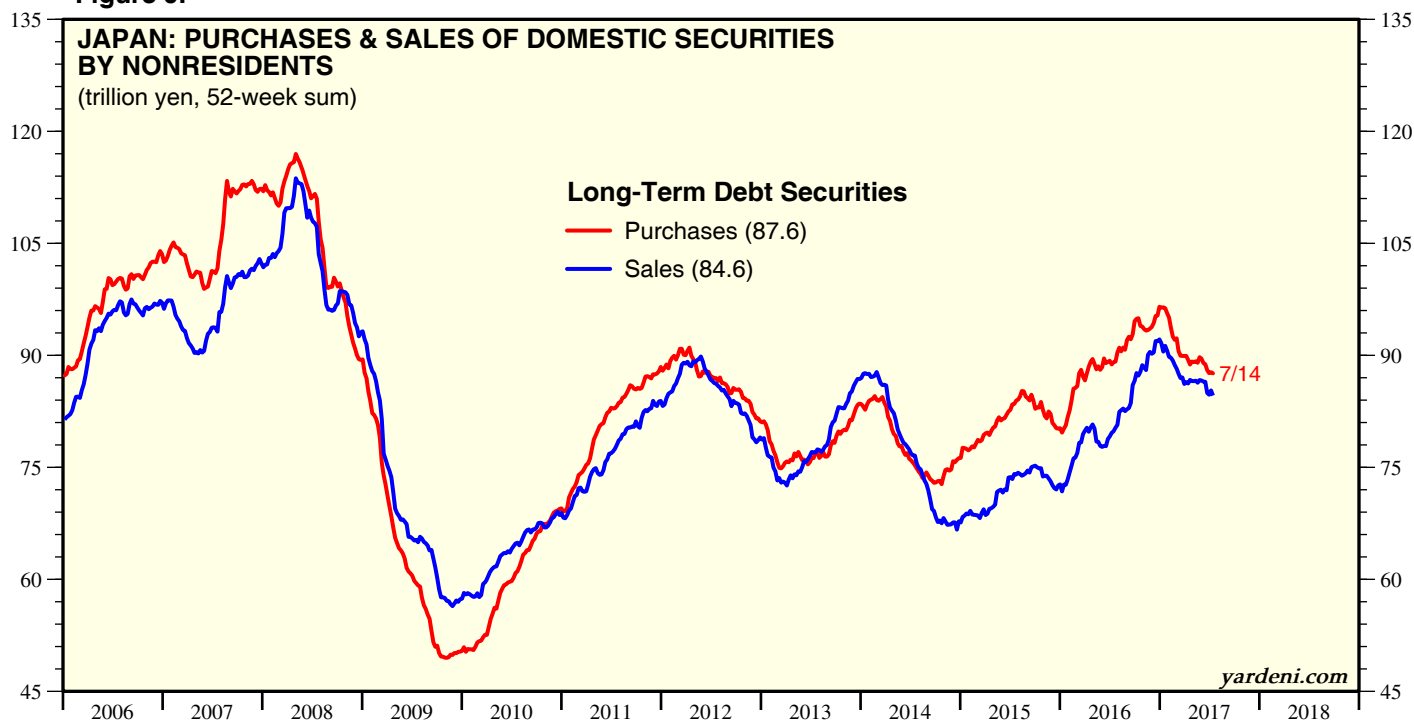

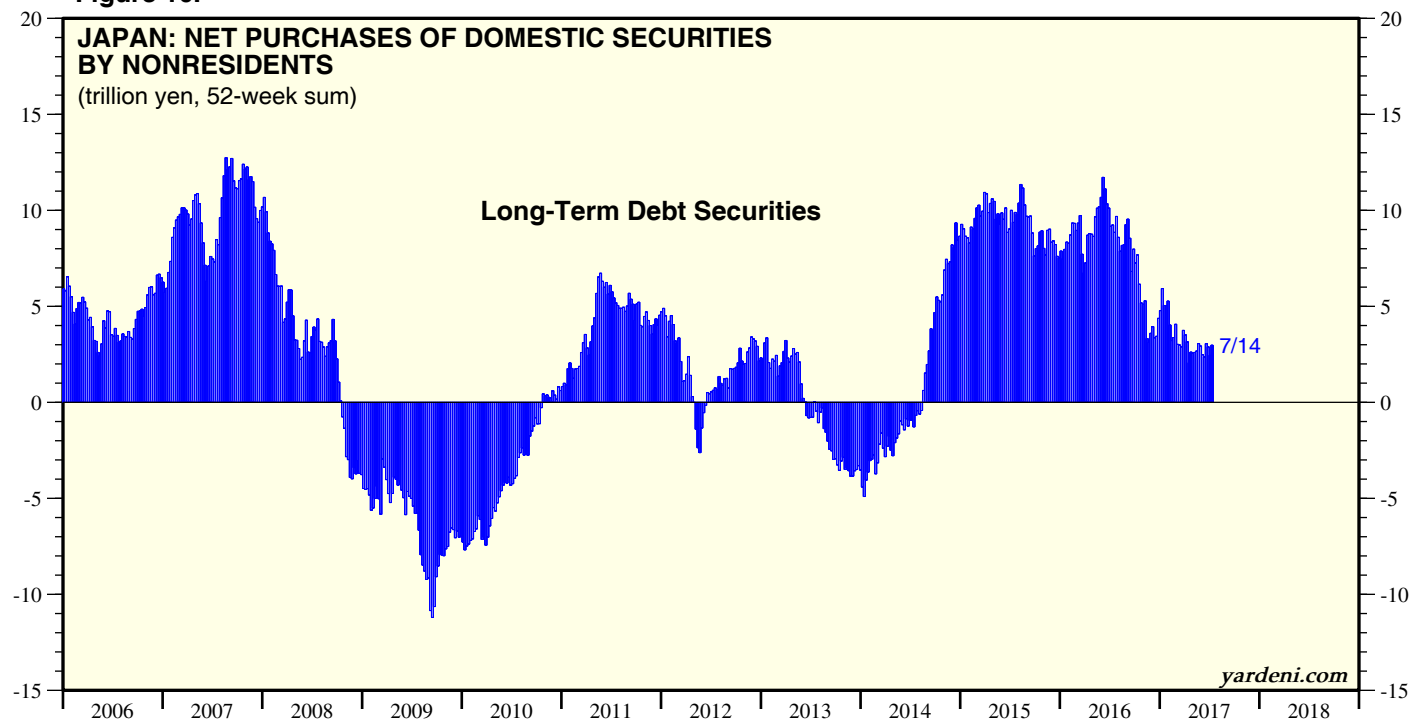

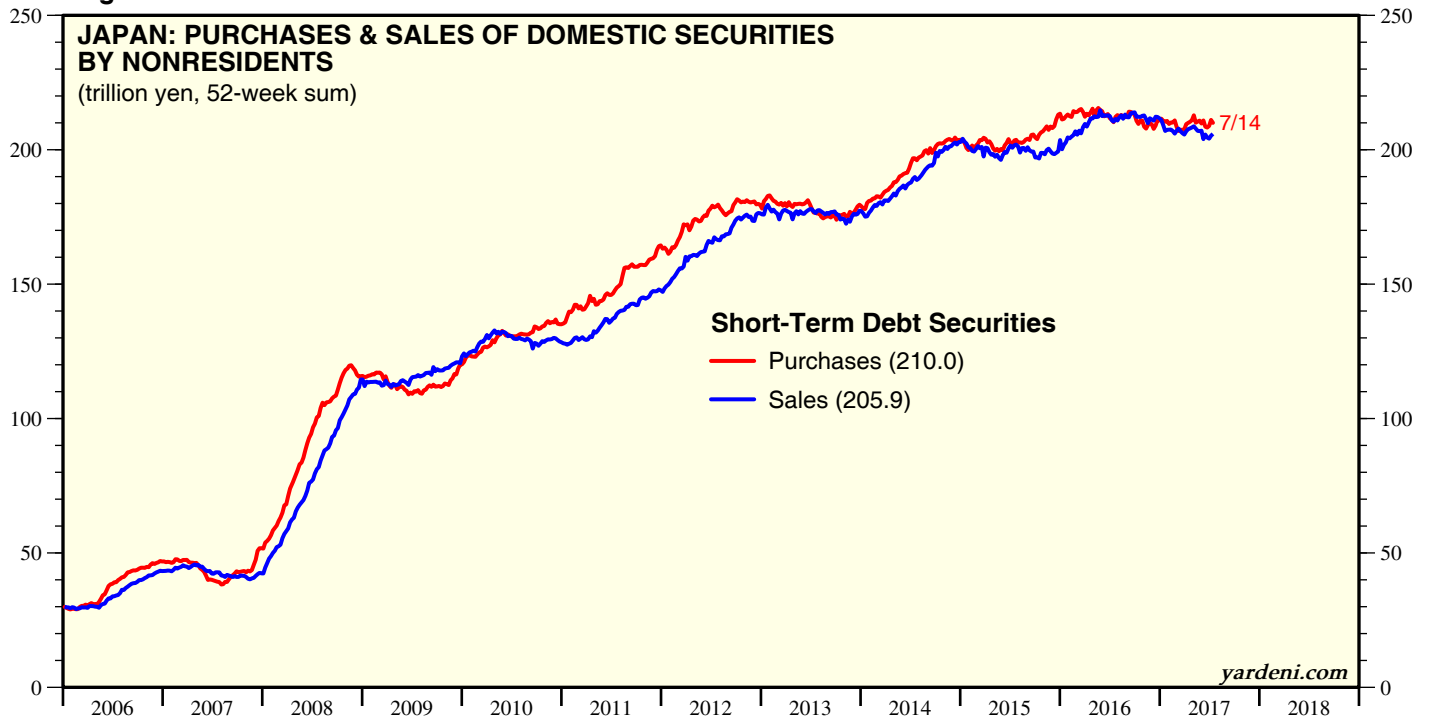

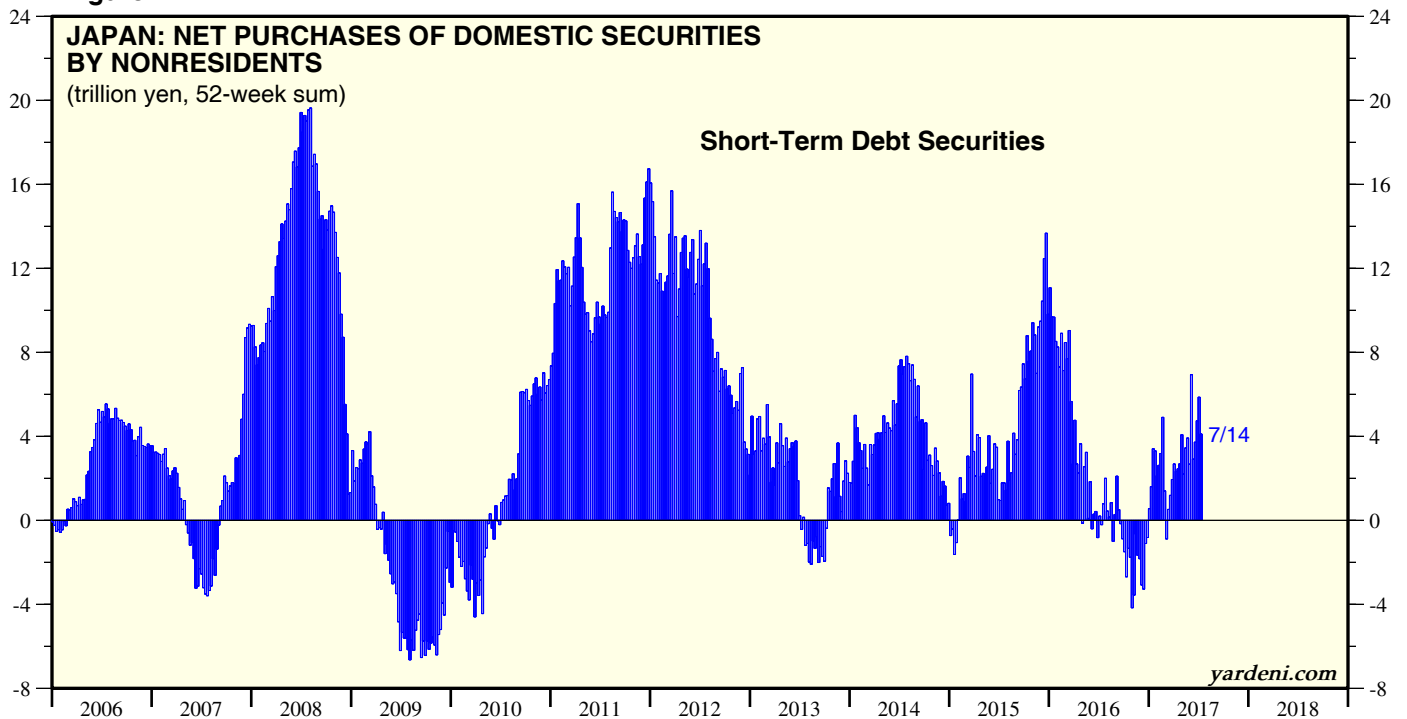
