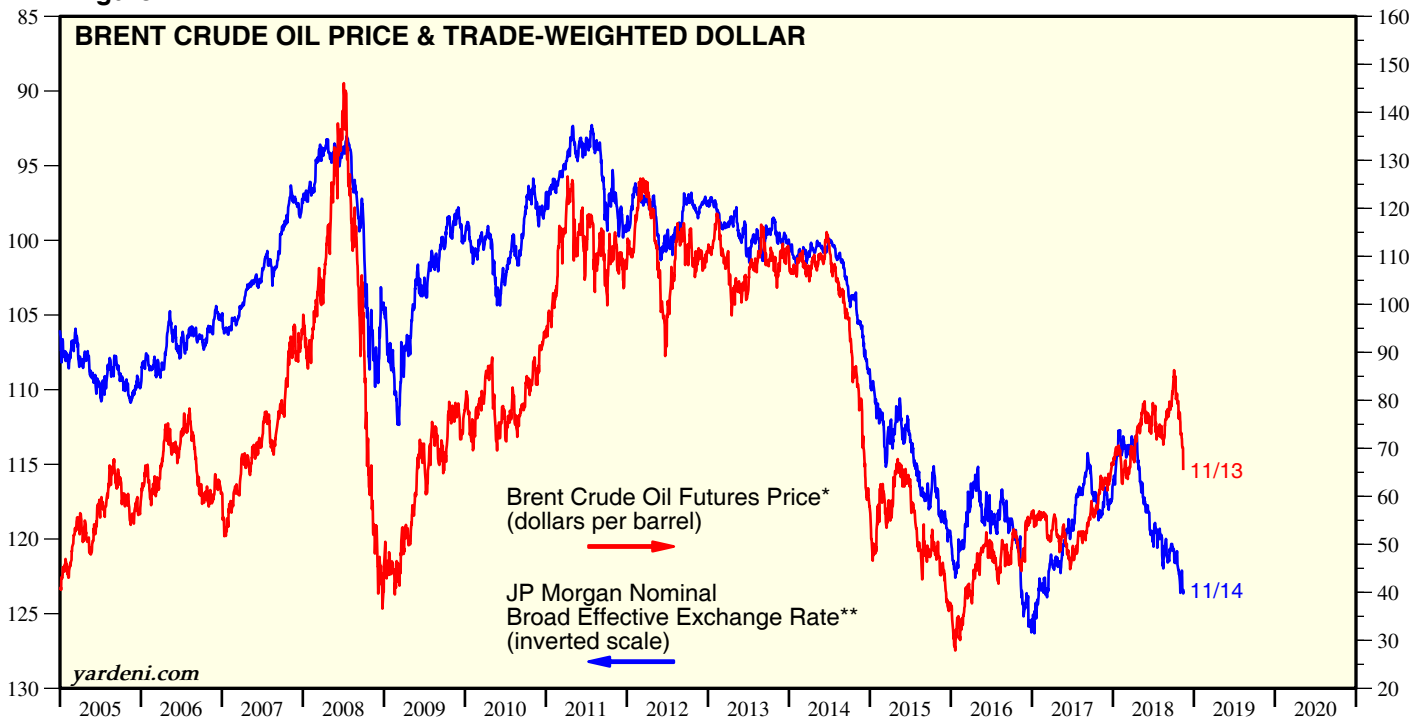

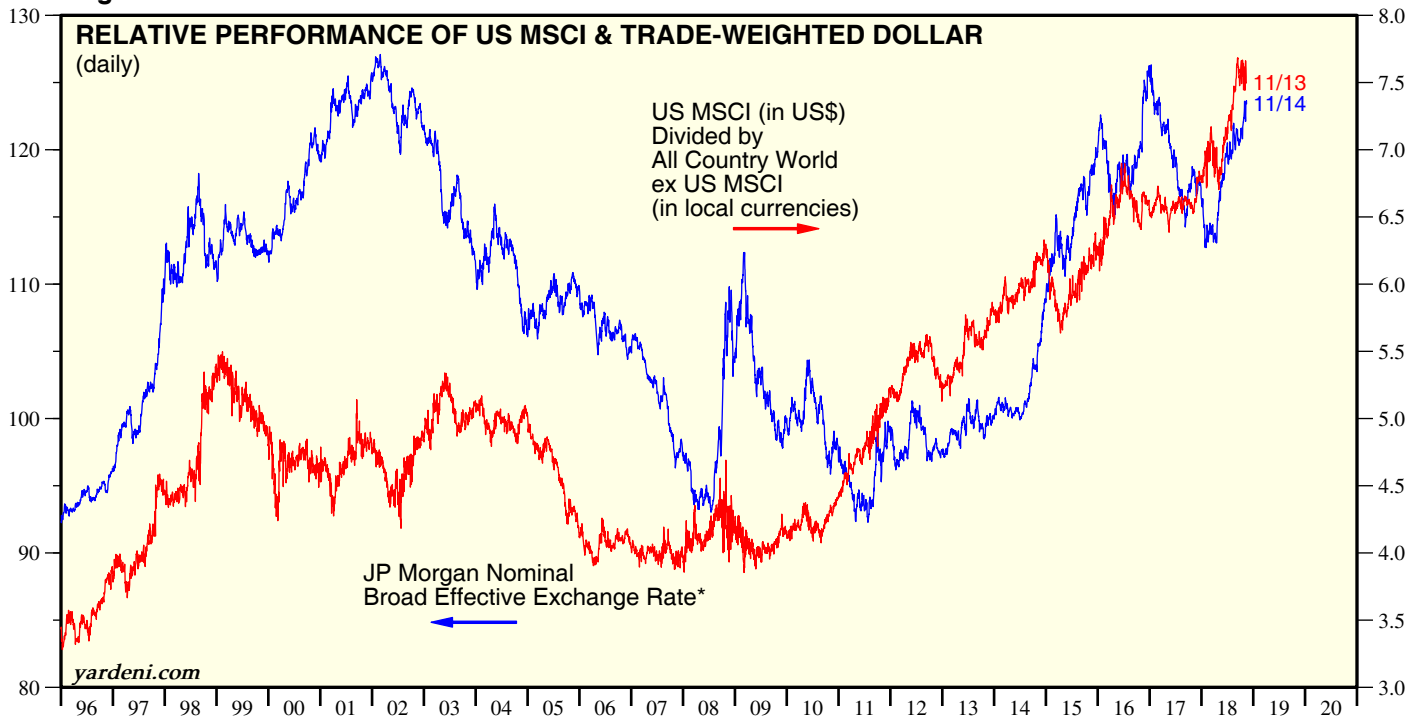

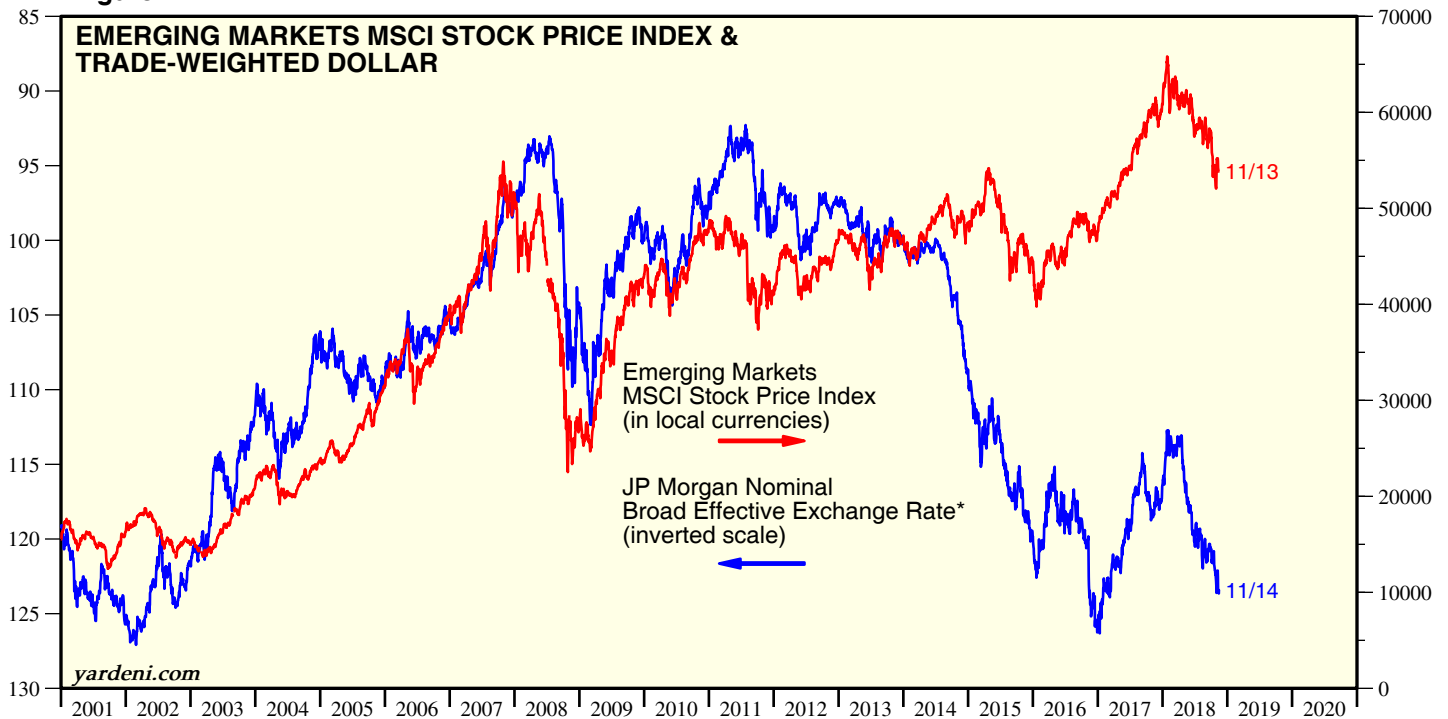

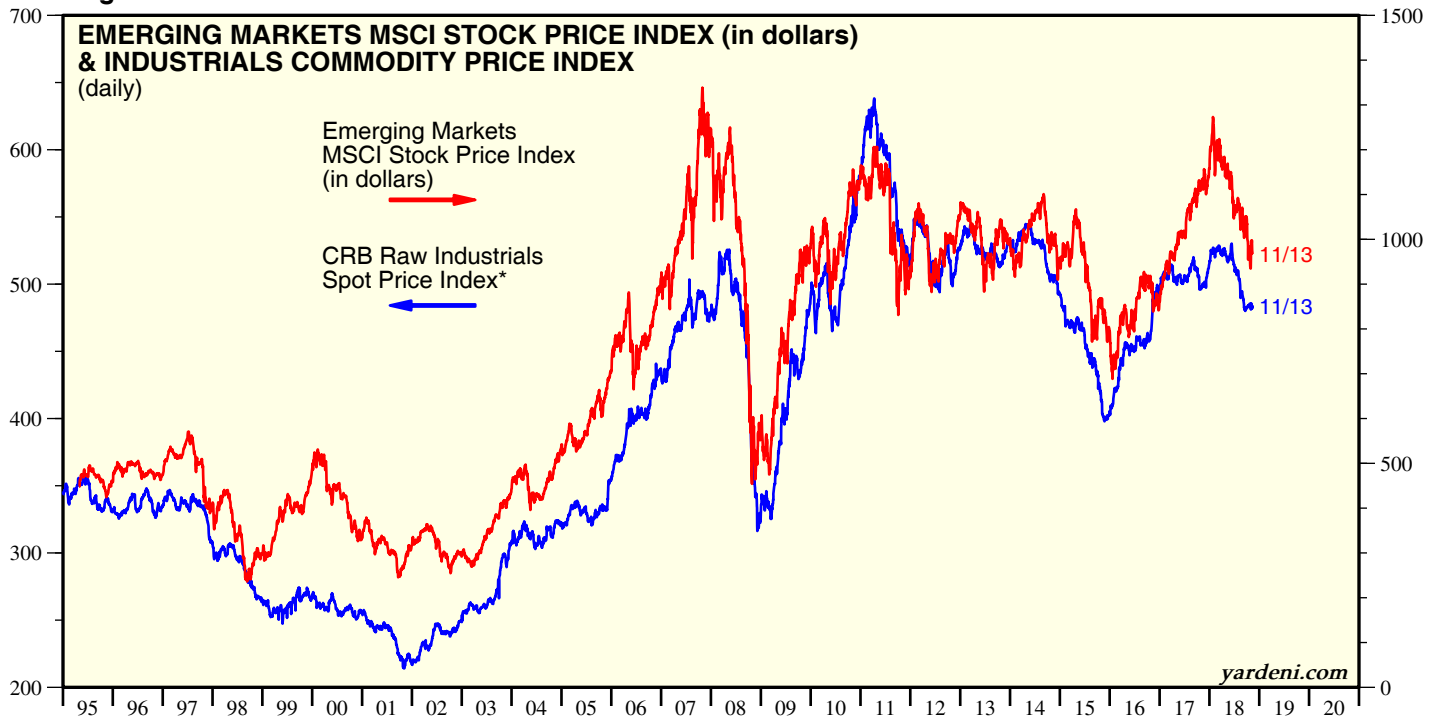

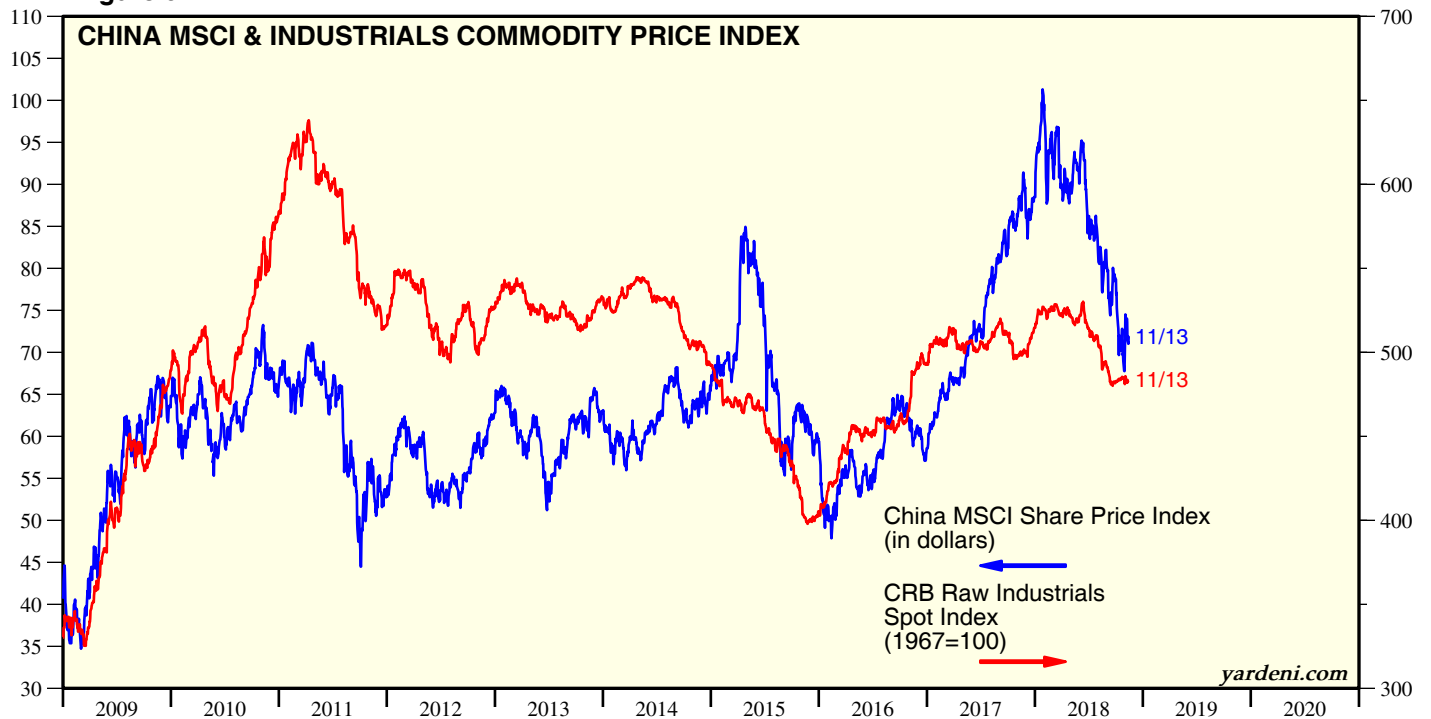

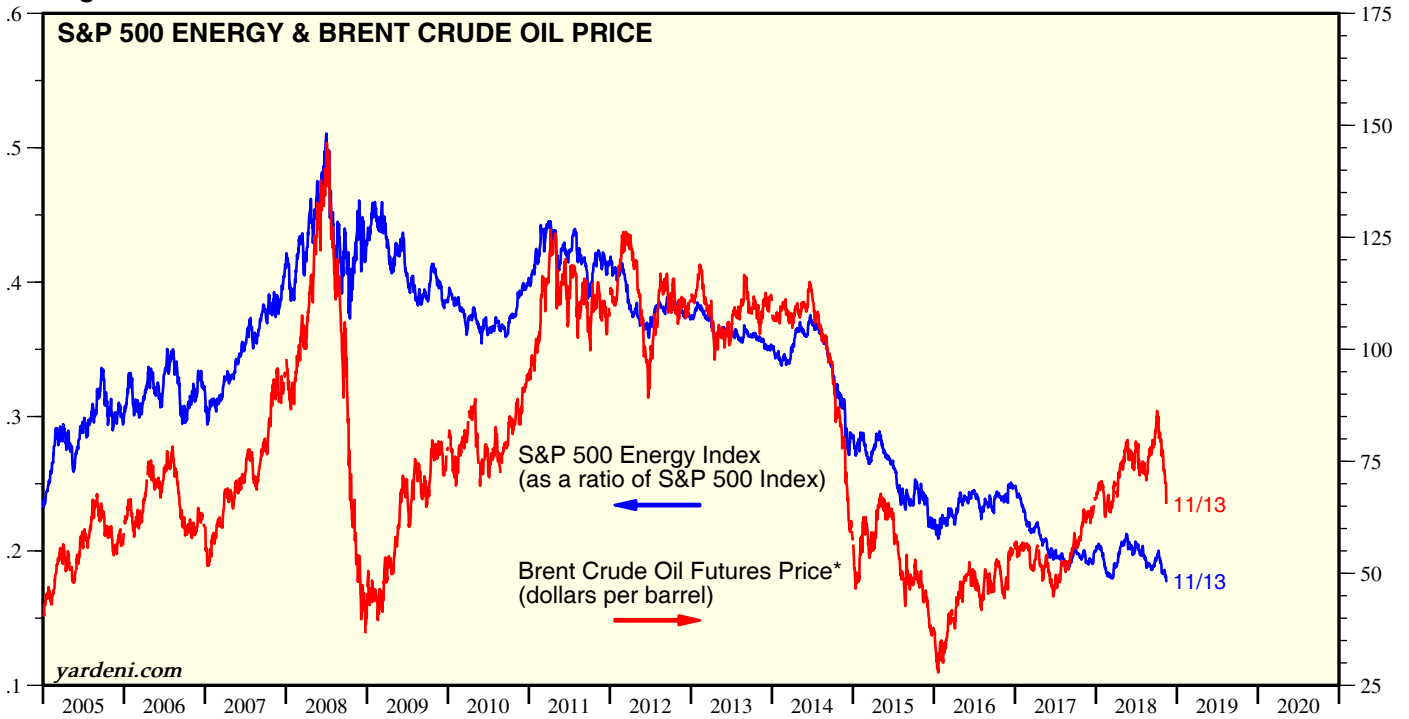

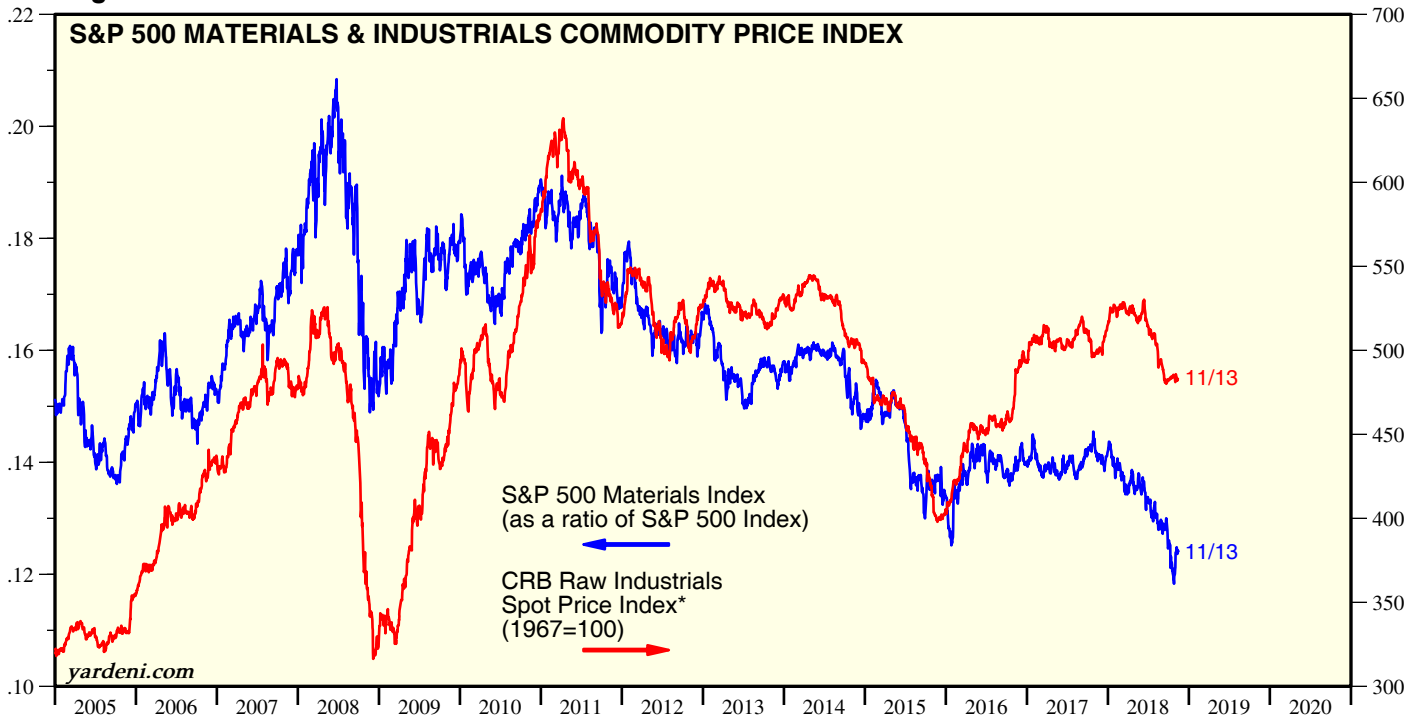
S&P 500 Sectors & Commodities

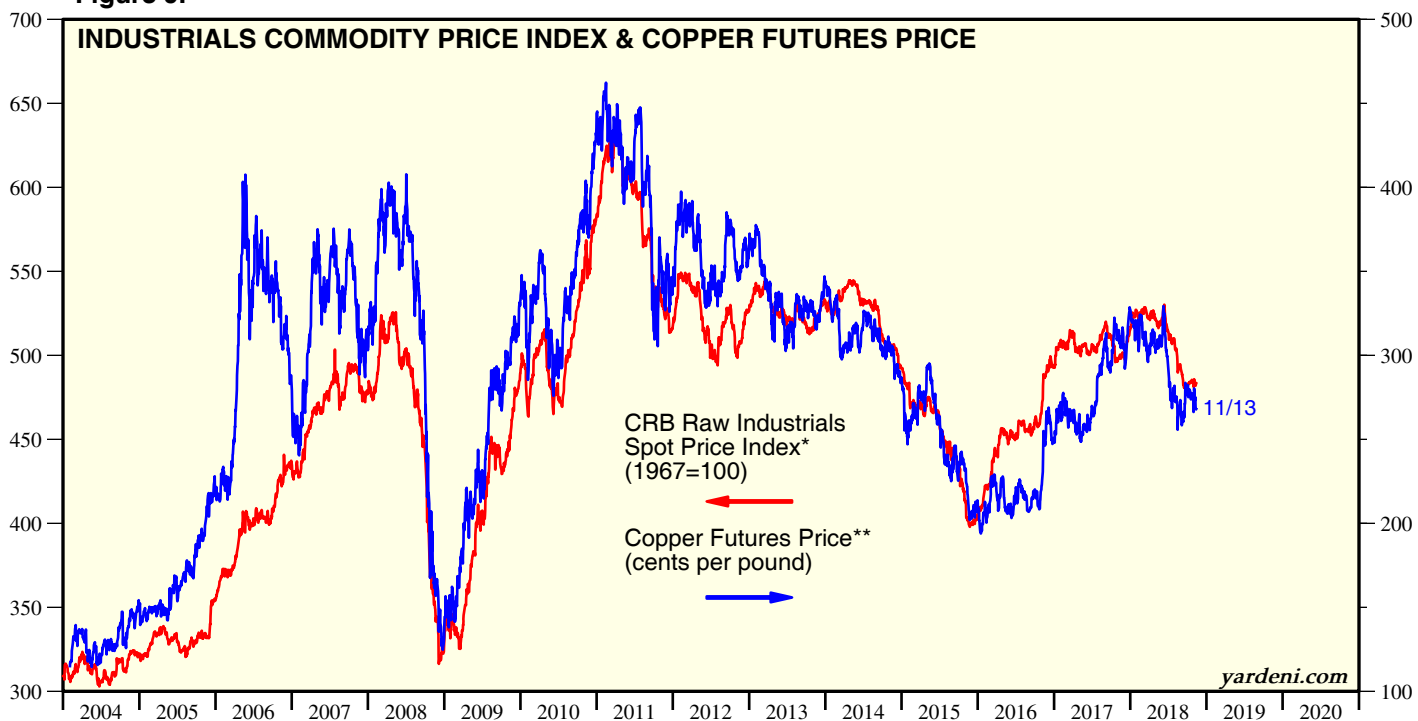

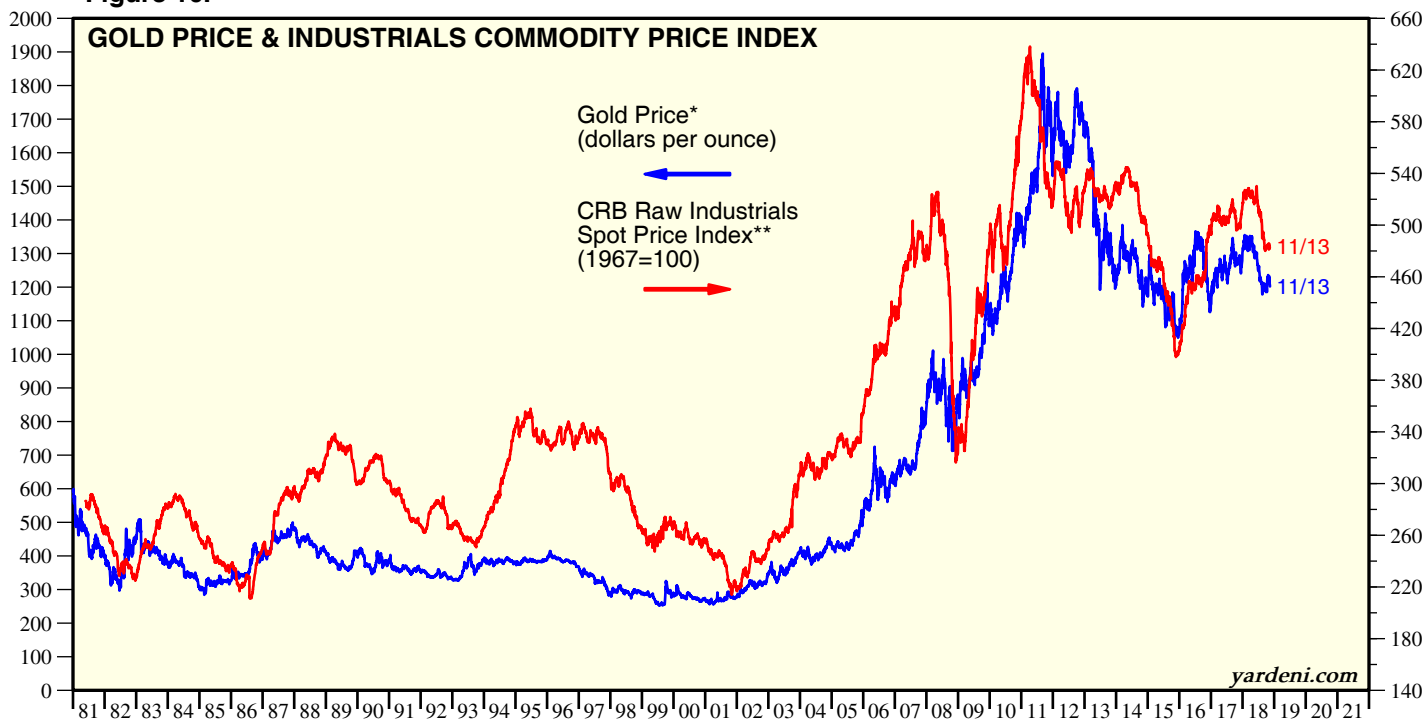

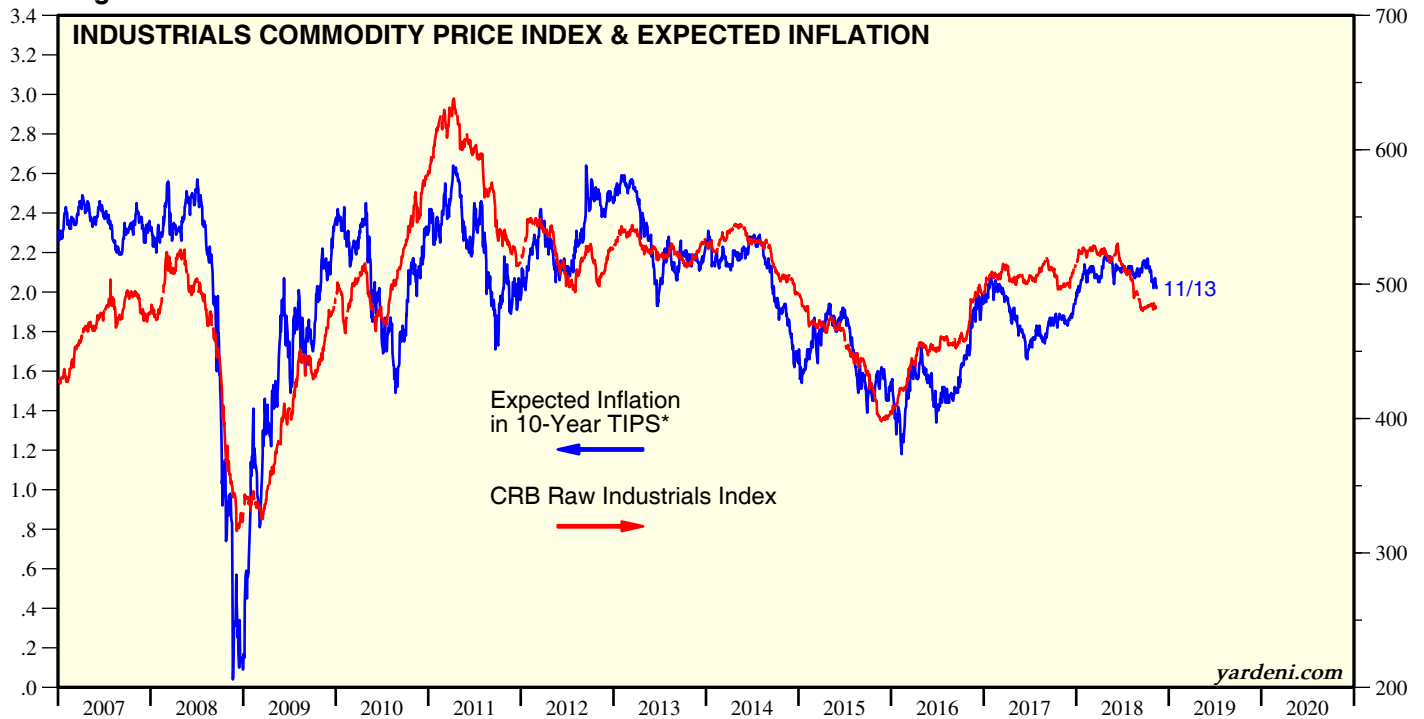

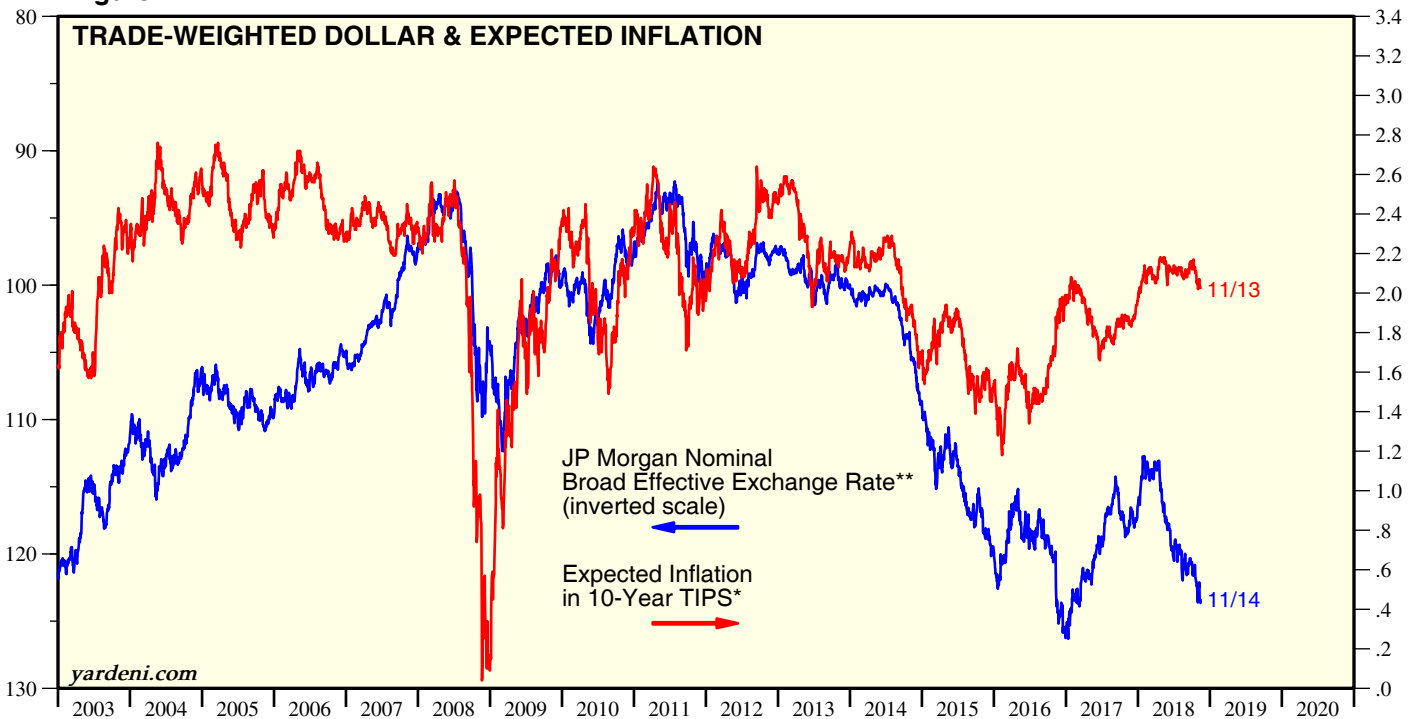

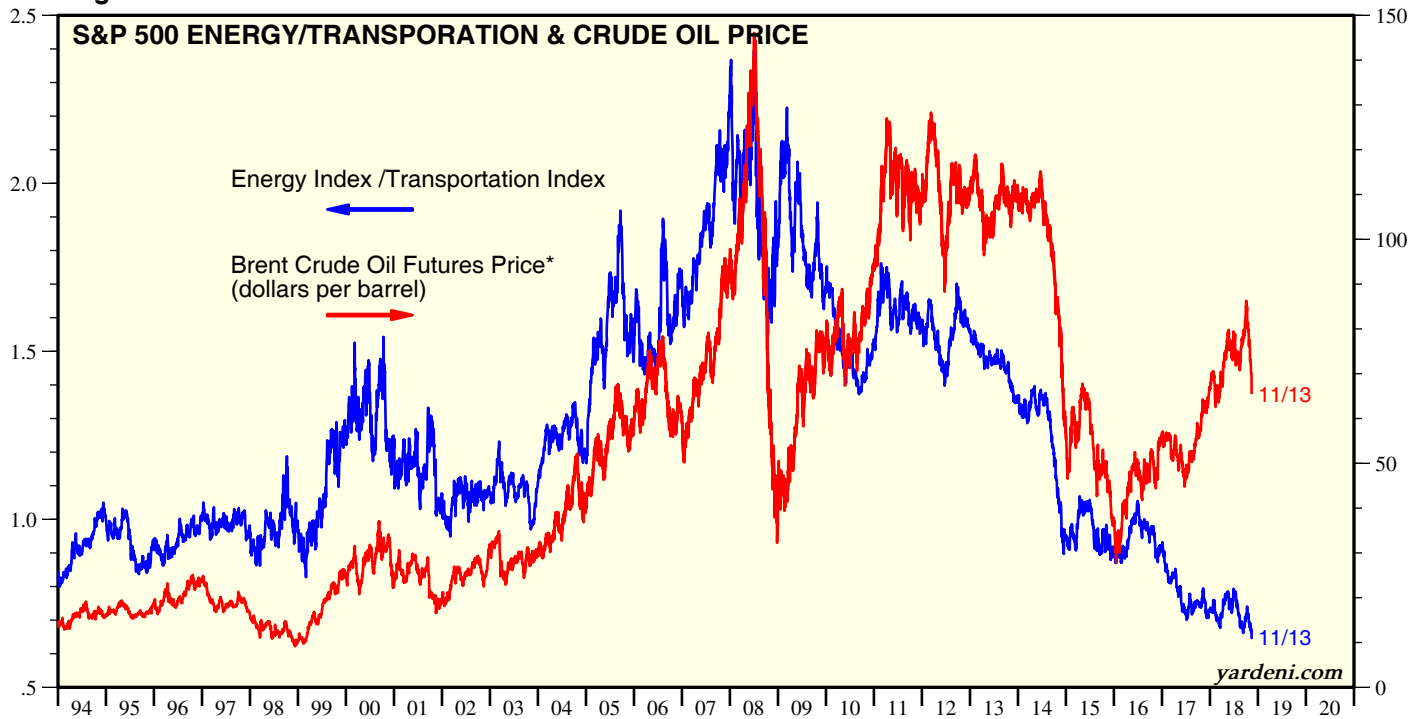

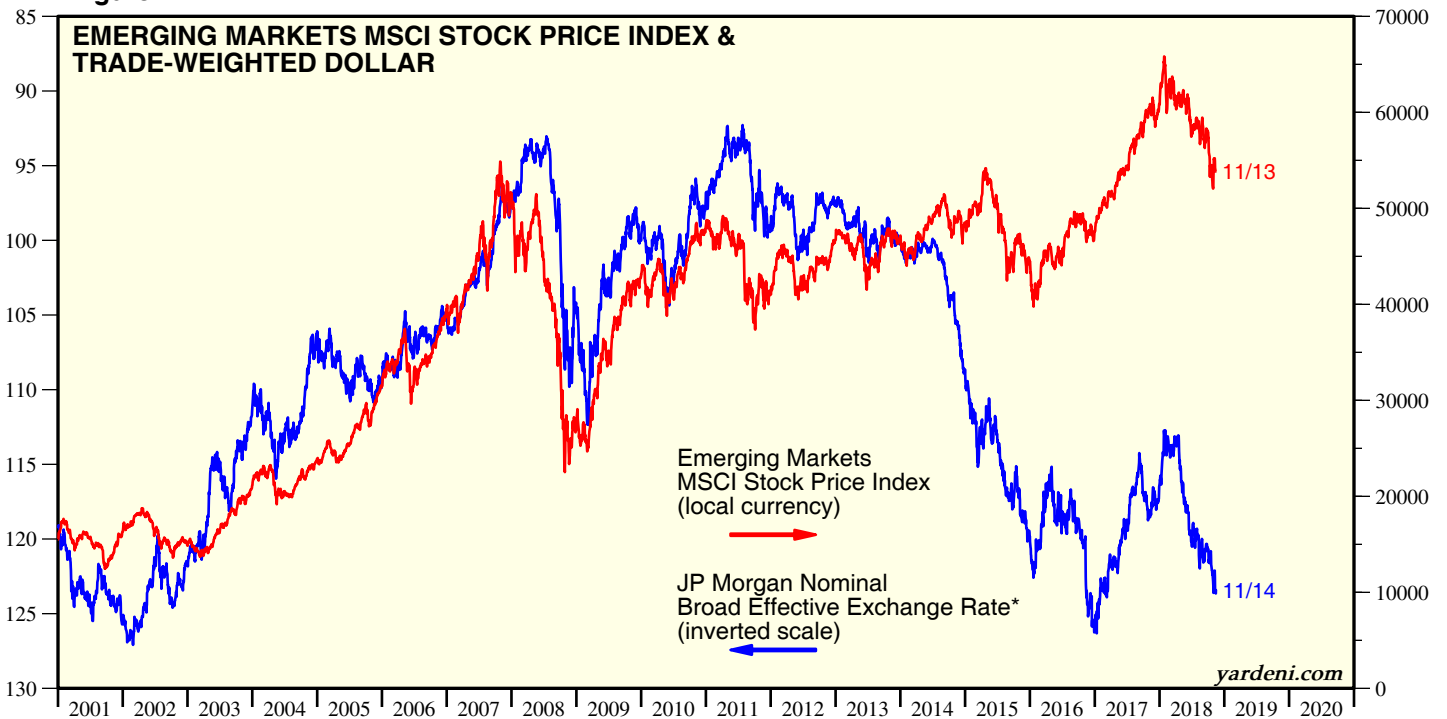

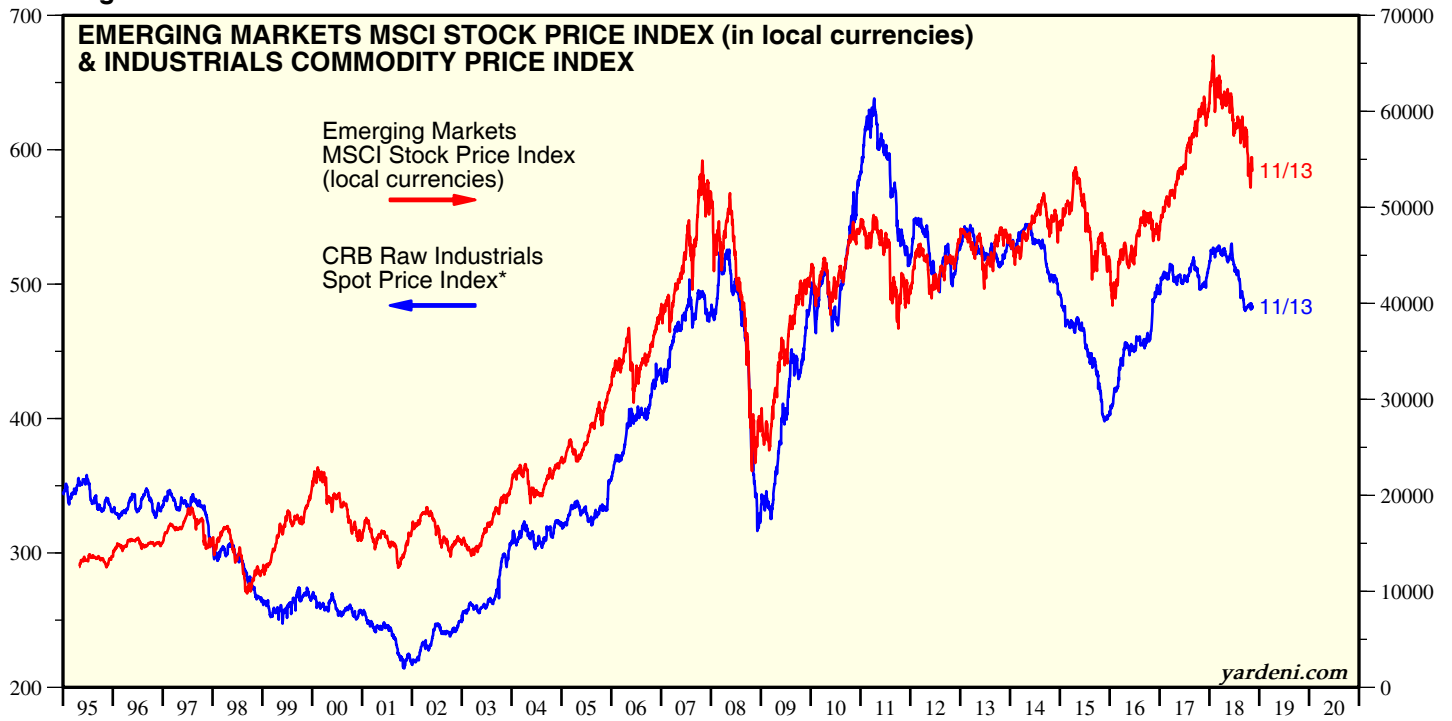
