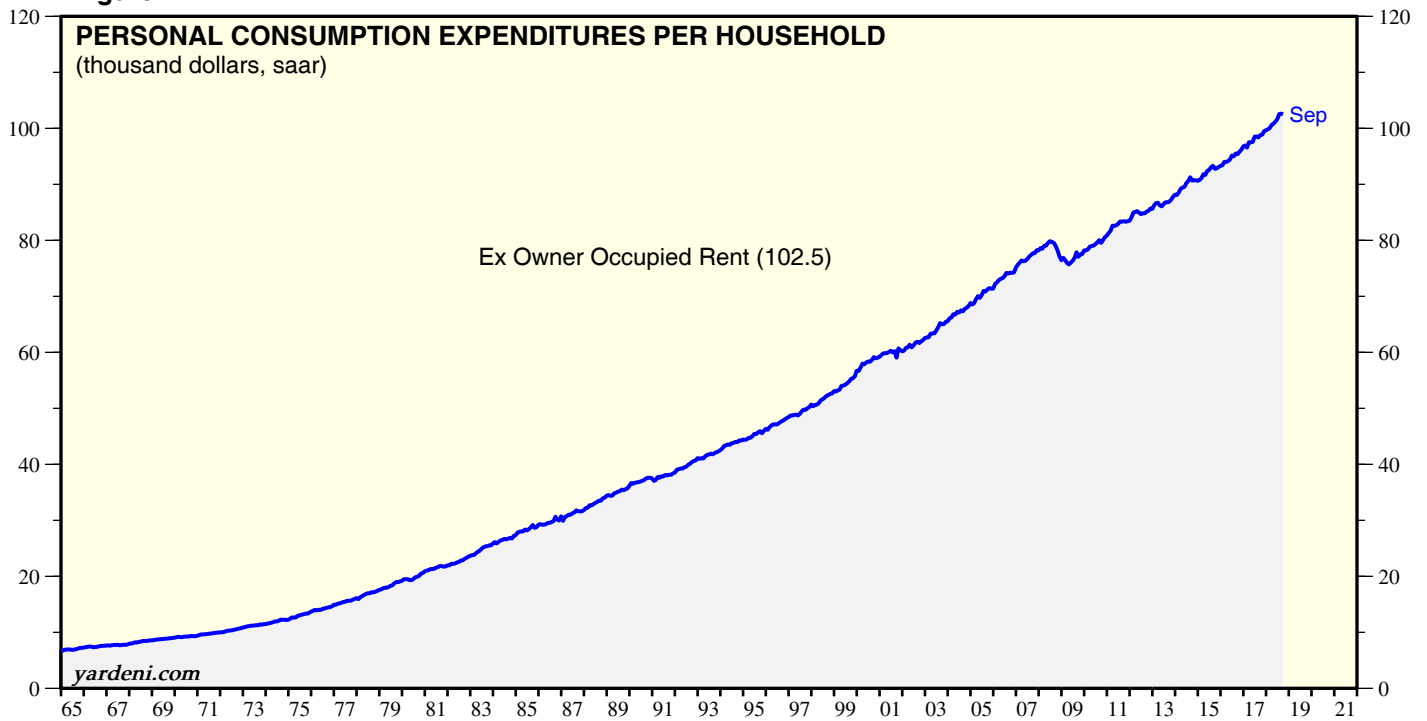

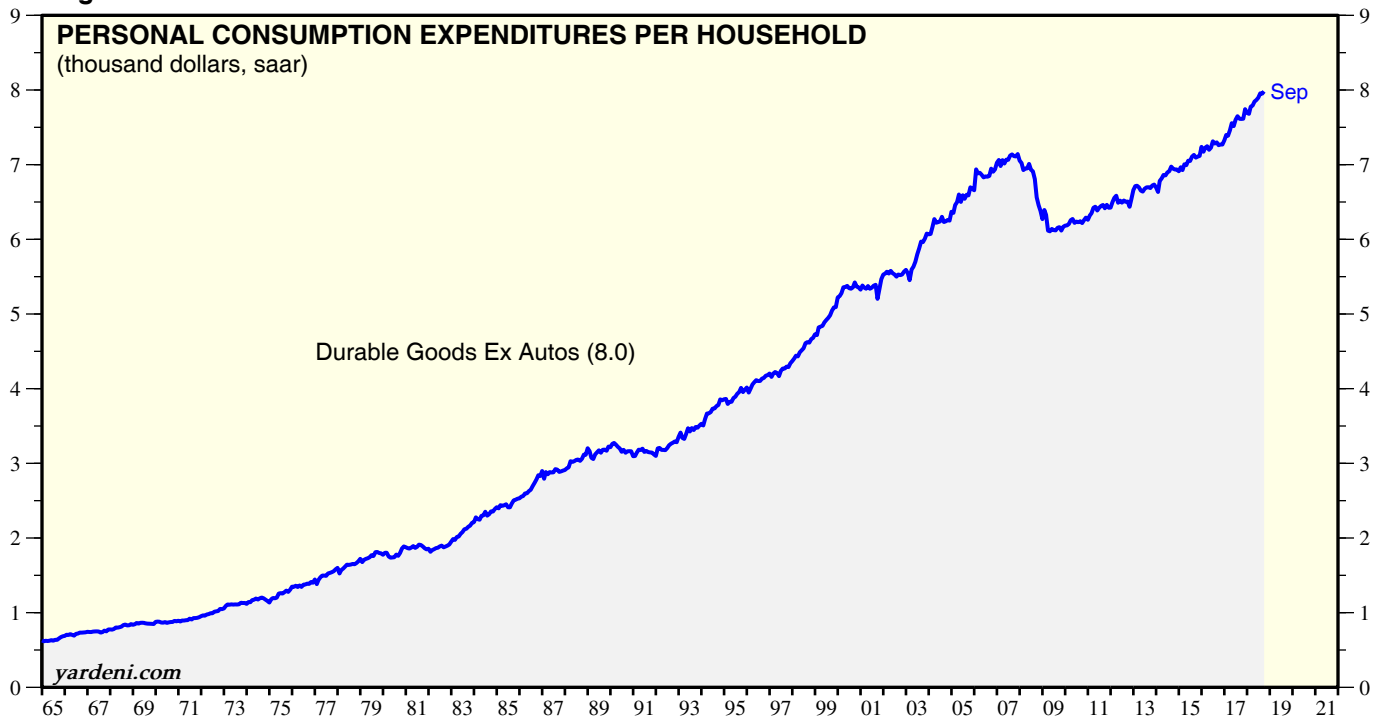

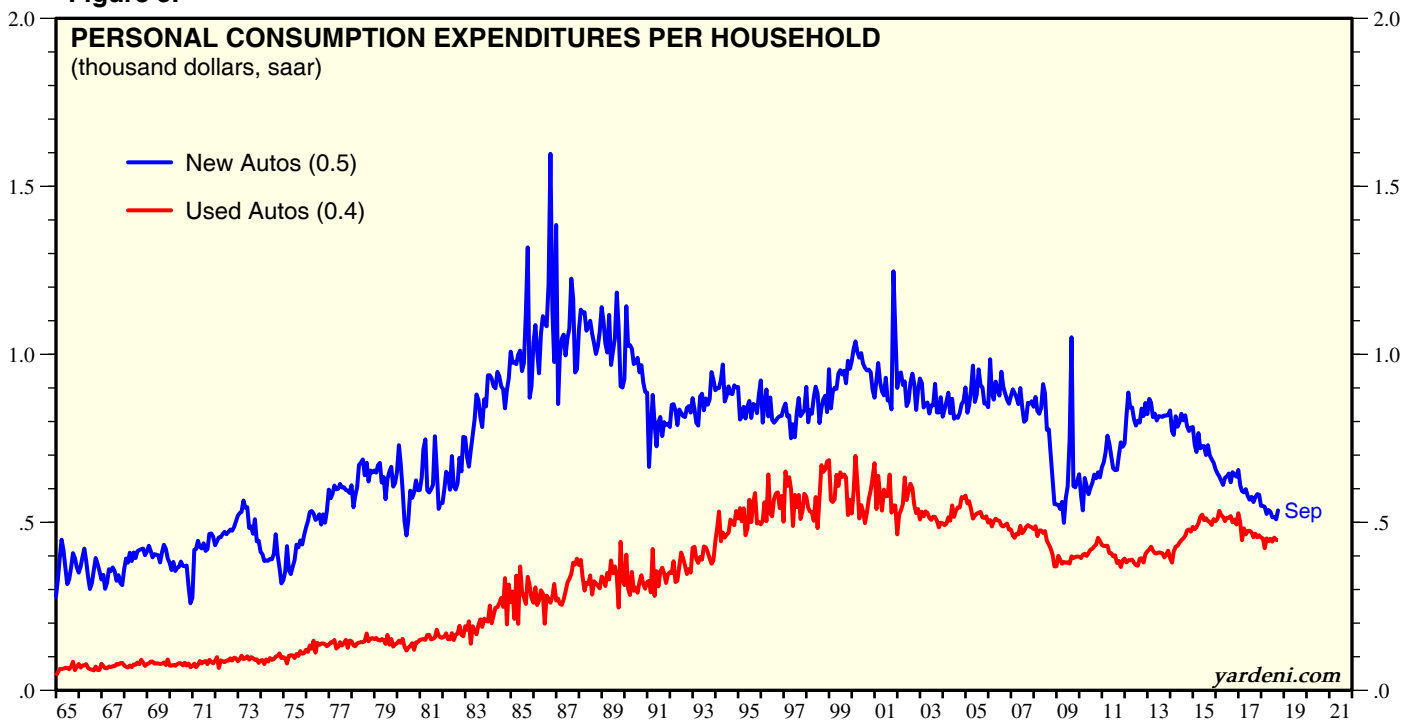

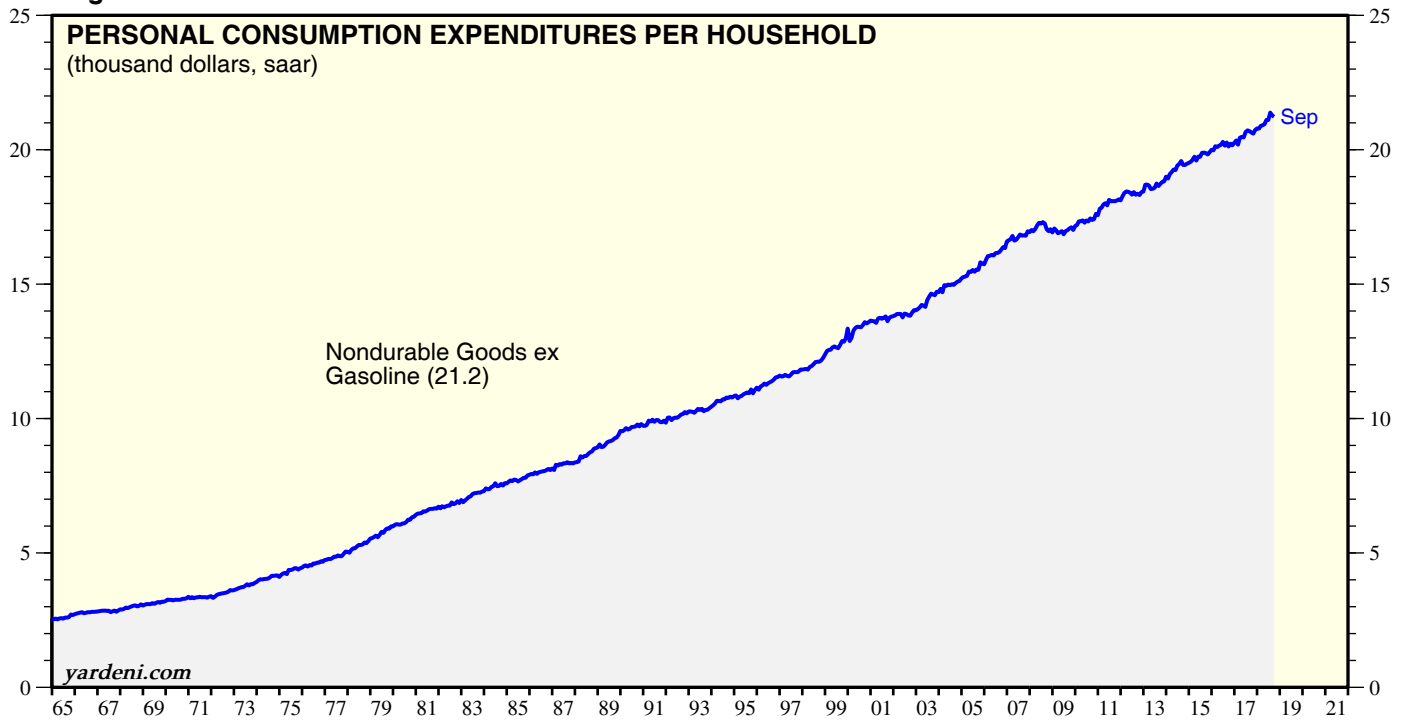

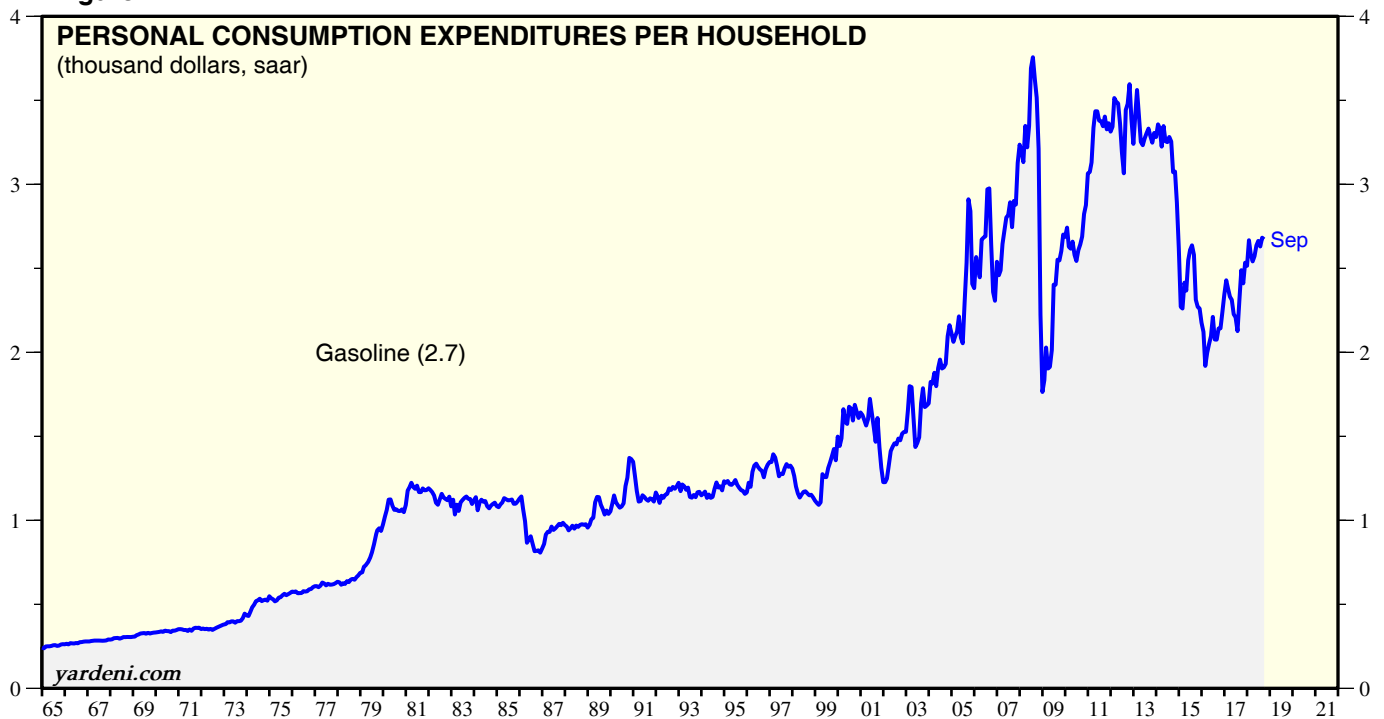

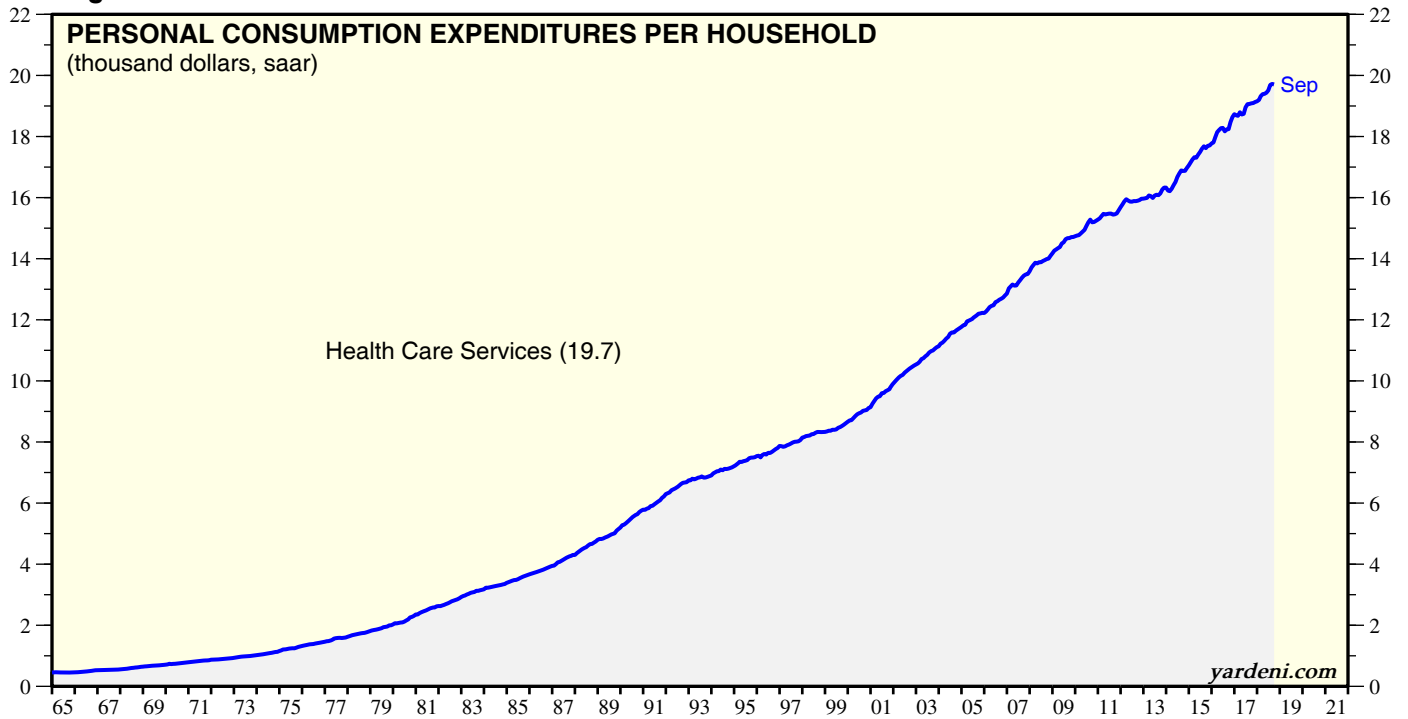

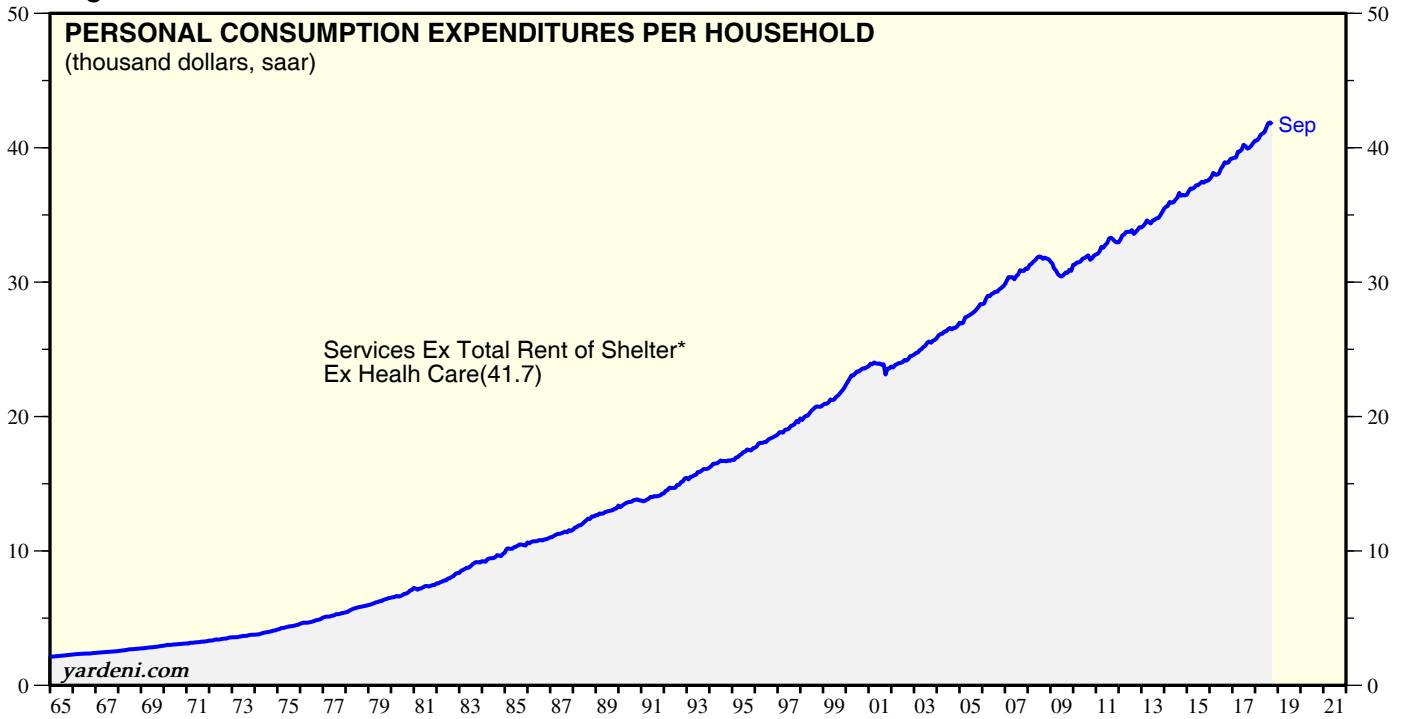

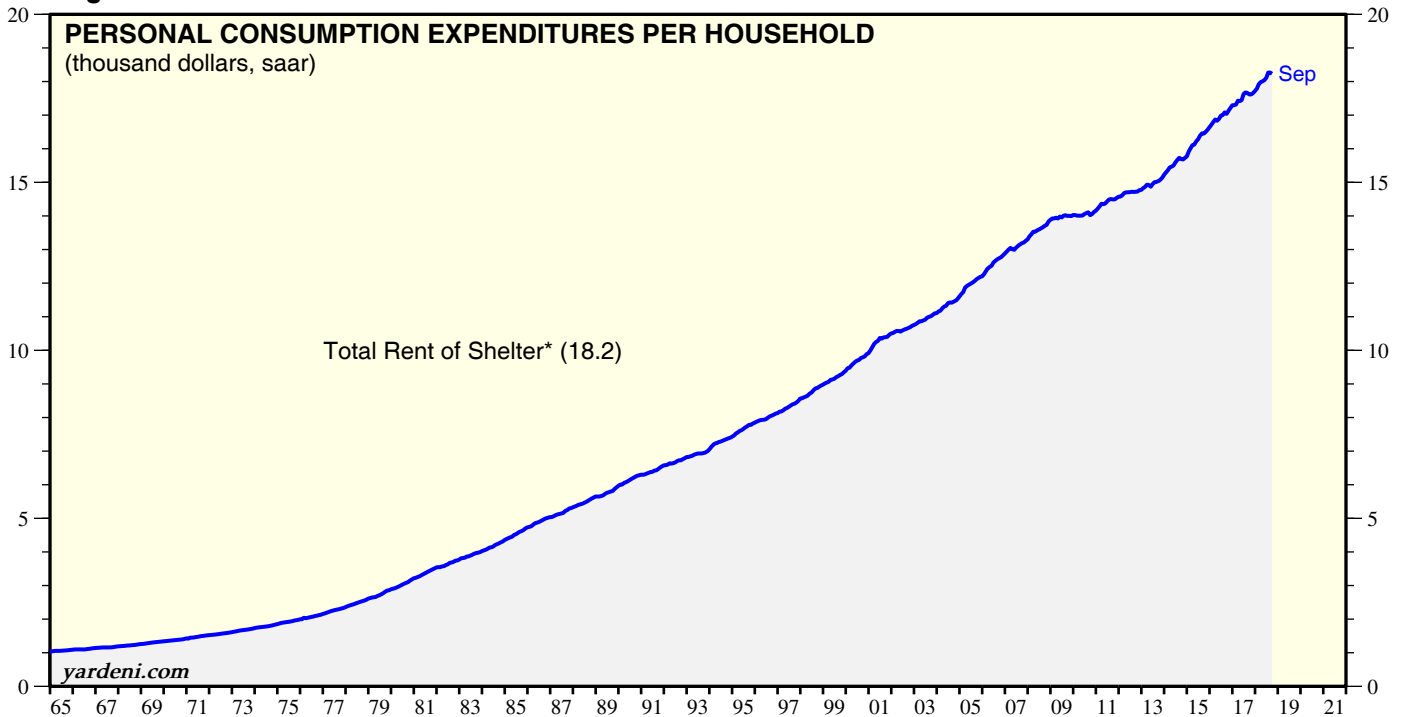

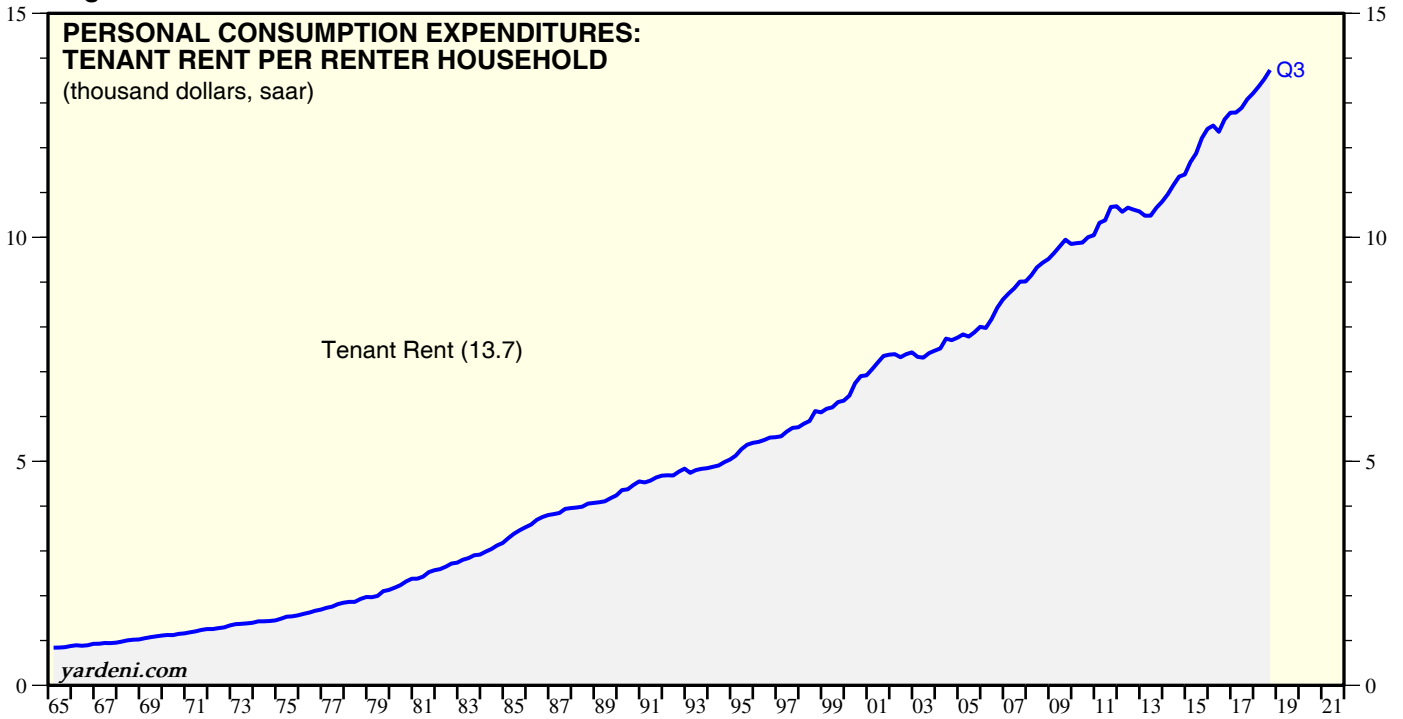

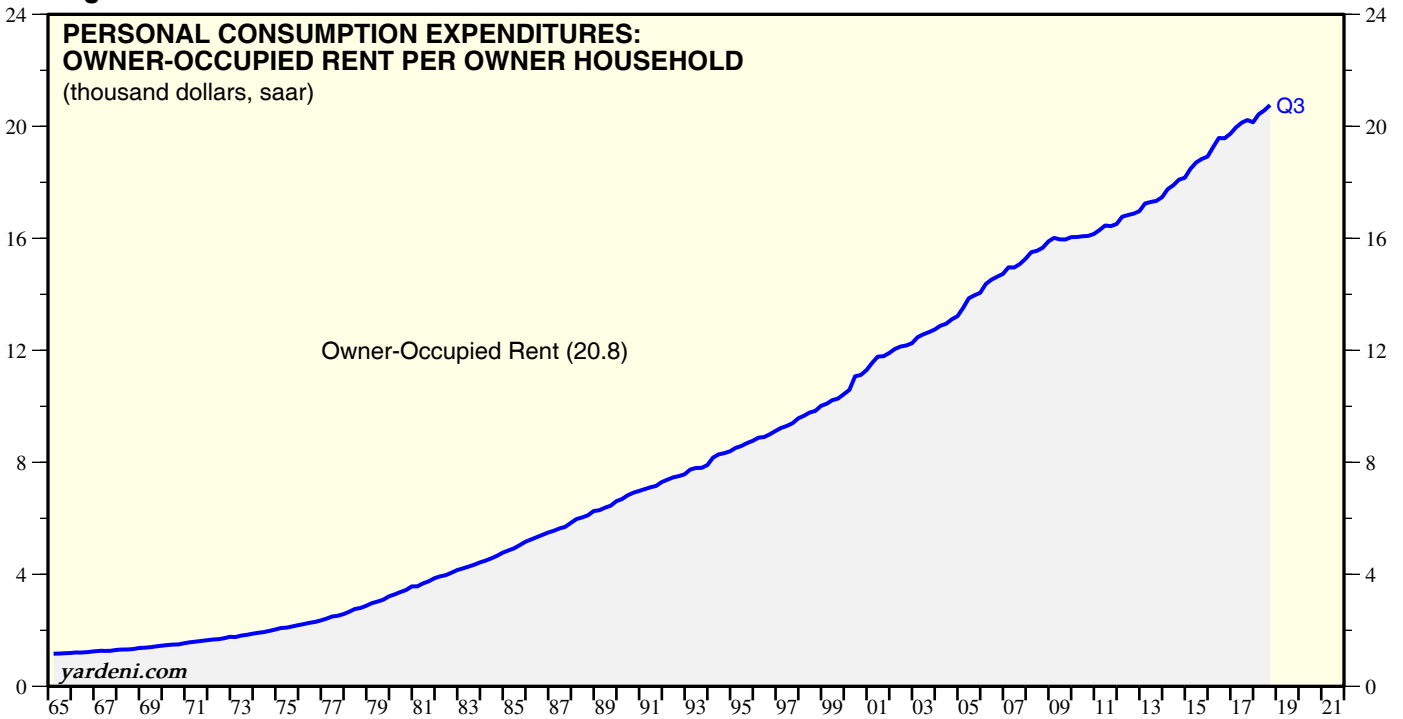

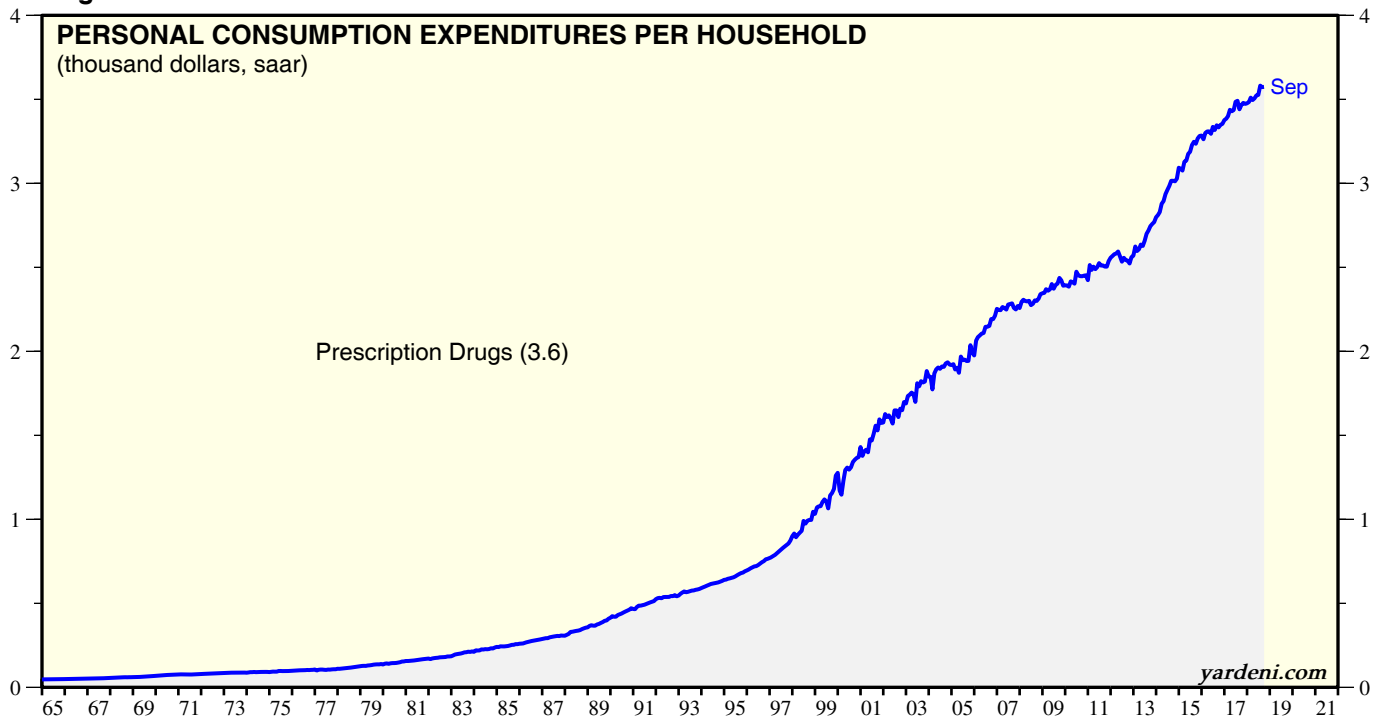

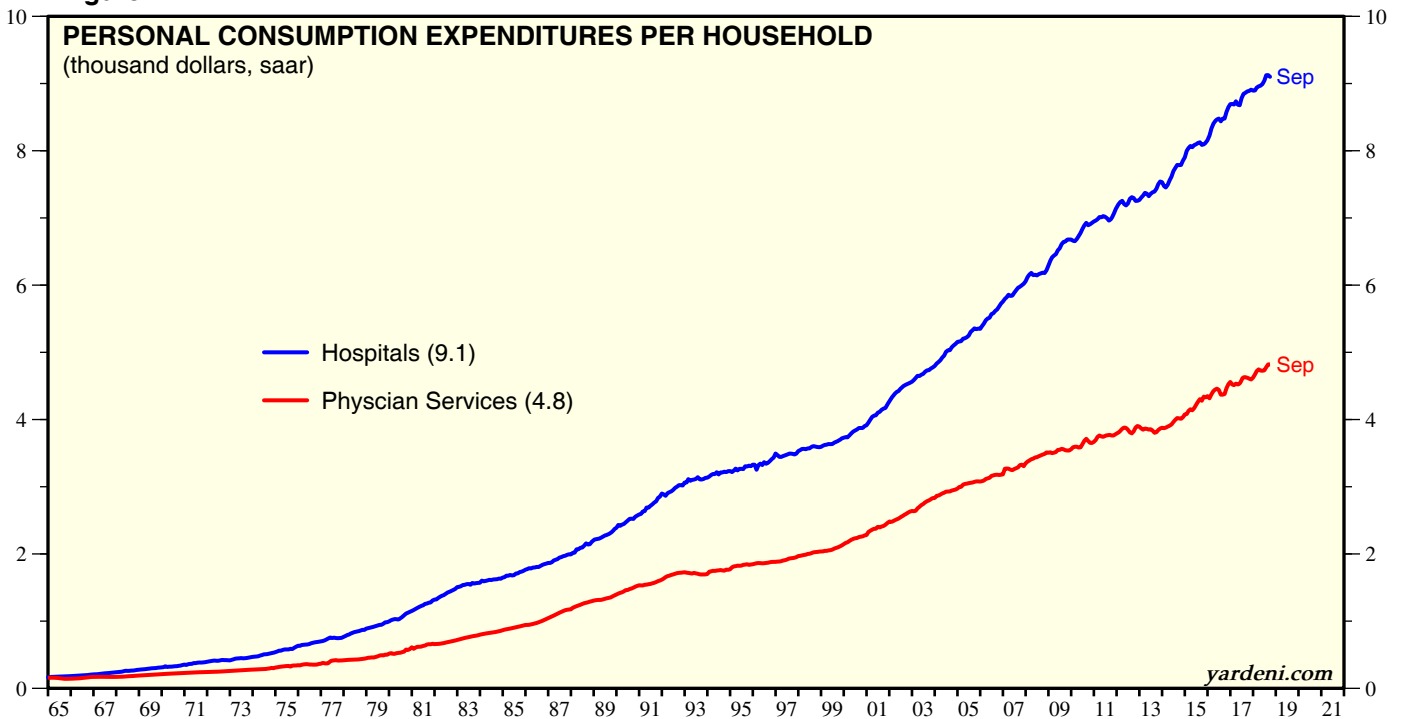

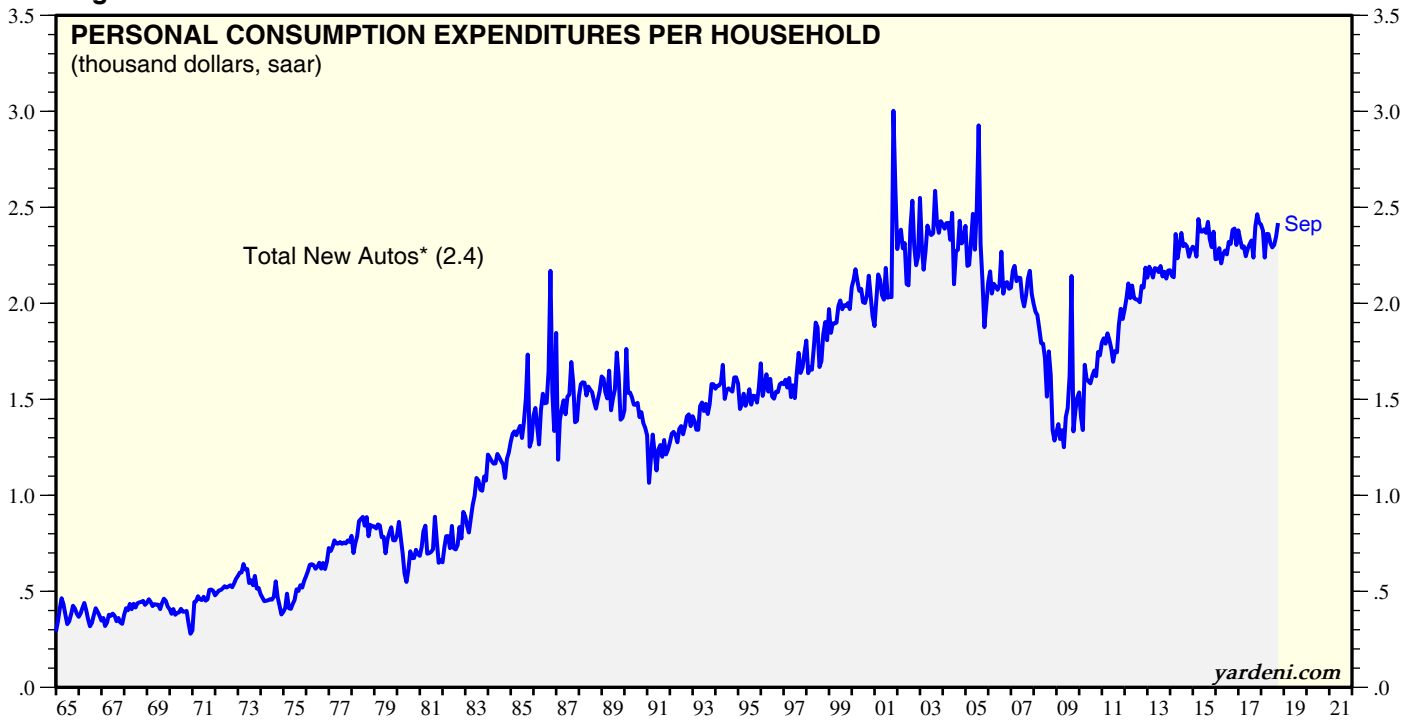

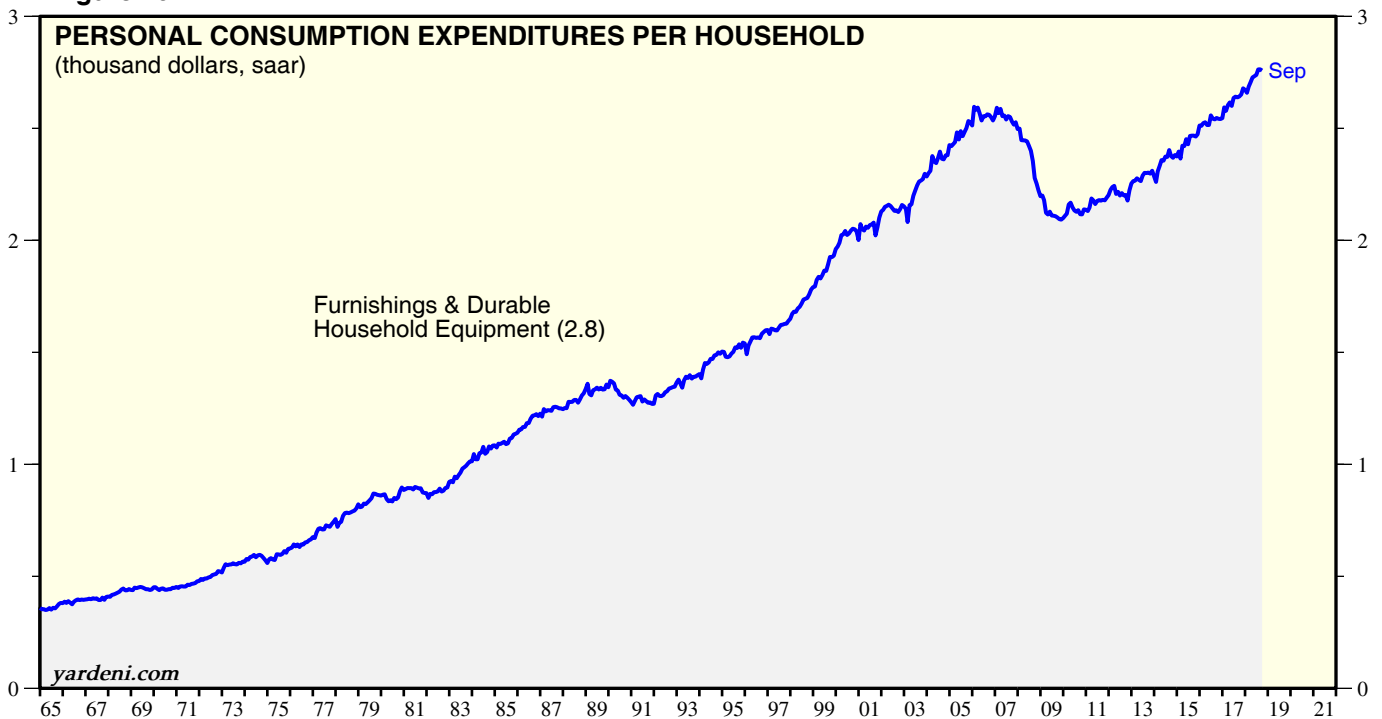

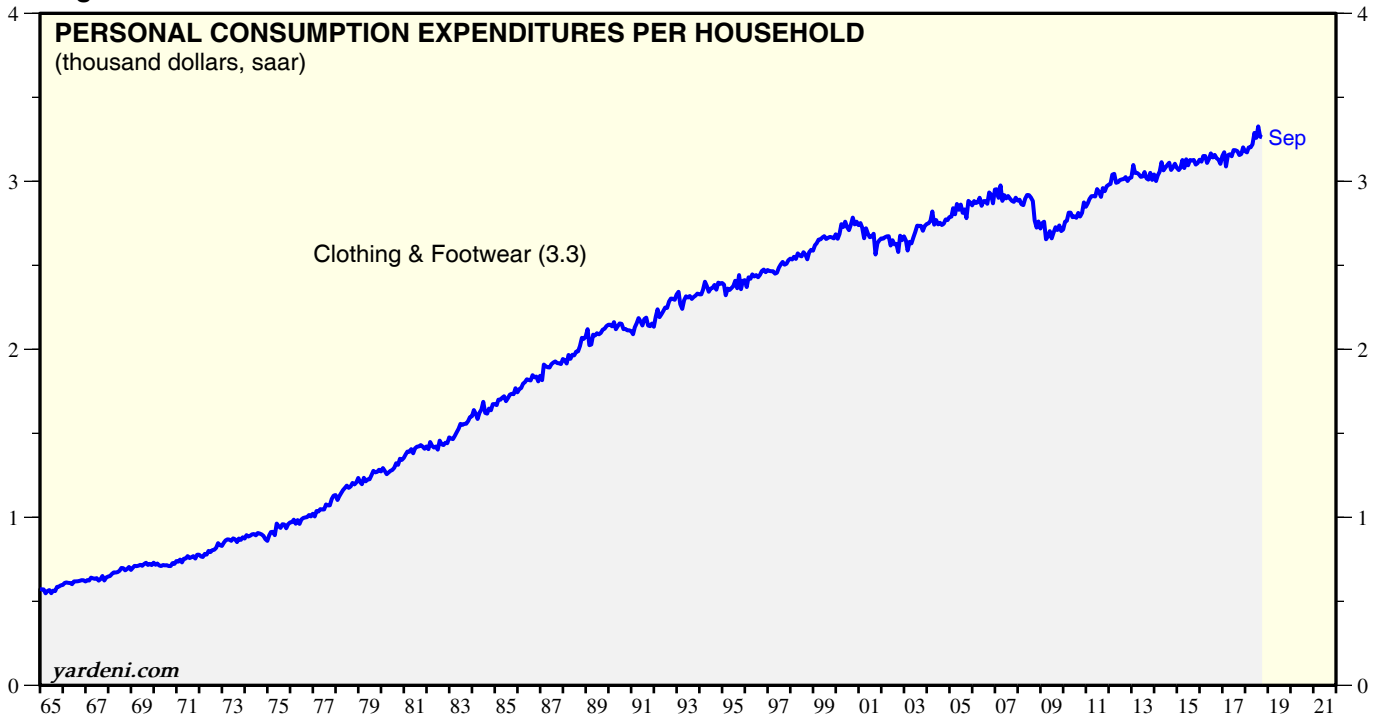

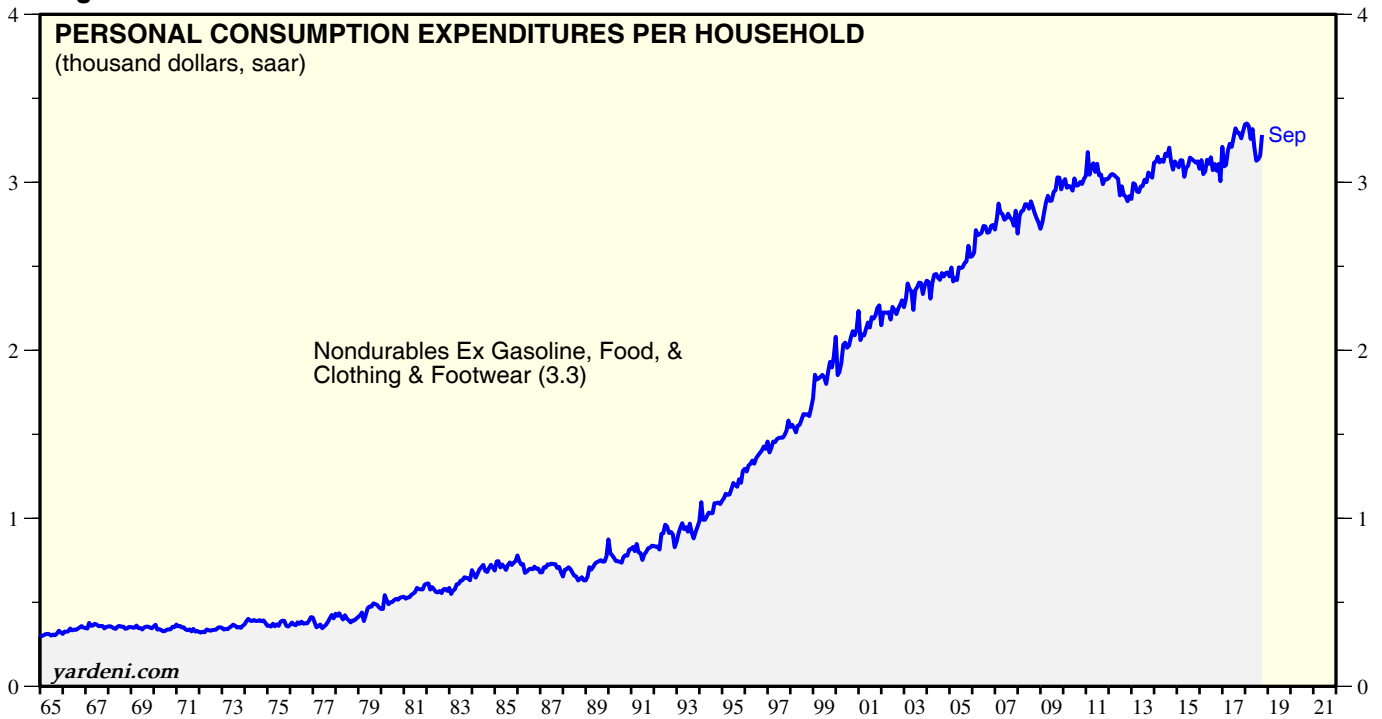

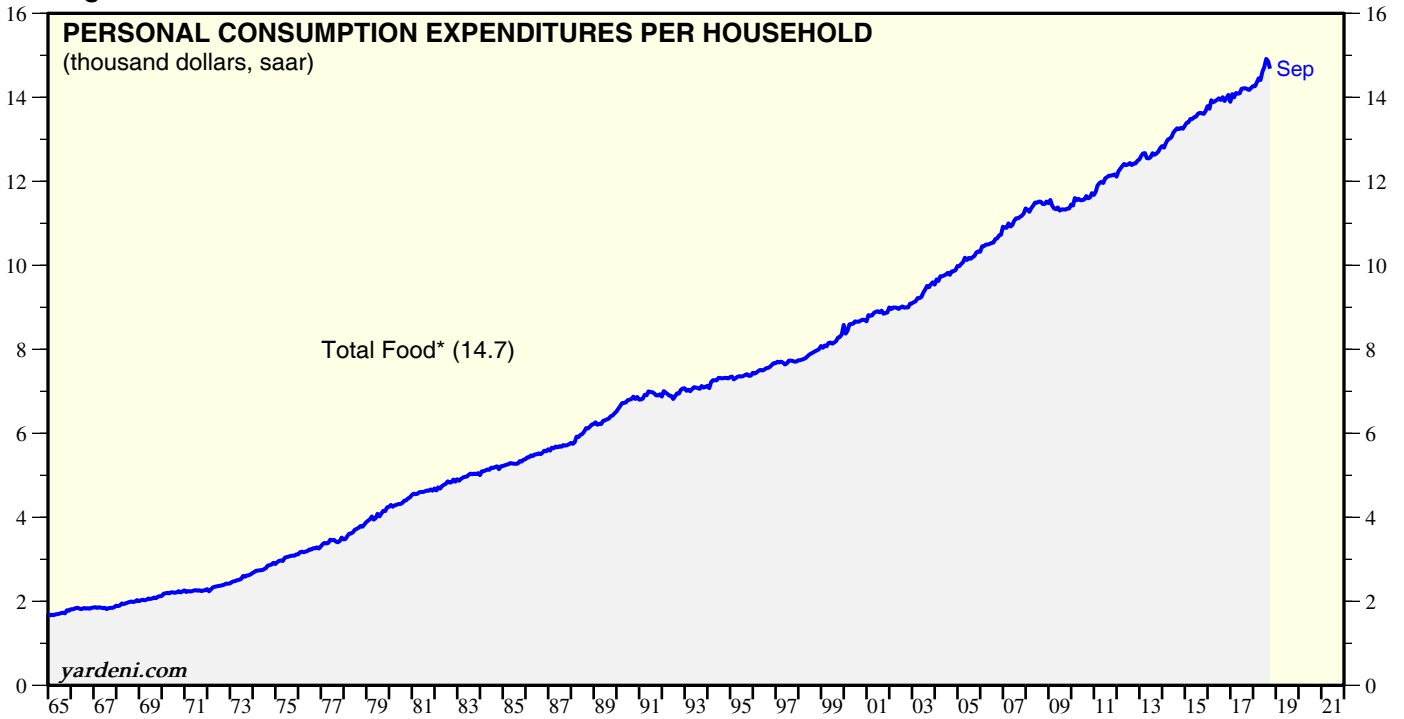

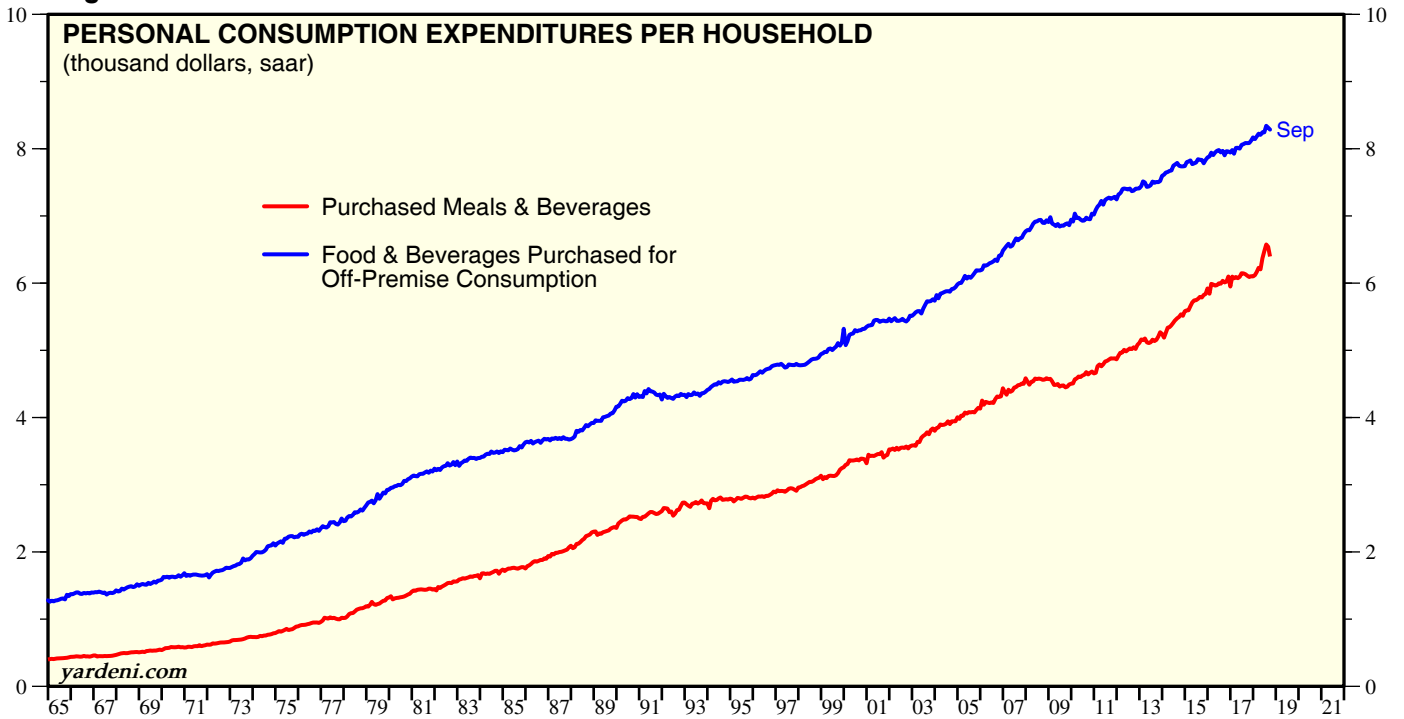

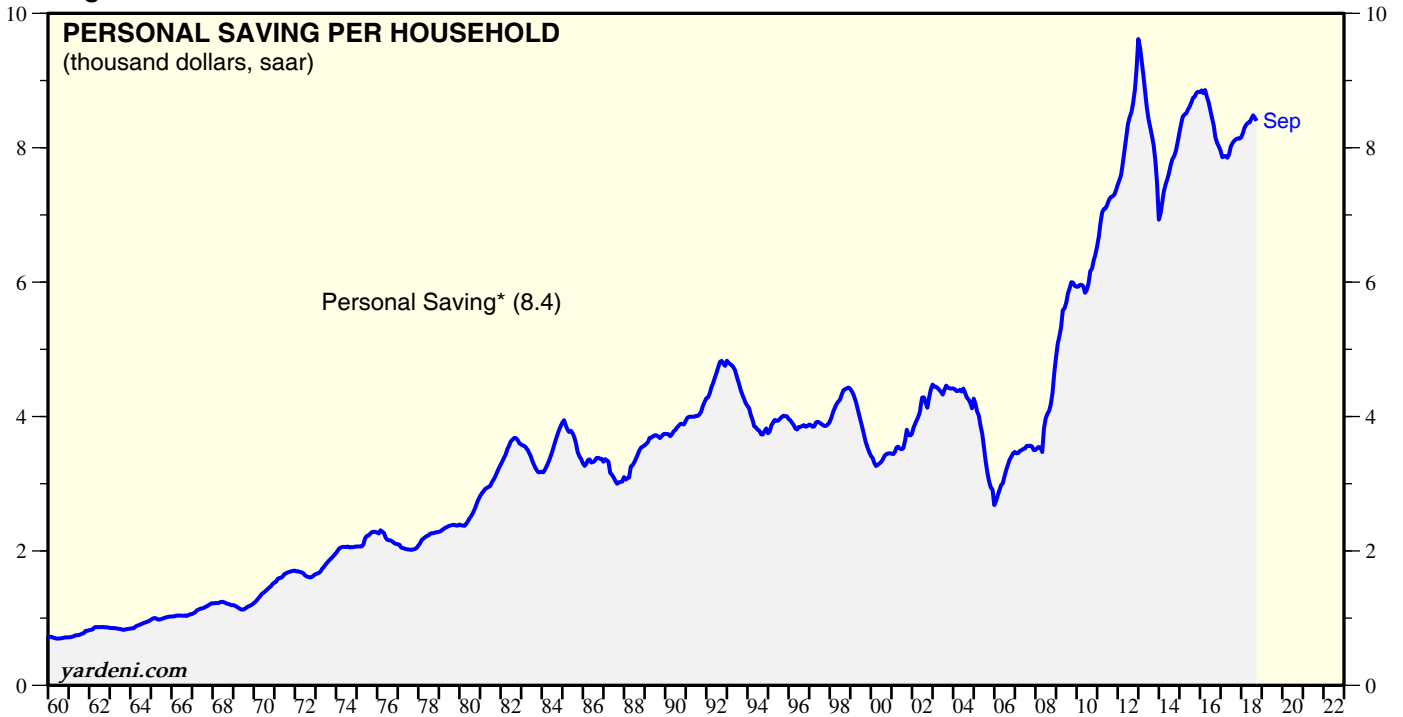

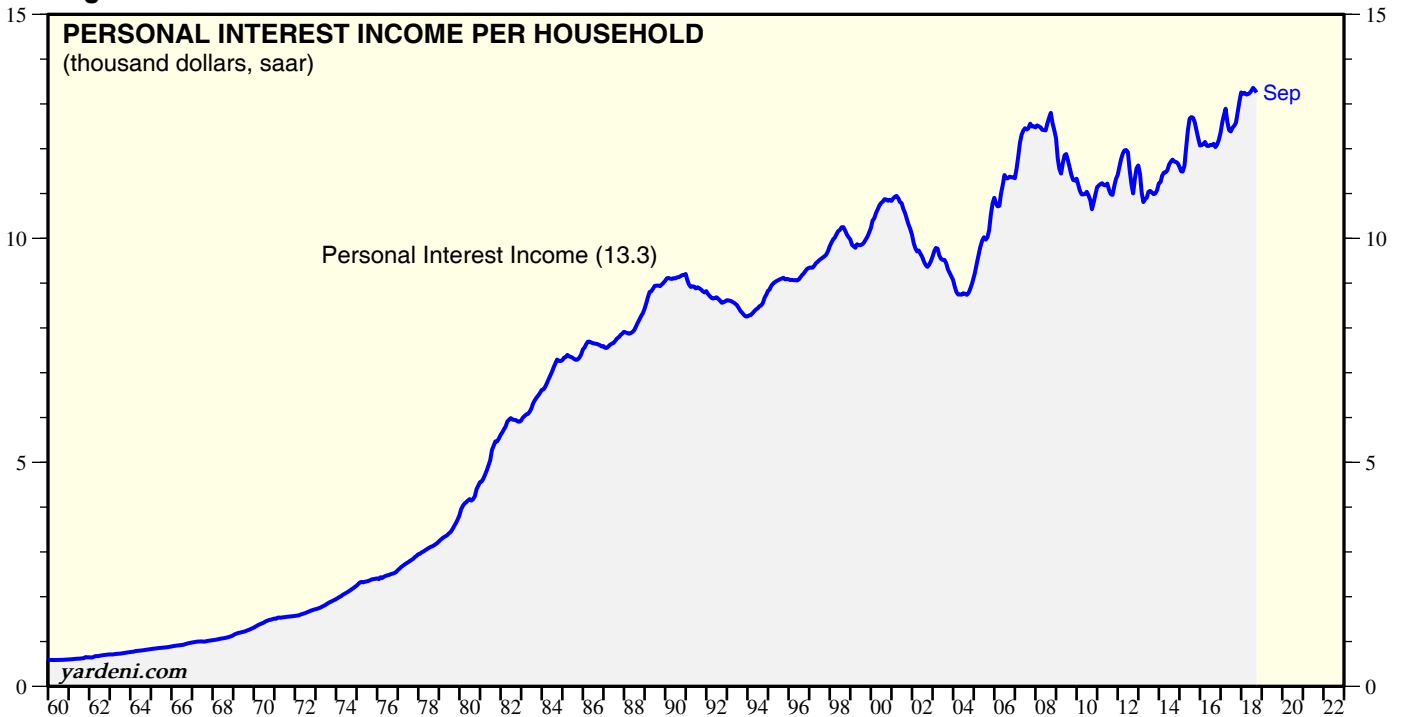

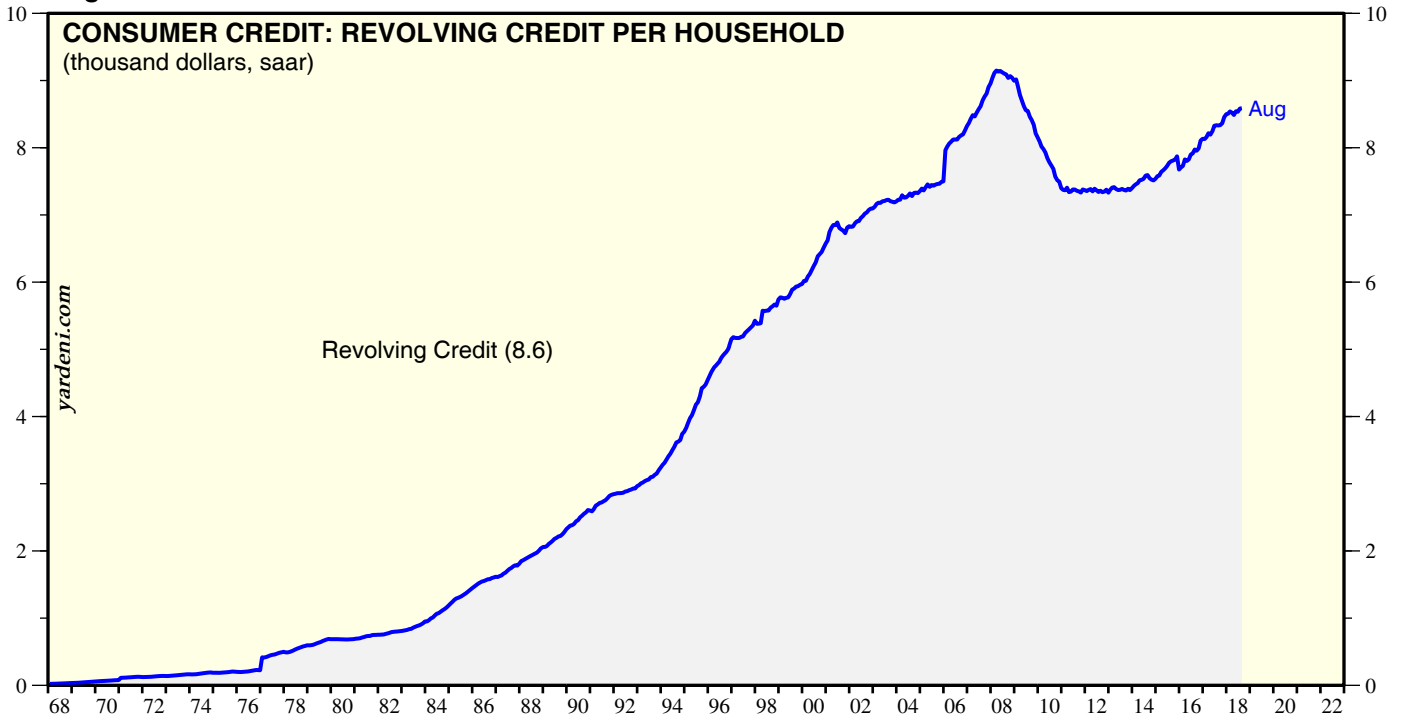

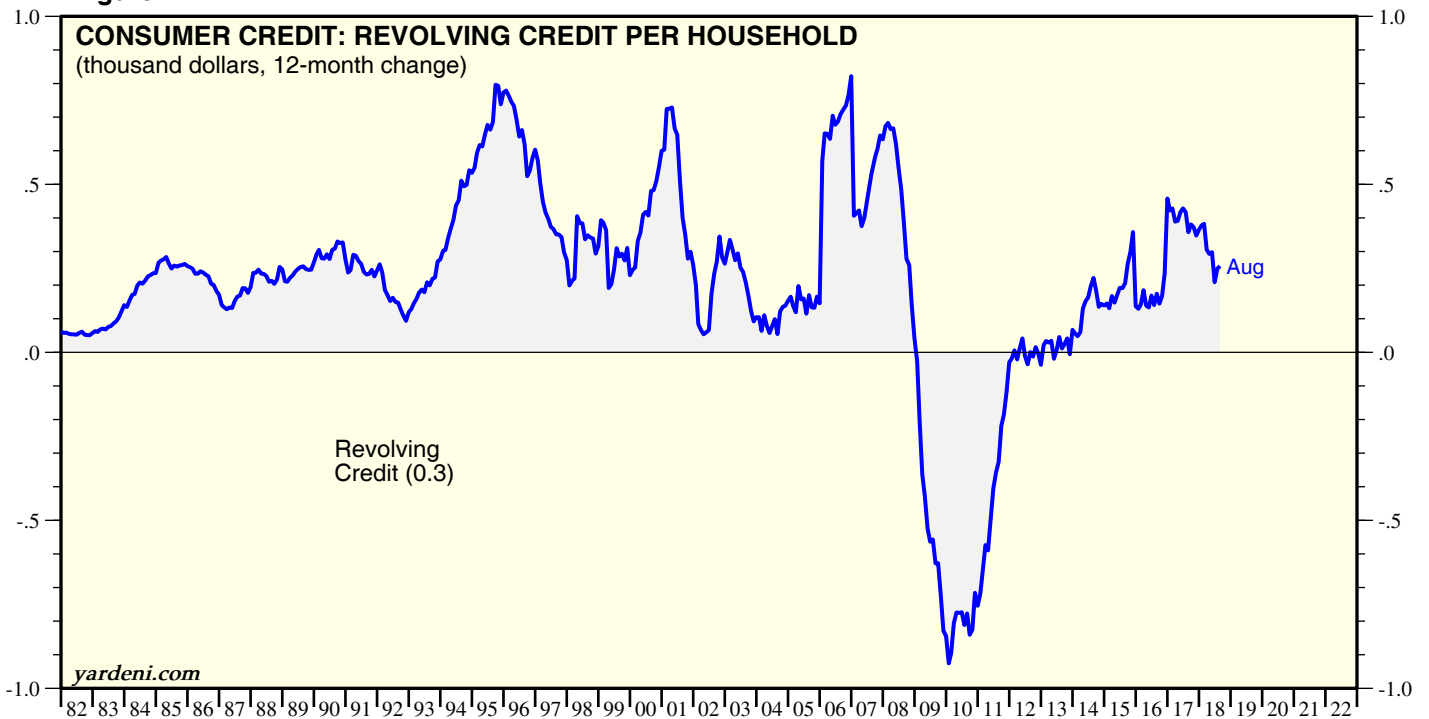

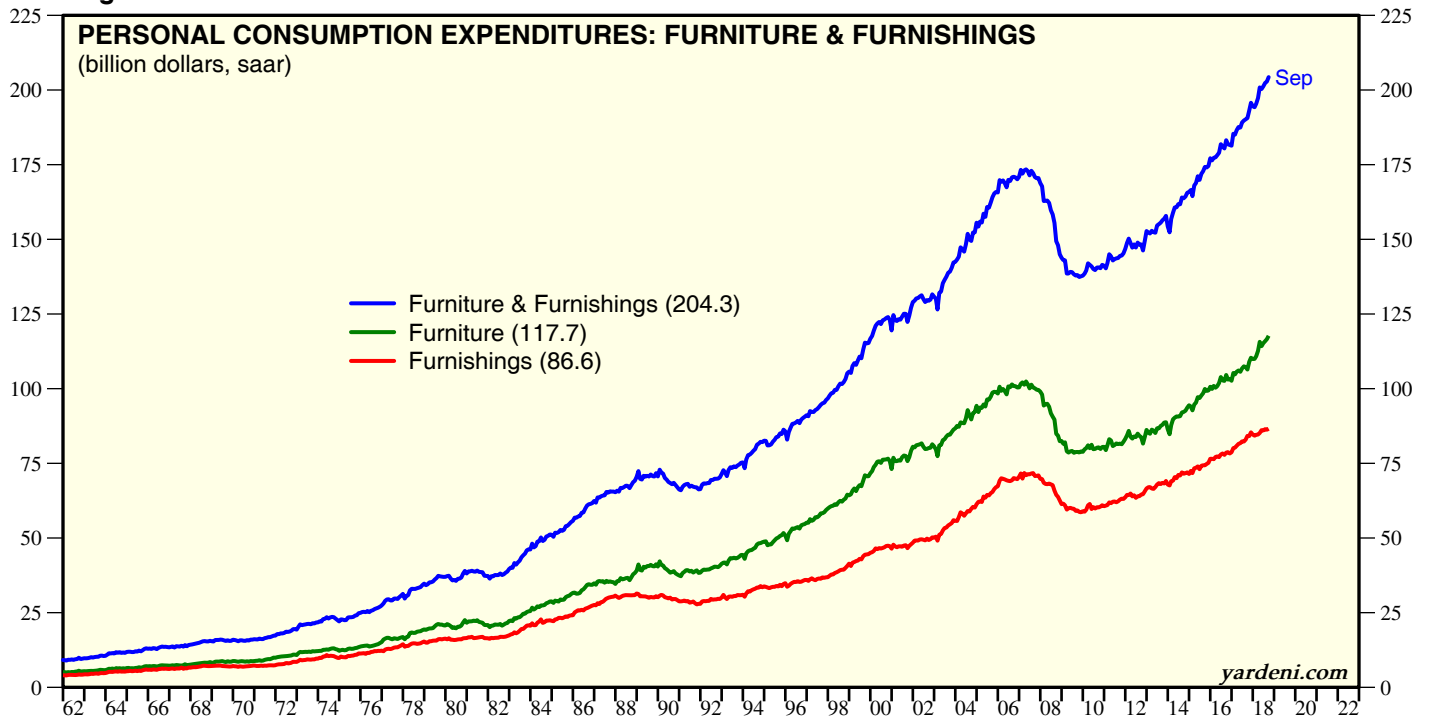

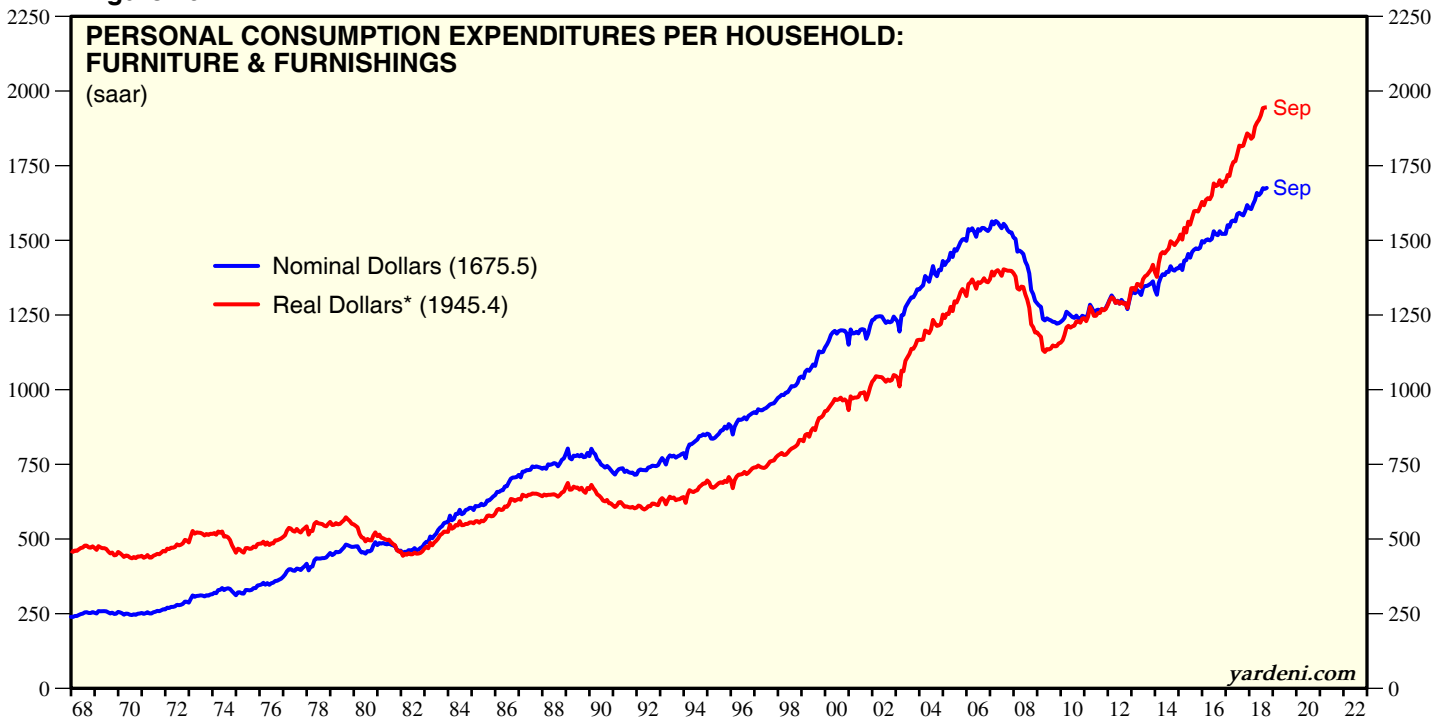

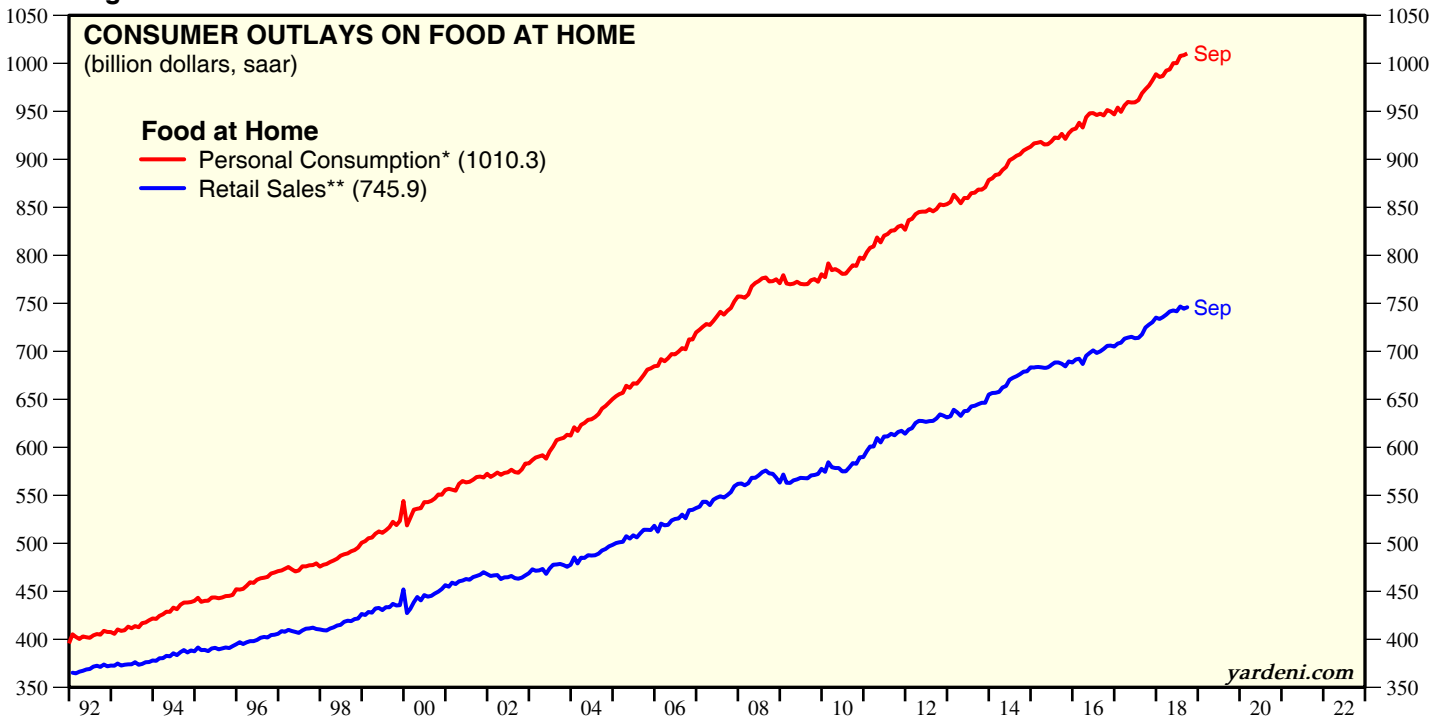

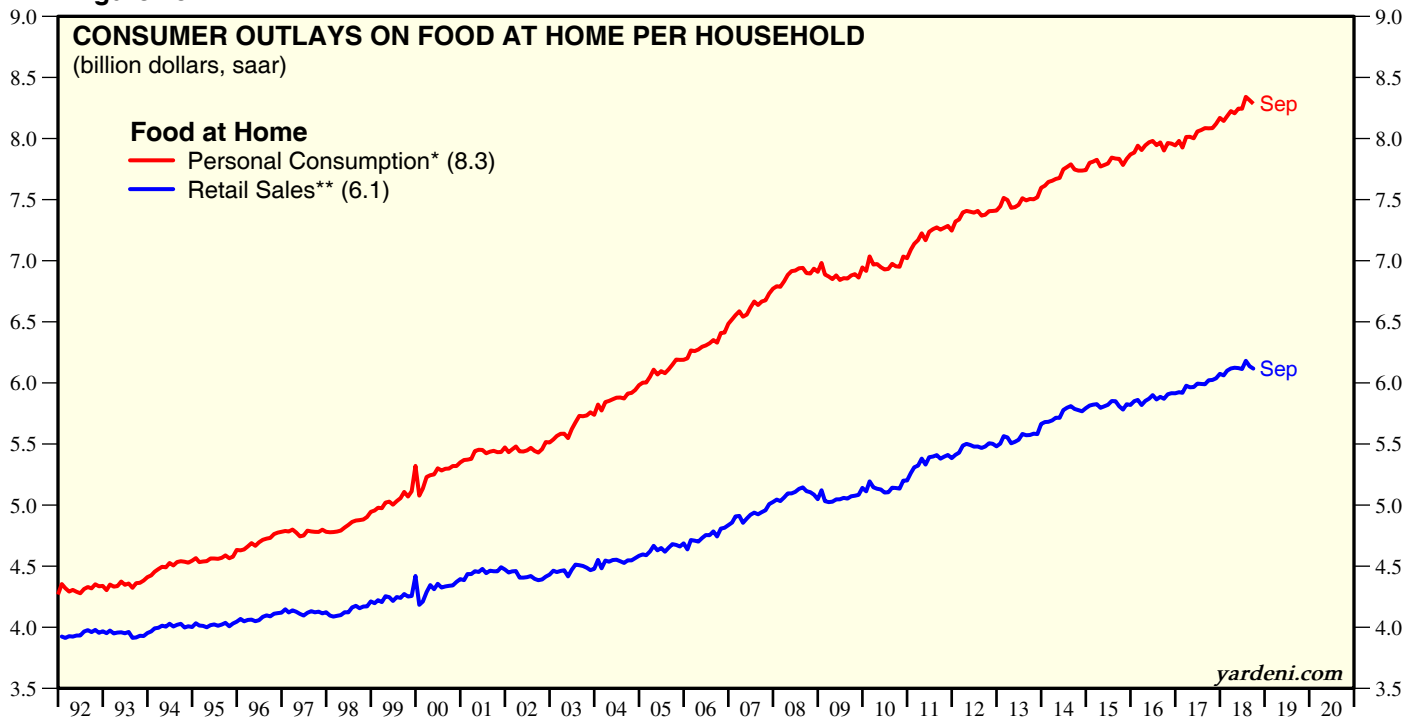


* Food & beverages purchased for off-premises consumption.

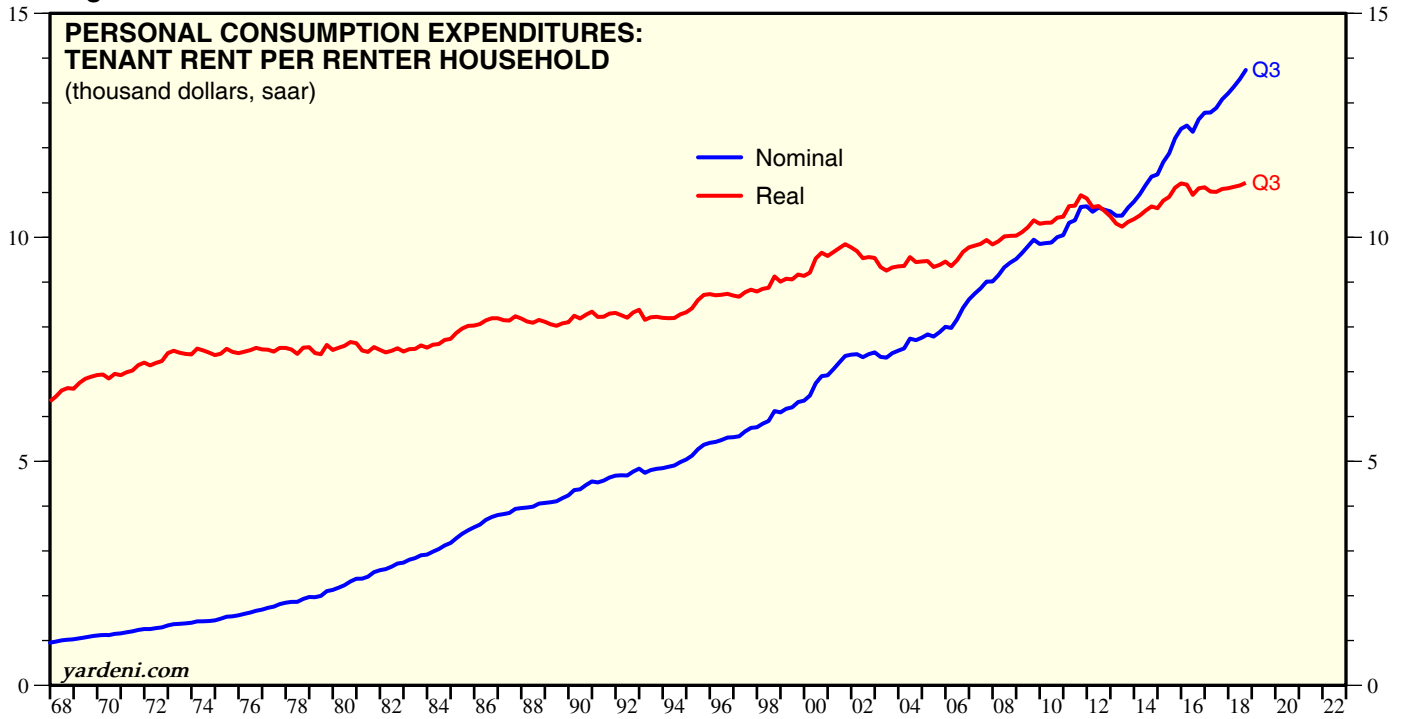

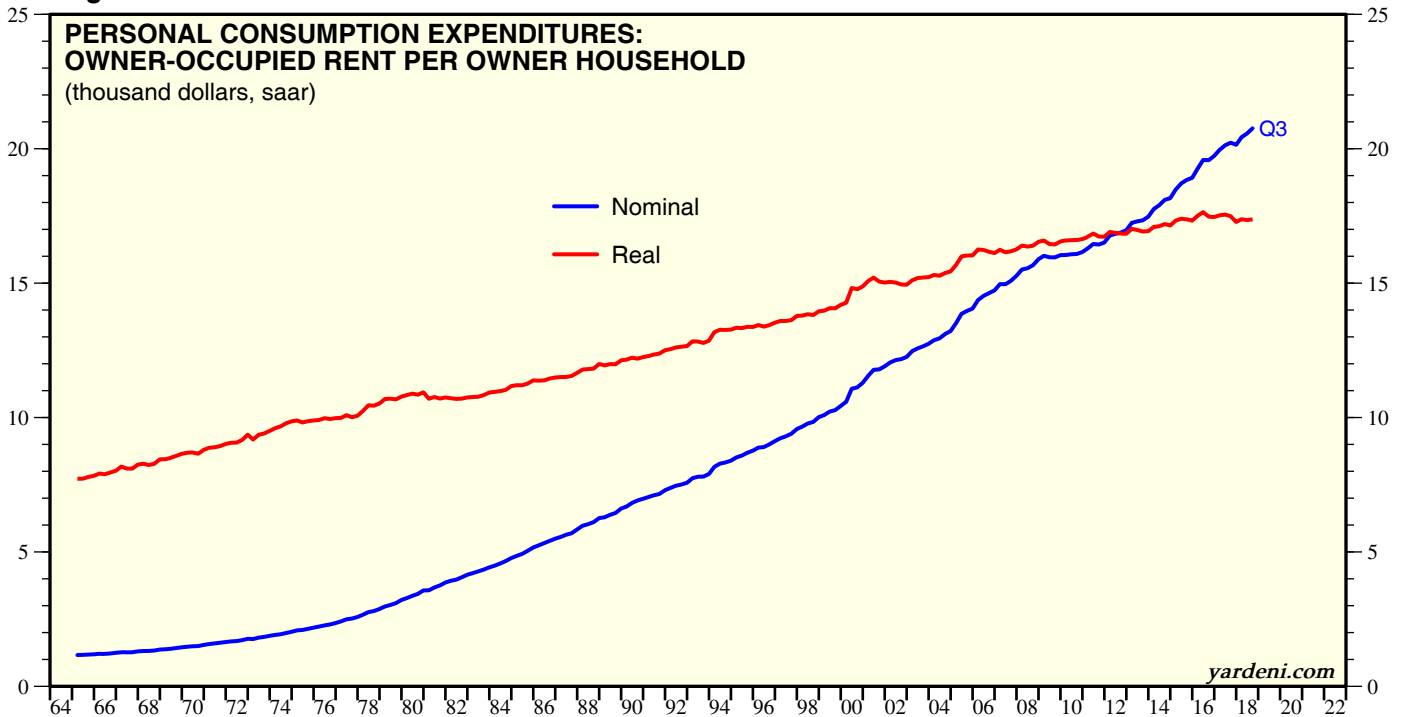
