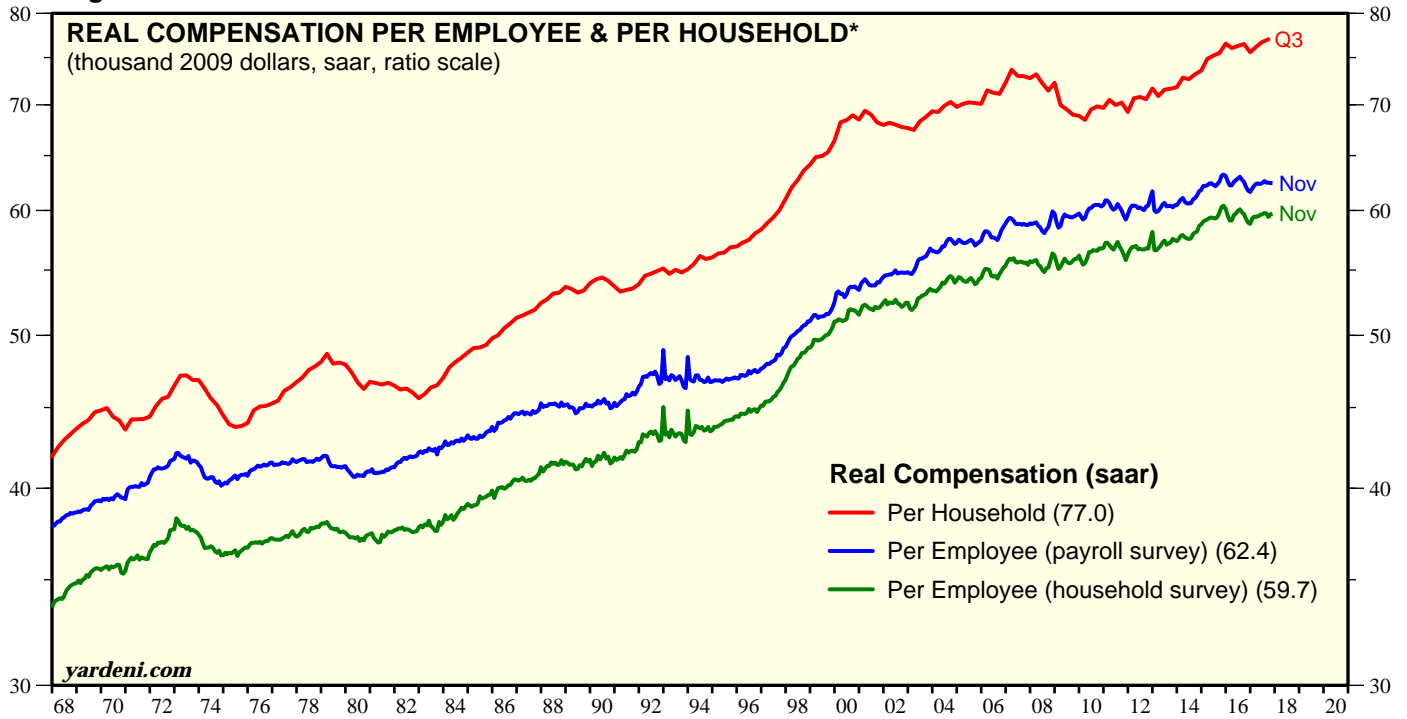

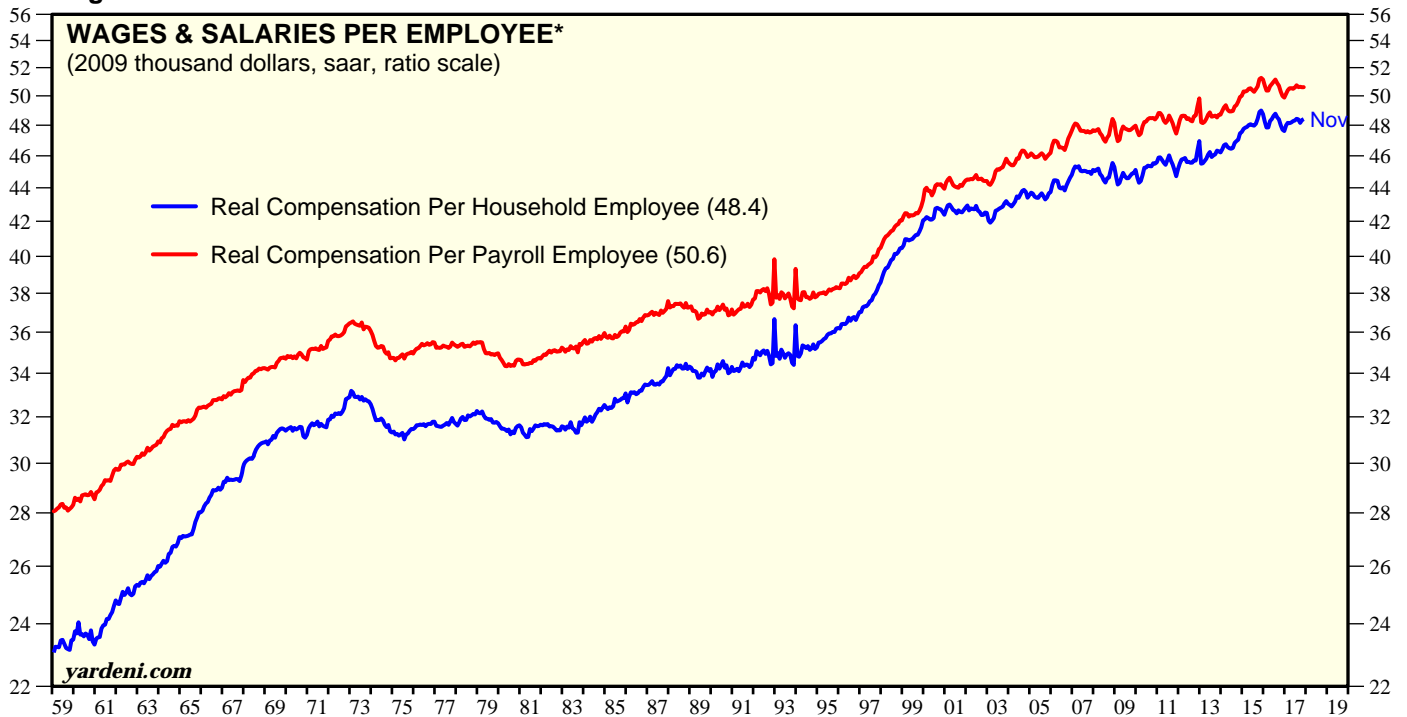

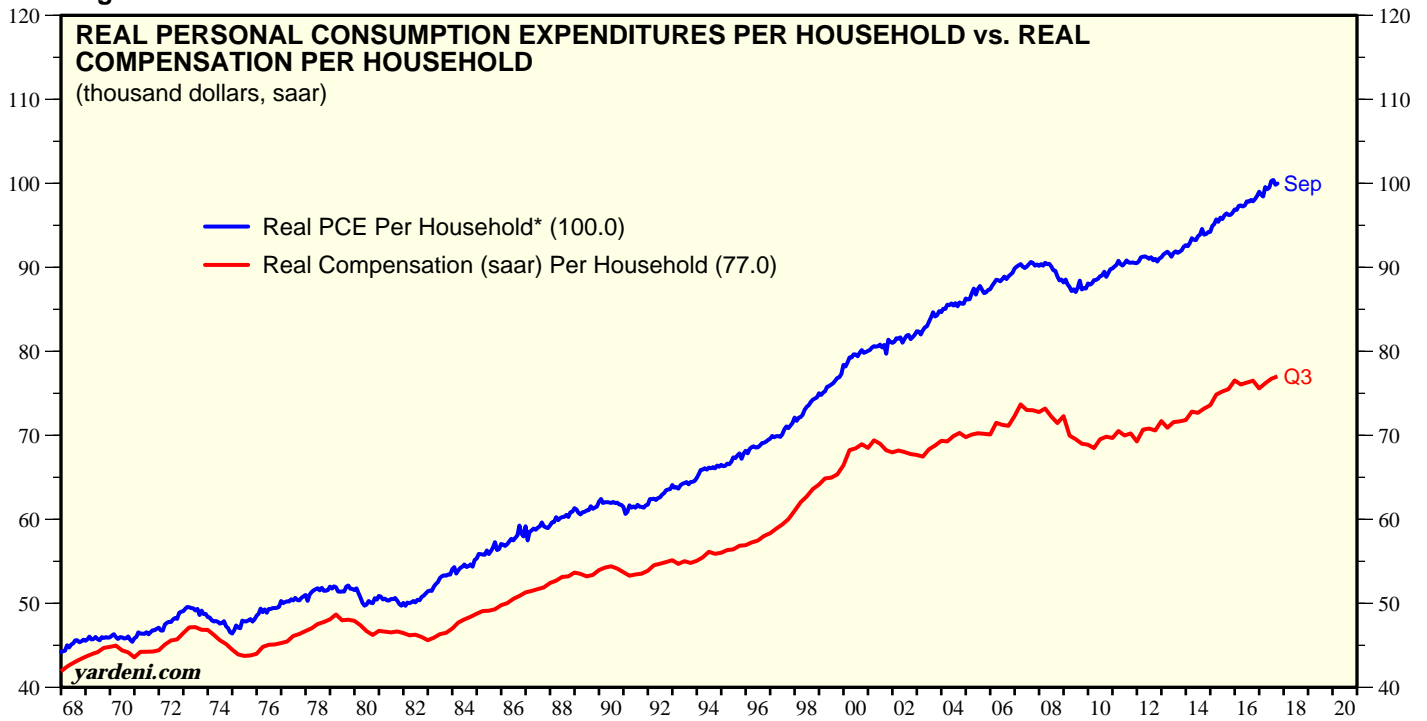

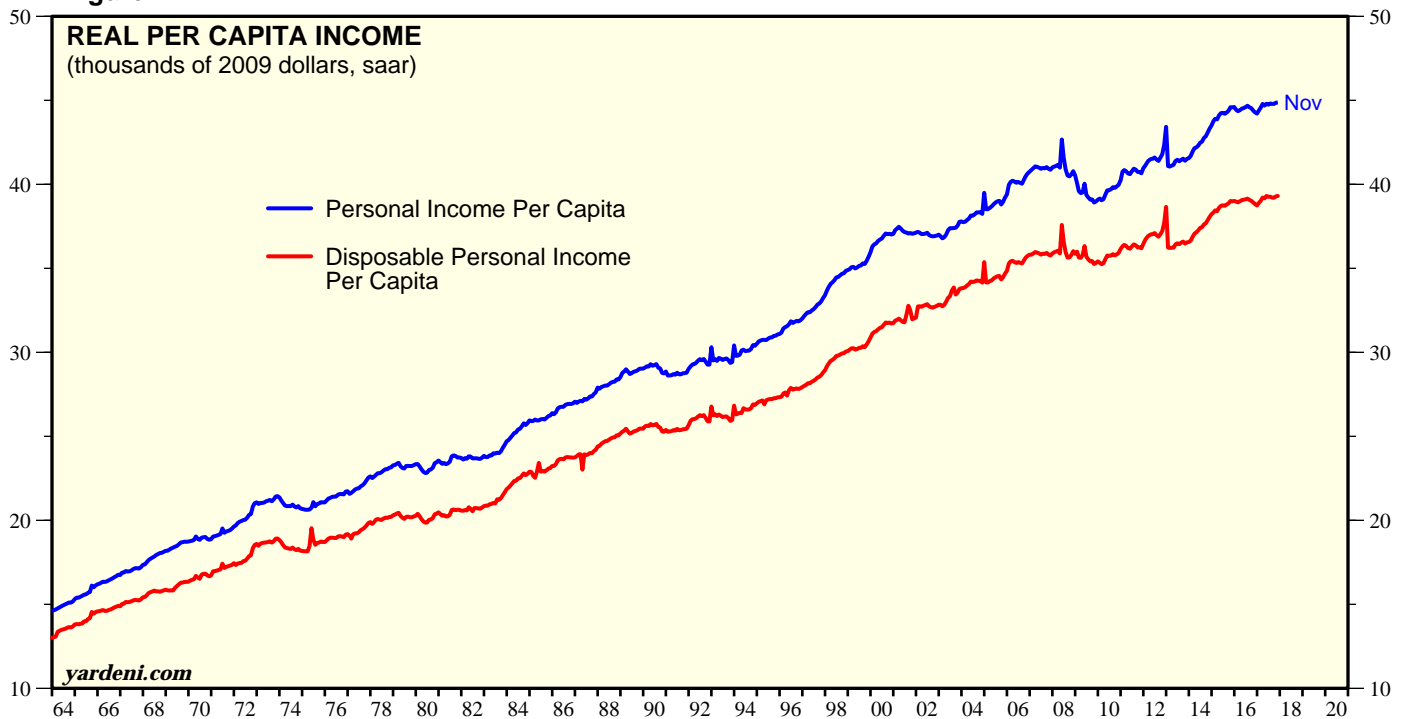

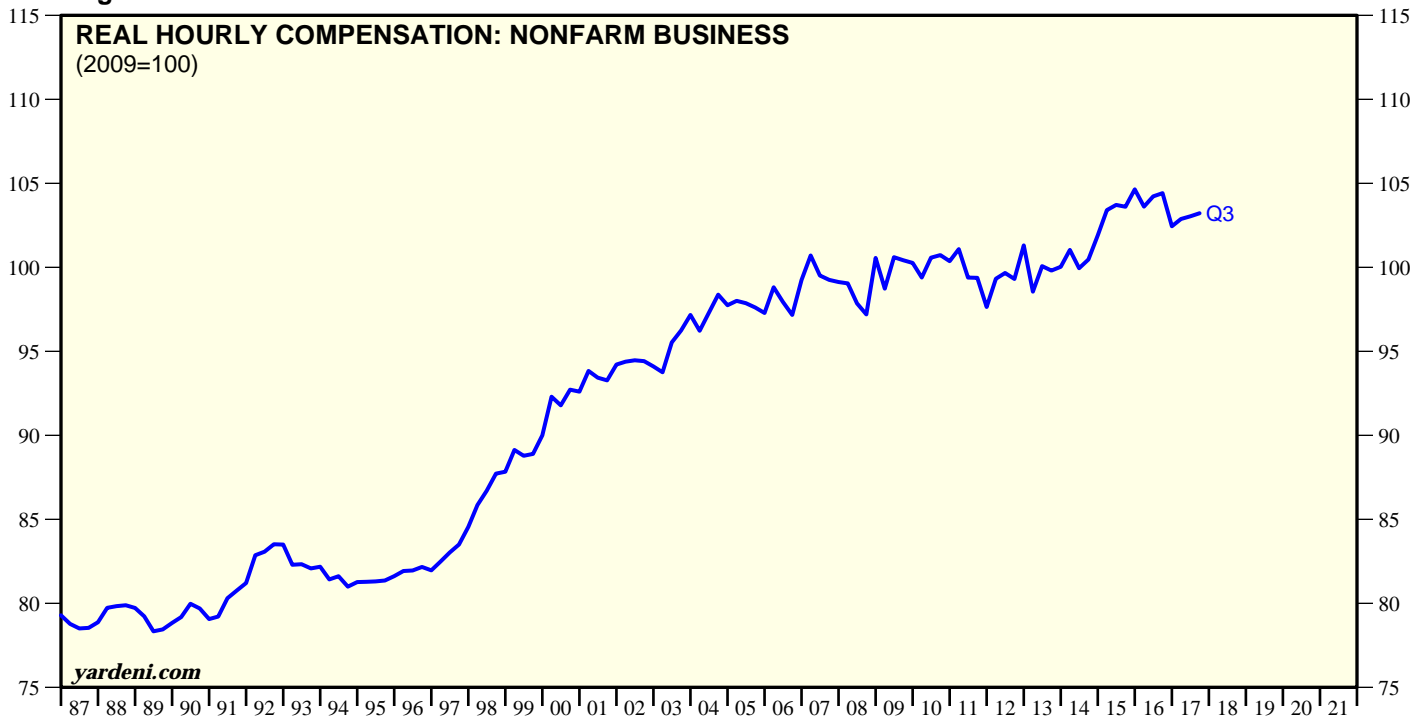

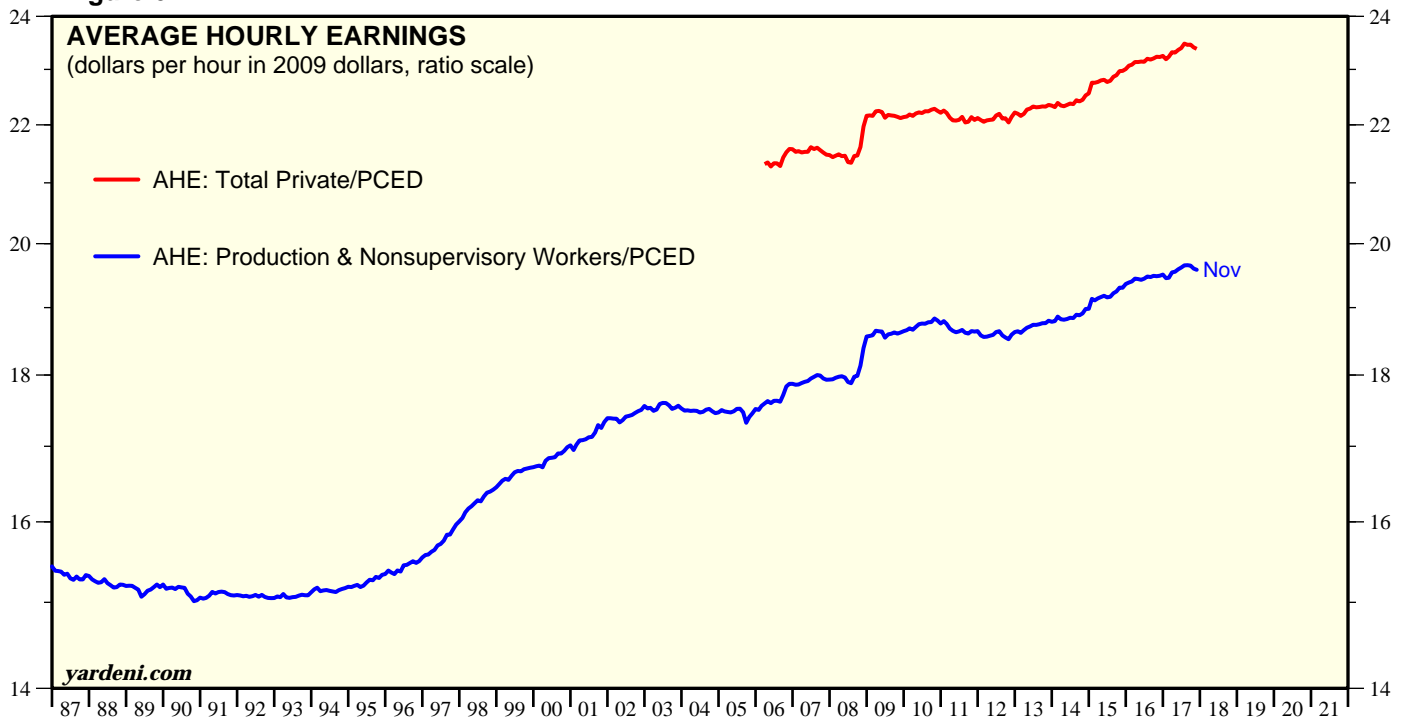

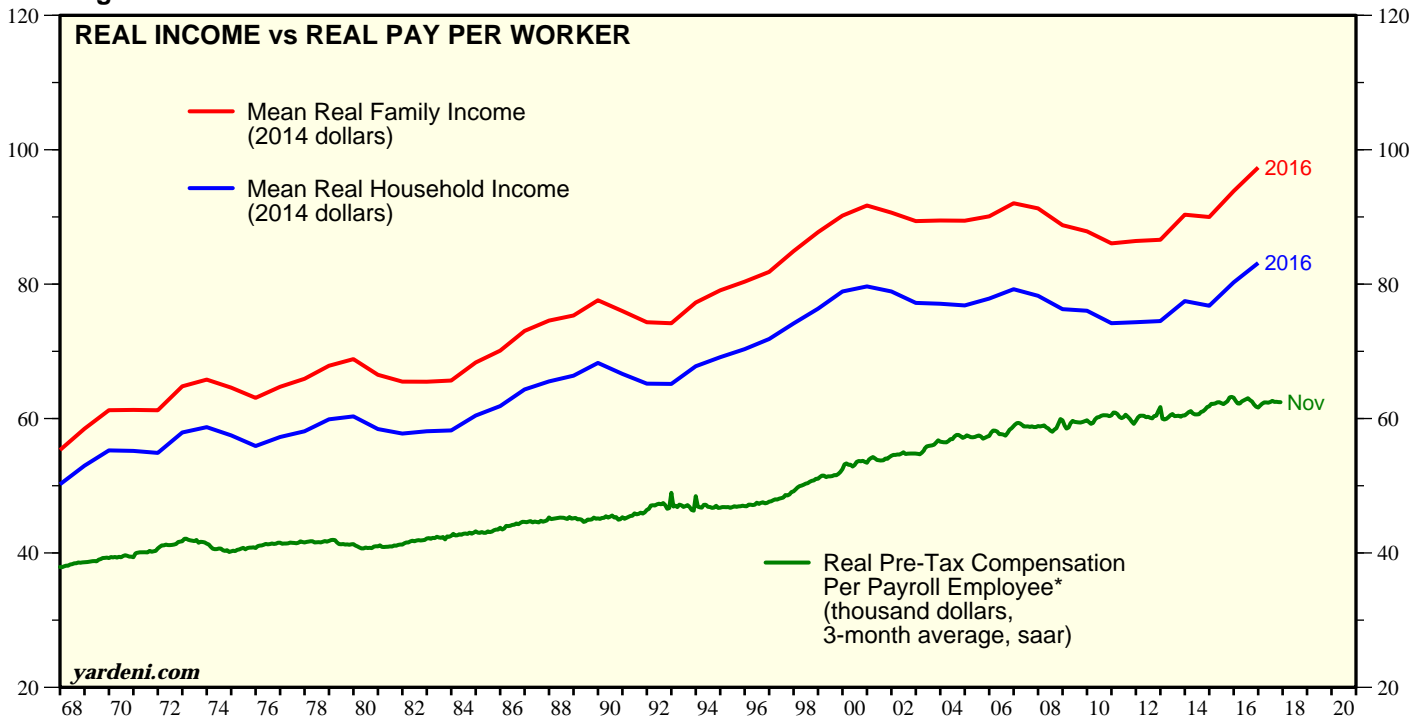

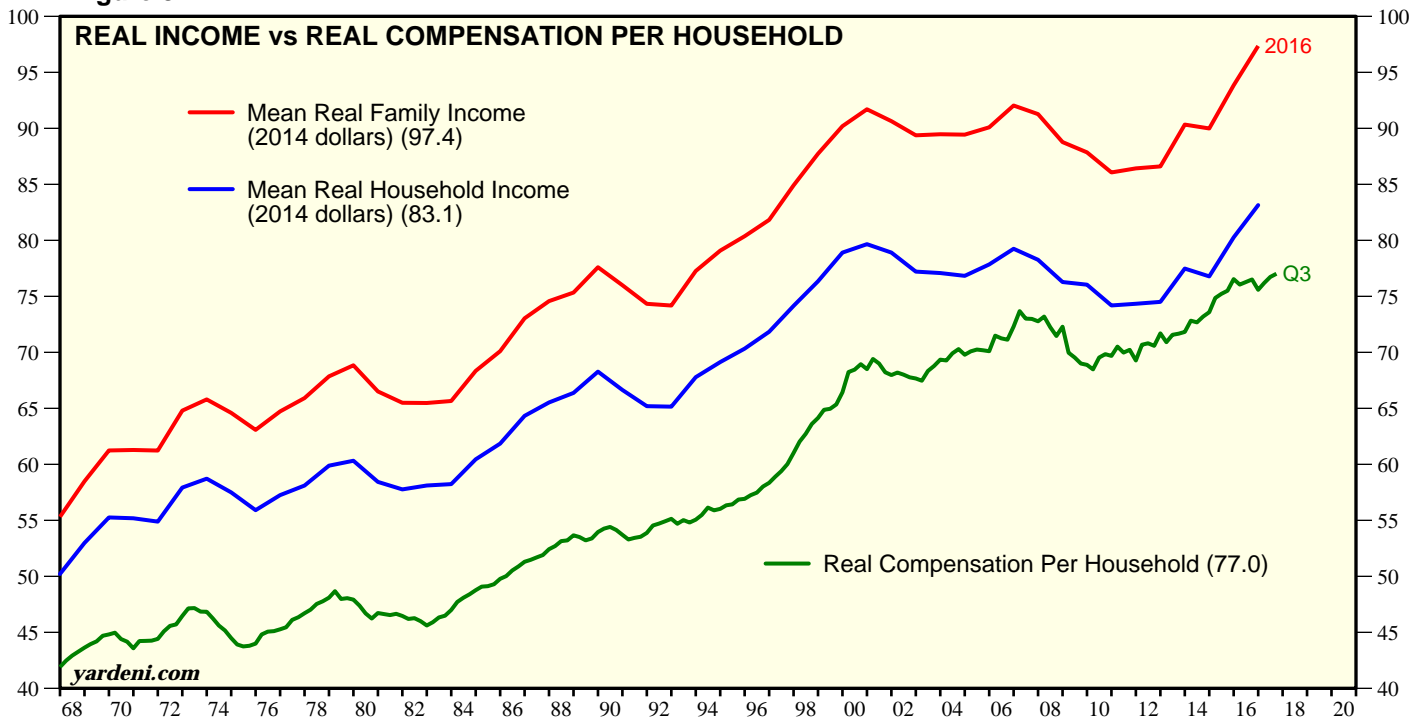
# Real Mean Household Income

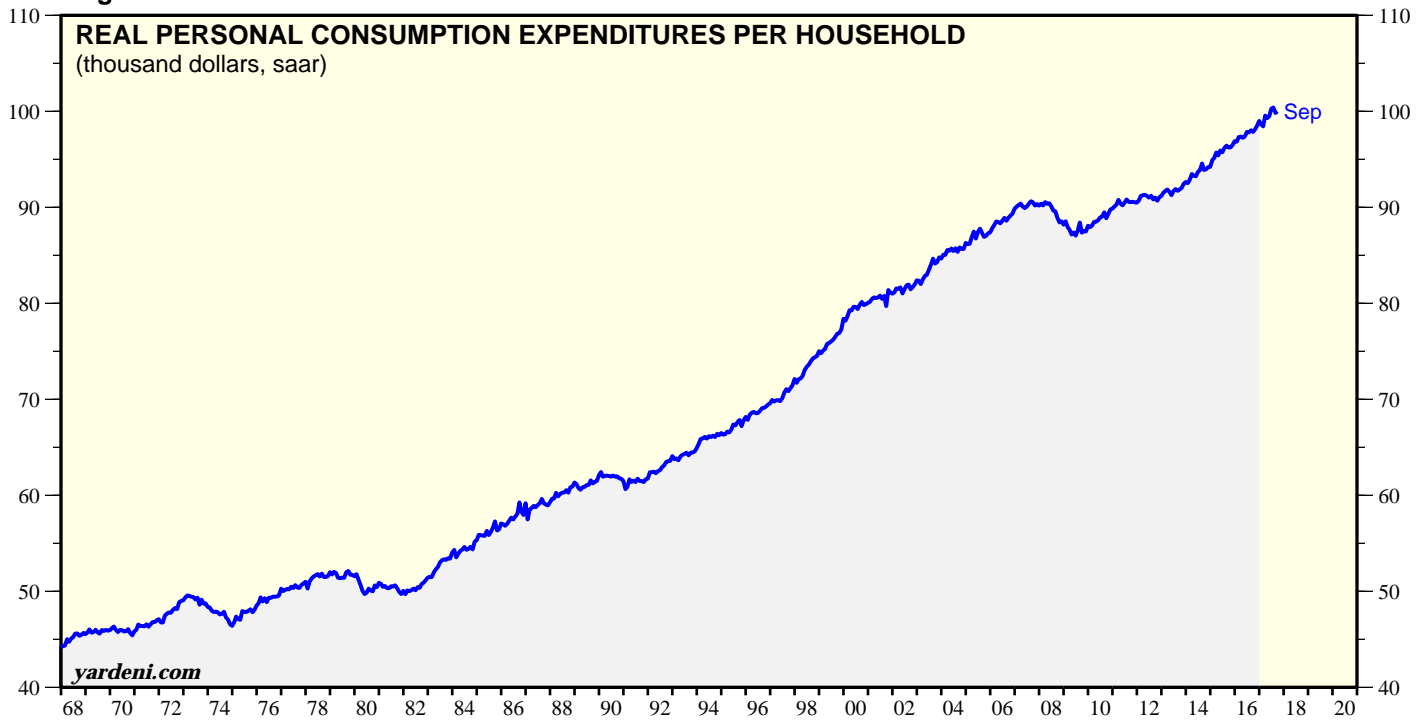

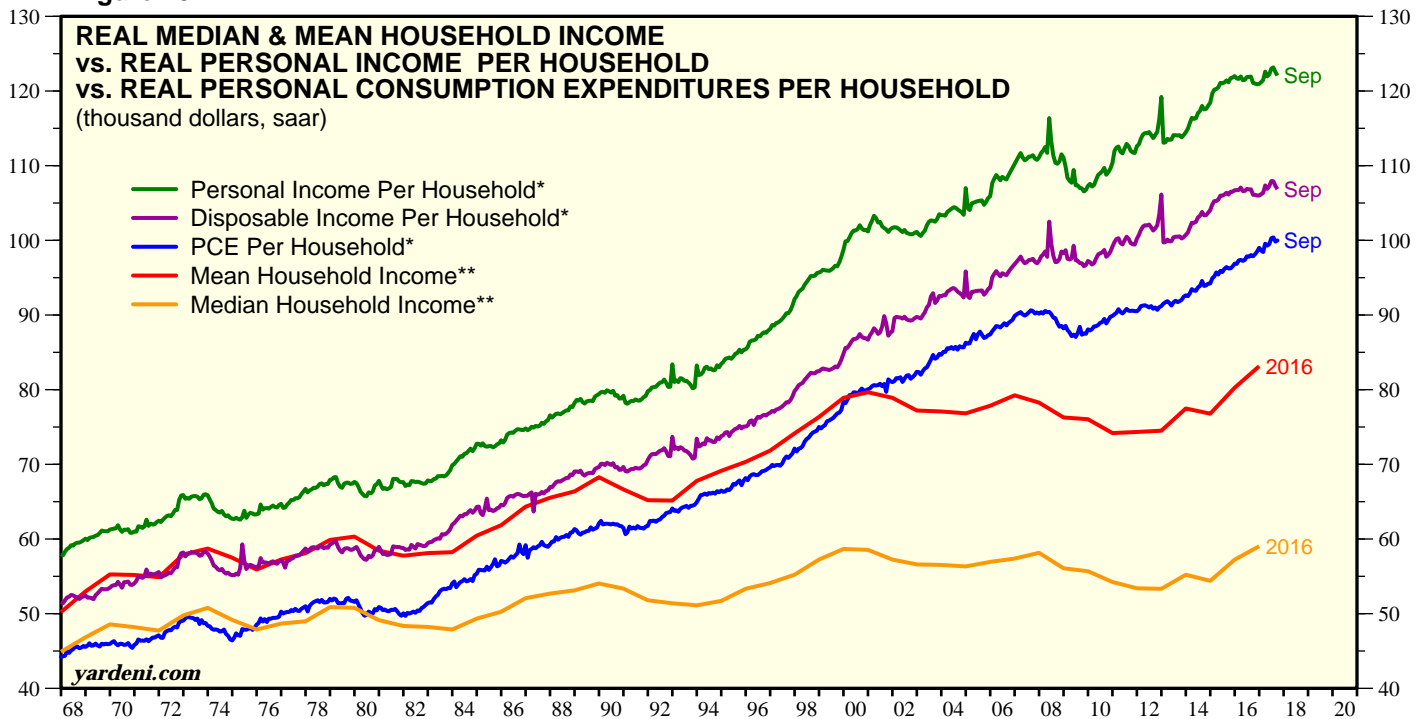

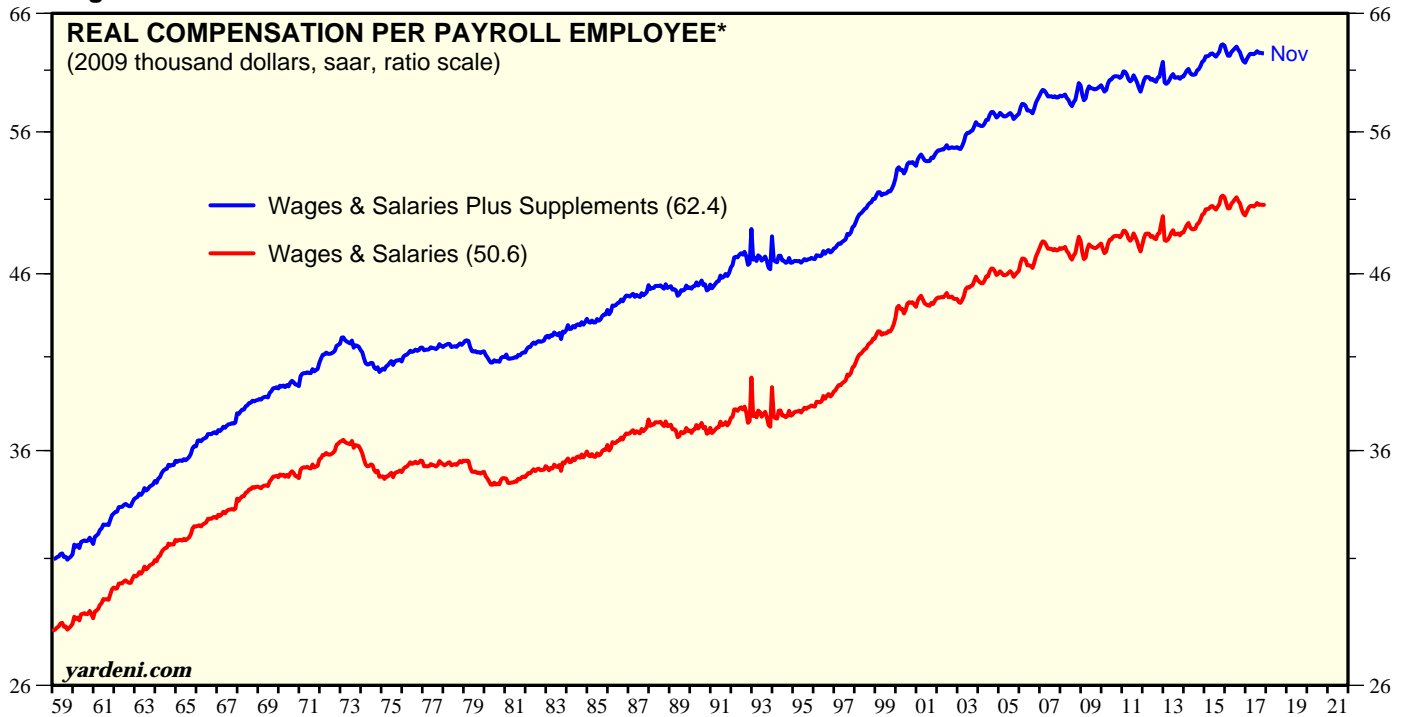

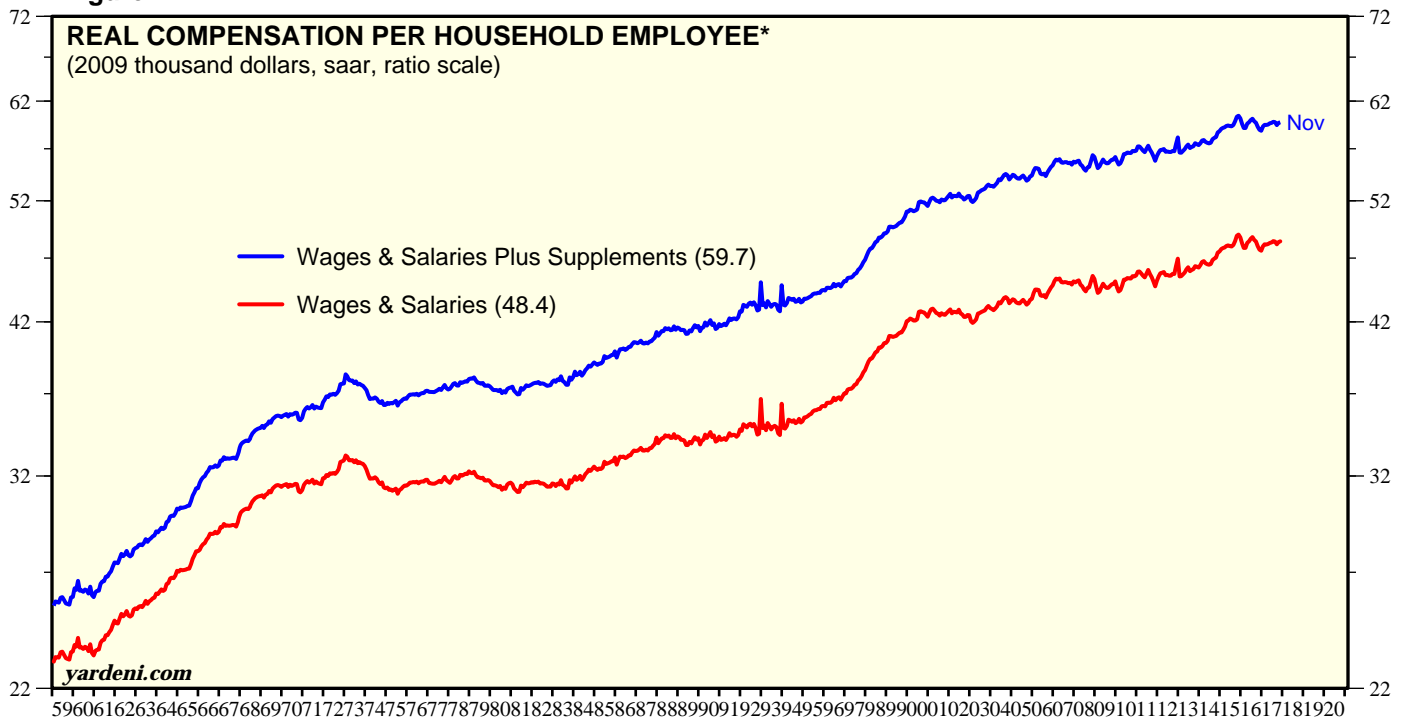
# Real Compensation Per Employee
