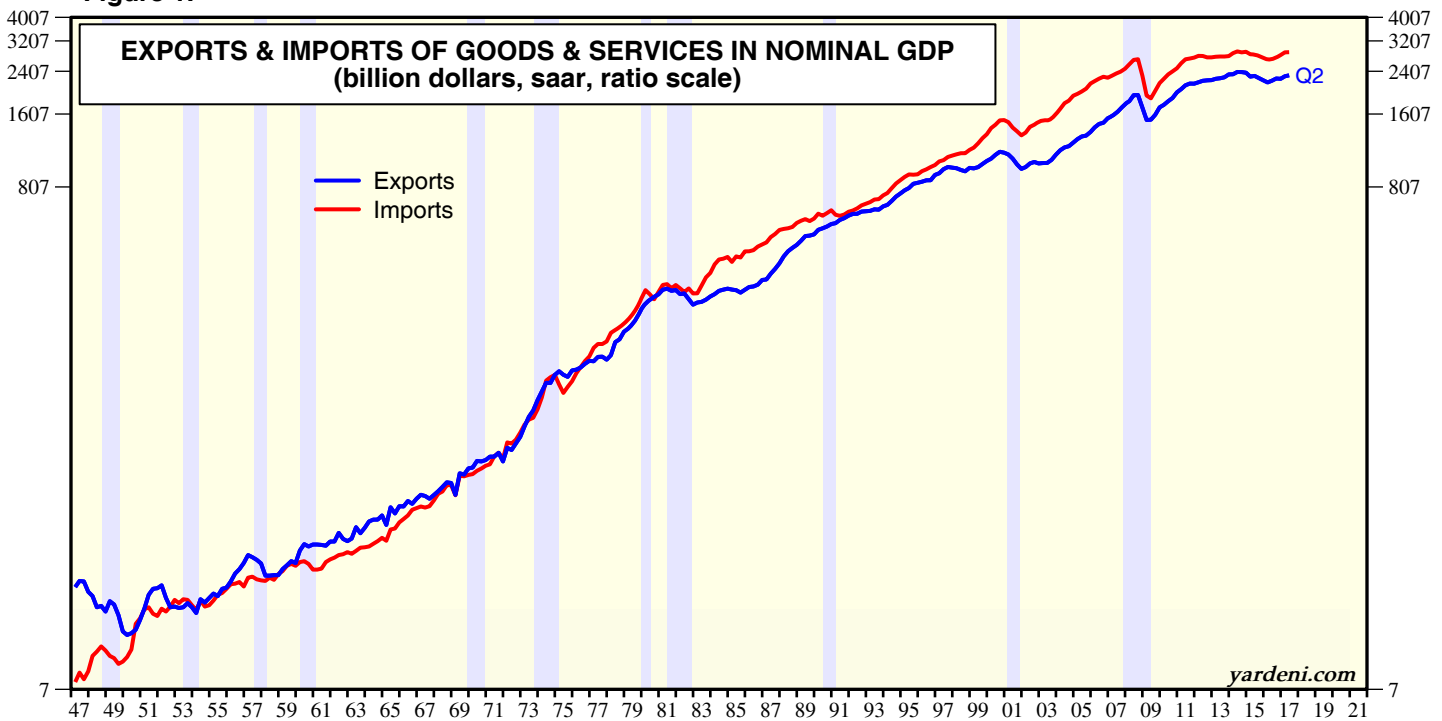

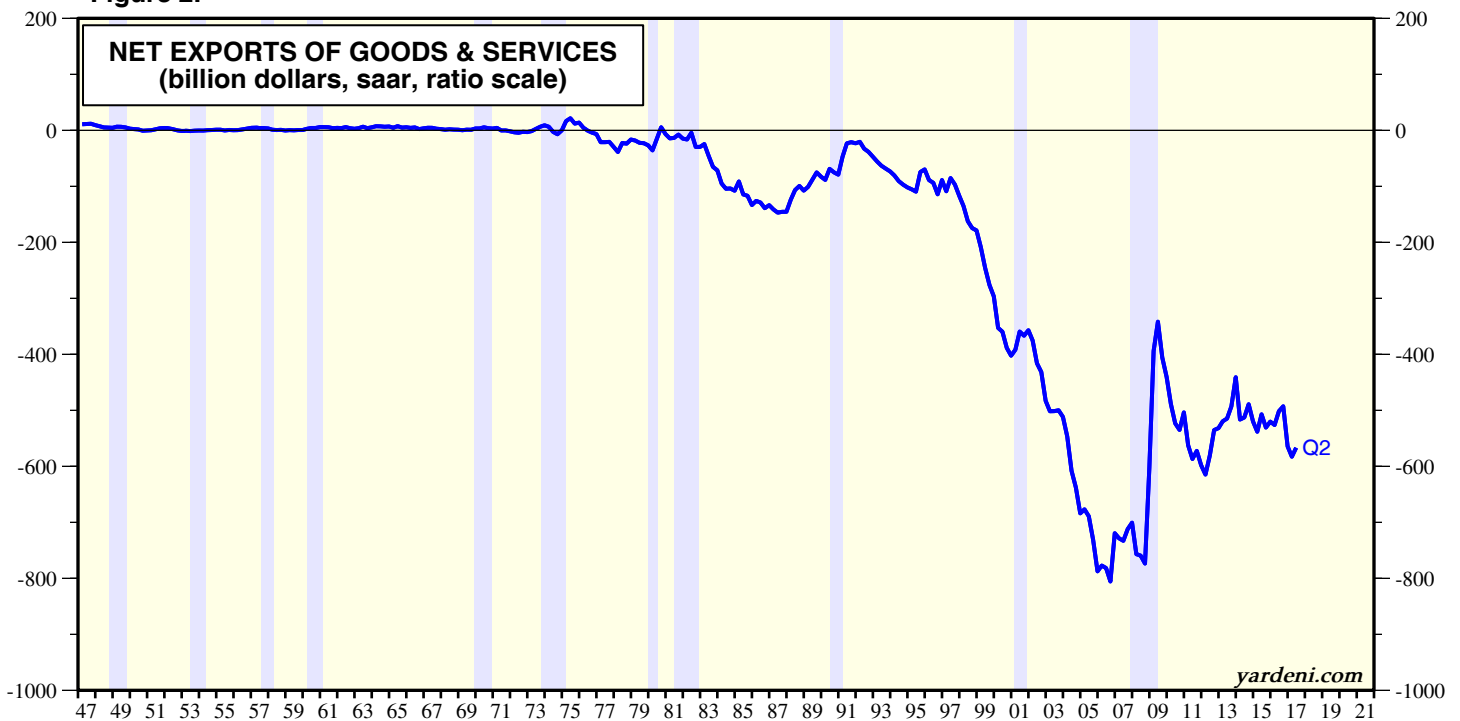

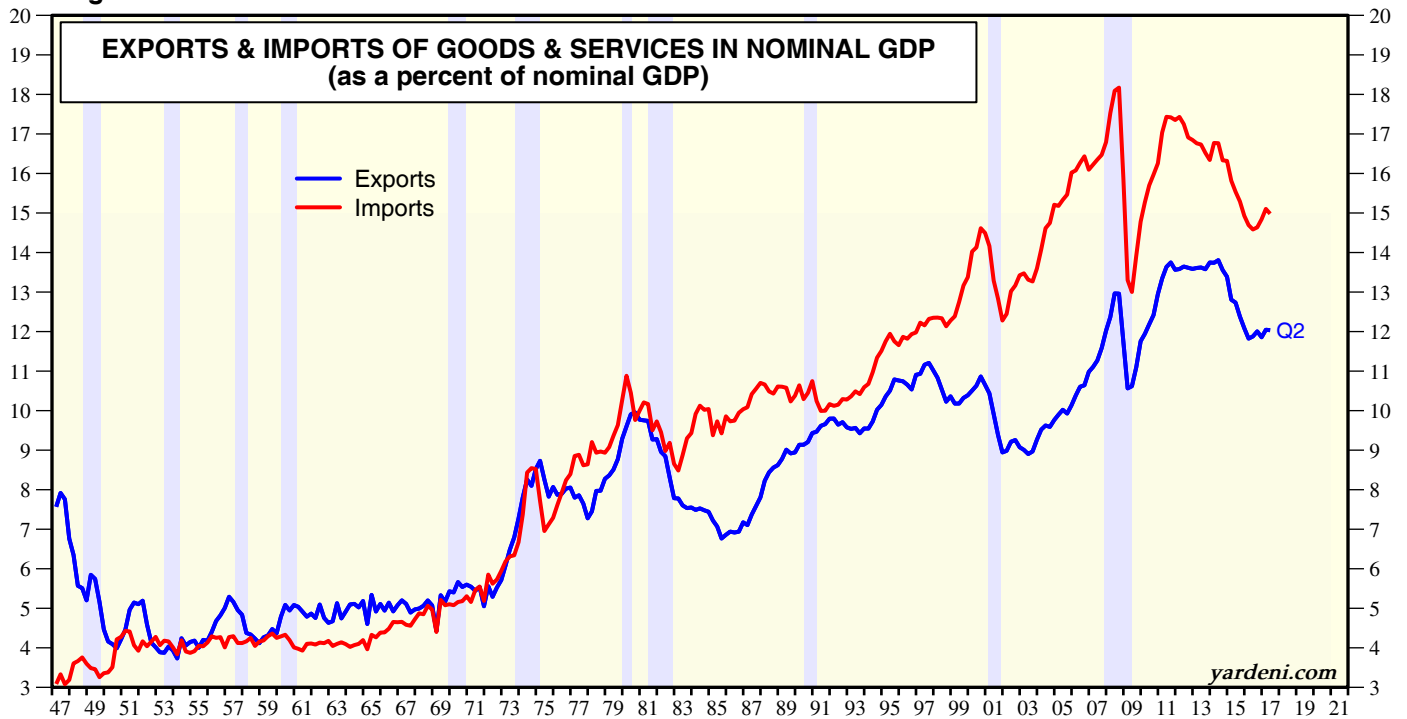

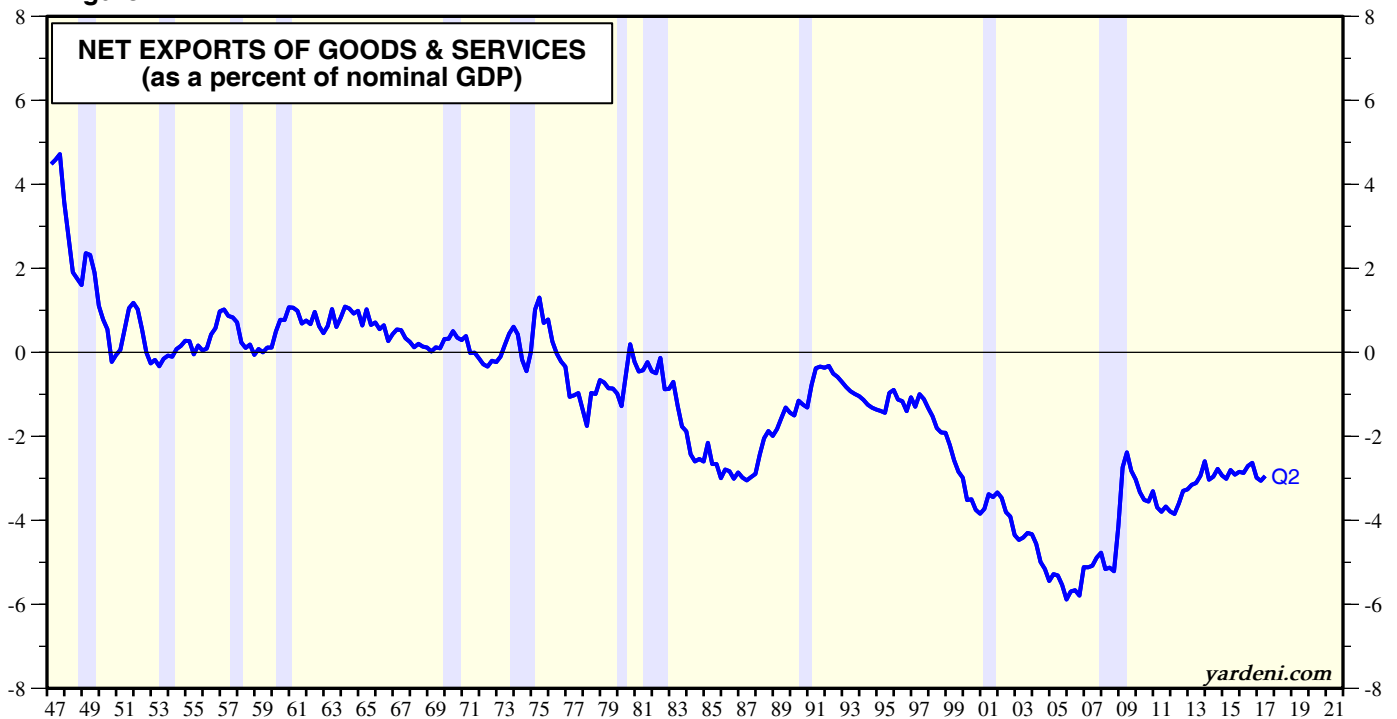

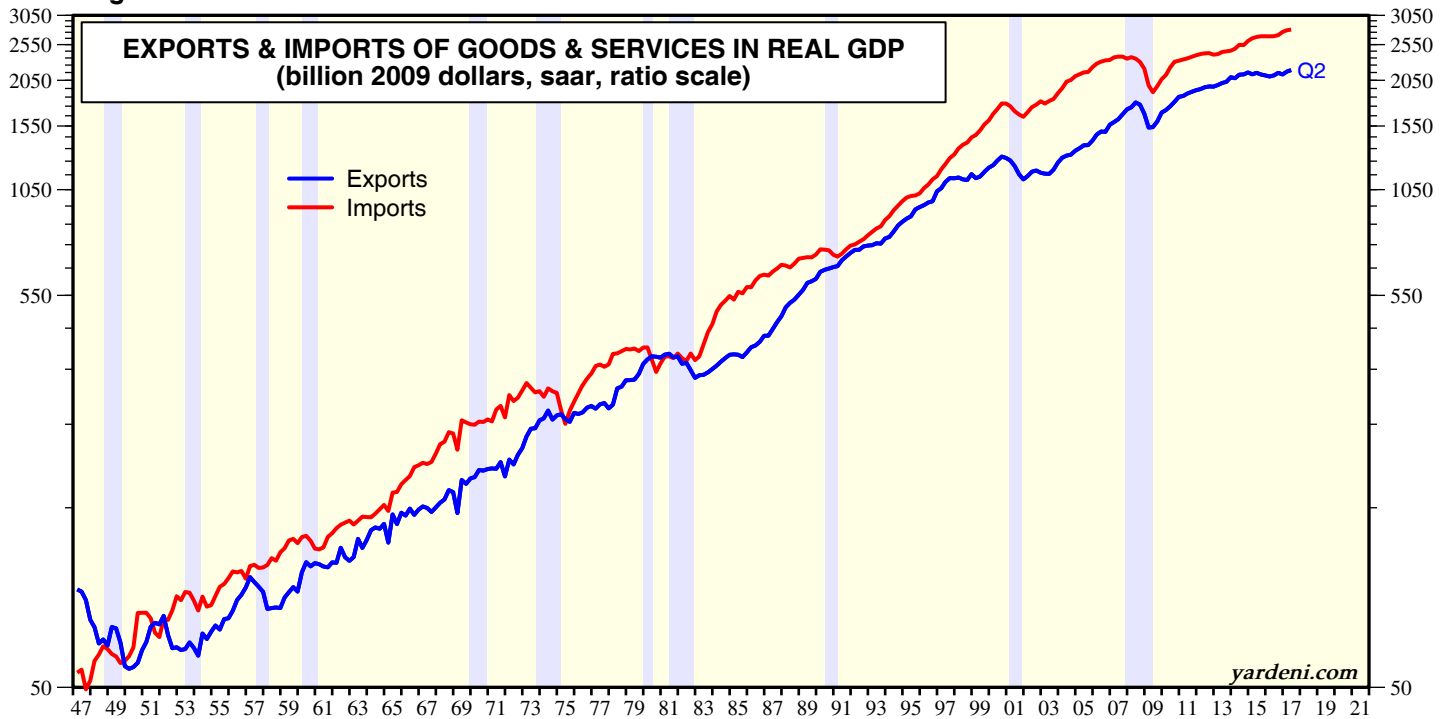

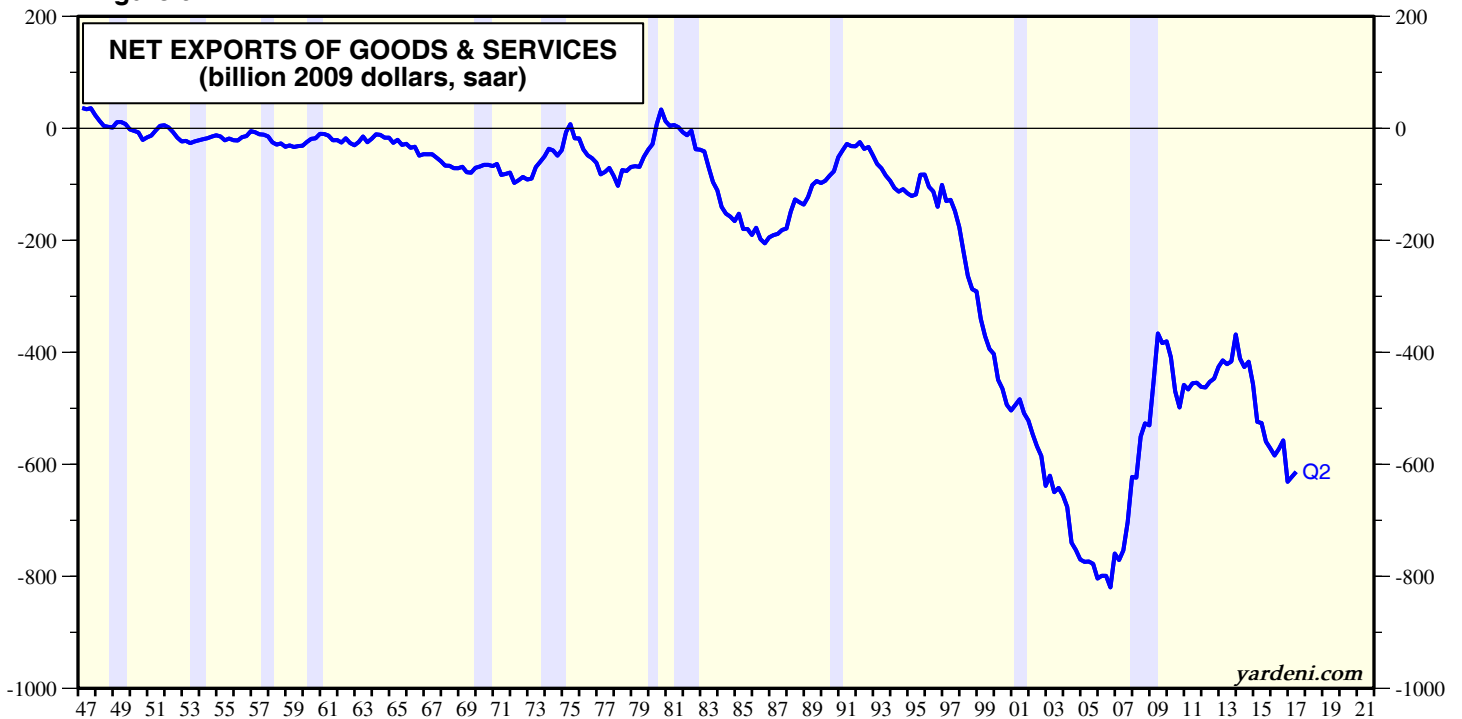

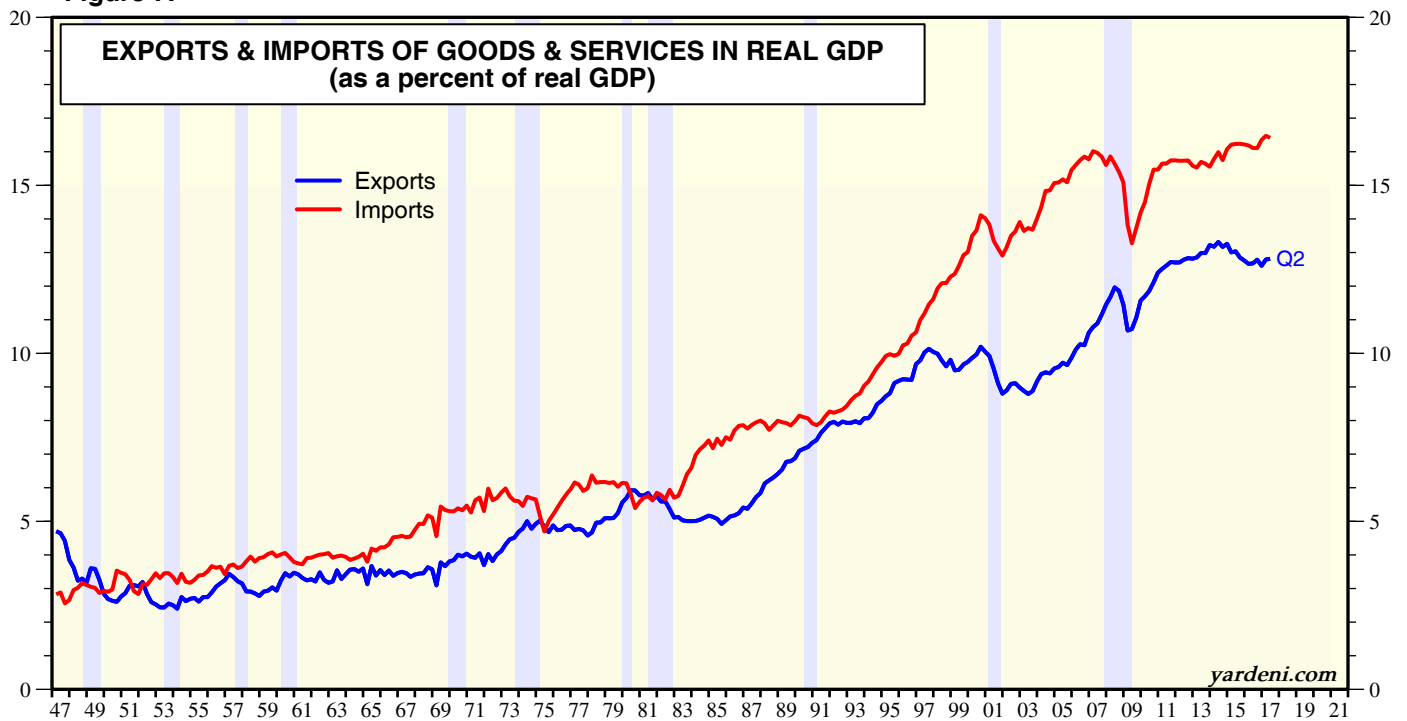

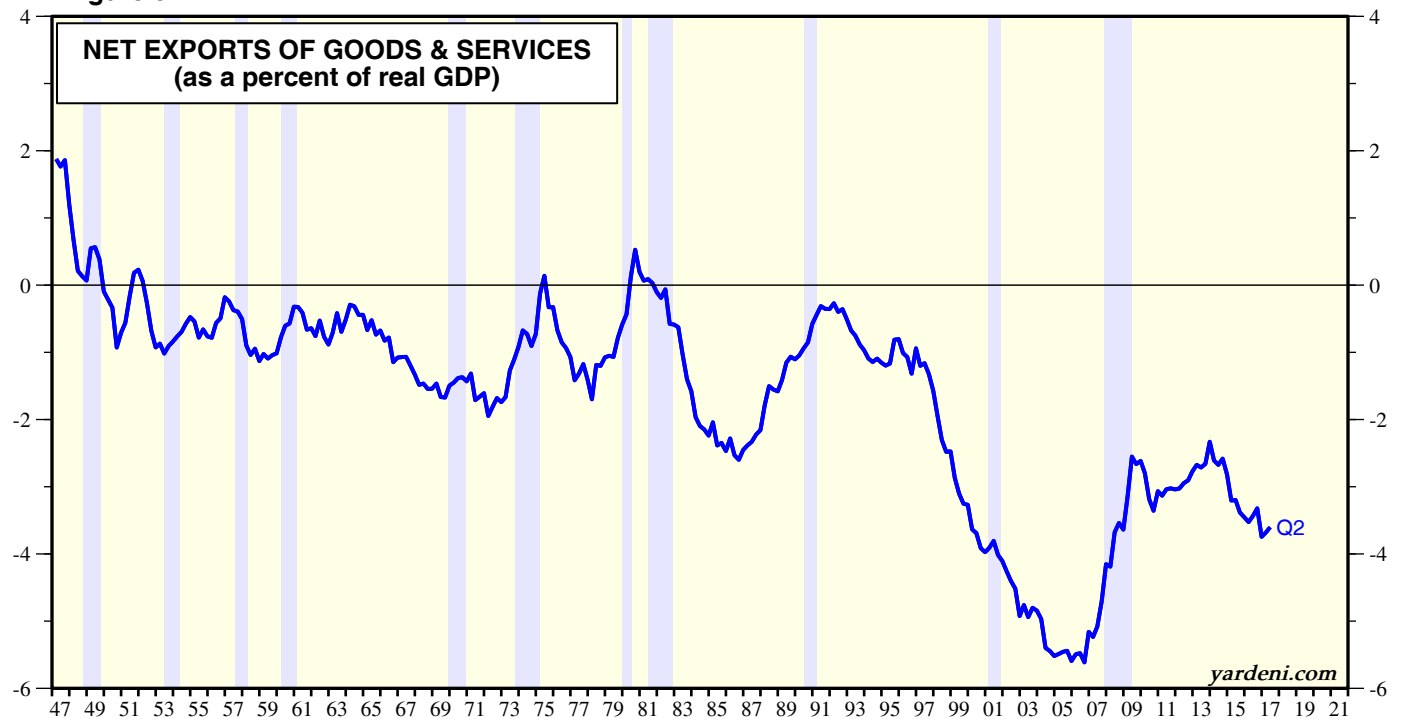

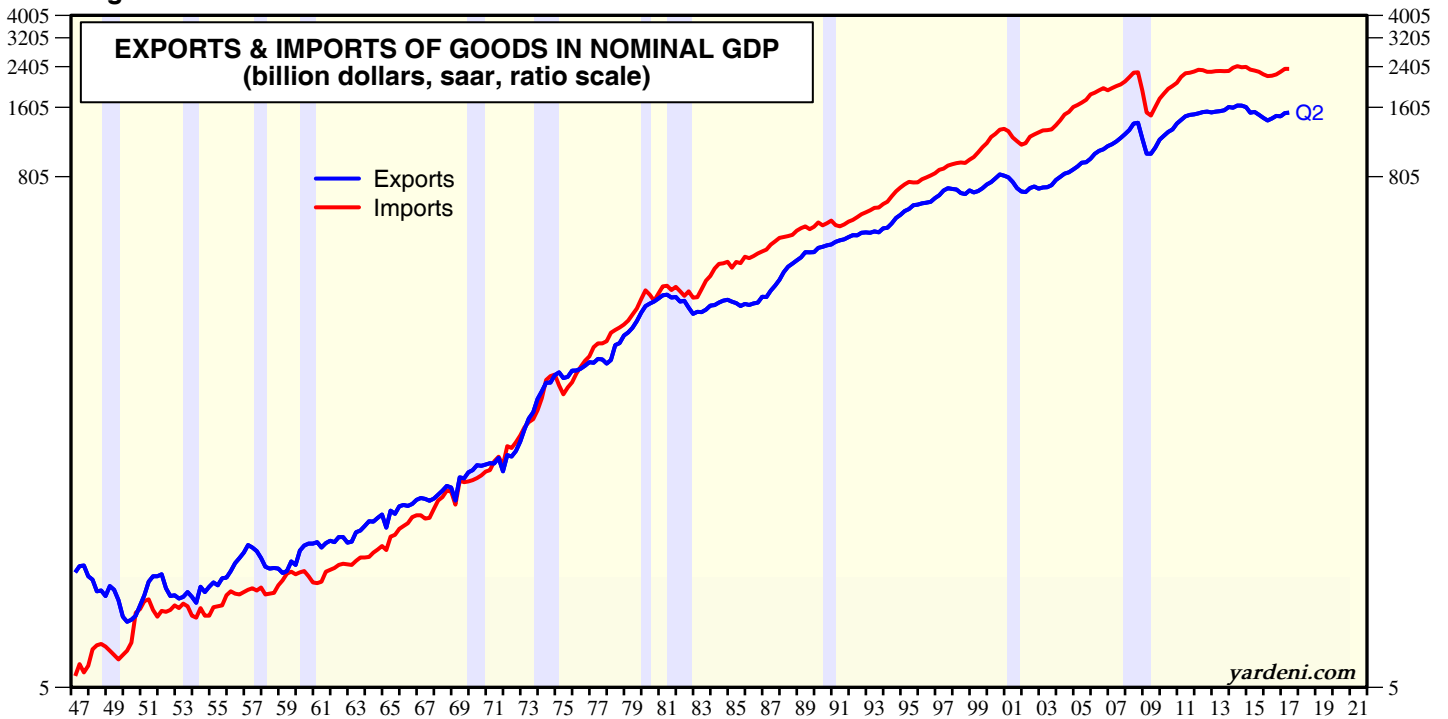

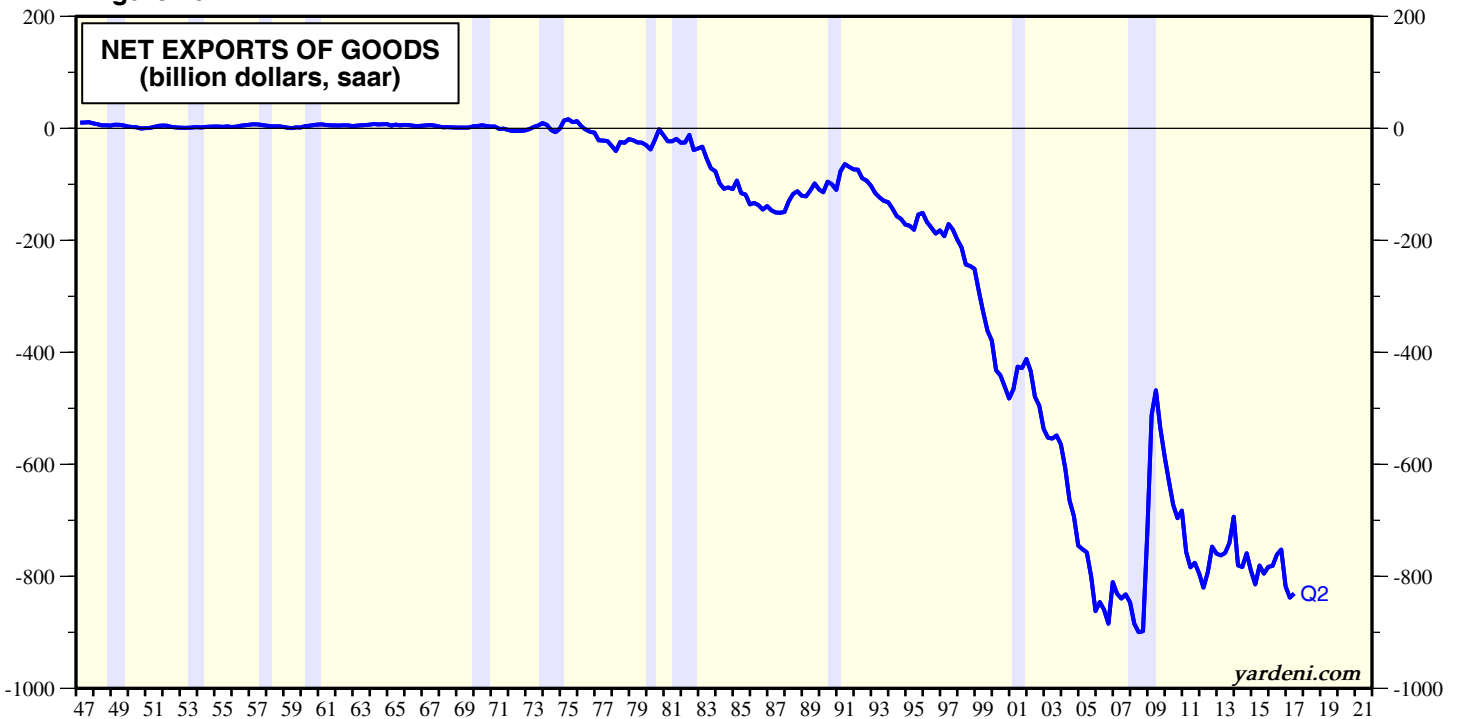

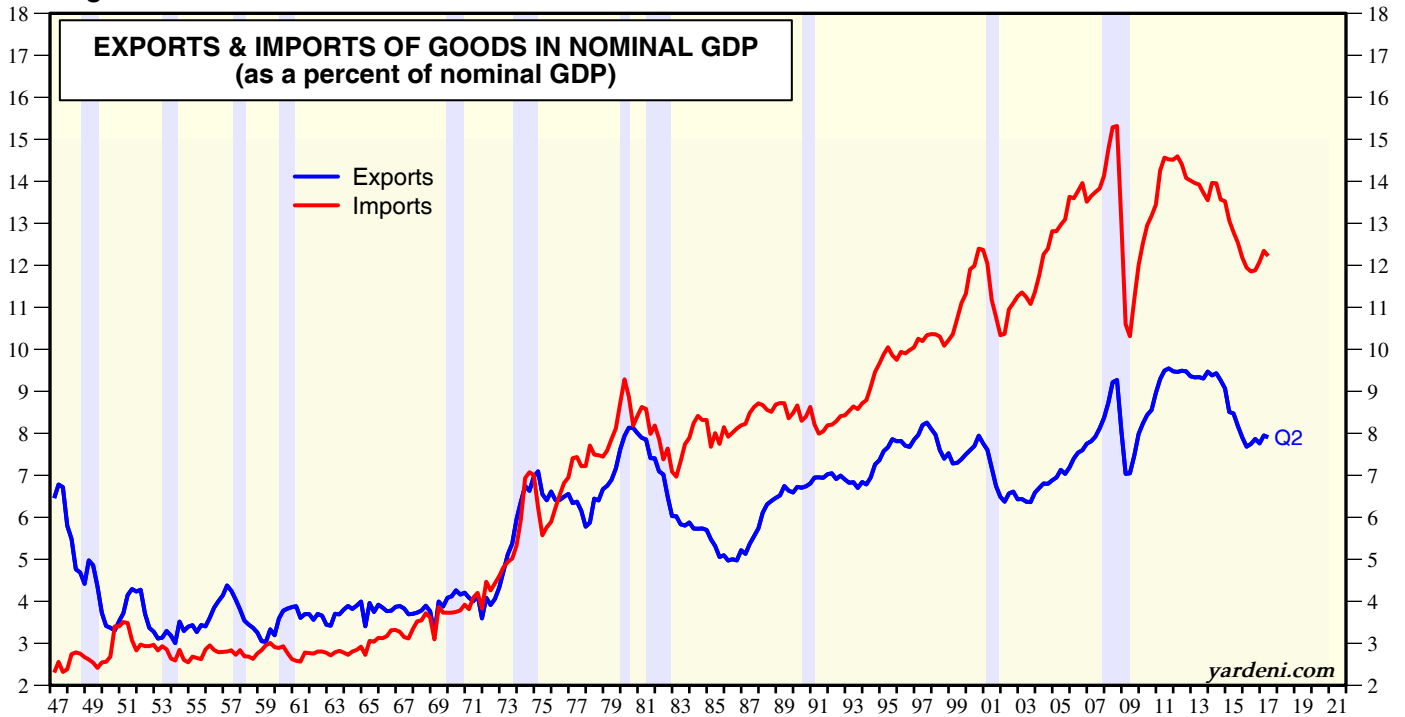

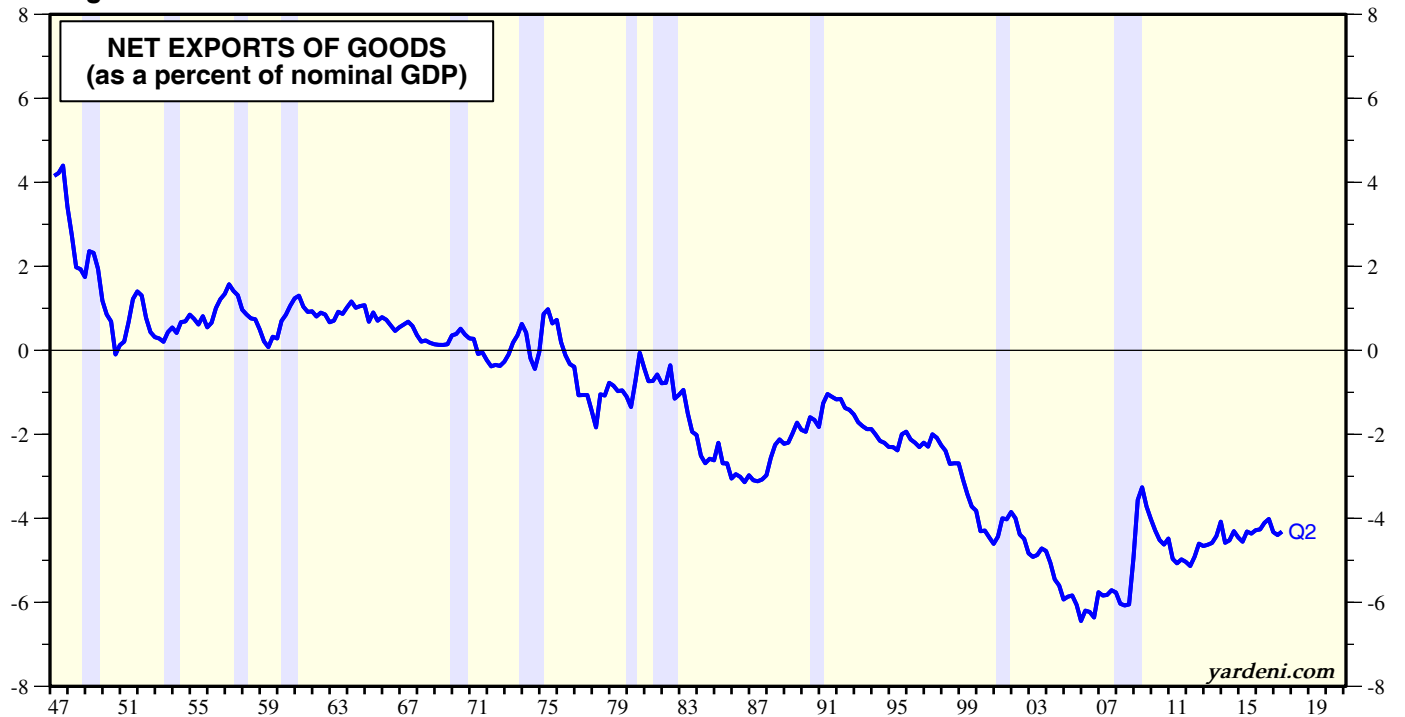
# Nominal Exports & Imports of Goods

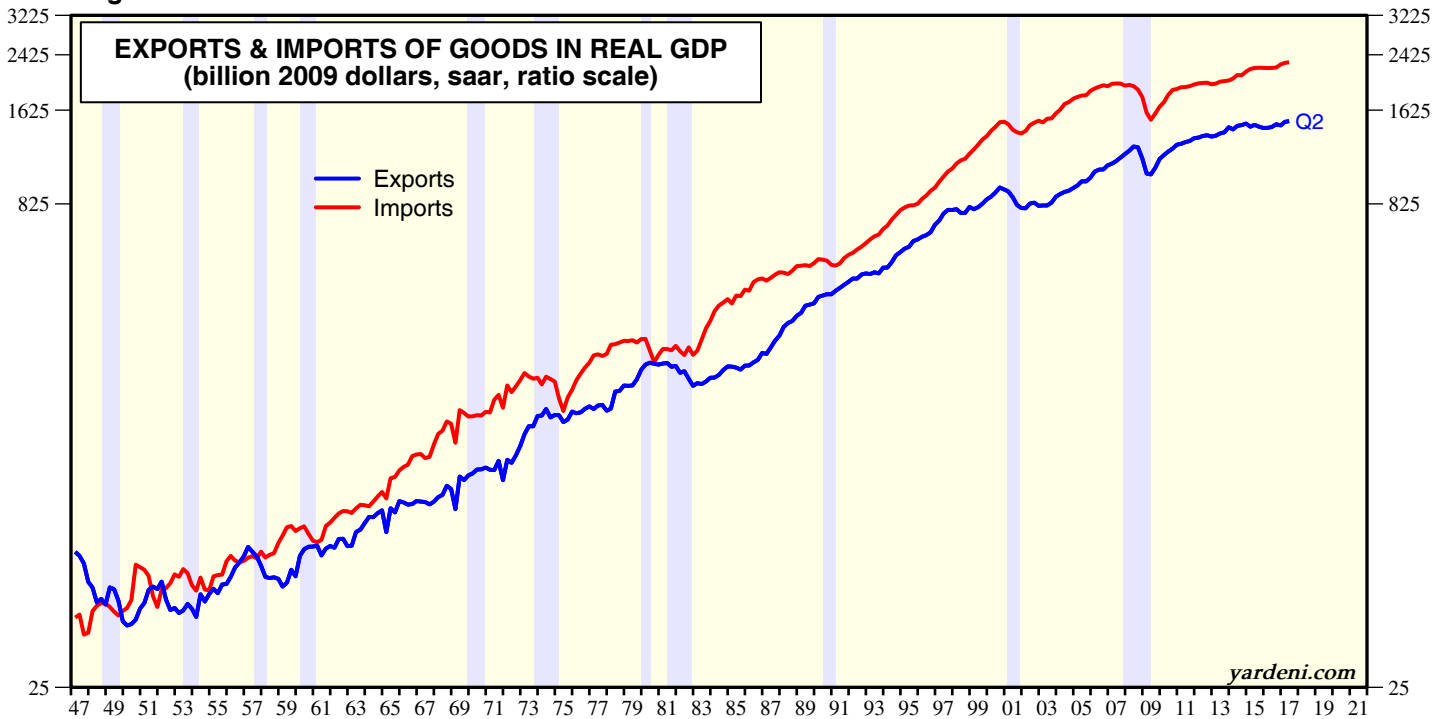

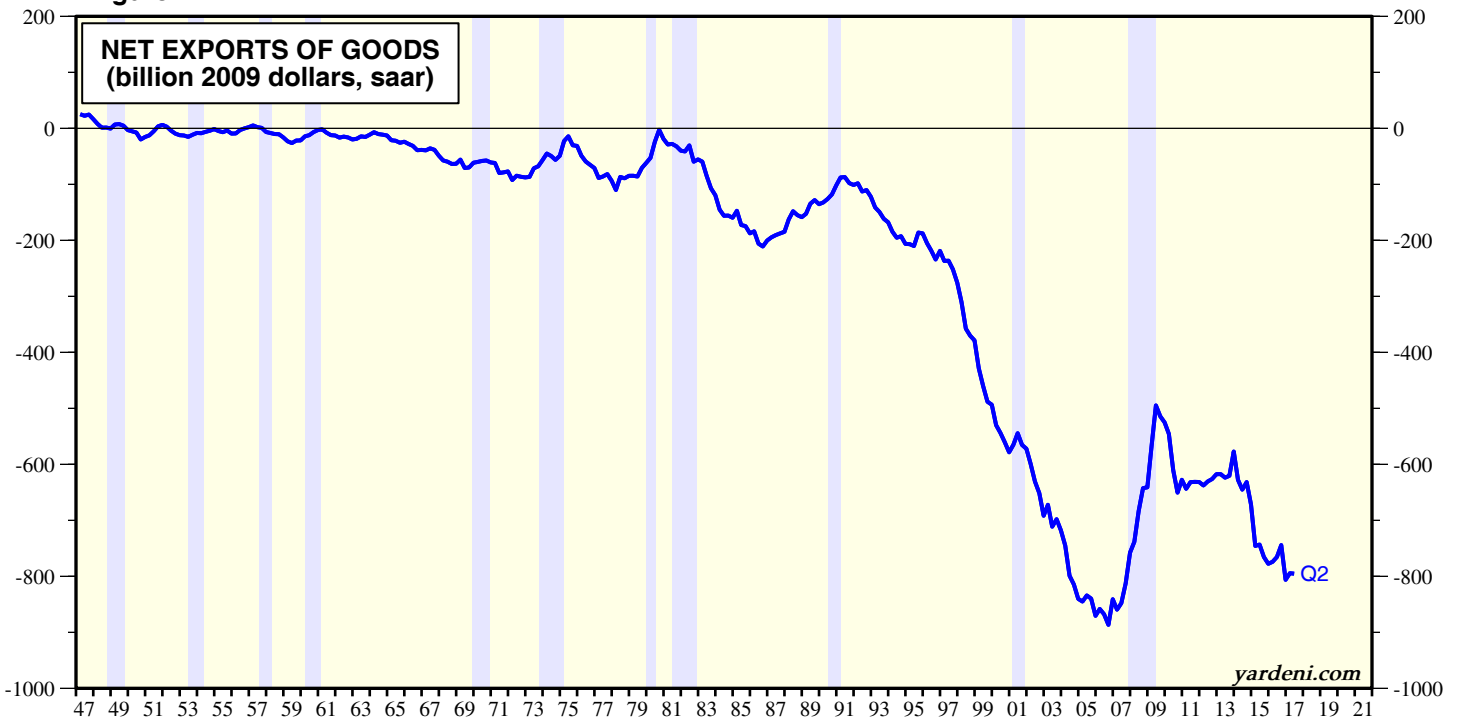

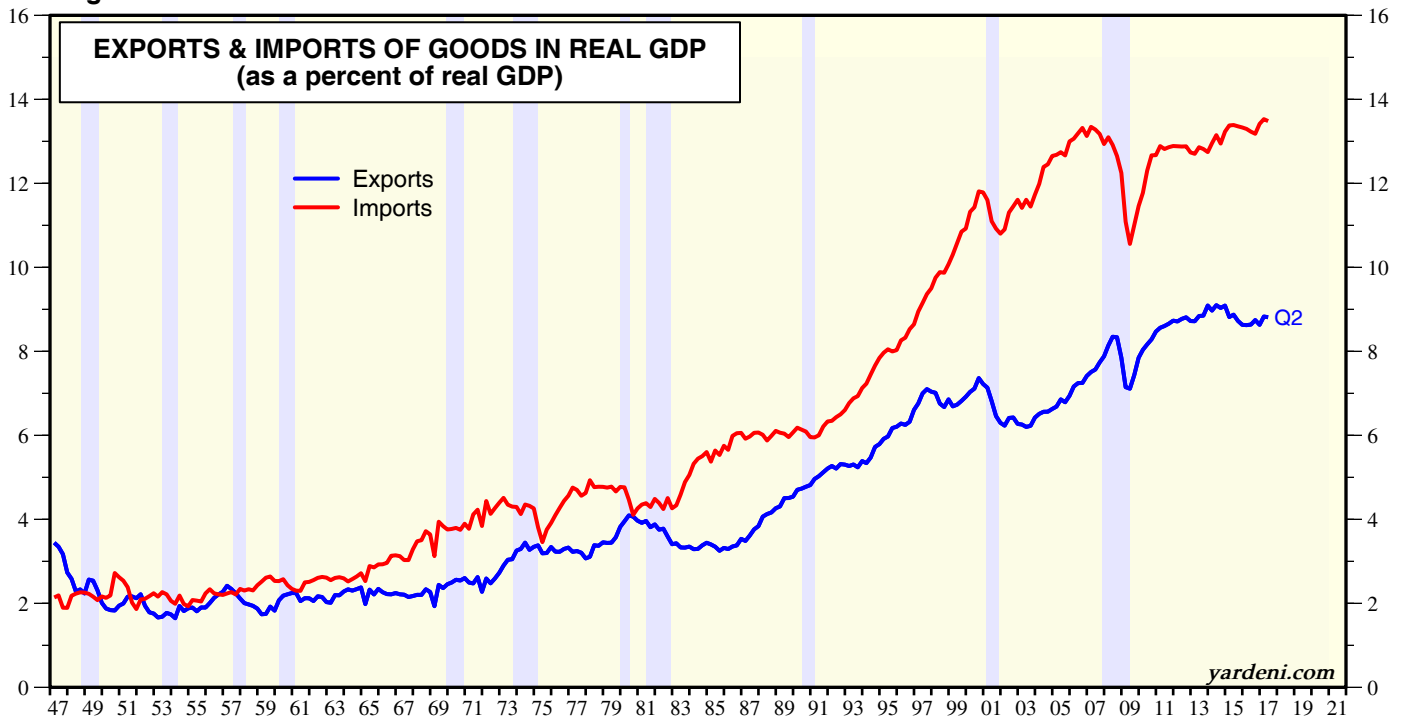

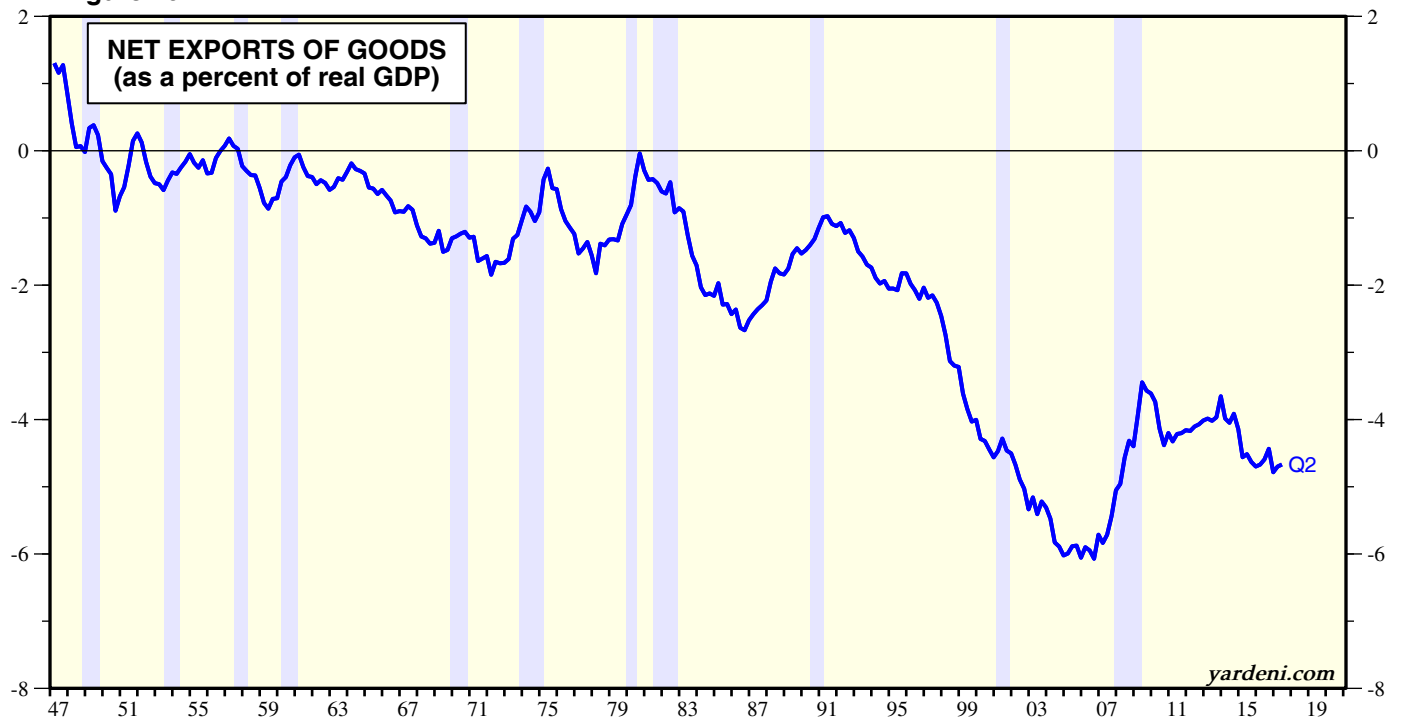
